Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Tuesday, 23 April 2019. Applicants are required to pay the maximum Offer Price of HK\$1.06 for each Public Offer Share together with 1.0% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Sole Bookrunner (for itself and on behalf of the Public Offer Underwriter) on or before Monday, 29 April 2019, the Share Offer will not proceed and will lapse.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.

The Company expects to announce the final Offer Price, the level of indication of interest in the Placing, the level of applications in the Public Offer, the basis of allocation and the results of applications of the Public Offer on Monday, 29 April 2019 on the website of the Stock Exchange at www.hkexnews.hk and the website of our Company at www.bnd-strategic.com.hk. Results of allocations in the Public Offer, and the Hong Kong Identity Card/passport/Hong Kong business registration numbers of successful applicants under the Public Offer (where applicable) will be available on the above websites.

The allocation of Offer Shares between the Public Offer and the Placing is subject to reallocation as described in the paragraph headed "Structure and conditions of the Share Offer — The Public Offer — Reallocation" in the Prospectus. The Sole Bookrunner may reallocate the Offer Shares from the Placing to the Public Offer to satisfy valid applications under the Public Offer.
