MAJOR TRANSACTION ACQUISITION OF ELEMIS

DELAY IN DESPATCH OF CIRCULAR

Reference is made to the announcement (the “**Announcement**”) issued by L’Occitane International S.A. (the “**Company**”) on 13 January 2019 in relation to the acquisition of ELEMIS through the acquisition of the Target Companies. Unless otherwise stated, terms used in this announcement shall have the same meanings as those defined in the Announcement.

Pursuant to Rule 14.41(a) of the Listing Rules, a circular (the “**Circular**”), containing among other things, details of the Acquisition, is required to be despatched to the shareholders of the Company within 15 business days after the publication of the Announcement. As stated in the Announcement, the Company expected to despatch the Circular on or before 15 April 2019.

As the financial information of the Target Group is prepared under US GAAP, it is expected that additional time is required by the Company to prepare the accountants’ report on the Target Group in International Financial Reporting Standards to comply with Rule 14.67(6)(a)(i) of the Listing Rules. The Company has applied to the Stock Exchange for a waiver from strict compliance with Rule 14.41(a) of the Listing Rules to extend the date for the despatch of the Circular. Subject to the waiver being granted, the Circular is expected to be despatched on or before 30 June 2019.
