Determination of Offer Price and Allocation of Hong Kong Public Offer Shares

The Offer Price is expected to be fixed on or around Friday, 20 December 2019. Applicants are required to pay the maximum Offer Price of HK\$1.80 for each Hong Kong Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Hong Kong Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Global Coordinators (on behalf of the Underwriters) on or before Monday, 30 December 2019, the Global Offering will not proceed and will lapse.

If the Company decides to set the Offer Price after making a Downward Offer Price Adjustment (a reduction of up to 10% below HK\$1.40 (bottom end of the indicative Offer Price range), the Company will separately announce the final Offer Price no later than 30 December 2019 on the website of the Stock Exchange at www.hkexnews.hk and the Company's website at www.newborntown.com.
