5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the U.S. Securities Act) and not be a legal or natural person of the PRC.
6. Unless permitted by the GEM Listing Rules, you cannot apply for any Public Offer Shares if you are:
 - an existing beneficial owner of shares in the Company and/or any of its subsidiaries;
 - a Director or chief executive officer of the Company and/or any of its subsidiaries;
 - a connected person of the Company or will become a connected person of the Company immediately upon completion of the Share Offer;
 - an associate of any of the above; or
 - have been allocated or have applied for or indicated an interest in any Offer Shares under the Placing or otherwise participated in the Placing.

B. If you are a nominee

C. Effect of completing and submitting this Application Form

The Offer Price is expected to be fixed on or about Tuesday, 7 January 2020. Applicants are required to pay the maximum Offer Price of HK\$1.98 for each Offer Share together with 1.0% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Sole Bookrunner (for itself and on behalf of the Underwriters) on or before Monday, 13 January 2020, the Share Offer will not proceed.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
