**ANNOUNCEMENT ON THE PROGRESS OF
THE ACQUISITION OF ASSETS BY ISSUANCE OF SHARES
AND RELATED PARTY TRANSACTIONS OF THE COMPANY**

References are made to the announcement dated 30 October 2019 in relation to the unconditional approval of the acquisition of assets by issuance of shares and related party transactions of CITIC Securities Company Limited (the “**Company**”) by the Listed Companies Merger and Reorganisation Vetting Committee of the China Securities Regulatory Commission (the “**CSRC**”) and the resumption of trading in A shares of the Company, the announcement dated 27 December 2019 in relation to obtaining approval of the acquisition of assets by issuance of shares and related party transactions of the Company from the CSRC and adjustment to the issue price and number of shares to be issued under the acquisition of assets by issuance of shares of the Company and the announcement dated 3 January 2020 on the progress of the acquisition of assets by issuance of shares and related party transactions of the Company, in relation to the completion of the industrial and commercial registration of changes in respect of the transfer of equity interest in Golden Eagle Fund Management Co., Ltd. (“**Golden Eagle**”) by Guangzhou Securities Company Limited (“**Guangzhou Securities**”) to Guangzhou Yuexiu Financial Holdings Group Co., Ltd. (“**Yuexiu Financial Holdings**”).

On 9 January 2020, the Company received a notice from Yuexiu Financial Holdings, stating that Guangzhou Futures Co., Ltd. (“**Guangzhou Futures**”) has received a confirmation of securities transfer registration issued by China Securities Depository and Clearing Corporation Limited. The securities transfer registration in relation to the transfer of its shares in Guangzhou Futures by Guangzhou Securities to Yuexiu Financial Holdings has been completed. So far, Guangzhou Securities has completed the transfer of its equity interest in Guangzhou Futures and Golden Eagle, respectively.

Currently, the acquisition of assets by issuance of shares and related party transactions of the Company are still in progress, and investors are advised to pay attention to the subsequent announcements of the Company and be aware of investment risks.
