### **GRANT OF SHARE OPTIONS**

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board of directors (the “**Board**”) of MGM China Holdings Limited (the “**Company**”) announces that on May 15, 2020, the Company offered to grant share options (the “**Share Options**”) to subscribe for a total of 220,000 shares of HKD1.00 each in the capital of the Company (the “**Shares**”) to certain eligible persons (collectively, the “**Grantees**”), subject to acceptance of the Grantees, under the revised share option scheme adopted by the Company on May 24, 2017. Vesting date of the Share Options : 25% of the Share Options granted will vest on each of May 15, 2021, May 15, 2022, May 15, 2023 and May 15, 2024
