POLL RESULTS OF THE ANNUAL GENERAL MEETING

Reference is made to the circular dated 21 April 2020 (the “**Circular**”) of Kingboard Laminates Holdings Limited (the “**Company**”) and the joint announcement dated 11 May 2020 of the Company and Kingboard Holdings Limited. Unless the context otherwise requires, capitalised terms used in this announcement have the same meaning as those defined in the Circular.

At the AGM held at 25/F., Delta House, 3 On Yiu Street, Shek Mun, Shatin, New Territories, Hong Kong on 25 May 2020, all the resolutions proposed were duly passed by way of poll.

As at the date of the AGM, a total of 3,081,000,000 ordinary shares of the Company were in issue and entitled the holders of which to attend and vote at the AGM.

The respective Directors who is also a Shareholder and subject to re-election at the AGM abstained from voting on the respective resolution concerning his own re-election. Save as disclosed above, there were no restrictions on any Shareholders to cast votes on any of the resolutions at the AGM under the Listing Rules. No Shareholder was required to attend and vote only against the resolutions at the AGM. No Shareholder has stated his/her/its intention in the Circular to vote against the resolutions or to abstain from voting at the AGM.
