RESULT OF POLL VOTING OF ANNUAL GENERAL MEETING HELD ON 26 MAY 2020

At the Annual General Meeting of Poly Property Group Co., Limited (the “Company”) held on 26 May 2020 (the “AGM”), all the proposed resolutions as set out in the Notice of Annual General Meeting dated 22 April 2020 are passed by the shareholders of the Company (the “Shareholders”) as ordinary resolutions by way of poll.

Computershare Hong Kong Investor Services Limited, the Company’s share registrar, was appointed as the scrutineer for the vote-taking at the AGM.

As at the date of the AGM, the total number of issued shares in the Company was 3,661,537,046 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There were no shares entitling the Shareholders to attend and abstain from voting in favour of the resolutions at the AGM in accordance with Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”). No Shareholder was required under the Listing Rules to abstain from voting on the resolutions at the AGM. None of the Shareholders has stated his or her or its intention in the circular of the Company dated 22 April 2020 to vote against or to abstain from voting on the resolutions at the AGM.
