5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the U.S. Securities Act) and (unless permitted by applicable PRC laws and regulations to subscribe for the Public Offer Shares) not be a legal or natural person of the PRC.

### Determination of Offer Price and allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Thursday, 2 July 2020. Applicants are required to pay the maximum Offer Price of HK\$0.40 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Bookrunners (for themselves and on behalf of the Underwriters) on or before Friday, 3 July 2020, the Share Offer will not proceed. Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
