## **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 18 AUGUST 2020**

The Board is pleased to announce that all the Proposed Resolutions set out in the Notice of AGM dated 17 July 2020 were duly passed as ordinary resolutions by the Shareholders by way of poll at the AGM held on 18 August 2020.

The board (the “**Board**”) of directors (the “**Directors**”) of Best Mart 360 Holdings Limited (the “**Company**”) is pleased to announce that all the ordinary resolutions (the “**Proposed Resolutions**”) set out in the Notice of Annual General Meeting dated 17 July 2020 (the “**Notice of AGM**”) were duly passed as ordinary resolutions by the holders (the “**Shareholders**”) of the Company’s ordinary shares of HK\$0.01 each (the “**Shares**”) by way of poll at the Annual General Meeting (the “**AGM**”) of the Company held on 18 August 2020.

As at the date of the AGM, the total number of issued Shares entitling the Shareholders to attend and vote for or against the Proposed Resolutions at the AGM was 1,000,000,000 Shares. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Proposed Resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”).

No Shareholder was required under the Listing Rules to abstain from voting on any of the Proposed Resolutions at the AGM. None of the Shareholders have stated their intention in the Company’s circular dated 17 July 2020 to vote against or to abstain from voting on any of the Proposed Resolutions at the AGM.
