DISCLOSEABLE TRANSACTION ACQUISITION OF LAND IN CHANGCHUN, THE PRC

The Board announces that on 30 September 2020, Jilin Yusei, a non-wholly owned subsidiary of the Company, entered into the Land Use Rights Transfer Contract with Changchun Land Bureau to acquire the Land in Changchun, the PRC from Changchun Land Bureau for a total consideration of RMB31,000,000. The permitted use of the Land is for industrial use.

As one or more of the applicable percentage ratios in respect of the Acquisition exceeds 5% but none of such percentage ratios is 25% or above, the Acquisition constitutes a discloseable transaction of the Company and is subject to the reporting and announcement requirements, but is exempt from the circular and shareholders' approval requirements under Chapter 14 of the Listing Rules.

BACKGROUND OF THE ACQUISITION

The Board announces that on 30 September 2020, Jilin Yusei, a non-wholly owned subsidiary of the Company, entered into the Land Use Rights Transfer Contract with Changchun Land Bureau for the acquisition of the Land in Changchun, the PRC by Jilin Yusei for a total consideration of RMB31,000,000. The Land was put up for sale by Changchun Land Bureau in an open bidding auction in which Jilin Yusei participated and was ultimately awarded with the Land. The principal terms of the Land Use Rights Transfer Contract are set out below:

DETAILS OF THE LAND USE RIGHTS TRANSFER CONTRACT

Date: 30 September 2020

<u>Parties</u>: (1) Jilin Yusei, a non-wholly owned subsidiary of the Company (as purchaser)

(2) Changchun Land Bureau (as seller)

To the best of the Directors' knowledge, information and belief after having made all reasonable enquiries, Changchun Land Bureau is a PRC Governmental Body as defined in the Listing Rules.

<u>Subject matter</u>: The land use rights to the Land.

The Land is situated at the Economic Development Zone (經開區), Changchun, the PRC with a site area of approximately 78,675 square metres.

Permitted land uses and term

Industrial use for a term of 50 years from the date of delivery of the Land.

Completion

Changchun Land Bureau shall deliver the Land, as a vacant site, to Jilin Yusei immediately after the Consideration has been settled in full.

Consideration

RMB31,000,000, being the price of the final winning bid at the open bidding auction held by Changchun Land Bureau.

Payment terms

The Consideration is payable as follows: (1) a guarantee deposit in the amount of RMB15,500,000 (being 50% of the Consideration), which has been paid prior to the date of this announcement; and (2) the remaining balance in the amount of RMB15,500,000 is payable on or before 3 October 2020. As at the date of this announcement, Jilin Yusei intends to settle the Consideration in full in cash using its internal resources.

REASONS FOR AND BENEFITS OF THE ACQUISITION

The Company is a limited company incorporated in the Cayman Islands as an exempted company with limited liability, and is an investment holding company. The principal activities of the Group are moulding fabrication, manufacturing and trading of moulds and plastic components.

The Group is planning to construct a new factory for business expansion of Jilin Yusei and the Acquisition complements well with the Group's overall strategic business development.

The Acquisition was conducted by way of an open bidding auction by Changchun Land Bureau. The Consideration reflected the final bidding price submitted by Jilin Yusei and it was determined after taking into account, among other matters, the prevailing market price of comparable land and buildings in Changchun. The Directors are of the view that the terms of the Acquisition are fair and reasonable and in the interests of the shareholders of the Company as a whole.

INFORMATION OF THE PARTIES

Jilin Yusei is a non-wholly owned subsidiary of the Company owned as to 65% by the Group. The remaining 35% is owned by Jilin Dongguang Group Co., Limited 吉林東光集團有限公司, a state-owned enterprise established in the PRC. It is principally engaged in manufacturing and trading of the plastic components.

Changchun Land Bureau is a local governmental body of the PRC, which is in charge of, among others things, the sale of land use rights to lands in Changchun.
