#### 1. 收集 閣下個人資料的原因

證券申請人及登記持有人申請證券或將證券轉往其名下,或將 名下證券轉讓予他人,或要求香港股份過戶登記分處提供服務 時,須向本公司或其代理及香港股份過戶登記分處提供準確個 人資料。

未能提供所要求的資料可能導致 閣下申請證券被拒或延遲,或本公司或其香港股份過戶登記分處無法落實證券轉讓或提供服務。此舉亦可能妨礙或延遲登記或轉讓 閣下獲接納成功申請的公開發售股份及/或寄發 閣下應得的股票及/或退款支票及/或電子自動退款指示。

證券持有人所提供的個人資料如有任何錯誤,須立即通知本公司及香港股份過戶登記分處。

#### 2. 目的

證券持有人的個人資料可以任何方式作以下用途使用、持有、 處理及/或保存:

- 處理 閣下的申請及退款支票及電子自動退款指示(如 適用)、核實是否符合本申請表格及招股章程所載條款 和申請手續及公佈公開發售股份的分配結果;
- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如適用))的名義登 記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如股息、供股和 紅股等;
- 分發本公司及其附屬公司的通訊;
- 編製統計數據和證券持有人資料;
- 披露有關資料以便就權益索償;及

與上述有關的任何其他附帶或相關目的及/或使本公司及香港股份過戶登記分處能履行對證券持有人及/或監管機構承擔的責任及/或證券持有人不時同意的任何其他目的。

#### 3. 轉交個人資料

- 向本公司或香港股份過戶登記分處提供與其各自業務營 運有關的行政、電訊、電腦、付款或其他服務的任何代 理、承包商或第三方服務供應商;
- 香港聯交所、證監會及任何其他法定監管機關或政府部 門或法例、規則或法規另行規定者;及
