CONNECTED TRANSACTION
ACQUISITION OF PROPERTIES

Reference is made to the announcement of JiaXing Gas Group Co., Ltd.* (the “**Company**”) dated 21 April 2022 (the “**Announcement**”) in relation to the connected transaction regarding the acquisition of Properties under the Sale and Purchase Agreements. The Company would like to provide the following supplemental information on the identity of the company holding the remaining 15.1% interest in Jiaying Yintai and the identities of the ultimate beneficial owners of that company. Based on publicly available information, as at the date of the Announcement, Zhejiang Jiayu Engineering Management Co., Ltd.* (浙江嘉宇工程管理有限公司) (“**Zhejiang Jiayu**”) held an interest of 15.1% in Jiaying Yintai, and Zhejiang Jiayu was owned as to 47.80% by Zhang Jian* (張建), 15.00% by Lu Yong* (盧甬), 10.00% by Zhang Qingqun* (章青群), 5.40% by Han Jiang* (韓江), 4.00% by Hu Jiaping* (胡加平), 3.00% by Dai Ling* (戴凌), 2.25% by Chen Long* (陳龍), 2.00% by Chen Zhirong* (陳志榮), 1.50% by Qian Yao* (錢曜), 1.25% by Liu Mingfa* (劉明發), 1.00% by Tao Yugen* (陶玉根), 1.00% by Pan Xuming* (潘旭明), 0.75% by Zhu Jianzhong* (朱建忠), 0.75% by Zhang Jiming* (張紀明), 0.75% by Feng Xiaohong* (馮曉洪), 0.50% by Dai Yaming* (代亞明), 0.50% by Zhou Bosong* (周伯松), 0.50% by Wang Mingkui* (王明奎), 0.50% by Wang Gongyi* (王公義), 0.50% by Lin Moucheng* (林謀成), 0.35% by Gao Wangying* (高王鶯), 0.35% by Cha Chengwei* (查成璋) and 0.35% by Zhang Sun* (張筭).
