## **CHARACTERISTICS OF GEM**

**GEM has been positioned as a market designed to accommodate small and mid-sized companies to which a higher investment risk may be attached than other companies listed on the Stock Exchange. Prospective investors should be aware of the potential risks of investing in such companies and should make the decision to invest only after due and careful consideration.**

**Given that the companies listed on GEM are generally small and mid-sized companies, there is a risk that securities traded on GEM may be more susceptible to high market volatility than securities traded on the Main Board of the Stock Exchange and no assurance is given that there will be a liquid market in the securities traded on GEM.**

## PRECAUTIONARY MEASURES FOR THE EGM

To prevent and control the spread of the coronavirus disease (“COVID-19”), the Company will take the following precautionary measures at the EGM:

- (i) compulsory body temperature checks will be conducted for every Shareholder, proxy or other attendee at each entrance of the meeting venue. Any person with a body temperature above the reference range quoted by the Department of Health from time to time, or is exhibiting flu-like symptoms, may be denied entry into or be required to leave the venue of the EGM at the Company’s discretion, to the extent permitted by the applicable laws and regulations;
- (ii) each attendee is required to wear a surgical face mask throughout the EGM and inside the meeting venue, and to maintain a safe distance from other attendees;
- (iii) any person attending the EGM will be required to scan the “Leave Home Safe” venue QR code and make a declaration as to whether they have travelled outside Hong Kong in the 14-day period prior to the EGM, and those who have travelled outside Hong Kong in the 14-day period prior to the EGM will not be permitted to attend the EGM; and
- (iv) no corporate gift will be distributed and no refreshment will be served at the EGM.

The Company reserves the right in refusing the entry of any person who does not comply with the precautionary measures to the venue of the EGM to the extent permitted by the applicable laws and regulations.

**The Company wishes to encourage the Shareholders to exercise their rights to vote at the EGM by appointing the chairman of the EGM as their proxy as an alternative to attending the EGM in person, by completing and return the proxy form attached to this circular.**

If any Shareholder chooses not to attend the EGM in person but has any question about any resolution or about the Company, or has any matter for putting to the board of directors of the Company, he/she is welcome to send such question or matter in writing to our registered office. **INTRODUCTION**

Reference is made to the AGM Poll Results Announcement in respect of the Annual General Meeting.



## LETTER FROM THE BOARD

As disclosed in the AGM Poll Results Announcement, the voting on each of the Resolution nos. 2(g), 3, 4, 5 and 6 (the “**Outstanding Resolutions**”) were temporarily withheld at the Annual General Meeting due to different views among the Directors present on certain procedural issues which are to be clarified after professional advice is being sought.

The procedural issues on which the Directors had divergence of views at the Annual General Meeting was concerned about whether or not a resolution proposed at a general meeting is legally or necessarily required to be moved by a Shareholder and/or seconded by another Shareholder before it can be put forward to the Shareholders for voting at a general meeting (the “**Procedural Issues**”).

In this connection, the Company has sought legal advice on the Procedural Issues from its Cayman Islands legal advisers, Conyers Dill & Pearman (the “**Cayman Legal Advisers**”). As advised by the Cayman Legal Advisers, (i) whilst it is custom for shareholders to propose a resolution, the chairman of a meeting is required to ensure that the business of a meeting, namely the resolutions set out in the notice of the meeting, should be properly considered. It is therefore incumbent on the chairman of a meeting to ensure that the business of the meeting, namely the resolutions set out in the notice of meeting are put and considered by shareholders at the meeting *without any additional motion* and (ii) there is *no* requirement under the Companies Act, Cap. 22 (Act 3 of 1961, as consolidated and revised) of the Cayman Islands that a resolution of a meeting of shareholders be seconded nor is there such a requirement under Cayman Islands common law.

As the Procedural Issues have been clarified, the Board would convene and hold an Extraordinary General Meeting to put forward, among other Resolutions, the Outstanding Resolutions for consideration and (if thought fit) approval by the Shareholders.

The primary purposes of this circular are to provide you with information regarding (a) the Outstanding Resolutions (which were withheld from voting at the Annual General Meeting) that are to be put to Shareholders for voting at the Extraordinary General Meeting; (b) the re-election of those Directors appointed by the Board after the Annual General Meeting (namely, Mr Chan Kin Chung and Mr Chan William) pursuant to the Articles of Association so as to enable Shareholders to make an informed decision on whether to vote for or against those resolutions and (c) to give you notice of the Extraordinary General Meeting.

The resolutions to be proposed at the Extraordinary General Meeting include:

- (i) ordinary resolutions relating to the proposed re-election of Directors;
- (ii) ordinary resolution relating to the grant of authority to the Board to fix the remuneration of Directors (*being Resolution no. 2(g) originally proposed at the AGM*);
- (iii) ordinary resolution relating to the re-appointment of the Auditor (*being Resolution no. 3 originally proposed at the AGM*); and

- (iv) ordinary resolutions relating to the grant of the General Mandate, the Buy-back Mandate and the Extension Mandate (*being Resolution nos. 4, 5 and 6 originally proposed at the AGM*).

### **GRANT OF BUY-BACK MANDATE, GENERAL MANDATE AND EXTENSION MANDATE**

At the Extraordinary General Meeting, an ordinary resolution will be proposed to grant to the Directors a general and unconditional mandate to exercise all powers of the Company to purchase or buy back issued Shares. The maximum number of Shares that may be purchased or bought back pursuant to the Buy-back Mandate will be such number which represents 10% of the aggregate number of Shares in issue as at the date of passing of the relevant resolution subject to the GEM Listing Rules.

The Buy-back Mandate will lapse on the earliest of (i) the conclusion of the next annual general meeting of the Company, or (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws to be held, or (iii) the date on which such authority is revoked or varied by an ordinary resolution of the Company in a general meeting.

The explanatory statement required by the GEM Listing Rules to be sent to the Shareholders in connection with the proposed resolution to grant to the Directors the Buy-back Mandate is set out in **Appendix I** to this circular. This contains all the information reasonably necessary to enable Shareholders to make an informed decision on whether to vote for or against the resolution.

At the Extraordinary General Meeting, an ordinary resolution will be proposed to grant to the Directors a general and unconditional mandate to allot, issue, and deal with further Shares representing up to 20% of the aggregate number of Shares in issue as at the date of passing of the relevant resolution.

Subject to the passing of the ordinary resolution of the Buy-back Mandate and the General Mandate, an ordinary resolution will also be proposed to grant to the Directors the Extension Mandate to authorise the Directors to issue new Shares in an amount not exceeding the aggregate number of the Shares purchased or bought back pursuant to the Buy-back Mandate.

Based on 600,000,000 Shares in issue as at the Latest Practicable Date and on the basis that no new Shares will be issued and no Shares will be purchased or bought back by the Company for the period from the Latest Practicable Date up to and including the date of the Extraordinary General Meeting:

- (1) subject to the passing of the proposed resolution granting the General Mandate to the Directors, the Company will be allowed under the General Mandate to issue up to a maximum of 120,000,000 Shares, representing 20% of the Shares in issue as at the Latest Practicable Date; and

- (2) subject to the passing of the proposed resolution granting the Buy-back Mandate to the Directors, the Company will be allowed under the Buy-back Mandate to purchase or buy back up to a maximum of 60,000,000 Shares, representing 10% of the Shares in issue as at the Latest Practicable Date.

The Directors wish to state that they have no immediate plans to purchase or buy back any Shares or to allot and issue any new Shares, other than Shares which may fall to be allotted and issued upon the exercise of any options granted under the share option scheme of the Company.

### RE-ELECTION OF DIRECTORS

At as the Latest Practicable Date, the Board consisted of six (6) Directors, namely:

In accordance with Article 84(1) of the Articles of Association, at each annual general meeting of the Company, one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at least once every three years. At the Annual General Meeting, Mr Ng Chin Hung (an executive Director) and Mr Lee Kwong Chak Bonnio (an independent non-executive Director) had retired pursuant to Article 84(1) of the Articles of Association and being eligible, offered themselves for re-election at the Annual General Meeting. The resolutions for their re-election as Directors were both approved at the Annual General Meeting.

According to Article 83(3) of the Articles of Association, any Director appointed by the Board (i) to fill a casual vacancy on the Board shall hold office until the first general meeting of Shareholders after his appointment and be subject to re-election at such meeting or (ii) as an addition to the existing Board shall hold office until the next following annual general meeting of the Company and shall then be eligible for re-election.

By virtue of Article 83(3) of the Articles of Association, the office of Mr Chan Kin Chung and Mr Chan William will each end at the Extraordinary General Meeting, and, being eligible, will offer himself for re-election at the Extraordinary General Meeting.

Biographical details of each of the above retiring Directors who has offered himself for re-election at the Extraordinary General Meeting are set out in **Appendix II** to this circular.

### **Views and recommendation of the Nomination Committee and the Board**

The Nomination Committee, having reviewed the composition of the Board and to ensure a balance of skills, experience and diversity of perspective appropriate to the business of the Group among members of the Board, had nominated Mr Chan Kin Chung and Mr Chan William to the Board for it to recommend to the Shareholders for re-election at the Extraordinary General Meeting.

Mr Chan William, being a member of the Nomination Committee, had abstained from voting at the relevant meeting of the Nomination Committee when his nomination was being considered.

The nominations were made by the Nomination Committee in accordance with the nomination policy and the objective criteria (including but not limited to background, experience, skills and knowledge), with due regard for the benefits of diversity of the Board, the commitment of the nominated Directors to their respective roles and functions within the Group and their respective contributions brought and/or expected to be brought to the Group. None of the Directors who is nominated for re-election at the Extraordinary General Meeting holds seven or more directorship in any listed companies.

The Nomination Committee was satisfied with the independence of Mr Chan William (as independent non-executive Director) having regard to the independence criteria as set out in Rule 5.09 of the GEM Listing Rules.

The Board accepted the Nomination Committee's nominations. The Board was and is satisfied that each of the Directors proposed to be re-elected (i) had properly discharged his duties and responsibilities as a Director and had made or is expected to continue to make positive contributions to the development of the Group through constructive comments and participation at the business and other affairs relating to the Group and (ii) is a person of integrity and stature. The Board believes that the re-election and continued appointment of each of the Directors proposed to be re-elected will allow the Group to continue benefit from the sharing of his invaluable experience, contribution and participation, which is in the interests of the Company and the Shareholders as a whole. The Board, therefore, recommended each of these retiring Directors to stand for re-election by Shareholders at the Extraordinary General Meeting.

Each of the Directors proposed to be re-elected at the Extraordinary General Meeting had abstained from the discussion and voting at the meeting of the Board regarding their respective nominations.

### **RE-APPOINTMENT OF THE AUDITOR**

Messrs McM (HK) CPA Limited has retired as the auditor of the Company at the Annual General Meeting and being eligible, will offer themselves for re-appointment as the auditor of the Company at the Extraordinary General Meeting.

### **ACTIONS TO BE TAKEN**

Set out on pages N-1 to N-7 of this circular is a notice convening the Extraordinary General Meeting at which ordinary resolutions will be proposed to approve each of the resolutions set out in the notice.

### **RECOMMENDATIONS**

The Directors consider that the proposals regarding the grant of the General Mandate, the Buy-back Mandate and the Extension Mandate, the re-election of Directors, the grant of authority to the Board to fix the remuneration of Directors and the re-appointment of the Auditor are in the best interests of the Company and the Shareholders as a whole and recommend the Shareholders to vote in favour of the relevant resolutions at the Extraordinary General Meeting.

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the GEM Listing Rules for the purpose of giving information with regard to the Company. This appendix serves as an explanatory statement, as required under Rule 13.08 of the GEM Listing Rules, to provide Shareholders with all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the ordinary resolution to approve the grant of the Buy-back Mandate to the Directors.

## **1. GEM LISTING RULES RELATING TO BUY-BACK OF SHARES**

The GEM Listing Rules permit companies whose primary listings are on the Stock Exchange to purchase or buy back their securities on the Stock Exchange and any other stock exchange on which securities of the company are listed and such exchange is recognised by the Securities and Futures Commission of Hong Kong subject to certain restrictions. Among such restrictions, the GEM Listing Rules provide that the shares of such company must be fully paid up and all buy-backs of shares by such company must be approved in advance by an ordinary resolution of shareholders, either by way of a general mandate or by specific approval of a particular transaction.

## **2. SHARE CAPITAL**

As at the Latest Practicable Date, there were a total of 600,000,000 Shares in issue.

Subject to the passing of the proposed resolution granting the Buy-back Mandate and on the basis that no new Shares are issued and no Shares are purchased or bought back for the period from the Latest Practicable Date up to and including the date of the Annual General Meeting, the Company will be allowed under the Buy-back Mandate to buy back up to a maximum of 60,000,000 Shares, representing 10% of the issued share capital of the Company as at the Latest Practicable Date.

## **3. REASONS FOR THE BUY-BACKS**

The Directors believe that the Buy-back Mandate is in the best interests of the Company and the Shareholders as a whole to seek a general authority from the Shareholders to enable the Company to purchase or buy back Shares on the Stock Exchange or any other stock exchange on which the Shares are listed. Such purchase(s) or buy back(s) may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such purchase(s) or buy-backs will benefit the Company and the Shareholders as a whole.

## **4. FUNDING OF BUY-BACKS**

In making any purchase or buy-back of Shares, the Company may only apply funds legally available for such purposes in accordance with the memorandum of association of the Company, the Articles of Association, the applicable laws of the Cayman Islands, the GEM Listing Rules and all other applicable laws, rules and regulations (as the case may be).

The Company may not purchase or buy back its own Shares on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange in effect from time to time.

<b>APPENDIX I      EXPLANATORY STATEMENT FOR THE BUY-BACK MANDATE</b>

Subject to the foregoing, any purchase or buy back of the Shares by the Company may be made out of profits of the Company, out of share premium, or out of the proceeds of a fresh issue of the Shares made for the purpose of the purchase or buy back or, subject to the Companies Act, out of capital. Any amount of premium payable on the purchase or buy back over the par value of the Shares to be purchased or bought back must be out of profits of the Company, out of the Company's share premium account before or at the time the Shares are purchased or bought back, or subject to the Companies Act, out of capital.

#### **5. MATERIAL ADVERSE IMPACT IN THE EVENT OF BUY-BACK IN FULL**

Taking into account the current working capital position of the Group, the Directors consider that, if the Buy-back Mandate were to be carried out in full at any time during the proposed buy-back period, it might have a material adverse impact on the working capital and/or gearing position of the Company as compared with the position as at 31 December 2021, being the date on which its latest published audited consolidated financial statements were made up. However, the Directors do not intend to exercise the Buy-back Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing position of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

## 7. UNDERTAKING

He is also the founder of Comboxx Group, a logistics technology company dedicated to developing the largest fully automated warehouse with the application of automation, AI and blockchain technology. He is also the founder and chief investment officer of Star Capital Group Limited, a private equity company, which focuses on the investments in real estate projects and technology ventures. Mr Chan has over 15 years of professional experience in corporate finance, asset management and real estate project investment.

Mr Chan has entered into a letter of appointment with the Company for an initial term of one year commencing on 10 June 2022, renewable automatically for successive terms of one year upon expiry of the then current term of his appointment, unless terminated by either the Company or Mr Chan by giving at least three months’ written notice before the expiry of the then existing term. Mr Chan is also subject to retirement by rotation and re-election in accordance with the provisions of the Articles of Association.

As a non-executive Director and the Chairman of the Board, Mr Chan is entitled to an annual remuneration of HK\$600,000. He is also entitled to be reimbursed for all necessary and reasonable out-of-pocket expenses properly incurred in connection with the performance of his duties to the Company, and such other benefits as may be determined by, and at the discretion of, the Board (upon recommendation of the remuneration committee of the Board) from time to time. Mr Chan’s remuneration package is determined by the Board according to the Group’s policy on Directors’ and senior management’s remuneration (having considered such factors including his qualifications, experience, duties and responsibilities with the Company, as well as the Company’s performance and the prevailing market conditions).

As at the Latest Practicable Date and save as disclosed above, Mr Chan:

Prior to founding Wall CPA Limited, Mr W Chan had worked in Crowe Horwath (HK) CPA Limited as a senior audit manager from February 2009 to April 2016 and in the assurance department of PricewaterhouseCoopers from December 2003 to February 2009, where he was responsible for various audit, merger and acquisition and initial public offering assignments for clients from various backgrounds, including some highly specialised industries such as telecommunication, banking, mining, petroleum, gaming, agriculture, education, etc. The experience Mr W Chan has gained throughout his career has developed his diverse, in-depth and up-to-date knowledge in the current business world and capital market.

Mr W Chan is currently an independent non-executive director and the chairman of the audit committee of JTF International Holdings Limited, a GEM-listed issuer (stock code: 8479).

Mr W Chan has entered into a letter of appointment with the Company for an initial term of one year commencing on 10 June 2022, renewable automatically for successive terms of one year upon expiry of the then current term of his appointment, unless terminated by either the Company or Mr W Chan by giving at least three months' written notice before the expiry of the then existing term. Mr W Chan is also subject to retirement by rotation and re-election in accordance with the provisions of the Articles of Association.

As an independent non-executive Director, a member of the audit committee, the chairman of the remuneration committee and a member of the nomination committee of the Board, Mr W Chan is entitled to an annual remuneration of HK\$300,000. He is also entitled to be reimbursed for all necessary and reasonable out-of-pocket expenses properly incurred in connection with the performance of his duties to the Company, and such other benefits as may be determined by, and at the discretion of, the Board from time to time. Mr W Chan's remuneration package is determined by the Board according to the Group's policy on the Directors' and senior management's remuneration (having considered such factors including his qualifications, experience, duties and responsibilities with the Company, as well as the Company's performance and the prevailing market conditions).
