**POLL RESULTS OF ANNUAL GENERAL MEETING
HELD ON JUNE 28, 2022**

Reference is made to the circular of Maoyan Entertainment (the “**Company**”) dated April 26, 2022 (the “**Circular**”). Unless the context otherwise requires, capitalized terms used herein shall have the same meanings as those defined in the Circular.

At the AGM held on June 28, 2022, poll voting was demanded by the chairman of the AGM for voting on all the proposed resolutions as set out in the notice of AGM dated April 26, 2022.

As at the date of the AGM, the total number of issued shares of the Company was 1,143,646,425 shares, which was the total number of Shares entitling the holders to attend and vote on the resolutions proposed at the AGM. There was no Share entitling the Shareholders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 13.40 of the Listing Rules. No Shareholder was required under the Listing Rules to abstain from voting at the AGM and none of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on any of the proposed resolutions at the AGM.

Among the twelve directors of the Company, Mr. Zheng Zhihao, Mr. Wang Changtian, Ms. Wang Jian, Mr. Chen Shaohui, Mr. Tang Lichun, Troy, Mr. Wang Hua and Mr. Chan Charles Sheung Wai attended the AGM either in person or by electronic means while the other directors were unable to attend the AGM due to other work commitment.

The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. The poll results in respect of the resolutions proposed at the AGM were as follows:
