# Chairman's Message

## 主席訊息

On behalf of the board of directors (the "Board"), I hereby present the annual results of China Best Group Holding Limited (the "Company") and its subsidiaries (the "Group") for the year ended 31 March 2022.

Looking back to the past financial year, the number of confirmed cases has remained high around the world due to the successive emergence of the novel coronavirus (COVID-19) variants, Delta and Omicron. Even though mainland China and Hong Kong have adhered to a stringent strategy to prevent the pandemic, both still failed to avoid the pandemic from reaching a record high. Under such severe circumstance, the Group's business operations were affected to a certain extent, especially the property brokerage business. During this financial year, there were three major changes at the business level: (i) the Group disposed of its Chongming Island project and exited the property development business during the year due to the uncertainties and risks of this business; (ii) the Group increased its shareholding in an associate engaged in big data services, making it a subsidiary of the Group to create better synergy effects with the Group's other real-estate related businesses and the metaverse-related businesses that will be expanded later; and (iii) in the first quarter of 2022, the Group announced to build an ecological environment of the whole industry chain of metaverse and to develop the metaverse related businesses, but the related businesses were still in the initial stage and no revenue has been generated during the year. Except for the impact of the pandemic and the aforementioned changes, each of the Group's other major businesses remained generally stable. The Group was still committed to consolidating existing businesses, strengthening operation management and cost control. Meanwhile, net loss for the year of the Group was further reduced. The Group also completed a funding raising activity by way of rights issue during the year to strengthen its capital strength and lay the foundation for further business expansion.

本人謹代表董事局（「董事局」）提呈國華集團控股有限公司（「本公司」）及其附屬公司（「本集團」）截至二零二二年三月三十一日止年度之全年業績。

回顧過去財年，因新型冠狀病毒(COVID-19)變種Delta和Omicron的前後出現，疫情數字在世界各地居高難下，即使中國內地及香港始終堅守嚴謹的防疫策略，兩地仍未能避免疫情出現新高峰。在此嚴峻形勢下，本集團業務進展受到一定程度的影響，尤其是物業經紀業務。本財年期間，業務層面主要變動有三項：（一）由於經營物業開發業務具有不確定性和風險，本集團於年內出售持有的崇明島項目並退出該業務；（二）本集團增持了從事於大數據服務之聯營公司的股份，使其成為集團附屬公司更好地與本集團其他房地產相關業務和之後拓展的元宇宙相關業務產生協同效應；（三）於二零二二年第一季度，本集團宣佈將為元宇宙生態環境打造完整產業鏈以及發展元宇宙相關業務，目前相關業務仍在初始階段，年內暫未產生收益貢獻。撇除疫情因素影響和前述變動外，本集團的其他各項主要業務發展大致平穩。本集團仍不斷致力於鞏固現有業務，加強運營管理，實施成本控制。本集團年內的淨虧損也獲得進一步縮窄。本集團亦在年內完成一次供股集資活動，藉此加強資本實力，為深入拓展業務奠定基礎。

## Chairman's Message 主席訊息

Looking forward into 2023, the global economic recovery will face difficulties against the backdrop of the continuing novel coronavirus (COVID-19) pandemic and the military and political conflicts among the world superpowers. Due to the inflation trend caused by supply-demand imbalance, many of the world's major economies have tightened their monetary policies, creating a more challenging business environment. The Group will remain focus on mainland China and Hong Kong as its place of business. Under the background of state support and social stability, Hong Kong, the Group's listing place, is expected to continue to give play to its own advantages in line with the national strategy in an effective manner. Hong Kong's capital market still has a unique advantage for the listing and financing of mainland Chinese companies and attracting foreign capital to the mainland market, and its status of a global financial center remains unshakable. Rooted in mainland China and Hong Kong, the Group has always been confident about the future operation of the business. The Group will continue to strengthen the development of its main businesses, including exploiting metaverse related business opportunities by leveraging its existing business advantages, and seek opportunities to expand the synergy among various businesses. On the other hand, the Group will still pay attention to mergers and acquisitions opportunities that appear from time to time and introduce promising projects where appropriate to further improve the profitability of the Group, intensify the sustainability of its business and bring benefits to the shareholders of the Company.

Last but not least, on behalf of the Board, I would like to extend my heartfelt thanks to the management, all our employees and partners for their contributions to the development of the Group as well as to shareholders for their continued support to the Company. With the support and contributions from all parties, the Group will continue to strive for the best to achieve a better performance and create a greater value for our shareholders!

# Management Discussion and Analysis

## 管理層討論及分析

### OVERVIEW

Pursuant to a resolution of the Board dated 19 June 2020, the Company's financial year end date has been changed from 31 December to 31 March commencing from the financial year of 2020/2021. Accordingly, the current financial year will cover a period of twelve months from 1 April 2021 to 31 March 2022. The corresponding comparative amounts shown covered fifteen months from 1 January 2020 to 31 March 2021, and therefore may not be entirely comparable with amounts shown for the current period.

For the year ended 31 March 2022, the Group's turnover was approximately HK\$858.5 million, representing an decrease of 27.6% as compared with approximately HK\$1,186.3 million for the fifteen months ended 31 March 2021. The net loss for the year ended 31 March 2022 was approximately HK\$11.1 million as compared with approximately HK\$36.4 million for the fifteen months ended 31 March 2021. The decrease in loss was mainly attributable to the combined effect of, among other thing, (i) the increase in unrealised gain on fair value change on financial assets at fair value through profit or loss by approximately HK\$8.5 million based on independent valuation results, (ii) the recognition of a gain on disposal of a subsidiary of approximately HK\$48.2 million, and (iii) the increase in impairment loss on the Group's assets by approximately HK\$24.2 million in aggregate.

### BUSINESS AND FINANCIAL REVIEW

#### Finance Leasing Business

The Group commenced its finance leasing business in July 2015 and has been engaged in providing finance lease services in the People's Republic of China (the "PRC"). The principal focus of the Group's finance leasing business is to provide an alternative way of financing to corporate clients in the PRC via a sale and lease-back arrangement of tangible assets, like plant and machinery, as well as to render consultancy services with respect of finance leasing. For the year ended 31 March 2022, the turnover of the Group's finance leasing business amounted to approximately HK\$2.3 million (fifteen months ended 31 March 2021: approximately HK\$2.9 million). Corresponding segment loss of approximately HK\$12.2 million, including the impairment loss of approximately HK\$10.8 million, was incurred for the year ended 31 March 2022 (fifteen months ended 31 March 2021: approximately HK\$4.8 million).

### 概要

根據日期為二零二零年六月十九日的董事局決議，本公司財政年度結算日由二零二零年／二零二一年財政年度開始，由十二月三十一日更改為三月三十一日。因此，本財政年度將涵蓋自二零二一年四月一日至二零二二年三月三十一日止十二個月期間。所示相應比較金額涵蓋自二零二零年一月一日至二零二一年三月三十一日止十五個月，故此或不可完全地與本期間所示之金額相比較。

截至二零二二年三月三十一日止年度，本集團之營業額約為858,500,000港元，較截至二零二一年三月三十一日止十五個月之約1,186,300,000港元減少27.6%。截至二零二二年三月三十一日止年度之虧損淨額約為11,100,000港元，而截至二零二一年三月三十一日止十五個月則為約36,400,000港元。虧損減少乃主要由於（其中包括）(i)根據獨立估值結果，按公平值計入損益之金融資產公平值變動之未變現收益增加約8,500,000港元，(ii)確認出售一間附屬公司收益約48,200,000港元，及(iii)本集團資產減值虧損增加合共約24,200,000港元的綜合影響。

### 業務及財務回顧

#### 融資租賃業務

本集團於二零一五年七月開展其融資租賃業務，並於中華人民共和國（「中國」）從事提供融資租賃服務。本集團融資租賃業務主要專注於通過有形資產（例如廠房及機器）的售後租回安排為中國企業客戶提供另一種融資方式，以及就融資租賃提供諮詢服務。截至二零二二年三月三十一日止年度，本集團融資租賃業務之營業額約為2,300,000港元（截至二零二一年三月三十一日止十五個月：約2,900,000港元）。截至二零二二年三月三十一日止年度產生相應分部虧損約12,200,000港元，包括減值虧損約10,800,000港元（截至二零二一年三月三十一日止十五個月：約4,800,000港元）。

## 管理層討論及分析

### Money Lending Business

The Group holds a money lenders licence in Hong Kong and provides loan facilities to prospective customers including enterprises and individuals. This segment has begun to generate returns to the Group since April 2016. For the year ended 31 March 2022, the turnover of the Group's money lending business amounted to approximately HK\$23.8 million (fifteen months ended 31 March 2021: approximately HK\$25.4 million). Corresponding segment loss of approximately HK\$3.8 million, including the impairment loss on loan and interest receivables of approximately HK\$23.0 million, was incurred for the year ended 31 March 2022 (fifteen months ended 31 March 2021: segment profit of approximately HK\$16.9 million).

### Securities and Futures Brokerage Business

The Group has been providing brokerage services for securities and futures traded on exchanges in Hong Kong and major overseas countries since August 2017. For the year ended 31 March 2022, the turnover of the Group's securities and futures brokerage business amounted to approximately HK\$0.4 million (fifteen months ended 31 March 2021: approximately HK\$1,000). Considering this segment's past performance and the current conditions, in particular uncertainties in the financial market, an impairment loss on goodwill of HK\$14.0 million was recognised in the year ended 31 March 2022 with the reference to the valuation result conducted by independent professional valuers. Corresponding segment loss of approximately HK\$19.1 million, including the impairment loss on goodwill, was incurred for the current year (fifteen months ended 31 March 2021: approximately HK\$21.1 million, including the impairment loss on goodwill of approximately HK\$13.0 million).

### Trading Business

With the established distribution channels and upstream suppliers network in niche market of electronics, the trading of goods business mainly focuses on trading of semi-finished electronic components produced in mainland China and Taiwan which are equippable to mobile electronic appliances and laptops computers. For the year ended 31 March 2022, the turnover of the Group's trading business amounted to approximately HK\$345.6 million (fifteen months ended 31 March 2021: approximately HK\$571.4 million) whereas the gross profit was approximately HK\$5.1 million (fifteen months ended 31 March 2021: approximately HK\$7.5 million). The Group recorded a loss of approximately HK\$8.7 million (fifteen months ended 31 March 2021: approximately HK\$9.9 million) in this segment.

### 借貸業務

本集團持有香港放債人牌照並向包括企業及個人在內之潛在客戶提供貸款融資。此分部已自二零一六年四月起開始為本集團產生回報。截至二零二二年三月三十一日止年度，本集團借貸業務之營業額約為23,800,000港元（截至二零二一年三月三十一日止十五個月：約25,400,000港元）。截至二零二二年三月三十一日止年度產生相應分部虧損約3,800,000港元，包括應收貸款及利息減值虧損約23,000,000港元（截至二零二一年三月三十一日止十五個月：分部溢利約16,900,000港元）。

### 證券及期貨經紀業務

本集團自二零一七年八月起一直為於香港及主要海外國家交易所買賣之證券及期貨提供經紀服務。截至二零二二年三月三十一日止年度，本集團證券及期貨經紀業務之營業額約為400,000港元（截至二零二一年三月三十一日止十五個月：約1,000港元）。經考慮此分部的過往表現及現時狀況，特別是金融市場的不穩定性，經參考獨立專業估值師進行的估值結果，截至二零二二年三月三十一日止年度已確認商譽減值虧損14,000,000港元。於本年度產生相應分部虧損（包括商譽減值虧損）約19,100,000港元（截至二零二一年三月三十一日止十五個月：約21,100,000港元，包括商譽減值虧損約13,000,000港元）。

### 買賣業務

憑藉在電子細分市場建立的分銷渠道及上游供應商網絡，買賣商品業務主要專注於買賣中國內地及台灣所生產的半成品電子元件，其可配備至移動電子設備及筆記本電腦。截至二零二二年三月三十一日止年度，本集團買賣業務之營業額約為345,600,000港元（截至二零二一年三月三十一日止十五個月：約571,400,000港元），而毛利約為5,100,000港元（截至二零二一年三月三十一日止十五個月：約7,500,000港元）。本集團在此分部錄得虧損約8,700,000港元（截至二零二一年三月三十一日止十五個月：約9,900,000港元）。

## 管理層討論及分析

### Securities Investment Business

It represents trading of listed equity securities in the Hong Kong stock market and dividend income (if any) from such listed equity securities. For the year ended 31 March 2022, the Group did not trade any listed equity securities and hence no turnover and realised gain/loss of the Group's securities investment business was generated (fifteen months ended 31 March 2021: turnover of HK\$3.8 million and realised gain on the listed securities of approximately HK\$2.3 million was recorded). As the Group did not hold any trading securities during the year and at the end of the reporting period (31 March 2021: nil), the Group did not receive any dividend income (fifteen months ended 31 March 2021: nil) and did not record any unrealised fair value gain/loss on the Group's securities investment for the year ended 31 March 2022 (fifteen months ended 31 March 2021: nil).

### Freight Forwarding Business

The freight forwarding business of the Group provides international air and sea freight forwarding and logistic services to local customers in Singapore and the United State of America which consist of small and medium trading companies and forwarders. During the year, the freight forwarding business in United States of America was faded out for the reason of resources reallocation. For the year ended 31 March 2022, the turnover of the Group's freight forwarding business amounted to approximately HK\$1.2 million (fifteen months ended 31 March 2021: approximately HK\$2.0 million). Corresponding gross profit of approximately HK\$0.4 million and segment loss of approximately HK\$0.4 million were made for the current year respectively (fifteen months ended 31 March 2021: gross profit of approximately HK\$0.7 million and segment loss of approximately HK\$1.0 million).

### Property Investment Business

The Group acquired a group of companies which mainly hold the investment properties in the PRC for rental income and capital appreciation since January 2019. For the year ended 31 March 2022, the rental income generated from such investment properties amounted to approximately HK\$7.1 million (fifteen months ended 31 March 2021: nil). Corresponding profit of approximately HK\$12.0 million (fifteen months ended 31 March 2021: segment loss of approximately HK\$1.9 million) was made in this segment. As at 31 March 2022, the fair value of the investment properties was approximately HK\$129.0 million after addition of unrealised fair value gain of approximately HK\$6.6 million with reference to the valuation result conducted by independent professional valuers (2021: approximately HK\$117.6 million).

### 證券投資業務

該業務指於香港股票市場買賣上市股本證券及來自有關上市股本證券之股息收入(如有)。截至二零二二年三月三十一日止年度，本集團並無買賣任何上市股本證券，因而本集團的證券投資業務並無產生任何營業額及已變現收益／虧損(截至二零二一年三月三十一日止十五個月：錄得營業額3,800,000港元及上市證券已變現收益約2,300,000港元)。由於本集團於年內及報告期末並無持有任何交易證券(二零二一年三月三十一日：無)，本集團於截至二零二二年三月三十一日止年度並無收到任何股息收入(截至二零二一年三月三十一日止十五個月：無)，且本集團的證券投資業務並無錄得任何未變現公平值收益／虧損(截至二零二一年三月三十一日止十五個月：無)。

### 貨運業務

本集團的貨運業務指向新加坡及美利堅合眾國的本地客戶(包括中小型貿易公司及貨運代理)提供國際航空及海上貨運以及物流服務。年內，美利堅合眾國的貨運業務由於資源重新配置而式微。截至二零二二年三月三十一日止年度，本集團貨運業務之營業額約為1,200,000港元(截至二零二一年三月三十一日止十五個月：約2,000,000港元)。於本年度內分別錄得相應毛利約400,000港元及分部虧損約400,000港元(截至二零二一年三月三十一日止十五個月：毛利約700,000港元及分部虧損約1,000,000港元)。

### 物業投資業務

本集團自二零一九年一月起收購一組公司，該等公司主要持有於中國為賺取租賃收入及資本增值之投資物業。截至二零二二年三月三十一日止年度，該等投資物業產生之租賃收入約為7,100,000港元(截至二零二一年三月三十一日止十五個月：零)。此分部錄得相應溢利約12,000,000港元(截至二零二一年三月三十一日止十五個月：分部虧損約1,900,000港元)。於二零二二年三月三十一日，經參考獨立專業估值師進行的估值結果，於增添未變現公平值收益約6,600,000港元後，投資物業之公平值約為129,000,000港元(二零二一年：約117,600,000港元)。

### Property Brokerage Business

The Group has been engaged in provision of residential and commercial property brokerage services in the PRC since June 2019. Currently, the major places of business activities are in Xi'an, Shaanxi Province and Xiangshan City, Zhejiang Province of the PRC. During the year, due to the re-bounce of coronavirus (COVID-19) cases in mainland China, the sentiment of real estate market was inevitably affected, which further disrupted the implementation of plans and projects of the Group. For the year ended 31 March 2022, no turnover of the Group's property brokerage business was generated (fifteen months ended 31 March 2021: approximately HK\$45.3 million) and the gross loss of approximately HK\$2.1 million was recorded (fifteen months ended 31 March 2021: gross profit of approximately HK\$28.0 million). Corresponding loss of approximately HK\$5.7 million was made in this segment (fifteen months ended 31 March 2021: segment profit of approximately HK\$19.8 million).

### Customised Technical Support Business

After the Group acquired a group of companies which are principally engaged in the provision of financial information, solutions and data analytical services to customers in finance and property related field in the PRC in August 2021, the Group combined such newly acquired business with its building architecture and interior design business so as to provide customised technical support services to customers in the PRC. For the year ended 31 March 2022, the turnover of the Group's customised technical support business amounted to approximately HK\$20.8 million (fifteen months ended 31 March 2021: approximately HK\$4.6 million) and the gross profit of approximately HK\$10.9 million was recorded (fifteen months ended 31 March 2021: approximately HK\$4.6 million). Segment loss of approximately HK\$0.7 million was incurred during the current year (fifteen months ended 31 March 2021: approximately HK\$8.1 million).

### Property Development and Project Management Business

The Group acquired a company in March 2020 which is principally engaged in property development in the PRC and holds land use rights of a land parcel at Haiyong Road, Haiyong Country, Haimen City, Jiangsu Province, with a total site area of 47,519 square meters and for commercial use. The Group originally is planning to develop properties for sale on such land parcel. However, due to various challenges and difficulties faced by property developers in the PRC and, in particular, a certain degree of volatility in property prices in the area where the Land Parcel is located at, the Group disposed the company engaged in property development business on 31 March 2022 and recognised the gain on disposal of approximately HK\$48.2 million. Immediately following the disposal, the Group ceased its property development business segment.

### 物業經紀業務

本集團自二零一九年六月起於中國從事提供住宅及商業物業經紀服務。目前，業務活動主要地點位於中國陝西省西安市及浙江省象山市。年內，由於中國內地冠狀病毒(COVID-19)疫情反彈，房地產市場信心不可避免地受到影響，進一步干擾了本集團的計劃及項目的實施。截至二零二二年三月三十一日止年度，本集團之物業經紀業務並無產生任何營業額(截至二零二一年三月三十一日止十五個月：約45,300,000港元)及錄得毛損約2,100,000港元(截至二零二一年三月三十一日止十五個月：毛利約28,000,000港元)。此分部產生相應虧損約5,700,000港元(截至二零二一年三月三十一日止十五個月：分部溢利約19,800,000港元)。

### 特製技術支援服務

本集團於二零二一年八月收購一組主要於中國從事向金融及物業相關領域之客戶提供財務資料、解決方案及數據分析服務的公司後，將該新收購業務與其樓宇建築及室內設計業務合併，以向中國客戶提供特製技術支援服務。截至二零二二年三月三十一日止年度，本集團特製技術支援業務之營業額錄得約為20,800,000港元(截至二零二一年三月三十一日止十五個月：約4,600,000港元)，毛利約為10,900,000港元(截至二零二一年三月三十一日止十五個月：約4,600,000港元)。於本年度產生分部虧損約700,000港元(截至二零二一年三月三十一日止十五個月：約8,100,000港元)。

### 物業發展及項目管理業務

本集團於二零二零年三月收購一間公司，該公司主要於中國從事物業發展並持有位於江蘇省海門市海永鄉海永大道，總佔地面積為47,519平方米用作商業用途之地塊的土地使用權。本集團原本計劃於該地塊上發展待售物業。然而，由於中國房地產開發商面臨的種種挑戰及困難，尤其是該地塊所在地區的房產價格出現一定程度的波動，本集團於二零二二年三月三十一日出售從事物業發展業務的公司，並確認出售收益約48,200,000港元。緊隨出售事項後，本集團終止其物業發展業務分部。

On the other hand, the Group has commenced to provide project management services in the PRC since July 2020. For the year ended 31 March 2022, the turnover of the Group's project management business amounted to approximately HK\$44.8 million (fifteen months ended 31 March 2021: approximately HK\$45.5 million) and the gross profit of approximately HK\$36.5 million was recorded (fifteen months ended 31 March 2021: approximately HK\$45.5 million). Segment loss of approximately HK\$13.1 million was incurred in this segment (fifteen months ended 31 March 2021: approximately HK\$9.3 million).

### Geothermal Energy Business

The Group acquired a group of companies, which are principally engaged in developing and utilising geothermal energy in provision of heating and cooling supply to various buildings located in residential areas in the PRC, in March 2020. Currently, the major places of business activities are in Xi'an, Shaanxi Province and Henan Province of the PRC. For the year ended 31 March 2022, the turnover of the Group's geothermal energy business amounted to approximately HK\$18.4 million (fifteen months ended 31 March 2021: approximately HK\$18.0 million) and the gross profit was approximately HK\$4.4 million (fifteen months ended 31 March 2021: approximately HK\$0.8 million). Corresponding segment loss of approximately HK\$6.9 million was incurred in this segment (fifteen months ended 31 March 2021: approximately HK\$8.3 million).

### Building Construction Contracting Business

The Group acquired a company, which is principally engaged in building construction contracting on project basis in the PRC, in May 2020. For the year ended 31 March 2022, the turnover of the Group's building construction contracting business amounted to approximately HK\$329.5 million (fifteen months ended 31 March 2021: approximately HK\$438.2 million) and the gross profit of approximately HK\$42.1 million (fifteen months ended 31 March 2021: approximately HK\$44.8 million) was made. Corresponding profit of approximately HK\$29.7 million (fifteen months ended 31 March 2021: approximately HK\$31.6 million) was achieved in this segment.

另一方面，本集團自二零二零年七月起開始在中國提供項目管理服務。截至二零二二年三月三十一日止年度，本集團項目管理業務之營業額約為44,800,000港元（截至二零二一年三月三十一日止十五個月：約45,500,000港元）及錄得毛利約36,500,000港元（截至二零二一年三月三十一日止十五個月：約45,500,000港元）。此分部產生分部虧損約13,100,000港元（截至二零二一年三月三十一日止十五個月：約9,300,000港元）。

### 地熱能業務

本集團於二零二零年三月收購一組主要從事開發及利用地熱能向位於中國住宅地區之多個樓宇供暖製冷的公司。目前，業務活動主要地點位於中國陝西省西安市及河南省。截至二零二二年三月三十一日止年度，本集團地熱能業務之營業額約為18,400,000港元（截至二零二一年三月三十一日止十五個月：約18,000,000港元），毛利約為4,400,000港元（截至二零二一年三月三十一日止十五個月：約800,000港元）。此分部產生相應分部虧損約6,900,000港元（截至二零二一年三月三十一日止十五個月：約8,300,000港元）。

### 樓宇建築承包業務

本集團於二零二零年五月收購一間主要於中國從事按項目基準進行樓宇建築承包的公司。截至二零二二年三月三十一日止年度，本集團樓宇建築承包業務之營業額約為329,500,000港元（截至二零二一年三月三十一日止十五個月：約438,200,000港元），毛利約為42,100,000港元（截至二零二一年三月三十一日止十五個月：約44,800,000港元）。此分部錄得相應溢利約29,700,000港元（截至二零二一年三月三十一日止十五個月：約31,600,000港元）。

### Centralised Heating Business

The Group started the centralised heating business after becoming the reorganisation investor of a company, which is principally engaged in the business of providing the heat and steam supply services in the licensed area of Yuncheng, Shanxi through centralised pipe networks, in September 2020. The Group was further granted an exclusive license for the provision of centralised heating service in Yuncheng City for 30 years from 1 January 2021. For the year ended 31 March 2022, the turnover of the Group's centralised heating business amounted to approximately HK\$64.6 million (fifteen months ended 31 March 2021: approximately HK\$29.2 million) and the gross loss of approximately HK\$0.4 million (fifteen months ended 31 March 2021: approximately HK\$0.5 million) was incurred. The Group recorded a loss of approximately HK\$7.7 million (fifteen months ended 31 March 2021: approximately HK\$4.0 million) in this segment.

### OUTLOOK

In order to increase the profitability of the Group and enhance its sustainability, the Group (i) will continuously improve its real estate-related businesses layout while developing its existing main businesses; (ii) will keep seeking opportunities to diversify its income and growth drivers, such as the metaverse related business mentioned below; and (iii) will further expand its client base and enrich its products and services mix by exploring possible intersegment development and collaboration between the Group's different business segments.

In first quarter of 2022, the Group has announced that it would build an ecological environment of the whole industry chain of metaverse and develop the metaverse related businesses. With the advanced development in technology, metaverse is universally regarded as the next frontier in technology services. The emerging of the metaverse has widened the spectrum of traditional industries by extending the space for development and transforming the physical shape of the ecosystem. The Directors considered that by leveraging the strength and experience of the Group in real-estate related business and the Group's exploration in the big data business, the Group would be able to provide comprehensive and customized metaverse solutions, including but not limited to designing, constructing and operating the metaverse offline entertainment experience venue.

Looking forward, the global economic situation and market sentiment is still vulnerable in the shadow of the continuing coronavirus pandemic and the military and political conflicts among the world superpowers. The Group will keep on reviewing and considering its existing resources, including the experience, expertise and social network of the directors and management of the Company, with the aim of further expanding the current principal businesses and exploring possible development in the metaverse related businesses. The Group firmly believes that challenges and opportunities coexist in the current situation. The Group will adopt prudent measures to control operating risks and continue to expand its businesses by seeking new opportunities.

### 集中供熱業務

本集團於二零二零年九月成為一間於山西運城特許經營區域主要從事通過集中管網提供供熱及供氣服務業務的公司之重組投資者後，開始集中供熱業務。本集團已進一步取得於運城市提供集中供熱服務的獨家許可，自二零二一年一月一日起計為期30年。截至二零二二年三月三十一日止年度，本集團集中供熱業務之營業額約為64,600,000港元（截至二零二一年三月三十一日止十五個月：約29,200,000港元），產生毛損約400,000港元（截至二零二一年三月三十一日止十五個月：約500,000港元）。本集團在此分部錄得虧損約7,700,000港元（截至二零二一年三月三十一日止十五個月：約4,000,000港元）。

### 前景

為了提高本集團的盈利能力及增強其可持續營運能力，本集團(i)將在發展現有主要業務的同時，不斷完善於房地產相關業務的佈局；(ii)將繼續尋求機會多樣化其收入及增長動力，如下文所述的元宇宙相關業務；及(iii)將通過探尋本集團不同業務分部之間可能的跨部發展及合作進一步擴大其客戶基礎並豐富其產品及服務組合。

於二零二二年第一季度，本集團宣佈將為元宇宙生態環境打造完整產業鏈以及發展元宇宙相關業務。隨著科技的進步，元宇宙被普遍認為是科技服務的下一個前沿。通過拓展開發空間及改變生態系統的物理形態，元宇宙的出現擴大了傳統產業的範疇。董事認為，憑藉本集團在房地產相關業務方面的實力和經驗，以及本集團在大數據業務方面的探索，本集團將能夠提供全面的定制化元宇宙解決方案，包括但不限於設計、建造及運營元宇宙線下娛樂體驗場地。

展望未來，全球經濟形勢及市場情緒在冠狀病毒疫情持續和世界超級大國軍事政治衝突的陰霾下依然脆弱。本集團將繼續檢討及權衡其現有資源，包括本公司董事及管理層之經驗、專業知識及人脈，旨在進一步擴展現有主要業務以及探尋在元宇宙相關業務的可能發展。本集團堅信，現今局勢下挑戰與機遇並存。本集團將採取審慎措施，以控制營運風險並繼續透過探索新機遇擴展其業務。

### LIQUIDITY AND CASHFLOW RESOURCES

As at 31 March 2022, the equity and net current assets of the Group amounted to approximately HK\$1,260.5 million (2021: approximately HK\$1,149.7 million) and HK\$448.4 million (2021: approximately HK\$483.4 million) respectively. On the same date, the Group had bank balances and cash of approximately HK\$46.0 million (2021: approximately HK\$50.3 million) and the current ratio was 1.42 (2021: 1.53). As at 31 March 2022, the Group had (i) secured trust loans of approximately HK\$246.9 million (2021: approximately HK\$237.3 million) bearing fixed interest rate at 12% per annum and to be repaid in March 2023, (ii) secured bank loans of approximately HK\$88.9 million (2021: approximately HK\$11.9 million) bearing fixed interest rate ranged from 3.8% to 5.6% per annum and to be repaid from November 2022 to March 2023, (iii) secured short-term loans from an independent lender of approximately HK\$9.9 million (2021: approximately HK\$20.2 million) bearing fixed interest rate at 16.8% per annum and to be repaid in March 2023, (iv) unsecured short-term loan from an independent lender of approximately HK\$3.7 million (2021: nil) bearing fixed interest rate at 6% per annum and to be repaid in June 2022, (v) interest-free and unsecured loan from a joint venture of approximately HK\$0.1 million (2021: HK\$0.1 million) to be repaid in December 2021, (vi) interest-free and unsecured advance payments from an independent third party and subcontractor of approximately HK\$13.7 million and HK\$110.3 million respectively to be repaid on demand (2021: interest-free and unsecured advance payment from an associate and subcontractor of approximately HK\$16.6 million and HK\$80.7 million respectively to be repaid on demand).

As at 31 March 2022, the gearing ratio of the Group was approximately 0.20 (2021: approximately 0.18). The gearing ratio is measured on the basis of the total amount of interest bearing and interest free borrowings/advance payments over the amount of total assets. As at 31 March 2022, the total amount of interest bearing and interest free borrowings/advance payments and the amount of total asset of the Group amounted to approximately HK\$473.5 million (2021: approximately HK\$366.8 million) and approximately HK\$2,340.9 million (2021: approximately HK\$2,072.9 million) respectively.

The Group has sufficient and readily available financial resources for both general working capital purposes and existing business operation.

### 流動資金及現金流量資源

於二零二二年三月三十一日，本集團之權益及流動資產淨值分別約為1,260,500,000港元（二零二一年：約1,149,700,000港元）及448,400,000港元（二零二一年：約483,400,000港元）。於同日，本集團有銀行結餘及現金約46,000,000港元（二零二一年：約50,300,000港元），流動比率為1.42（二零二一年：1.53）。於二零二二年三月三十一日，本集團有(i)按固定年利率12%計息及須於二零二三年三月償還之有抵押信託貸款約246,900,000港元（二零二一年：約237,300,000港元），(ii)按固定年利率3.8%至5.6%計息及須於二零二二年十一月至二零二三年三月償還之有抵押銀行貸款約88,900,000港元（二零二一年：約11,900,000港元），(iii)來自一名獨立貸款人之按固定年利率16.8%計息及須於二零二三年三月償還之有抵押短期貸款約9,900,000港元（二零二一年：約20,200,000港元），(iv)來自一名獨立貸款人之按固定年利率6%計息及須於二零二二年六月償還之無抵押短期貸款約3,700,000港元（二零二一年：無），(v)來自一間合營公司之不計息、無抵押及須於二零二一年十二月償還之貸款約100,000港元（二零二一年：100,000港元），(vi)來自一名獨立第三方及分包商之不計息、無抵押及須按要價償還之墊付款項分別約13,700,000港元及110,300,000港元（二零二一年：來自一間聯營公司及分包商之不計息、無抵押及須按要價償還之墊付款項分別約16,600,000港元及80,700,000港元）。

於二零二二年三月三十一日，本集團之資產負債比率約為0.20（二零二一年：約0.18）。資產負債比率乃按計息及免息借款總額／墊付款項除以資產總值金額計量。於二零二二年三月三十一日，本集團計息及免息借款／墊付款項總額以及資產總值金額分別約為473,500,000港元（二零二一年：約366,800,000港元）及約2,340,900,000港元（二零二一年：約2,072,900,000港元）。

本集團有充裕及可隨時使用之財務資源，可用作一般營運資金用途及用於現有業務營運。

### PLEDGE OF ASSETS

As at 31 March 2022 and 2021, none of the Group's securities was pledged to brokers to secure the margin loan. As at 31 March 2022, certain flats of the investment properties held by the Group were pledged to banks to secure the bank loans borrowed to the Group (2021: the properties under development for sale in amount of approximately HK\$86.3 million (including the land use rights of approximately HK\$27.2 million) was pledged to an independent lender to secure the trust loans borrowed to the Group).

### CONTINGENT LIABILITIES

As at 31 March 2022 and 2021, the Group had no material contingent liabilities.

### CAPITAL EXPENDITURE

During the year ended 31 March 2022, the Group incurred approximately HK\$13.9 million (fifteen months ended 31 March 2021: approximately HK\$41.7 million) as capital expenditure mainly in respect of plant and equipment situated in the PRC.

### CAPITAL COMMITMENTS

As at 31 March 2022, the Group had no material capital commitment (2021: nil).

### SIGNIFICANT INVESTMENTS HELD

As at 31 March 2022, the Group held financial assets at fair value through other comprehensive income of approximately HK\$8.6 million (2021: approximately HK\$8.6 million) which represented unlisted equity securities in Hong Kong. No financial assets at fair value through profit or loss in relation to equity securities was held as at 31 March 2022 (2021: nil).

The Board acknowledges that the performance of the equities may be affected by the degree of volatility in the stock market and susceptible to other external factors that may affect their values. Accordingly, in order to mitigate possible financial risks related to the equities, the Board will continue to closely monitor the performance of its investment portfolio (if any) from time to time.

As at 31 March 2022, the Company did not hold any significant investments in an investee company with a value of 5% or more of the Company's total assets.

### 資產抵押

### 所持重大投資

於二零二二年三月三十一日，本集團持有按公平值計入其他全面收益之金融資產約8,600,000港元（二零二一年：約8,600,000港元），其為於香港之非上市股本證券。於二零二二年三月三十一日，並無持有與股本證券有關的按公平值計入損益之金融資產（二零二一年：無）。

董事局確認股票之表現可能受股市之波動幅度影響及易受或會影響其價值之其他外部因素影響。因此，為降低與股票有關之潛在財務風險，董事局將繼續不時密切監控其投資組合（如有）之表現。

於二零二二年三月三十一日，本公司並無於任何被投資公司持有價值佔本公司總資產5%或以上的任何重大投資。

### MATERIAL ACQUISITION AND DISPOSAL

- (i) On 10 August 2021, China Best Financial Holdings Limited, a wholly owned subsidiary of the Company, entered into share transfer agreement with independent third party to acquire 42% of the issued share capital of Treasure Cart Holdings Limited (“Treasure Cart”) at a consideration of HK\$90 million (the “Treasure Cart Acquisition”). The major subsidiaries of Treasure Cart are principally engaged in the provision of financial information, solutions and data analytical services to customers in finance and property related field in the PRC. Before the acquisition, Treasure Cart and its subsidiaries (“Treasure Cart Group”) are associates of the Company with 25% equity interest held. After the completion of the acquisition on 12 August 2021, the Group held 67% equity interest in Treasure Cart and Treasure Cart Group has become non-wholly owned subsidiaries of the Company since then. Further details are set out in the Company’s announcement dated 10 August 2021.
- (ii) On 29 March 2022, Shenzhen Guohua Construction Industrial Co., Ltd.\* (深圳國華建業實業有限公司) (“Shenzhen Guohua”), a wholly owned subsidiary of the Company, and Beijing Taoli Chunfeng Real Estate Property Development Co., Ltd.\* (北京桃李春風房地產開發有限公司) (“Beijing Taoli Chunfeng”), an independent third party, among others, entered into an agreement pursuant to which Shenzhen Guohua agreed to dispose, and Beijing Taoli Chunfeng agreed to acquire and assume, 100% equity interest in Jiangsu Meili Kongjian Construction Design Development Co., Ltd.\* (江蘇美麗空間建築設計產業發展有限公司) (“Jiangsu Meili Kongjian”) and the benefit of the aggregate amount outstanding and owing by Jiangsu Meili Kongjian to the Group, at the consideration of RMB126 million. The disposal was completed on 31 March 2022 and the Group ceased to hold any interest in Jiangsu Meili Kongjian accordingly. Further details are set out in the Company’s announcement dated 29 March 2022.

Save as disclosed above, there was no other material acquisition or disposal (including the acquisition or disposal of subsidiaries and associated companies) for the year ended 31 March 2022.

### FUND RAISING ACTIVITIES

On 11 May 2021, the Company proposed to implement the rights issue ("Rights Issue") on the basis of one (1) rights share ("Rights Share(s)") for every two (2) existing shares held on 16 June 2021 at the subscription price of HK\$0.2 per Rights Share. The closing price per share of the Company was HK\$0.365 at the same date. The net price (after deduction of transaction and issue costs attributable to the Rights Issue) per Rights Share is approximately HK\$0.19. The Rights Issue was conducted for strengthening the Group's capital base and financial position. In particular, its proceeds would be utilised in developing existing businesses, financing mergers and acquisitions, and enhancing general working capital. The Rights Issue was completed on 14 July 2021 with 508,428,313 Rights Shares allotted and issued and the net proceeds were approximately HK\$96.7 million. Details of the Rights Issue were set out in the prospectus of the Company dated 17 June 2021 and the announcement of the Company dated 13 July 2021. As at 31 March 2022, the Group has utilised the net proceeds from the Rights Issue of approximately HK\$85.7 million. Details of the intended and actual use of proceeds were as follows:

### EXPOSURE TO FLUCTUATIONS IN EXCHANGE RATES

The Group's monetary assets and transactions are principally denominated in Hong Kong dollars, Renminbi and US dollars. During the year ended 31 March 2022, there was no significant fluctuation in the exchange rates of Hong Kong dollars and US dollars whereas Renminbi had an upward adjustment, resulting in an exchange gain of approximately HK\$21.6 million recognised as other comprehensive income of the Group. The Group will take a prudent approach against any impact arising from the fluctuation in exchange rates but currently is not engaged in any derivative activities and not committed to any financial instruments to hedge its balance sheet exposure.

### EMPLOYEE AND HUMAN RESOURCES POLICY

As at 31 March 2022, the Group had 332 staff (2021: 402 staff). The total staff cost incurred for the year ended 31 March 2022 was approximately HK\$81.4 million (fifteen months ended 31 March 2021: approximately HK\$111.3 million). The remuneration of employees was determined with reference to the qualification and experience of individual staff member, market circumstances and the Group's performance. In accordance with the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"), the staff of the Company's accounting and financial reporting function have adequate training programmes and budget.

Pursuant to a share option scheme adopted on 22 May 2012 and terminated on 1 September 2021 (the "2012 Share Option Scheme") and a share option scheme adopted on 1 September 2021 (the "2021 Share Option Scheme"), the Board may grant options to, among other, directors (including non-executive directors and independent non-executive directors) and employees of the Company and any of its subsidiaries or associated companies or any suppliers of goods or services to the Group, to subscribe for shares of the Company. During the year ended 31 March 2022, no options were granted under the 2012 Share Option Scheme and the 2021 Share Option Scheme.

### FINAL DIVIDEND

The Board has resolved not to recommend any final dividend for the year ended 31 March 2022 (fifteen months ended 31 March 2021: Nil).

### 匯率波動風險

The Board has established the audit committee of the Company (the "Audit Committee") in accordance with the Listing Rules. The Audit Committee currently comprises Mr. Ru Xiangnan, Mr. Liu Tonghui, and Ms. Yin Meiqun, the three independent non-executive directors of the Company. A summary of duties and works of the Audit Committee is set out in the "Corporate Governance Report" of this annual report.

The Audit Committee has reviewed the accounting principles and practices adopted by the Group and discussed auditing, internal control and financial reporting matters. The Audit Committee has reviewed the financial statements of the Group for the year ended 31 March 2022 in conjunction with the Company's external auditor, ZHONGHUI ANDA CPA Limited.

### CORPORATE GOVERNANCE CODE OF THE LISTING RULES

A new Corporate Governance Code (the "CG Code") came into effect on 1 January 2022 and the requirements under the new CG Code apply to corporate governance reports for financial year commencing on or after 1 January 2022. As this annual report including the corporate governance report is for the year ended 31 March 2022, the CG Code described herein is the CG Code in effect during the year ended 31 March 2022.

During the year ended 31 March 2022, the Company has fully complied with the code provisions of the CG Code as set out in Appendix 14 of the Listing Rules, with deviation from the code provisions A.6.7 and C.2.5. ### CORPORATE GOVERNANCE PRACTICES

The Group strives to attain and maintain high standards of corporate governance to enhance shareholders' value and safeguard shareholders' interests. The Group's corporate governance principles emphasize a quality Board, effective internal control and accountability to shareholders.

The Board believes that good corporate governance practices are increasingly important for maintaining and promoting shareholder value and investor confidence.

The CG Code contained in Appendix 14 of the Listing Rules sets out the principles of good corporate governance and two levels of corporate governance practices:

- (a) code provisions which listed issuers are expected to comply with or to give considered reasons for any deviation; and
- (b) recommended best practices for guidance only, which listed issuers are encouraged to comply with or give considered reasons for deviation.

The Company's corporate governance practices are based on the principles, code provisions and certain recommended best practices as set out in the CG Code.

A new CG Code came into effect on 1 January 2022 and the requirements under the new CG Code apply to corporate governance reports for financial year commencing on or after 1 January 2022. As this annual report including the corporate governance report is for the year ended 31 March 2022, the CG Code described herein is the CG Code in effect during the year ended 31 March 2022.

Throughout the year ended 31 March 2022, the Company has complied with the code provisions set out in the CG Code, save for the deviations from the code provisions A.6.7 and C.2.5 which are explained in the relevant paragraphs in this report.

### BOARD OF DIRECTORS

#### Responsibilities

The overall management of the Company's business is vested in the Board, which assumes the responsibility for leadership and control of the Company and is collectively responsible for promoting the success of the Company by directing and supervising its affairs. All directors should take decisions objectively in the best interests of the Company.

The Board sets policy direction and approves strategies/operational plans to ensure effective functioning and growth of the Company, in the interests of all shareholders.

Every director shall ensure that he/she carries out his/her duty in good faith and in compliance with the standards of applicable laws and regulations, and acts in the interests of the Company and its shareholders at all times.

### DELEGATION OF MANAGEMENT FUNCTIONS

The Board undertakes responsibility for decision making in major matters of the Company, including: the approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those may involve conflict of interests), financial information, appointment of directors and other significant financial and operational matters.

All directors have full and timely access to all relevant information as well as the advice and services of the Company Secretary, with a view to ensuring that Board's procedures and all applicable rules and regulations are followed.

Each director is normally able to seek independent professional advice in appropriate circumstances at the Company's expense, upon making request to the Board.

The day-to-day management, administration and operation of the Company are delegated to the executive directors and the senior management. The delegated functions and work tasks are periodically reviewed. Approval has to be obtained from the Board prior to any significant transactions entered into by the abovementioned officers.

The Board has the full support of the executive directors and the senior management to discharge its responsibility.

### BOARD COMPOSITION

The composition of the Board ensures a balance of skills and experience appropriate to the requirements of the business of the Company and to the exercising of independent judgment.

As at the date of this report, the Board currently comprises five executive directors and three independent non-executive directors. Save as disclosed in the section of “Biographical Details of Directors and Senior Management” of this annual report, members of the Board do not have any relationship with any other director.

The list of all directors and their biographies are set out under the section of “Corporate Information” and “Biographical Details of Directors and Senior Management” on page 2 and page 59 respectively and in all corporate communications issued by the Company pursuant to the Listing Rules from time to time. The independent non-executive directors are expressly identified in all corporate communications pursuant to the Listing Rules.

During the year, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive directors with at least one independent non-executive director possessing appropriate professional qualifications, or accounting or related financial management expertise.

The Company has received written annual confirmation from each independent non-executive director for his/her independence pursuant to the guidelines for assessing independence set out in Rule 3.13 and other requirements of the Listing Rules. The Company considers all independent non-executive directors to be independent in accordance with the independence guidelines set out in the Listing Rules.

All directors, including independent non-executive directors, have brought a wide spectrum of valuable business experience and skills, knowledge and professionalism to the Board for its efficient and effective functions. Independent non-executive directors are invited to serve on the Audit, Nomination and Remuneration Committees of the Company.

### APPOINTMENT, RE-ELECTION AND REMOVAL OF DIRECTORS

The procedures and process of appointment, re-election and removal of directors are set out in the Company's Bye-laws. The Nomination Committee is responsible for reviewing the Board composition, developing and formulating the relevant procedures for nomination and appointment of directors, monitoring the appointment and succession planning of directors and assessing the independence of independent non-executive directors. Details of the Nomination Committee and its works performed during the year are set out in the "Board Committees" section below.

Each of the directors has entered into a service contract or a letter of appointment with the Company for a term of three years, which can be terminated by not less than three months' or one month's notice in writing served by either party on the other.

In accordance with the Company's Bye-laws, all directors of the Company are subject to retirement by rotation at least once every three years and any new director appointed to fill a causal vacancy or as an addition to the Board shall submit himself for re-election by shareholders at the first general meeting after appointment.

In accordance with Bye-law 86(2) of the Company's Bye-laws, Mr. Li Haitao, Ms. Tao Lei and Ms. Yin Meiqun will be subject to re-election at the forthcoming annual general meeting.

In accordance with Bye-law 87(1) of the Company's Bye-laws, Mr. Qin Jie and Mr. Liu Tonghui shall retire at the forthcoming annual general meeting and eligible, will offer themselves for re-election at the annual general meeting.

The Board recommended the re-appointment of the directors standing for re-election at the forthcoming annual general meeting.

### TRAINING FOR DIRECTORS

Pursuant to requirement in the code provision A.6.1, each newly appointed director should receive a comprehensive, formal and tailored induction on appointment. Subsequently he or she should receive any briefing and professional development necessary to ensure that he or she has a proper understanding of the business and operations of the Company and that he or she is fully aware of his or her responsibilities and obligations under statute and common law, the Listing Rules, legal and other regulatory requirements and the Company's business and governance policies.

### 董事之委任、重選及罷免

Under the code provision A.6.7 of the CG Code, the independent non-executive directors and other non-executive directors should attend general meetings and develop a balanced understanding of the views of shareholders. Due to influence of COVID-19 pandemic, three independent non-executive directors namely, Mr. Ru Xiangan, Mr. Liu Tonghui and Mr. Liu Haiping (ceased on 29 April 2022), were unable to attend the Company's annual general meetings held on 1 September 2021.

### Practices and Conduct of Meetings

Annual meeting schedules and draft agenda of each meeting are normally made available to directors in advance.

Notices of regular Board meetings are served to all directors at least 14 days before the meetings. For other Board and committee meetings, reasonable notice is generally given.

Board papers together with all appropriate, complete and reliable information are sent to all directors at least 3 days before each Board meeting or committee meeting to keep the directors apprised of the latest developments and financial position of the Company and to enable them to make informed decisions. The Board and each director also have separate and independent access to the senior management whenever necessary.

The Chairman and the Company Secretary attend almost all regular Board meetings and when necessary, other Board and committee meetings to advise on business developments, financial and accounting matters, statutory compliance, corporate governance and other major aspects of the Company.

The Company Secretary is responsible for keeping minutes of all Board meetings and committee meetings. Draft minutes are normally circulated to directors for comment within a reasonable period of time after each meeting and the final version is open for directors' inspection.

According to the current Board practice, any material transaction which involves a material conflict of interests for a substantial shareholder or a director will be considered and dealt with by the Board at a duly convened Board meeting and independent non-executive directors who, and whose associates, have no material interest in the transaction are present at the Board meeting.

The Company's Bye-laws also contain provisions requiring directors to abstain from voting (nor be counted in the quorum) at meetings for approving transactions in which such directors or any of their associates have a material interest.

主席及公司秘書出席大部分董事局例行會議及（如需要）其他董事局及委員會會議，以就本公司之業務發展、財務及會計事宜、遵守法規、公司管治及其他主要事宜提供意見。

公司秘書負責保存全部董事局會議及委員會會議之會議記錄。會議記錄擬本一般會於每次會議後一段合理時間內供董事傳閱，董事可就此提供意見，會議記錄之定稿則公開予董事查閱。

根據董事局現行常規，凡有任何重大交易涉及主要股東或董事之重大利益衝突，將由董事局正式召開董事局會議審議及處理，而於該交易中並無擁有重大權益之獨立非執行董事及其聯繫人士會出席該董事局會議。

### CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Under the code provision A.2.1 of the CG Code, the roles of chairman and chief executive should be separate and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive should be clearly established and set out in writing.

The role of the chairman was performed by Ms. Wang Yingqian, who provided leadership for the Board and was responsible for chairing meetings, managing the operations of the Board and ensuring that all major and appropriate issues were discussed by the Board in a timely and constructive manner. She was also responsible for the strategic management of the Group and for formulating the Group's overall corporate direction and focus.

The role of chief executive officer was performed by Mr. Qin Jie, who was responsible for the overall management and operations of the Group. He was also responsible for running the businesses of the Group and implementing the Group's strategic plans and business goals.

### BOARD COMMITTEES

Currently, the Company has four committees, namely, the Audit Committee, the Nomination Committee, the Remuneration Committee and the Executive Committee, for overseeing particular aspects of the Company's affairs. All Board committees of the Company are established with defined written terms of reference. Save for the Executive Committee, the terms of reference of the other Board committees are made available to shareholders on the websites of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (<http://www.hkexnews.hk>) and the Company (<http://www.cbgroup.com.hk>) respectively.

The Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expenses.

The Company has adopted a board diversity policy setting out the approach to achieve diversity of the Board. The Nomination Committee carries out the process of selecting and recommending candidates for directorships and senior management by making reference to the skills, experience, professional knowledge, personal integrity and time commitments of such individuals, the Company's needs and other relevant statutory requirements and regulations. An external recruitment agency may be engaged to carry out the recruitment and selection process when necessary.

The Nomination Committee held two meetings during the year to review the structure, size, composition and diversity of the Board and made recommendations to the Board in accordance with the Nomination Committee's written terms of reference. The Nomination Committee considers that board appointments are based on merit and candidates are considered against objective criteria, having due regard for the benefits of diversity on the Board, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service.

The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board. The Nomination Committee shall discuss and where necessary, agree on the measurable objectives for achieving diversity on the Board and make recommendation to the Board. The Board may adopt and/or amend from time to time (as applicable) such diversity perspectives and/or measurable objectives that are appropriate to the Company's business and Board succession planning, as applicable.

The Company has also adopted a director nomination policy setting out the procedures and criteria to be used by the Company in relation to the selection, appointment and re-appointment of directors to ensure that the Board maintains an appropriate mix and balance of skills, knowledge, experience and diversity of perspectives to the requirements of the Company's business.

The Nomination Committee shall make reference to the director nomination policy and the board diversity policy to nominate suitably qualified candidates to the Board for it to consider and make recommendations to shareholders for election as directors at general meetings or appoint as directors to fill casual vacancies or as an addition to the Board.

### RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges that it has overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives, maintaining appropriate and effective risk management and internal control systems, and reviewing their effectiveness. The Board oversees management in the design, implementation and monitoring of the risk management and internal control systems. The systems and internal controls can only provide reasonable and not absolute assurance against material misstatement or loss, as they are designed to manage, rather than eliminate the risk of failure to achieve business objectives.

The Group has established an on-going process for identifying, evaluating and managing the significant risks of the Group. Business units are responsible for identifying, assessing and monitoring risks associated with their respective units. The results of evaluation will be reported to management through regular internal meetings. Each year, management prepares the risk assessment report listing the risks identified and management's assessment on the impact to the Group. The Board discusses findings in the risk assessment report and evaluates the effectiveness of the risk management and internal control system in Board meeting, and resolves any material internal control defects. The Board has conducted a review of the effectiveness of the risk management and internal control systems, and the Company considered them effective and adequate.

### 風險管理及內部監控

The key elements of the Group's risk management and internal control systems include the following:

- the organisational structure is clearly defined with distinct lines of authority and control responsibilities;
- a comprehensive financial accounting system has been established to provide for performance measurement indicators and to ensure compliance with relevant rules;
- the senior management shall prepare annual plans on financial reporting, operations and compliance aspects by reference to potential significant risks;
- unauthorised expenditures and release of confidential information are strictly prohibited;
- specific approval by executive director prior to commitment is required for all material matters; and
- the management shall review and evaluate the control process and monitor any risk factors on a regular basis and report to the Audit Committee on any findings and measures to address the variances and identified risks.

The Group handles and disseminates inside information with due care. Staff is required to comply with the confidentiality terms inside the staff manual. Only personnel at appropriate level can get reach of price sensitive and inside information. The Company regularly reminds the directors and employees about compliance with all policies adopted by the Company regarding inside information including the Model Code set out in Appendix 10 of the Listing Rules in relation to dealings in securities of the Company.

Appropriate policies and controls have been designed and established to ensure that assets are safeguarded against improper use or disposal, relevant rules and regulations are adhered to and complied with, reliable financial and accounting records are maintained in accordance with relevant accounting standards and regulatory reporting requirements.

Under the code provision C.2.5 of the CG Code, the Group should have an internal audit function. However, due to the size of the Group and for cost effectiveness consideration, the Group currently does not have an internal audit function. Instead, the Audit Committee is responsible for a review on the internal control system annually. The review covers major financial, operational controls in rotation basis and also the risk management functions. No significant deficiency was identified under current year's review and the systems were operating effectively and adequately. The Group continues to review the need for an internal audit function annually.

The Board shall take into account of, including but not limited to, the following factors when considering the declaration and payment of dividends:

- the Company’s actual and expected financial performance;
- retained earnings and distributable reserves of the Group;
- the level of the Group’s debts to equity ratio, return on equity and the relevant financial covenants;
- any restrictions on payment of dividends that may be imposed by the Group’s contracting parties;
- the Group’s expected working capital requirements and future expansion plans;
- general economic conditions, business cycle of the Group’s business and other internal or external factors that may have an impact on the business or financial performance and position of the Company; and
- any other factors that the Board may deem appropriate.

The Dividend Policy shall be reviewed when necessary, and can be revised by the Board from time to time.

### COMPANY SECRETARY

The position of the Company Secretary is held by Mr. Ho Yu. His biography is set out in the “Biographical Details of Directors and Senior Management” section on page 59. Mr. Ho reports to the Chairman of the Board from time to time. All directors have access to the advice and services of the Company Secretary to ensure that board procedures, and all applicable laws, rules and regulations are followed. During the year, Mr. Ho undertook not less than 15 hours of professional training to update his skills and knowledge.

### COMMUNICATIONS WITH SHAREHOLDERS AND INVESTORS

The Company believes that effective communication with shareholders is essential for enhancing investor relations and investors' understanding of the Group's business performance and strategies. The Group also recognises the importance of transparency and timely disclosure of corporate information which enables shareholders and investors to make a properly informed investment decision.

The Company continues to enhance communications and relationships with its investors. Enquiries from investors are dealt with in an informative and timely manner. Investors may write directly to the Company at its principal place of business in Hong Kong for any inquiries.

To promote effective communication, the Company maintains a website at [www.cbgroup.com.hk](http://www.cbgroup.com.hk), where extensive information and updates on the Company's business developments and operations, financial information, corporate governance practices and other information are available for public access.

The Board confirmed that, during the year, there were no significant changes made to the Company's Bye-laws affecting its operations and reporting practices.

### SHAREHOLDER RIGHTS

Under the Company's Bye-laws, the Board, on the requisition of shareholders of the Company holding not less than 10% of the paid-up capital of the Company by sending a written notice to the Board or the Company Secretary at the Company's principal place of business in Hong Kong, shall convene a special general meeting to address specific issues of the Company within 21 days from the date of deposit of written notice. The same requirement and procedure also applies to any proposal to be tabled at shareholders' meetings for adoption.

Specific enquiries by shareholders requiring the Board's attention can be sent in writing to the Board or the Company Secretary at the Company's principal place of business in Hong Kong.

In addition, the Company maintains contact with its shareholders through annual general meetings or other general meetings, and encourages shareholders to attend those meetings.

Notice of general meeting is sent by mail to the registered shareholders of the Company. Agenda and resolutions are set out in the notice of general meeting. A proxy form for use at a general meeting is enclosed with the notice. Shareholders who do not intend or are unable to be present at the meeting should fill out the form and return the same to the share registrar and transfer office of the Company, so as to appoint a representative, another shareholder or the chairman of the meeting as their proxy.

The Group is pleased to present its Environment, Social and Governance Report (the “ESG Report”) for the year ended 31 March 2022 (“Year 2021/22”) to demonstrate its commitment to sustainable development in aspects of environment, social and governance (the “ESG”).

### SCOPE OF REPORTING

The Group is principally engaged in: (i) trading of goods; (ii) the finance leasing business; (iii) the money lending business; (iv) the securities and futures brokerage business; (v) international air and sea freight forwarding and the provision of logistics services; (vi) trading of securities; (vii) property investment; (viii) the property brokerage services; (ix) customized technical support services; (x) the property development and project management business; (xi) the geothermal energy business; (xii) the building construction contracting and (xiii) centralized heating business, in Hong Kong, the PRC and other jurisdictions. The social data in this ESG Report covers the entire group, and the environmental data covers the business operations of the Company in Beijing, Henan, Shaanxi, Hebei, Shanxi and Hong Kong.

After the Group acquired a group of companies which are principally engaged in the provision of financial information, solutions and data analytical services to customers in finance and property related field in the PRC in August 2021, the Group combined such newly acquired business with its building architecture and interior design service business, so as to provide customized technical support services to customers in the PRC.

### REPORTING FRAMEWORK

This ESG Report is prepared in accordance with the Environmental, Social and Governance Reporting Guide (the “ESG Reporting Guide”) as set out in Appendix 27 of the Listing Rules, which covers two subject areas, Environment and Social. Please refer to the Corporate Governance Report in the annual report of the Company for details of corporate governance of the Group.

This ESG Report follows the four reporting principles in the ESG Reporting Guide, including (i) Materiality: the Group has identified a number of issues which cover ESG, and invited stakeholders to assess the materiality of such issues in the Year 2021/22. For details, please refer to the section headed “Materiality Assessment” in this ESG Report; (ii) Quantitative: this ESG Report details the standards, methodologies used and source of conversion factors used for the KPIs related to emissions and energy consumption; (iii) Balance: both positive and negative impacts brought by the business are presented with high transparency; and (iv) Consistency: unless otherwise stated, this ESG Report uses the same methodologies and KPIs as disclosed in previous ESG reports of the Group to facilitate comparability at any time. For the Year 2021/22, this ESG Report is disclosed under the “Comply or Explain” provision as set out in the ESG Reporting Guide.

### 報告範圍

本集團主要於香港、中國及其他司法權區從事：(i)買賣商品；(ii)融資租賃業務；(iii)借貸業務；(iv)證券及期貨經紀業務；(v)國際航空及海上貨運及提供物流服務；(vi)證券買賣；(vii)物業投資；(viii)物業經紀服務；(ix)特製技術支援服務；(x)物業發展及項目管理業務；(xi)地熱能業務；(xii)樓宇建築承包及(xiii)集中供熱業務。本ESG報告中的社會數據涵蓋整個集團，環境數據涵蓋本公司位於北京、河南、陝西、河北、山西及香港的業務營運。

本集團於2021年8月收購一組主要於中國從事向金融及物業相關領域之客戶提供財務資料、解決方案及數據分析服務的公司後，將該新收購業務與其樓宇建築及室內設計服務業務合併，以向中國客戶提供特製技術的支援服務。

### 報告框架

本ESG報告乃根據上市規則附錄27所載之環境、社會及管治報告指引（「ESG報告指引」）（其涵蓋兩大主題，環境及社會）而編製。有關本集團企業管治之詳情，請參閱本公司年報中的企業管治報告。

### GOVERNANCE STRUCTURE

#### The Board's oversight of ESG issues

The Board has a primary role in overseeing the Group's ESG issues. For the Year 2021/22, the Board and the management evaluated from time to time the impacts of ESG-related risks towards the operation and formulated ESG-related policies in dealing with relevant risks. The Board ensures that the management has all appropriate tools and resources to oversee the ESG issues. The Group highly values the opinions of each stakeholder and regards them as the cornerstone for the development of the Group. For the Year 2021/22, ESG governance and ESG related issues were reviewed at regular meetings.

#### The Board's ESG management approach and strategy for material ESG-related issues

In order to better understand the opinions and expectations of different stakeholders on the ESG issues, materiality assessment is conducted annually by the Group. The Group ensures various platforms, and channels of communication are used to reach, listen and respond to its key stakeholders. Through general communication with the stakeholders, the Group is able to understand the expectations and concerns from its stakeholders. The feedbacks obtained allow the Group to make more informed decisions, and to better assess and manage the resulting impacts of the business decisions.

The Group has evaluated the materiality in ESG aspects through the following steps: (i) identification of ESG issues by the Group; (ii) key ESG areas prioritization with stakeholder engagement; and (iii) validation and determining material ESG issues based on the results of communication with the stakeholders.

Engaging these steps can enhance the understanding of the degree of importance of the Group's stakeholders to each material ESG issue, and can enable the Group to plan the sustainable development direction more comprehensively in the future.

#### The Board's review progress against ESG-related objectives and targets

The performance and the implementation progress of the ESG-related objectives and targets should be carefully reviewed by the Group from time to time. If the progress falls short of expectation or changes of business operations, it may be necessary to make changes and communicate about the objectives and targets with key stakeholders such as employees, customers and suppliers.

The Group has set future strategic goals to enable the Group to develop a realistic path and focus on the development direction for achieving its visions. The ESG working group will carefully examine the attainability of the targets which should be weighed against the Group's philosophy and goals.

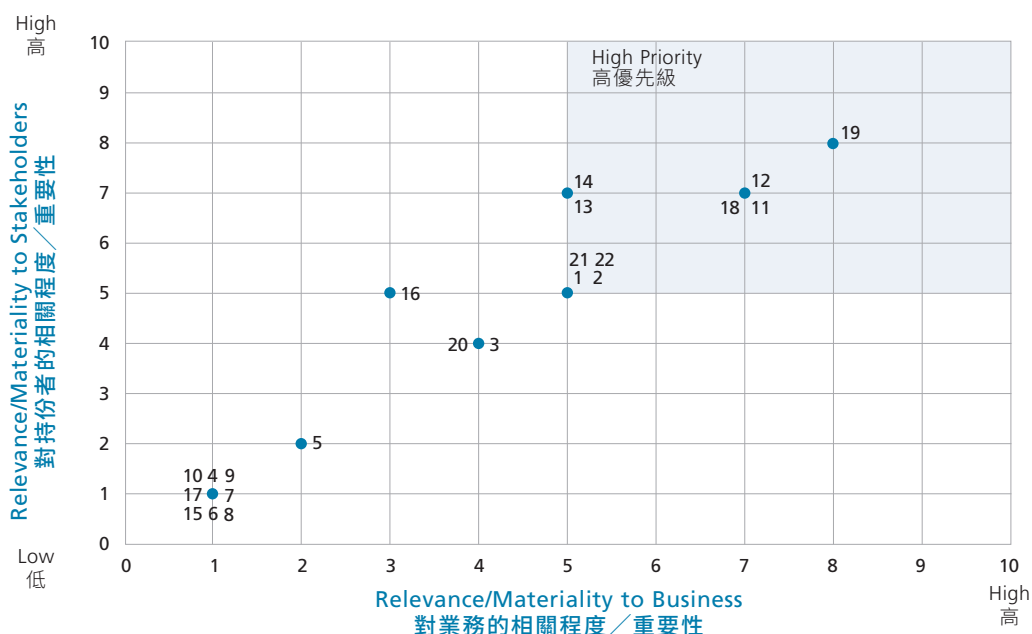

### ENVIRONMENT

To adhere to its commitment to sustainable development and to comply with the requirements under relevant laws and regulations related to environmental protection, the Group has been dedicated to reducing the impact of its operating activities on the environment.

#### Emissions

The development and utilization of geothermal energy of the Group may have some environmental impacts, including but not limited to: (i) thermal pollution; (ii) air pollution; (iii) water pollution; and (iv) soil pollution. The Group has conducted an environmental impact assessment with reference to the requirements of the Environmental Protection Law of the People's Republic of China.

In the Year 2021/22, the key environmental performance indicators of the Group's emissions are set out as follows:

### 環境

#### 排放物

Note 1: The emission factors used in the calculation of air pollutants are sourced from the EPD Vehicle Emission Calculation model and the Vehicle Emission Modeling Software of the United States Environmental Protection Agency. These factors are calculated on the assumption that the relative humidity is 80% and the temperature is 25 degrees Celsius with an average speed of 30 kilometers per hour and include running exhaust emission only.

Note 2: The data of emissions for the fifteen months ended 31 March 2021 has been restated to reflect the actual emissions.

Note 3: Greenhouse gas emissions (direct and indirect) and the removals can be categorized into the following three separate scopes:

scope 1: Greenhouse gas emissions that attribute to business owned or controlled by the Group (primarily from the fuel consumption of vehicles) and the greenhouse gas emissions removals from newly planted trees.

scope 2: Greenhouse gas emissions occurred in the production process resulting from generation of electricity purchased by the Group from electric power company.

scope 3: All other indirect greenhouse gas emissions generated outside the Group, including (i) methane gas generated at landfill by disposal of paper waste; and (ii) indirect emissions due to electricity used for processing drinking water/sewage water by external institutions.

The Group's five-year target is to reduce the air emissions and the greenhouse gas emissions intensity by 5% respectively based on the Year 2021/22 baseline by the Year 2026/27.

The Group adheres to the principle of "Three Simultaneously", i.e. the environmental governance design should be designed, constructed and put into operation simultaneously with the main part of a project. The Group's construction causes environmental impact during construction and operation, and the main pollution generated and protection measures taken include pollution and protection during construction and after use.

本集團堅持「三同時」的原則，即是環境治理設計應與項目的主體工程同時設計，同時施工及同時投產使用。本集團的建設對環保的影響可分為兩個階段，分別是施工期間及運營期間的影響，而主要污染及防護措施包括施工期和使用後產生污染及防護。

In order to reduce the dust pollution at the construction sites, the Group sprinkles water at regular time on the construction sites every day to prevent dust generation, and increases the volume and frequency of sprinkling water on windy days. Solid wastes produced during the construction period are mainly domestic waste and waste residual soil generated during construction, which will be collected in dustbins and then sent to refuse disposal plants by sanitation workers for disposal. And the waste residual soil will be cleaned up and transported in time.

為減少施工場地的揚塵污染，本集團於施工場地每天定時灑水，防止揚塵產生，在大風日加大灑水量及次數。施工期間所產生的固體廢棄物主要為生活垃圾和施工中產生的廢渣土，會用垃圾箱收集後交由環境衛生工人送到垃圾處理場處理，並及時清運廢渣土。

The wastewater generated during the construction period is mainly domestic sewage and wastewater generated from construction activities. The construction wastewater mainly contains sediment and suspended matter, which will be collected first and then treated before discharged to the sewer pipe. The wastewater generated during operation is mainly the heat pump room cleansing wastewater and system leakage wastewater. The wastewater will be discharged from the new pipe to regional existing storm water system.

施工期間的污水主要為生活污水和施工活動自身產生的污水。施工污水主要含泥沙、懸浮物，會先收集，處理後排至下水管道。運營期間的廢水則主要為熱泵房清潔廢水和系統滲漏廢水。廢水由新建管道排至區域已建雨水系統。

As the Group only generated insignificant amount of non-hazardous waste in its business activities for the Year 2021/22, relevant data were not quantified. Non-hazardous waste mainly includes domestic waste and waste residual soil generated during construction, which will be sent to refuse disposal plants by sanitation workers for disposal regularly. In addition, there were no relevant data as no hazardous waste was generated in the Group's operation. If any hazardous waste is required to be disposed of, the Group will engage professional institutions to dispose of it.

For the Year 2021/22, the Group was not aware of any material non-compliance of any relevant laws or regulations relating to air and greenhouse gas emissions, discharges into water and land, and generation of hazardous and non-hazardous waste, including the Environmental Protection Law of the People's Republic of China (《中華人民共和國環境保護法》) and the Law of the People's Republic of China on the Prevention and Control of Atmospheric Pollution (《中華人民共和國大氣污染防治法》). In addition, no major fines or sanctions relating to the non-compliance with the relevant laws and regulations have been received for the Year 2021/22.

The Group aims to maintain zero production of hazardous waste and minimal production of non-hazardous waste by the Year 2026/27.

本集團於2021/22年度的業務只產生少量無害廢棄物，故無量化有關數據。無害廢棄物主要為生活垃圾和施工中產生的廢渣土，並定期由環境衛生工人送到垃圾處理場處理。此外，本集團業務亦沒有產生有害廢棄物，故沒有任何相關數據。倘若需棄置任何有害廢物，本集團會聘請專業機構處理。

於2021/22年度，本集團並不知悉任何有關其於空氣及溫室氣體排放、向水及土地的排污以及有害及無害廢棄物的產生方面在相關法律法規下有任何重大違規情況，包括《中華人民共和國環境保護法》及《中華人民共和國大氣污染防治法》。此外，於2021/22年度亦未有接獲因未能遵守有關法律法規而遭受大額罰款或制裁的情況。

本集團的目標是於2026/27年度前維持有害廢棄物的零產生和無害廢棄物的最少產生。

### Use of Resources

The Group recognizes importance of environmental sustainability and endeavors to minimize the impact of business on environment through adopting numerous energy-saving and conservation initiatives. The Group's policy is to ensure compliance with applicable environmental laws and regulations and minimize its environmental footprint through efficient use of resources and adoption of pro-environmental management. The Group's eco-friendly measures at the office are as follows:

- staff is reminded to switch off lights and air-conditioning in the meeting rooms and computers at work stations when not in use;
- whenever possible, documents are handled electronically other than by using physical papers;
- staff is reminded to save water;
- staff is encouraged to reuse paper printed only on one side and duplex printing and copying. Data on printing and copying is regularly reviewed to assess efficiency of paper usage;
- recycled office supplies are provided whenever possible; and
- conference calls instead of face-to-face meetings are arranged where possible.

In addition, a series of energy conservation and emission reduction measures has been adopted for the Group's businesses of heating and cooling supply by geothermal energy and centralized heating in order to reduce the use of resources effectively.

To save electricity, the Group added transducers to electrical equipment in the plants, which effectively adjusted the power of motors and enabled them to operate at variable speeds, so as to achieve the goal of energy saving.

The Group introduced advanced environmental facilities to construct dry coal sheds in the plants, which could avoid natural losses caused by wind and rain and therefore reducing environmental pollution. Such construction also effectively prevented coal clogging in boilers due to wet coals caused by wind and rain, and eliminated the fluctuation of environmental data due to the unstable bottom temperature of boilers.

The Group set up a slag cooling system in the plants to recover waste heat, improve the thermal efficiency of boilers, and reduce energy consumption. Slag coolers facilitated the temperature of heated slags to decrease from 900°C to below 100°C, i.e. approximately 2.5 GJ of heat being recovered per hour based on the calculation of 12 tonnes of slags being disposed per hour. Without considering heat loss, the amount of heat collected from slags per hour approximate to that of about 150kg of coals, which indirectly improved the surrounding environment.

### 資源使用

本集團深明環境可持續性的重要性及致力透過採納多項節能減排舉措盡量減少對營商環境之影響。本集團政策乃確保符合適用環境法律及法規及透過資源的高效使用及採納環保管理盡量減少對環境之影響。本集團於辦公室採取之環保措施如下：

- 當會議室閒置時，提醒員工關掉房中的燈及空調以及當不工作時關閉電腦；
- 無論何時在可行情況下，文件以電子文件（非紙質文件）處理；
- 提醒員工節約用水；
- 鼓勵員工重複使用單面打印紙張及雙面打印及影印。定期審閱打印及影印數據以評估紙張使用效率；
- 盡量提供可回收辦公用品；及
- 盡量安排以電話會議代替面談。

此外，本集團的地熱能供暖製冷業務和集中供熱業務亦採取了一系列的節能減排措施，以有效減少資源使用。

本集團為了節省電力，對廠區內的電機類設備增加變頻器，有效調整電機的功率、實現電機的變速運行，以達到省電的目的。

本集團引進先進的環保設施，於廠區建設幹煤棚，可避免因風雨導致的自然流失，減少對環境的污染。該建設亦有效防止因風雨導致煤濕造成的鍋爐下煤不暢及杜絕因鍋爐床溫不穩定造成的環保數據波動。

本集團於廠區增加冷渣系統，可以回收餘熱，提高鍋爐熱效率，減少能源的消耗。冷渣機可以使900度熱渣降至100度以下，按每小時處理12噸渣量計算，即每小時可回收約2.5吉焦的熱量。於不考慮熱量損失的情況下，每小時從渣中吸收的熱量相當於約150公斤的煤，間接改善周邊環境。

In order to enhance employees' awareness of energy saving and emission reduction and management's sense of responsibility and mission of fulfilling such goals, the Group organized trainings on every Saturday to continuously teach them knowledge, good methods and tips, make modest improvement to unreasonable practices, and keep to make technological innovation, thereby making advancement in the work of energy saving and emission reduction to improve efficiency.

本集團為了提高員工對節能減排的認識及增強設備管理人員做好節能減排的責任感和使命感，每週六組織培訓，不斷的灌輸知識，培訓好方法、小竅門，對不合理的做法進行小改小造，不斷地技術革新，推動節能減排工作的向前發展，提高效益。

The Group started the centralized heating business after becoming the reorganization investor of a company, which is principally engaged in the business of providing the heat and steam supply services in the licensed area of Yuncheng, Shanxi through centralized pipe networks, in September 2020. The Group's electricity purchased for consumption for the fifteen months ended 31 March 2021 only included the data of the centralized heating business for 5 months, while the data of the Year 2021/22 included the electricity purchased for consumption of this business for 12 months, so there was more electricity purchased for consumption.

During the Year 2021/22, the Group did not encounter any difficulties in obtaining suitable water sources.

The 5-year target of the Group is to reduce the total energy consumption intensity and water consumption intensity by 5% by the Year 2026/27, respectively, based on the Year 2021/22 benchmark.

本集團於2020年9月成為一間於山西運城特許經營區域主要從事通過集中管網提供供熱及供氣服務業務的公司之重組投資者後，開始集中供熱業務。本集團截至2021年3月31日止15個月的購買電力耗量只包括了集中供熱業務5個月份的數據。而2021/22年度則包括了該業務12個月份的購買電力耗量，故購買電力耗量較多。

於2021/22年度，本集團在求取適用水源方面並未遇到任何困難。

本集團的5年期目標是於2026/27年度前根據2021/22年度的基線分別將總能源消耗密度及耗水密度減少5%。

### Environmental and Natural Resources

Featured with energy conservation, low carbon, and environmental protection, developing geothermal heating is in compliance with national policies. Such features determine that geothermal heating can be a realistic choice to replace fossil energy such as coal on a large scale and optimize the energy structure.

As a clean renewable energy, geothermal energy has the following advantages: (i) geothermal central heating can achieve regional modularized central heating without laying a large area of centralized heating network, and its heating cost is lower as compared with that of fossil energy; (ii) geothermal resources are environmentally friendly and clean and renewable, and do not produce waste gas or waste residue, which is of great significance for the reduction of haze and smog and suspended particles; and (iii) through the technology of geothermal reinjection into the same reservoir bed, the heat-extracted tail water is recharged into the same reservoir bed to achieve the renewable use of geothermal resources.

While the National Development and Reform Commission, the National Energy Administration and the Ministry of Land and Resources jointly published the “Thirteenth Five-year Plan on the Development and Utilization of Geothermal Energy” (《地熱能開發利用「十三五」規劃》) on 23 January 2017, which proposed to “innovate the geothermal energy development and utilization mode, actively develop the geothermal energy market, and comprehensively promote the effective utilization of geothermal energy in accordance with the general requirements of advanced technology, environmental friendliness and economic feasibility”, and mentioned that advantages such as “promoting hydrothermal geothermal heating based on the combination of centralized and decentralized methods, and replacing traditional heating with clean energy heating under the guiding principle of taking heat but not water”. Those advantages will be beneficial to the sustainable development of the Group’s business.

### 環境及天然資源

發展地熱供暖符合國家政策，具有節能、低碳、環保等特點。有關特點決定了地熱供暖可用於規模化替代煤炭等化石能源，優化能源結構的現實選擇。

地熱作為一種清潔可再生能源，具以下優勢：(i)地熱集中供暖可實現區域模塊化集中供熱，無需鋪設大面積的集中供熱管網，且採暖費相對化石能源低廉；(ii)地熱資源具有環保和清潔可再生的特點，不產生廢氣廢渣，對減少霧霾和懸浮粒子具有重大意義；及(iii)通過同層回灌技術，將取熱後的尾水回灌至同一熱儲層，達到地熱資源的可再生利用。

而隨著國家發展改革委、國家能源局和國土資源部於2017年1月23日聯合發佈的《地熱能開發利用「十三五」規劃》，當中提出「創新地熱能開發利用模式，積極培育地熱能市場，按照技術先進、環境友好、經濟可行的總體要求，全面促進地熱能有效利用」，並提到「按照集中式與分散式相結合的方式，推進水熱型地熱供暖，在取熱不取水的指導原則下，進行傳統供暖區域的清潔能源供暖替代」。該等優勢將有利於本集團業務的可持續性發展。

The Group's projects for supplying heat are mainly applied in Hebei, Shanxi and Shaanxi, etc. In order to improve the environmental quality of these regions, the Group has constructed geothermal energy heating projects to control the use of fossil energy and reduce emissions of carbon dioxide and suspended particles, so as to improve the regional environmental quality. These constructions bring both higher economic benefits and important social benefits.

### Climate Change

The continuous emission of greenhouse gas leads to climate change. In response to climate change, the Group refers to the framework of the Task Force on Climate-related Financial Disclosures (TCFD) of Financial Stability Board to assess climate-related risks. There are two main types of risks, which are: (i) physical risks associated with climate change impacts; and (ii) transition risks associated with low-carbon economy.

The climate-related risks identified by the Group are mainly structural damage to buildings caused by the increase in frequency of extreme weather events and flooding due to changes in rainfall patterns. Such climate change may affect labor management and planning, and also increase the risk of work-related injuries for the employees. In addition, there is a risk that the Group's infrastructure and machines may be damaged by climate change, and facilities damage will affect operations and lead to an increase in operation costs.

In response to the above climate-related risks, the Group has purchased employee injury insurances for all employees. Such insurances cover expenses for employees' injuries due to weather conditions. The Group has also purchased relevant property insurance for all construction projects, operating projects and the Group's key fixed assets to cover property losses due to weather conditions and reduce maintenance costs that may be required.

本集團供用熱力的項目主要在河北、山西、陝西等地區應用。為致力改善該些地區的環境質量，本集團透過建設地熱能供暖項目，控制化石能源的使用，減少二氧化碳排放，降低懸浮粒子排放，改善區域環境質量。該等建設同時帶來較高的經濟效益和重要的社會效益。

### 氣候變化

溫室氣體的持續排放導致氣候產生變化，為應對氣候變化，本集團參考了金融穩定委員會的氣候相關財務信息披露工作組(Task Force on Climate-related Financial Disclosures, 簡稱TCFD)框架，以評估氣候相關風險。有關風險分為兩大類別，分別是：(i)與氣候變遷影響相關的實體風險；及(ii)與低碳經濟相關的轉型風險。

本集團識別的氣候相關風險主要為極端天氣事件頻密程度提高令建築物結構受損及因降雨模式的改變而引致的水災。該等氣候變化或會影響勞動力管理和規劃，亦增加僱員因工受傷的風險。此外，本集團的基礎建設及機器亦存在可能受氣候變化損害的風險，設施損毀會影響營運及導致營運成本上升。

為應對上述氣候相關風險，本集團已經為所有的僱員購買了僱員的工傷保險。該等保險涵蓋因天氣因素而產生僱員損傷的支出保障。另外，本集團亦已為所有工程項目、運營項目及集團的主要固定資產購買了相關的財產保險，以保障因天氣因素而產生的財產損失，以及減少可能需要的維修費用。

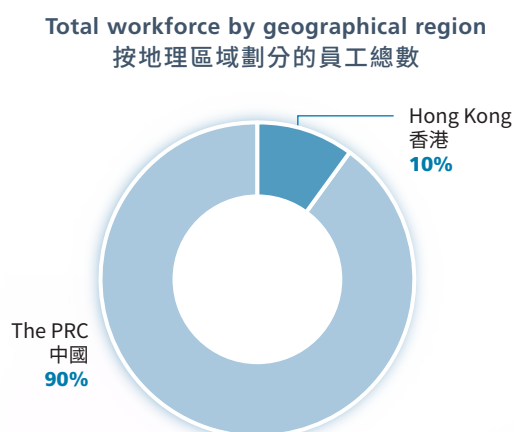
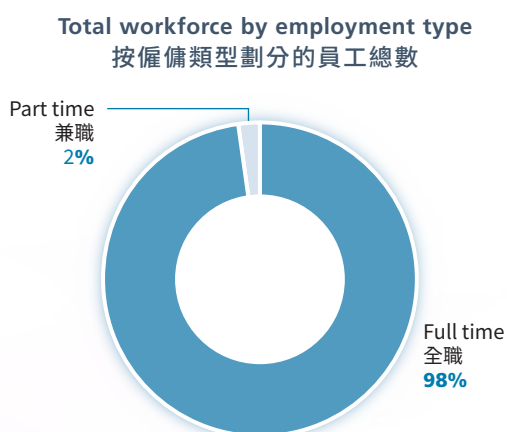
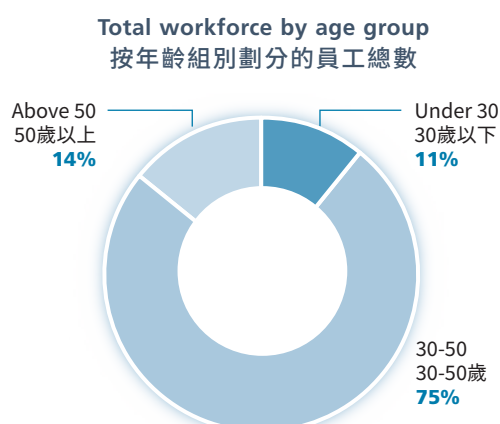
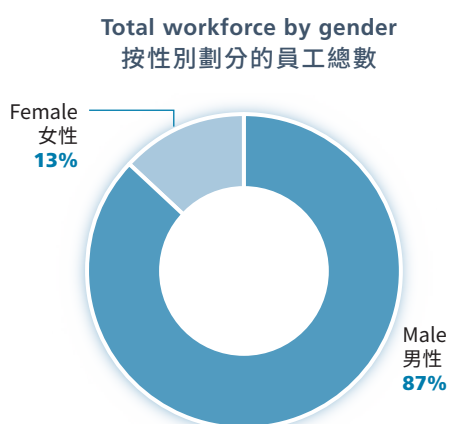

The Group offers competitive remuneration and employee benefits to attract talented staff and use a performance-based remuneration system to motivate and reward them in line with their contributions to growing its business. An employee's remuneration is determined with reference to performance and market benchmarks. Salary levels are not differentiated by gender. Salaries and benefits are in accordance with local minimum wages or above. All employees are treated fairly and equally, and their rights and interests are also protected.

The Group establishes objective basis of key qualities and requirements for candidates in its hiring processing and assess the suitability of the candidate to avoid risks of discrimination or bias. Job openings are also offered to all qualified employees with good work records, so as to promote career advancement among employees as well. Consistent criteria are applied to assess both internal and external candidates regardless of age, sex, race, nationality or physical disabilities to ensure fair judgment and avoid any risk of favoritism or discrimination.

All work are reasonably assigned and should be performed voluntarily by employees, and fair and reasonable working hours are arranged to respective staff in accordance with various job needs. All employees may resign upon reasonable notice and should not be dismissed for unreasonable grounds.

The Group is not aware of any material non-compliance with relevant laws and regulations relating to compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity, anti-discrimination and other benefits and welfare for the Year 2021/22. The Group strictly complies with local laws and regulations relating to employment, such as the Labor Law of the People's Republic of China and the Law of the People's Republic of China on the Employment Contracts. In addition, there was no circumstance of significant fines or sanctions as a result of non-compliance with the relevant laws and regulations for the Year 2021/22.

### Health and Safety

The Group's business includes the exploration and development of geothermal resources and geothermal energy heating projects, which mainly involve two types of hazards, one is the hazards or adverse effects caused by natural factors, generally including earthquakes, poor geology, high temperature in summer, low temperature in winter, lightning strikes and other factors; and another one is the hazards arising from the production process, including harmful dust and poison, fire and explosion accidents, mechanical injuries and electrical injuries, burn injuries due to high temperature, falling injuries and other factors.

To protect employees from the impacts of occupational hazards, the Group requires that the project must be designed in accordance with the "Hygienic Standards for the Design of Industrial Enterprises (GBZ 1-2010)" (《工業企業設計衛生標準》(GBZ 1-2010)) and the "Code for Design of Industrial Heating, Ventilation and Air Conditioning (GB 50019-2015)" (《工業採暖通風與空氣調節設計規範》(GB 50019-2015)) to prevent heatstroke. Measures such as heat insulation, ventilation, and heating shall be adopted in accordance with the requirements of the specification in the design to ensure a good working environment for the operation, maintenance and production personnel.

本集團於其聘用過程中設立候選人的主要質素及要求的客觀依據，並評估候選人是否適合以避免產生歧視或偏見風險。本集團亦會向所有具有良好工作記錄的合資格僱員提供就業機會，以促進僱員的職業發展。不論年齡、性別、種族、國籍或身體殘疾，本集團均採用一致標準評估內部及外部候選人，以確保作出公平的判斷及避免任何偏袒或歧視風險。

### 健康及安全

本集團業務當中包括地熱資源及地熱能供熱項目勘探及開發，有關項目主要涉及兩類危害因素，其一為自然因素形成的危害或不利影響，一般包括地震、不良地質、暑熱、冬季低溫、雷擊等因素；其二為生產過程中產生的危害，包括有害塵毒、火災爆炸事故、機械傷害事故及電傷、高溫燙傷、墜落等各種因素。

本集團為保護僱員免受職業危害產生的影響，要求工程必須根據《工業企業設計衛生標準》(GBZ 1-2010)和《工業採暖通風與空氣調節設計規範》(GB 50019-2015)對防暑降溫進行設計。在設計中依據規範要求，採取隔熱、通風、供暖等措施，以保證運行、檢修生產人員具有良好的工作環境。

The Group has also carried out the design of overvoltage protection and grounding of equipment in accordance with the requirements of the “Technical Regulations for Design of Overvoltage Protection for Power Equipment” (《電力設備過電壓保護設計技術規程》) and the “Technical Regulations for Grounding Design of Power Equipment” (《電力設備接地設計技術規程》), which include the design of anti-static for outdoor equipment. Moreover, outdoor equipment such as pumps and other equipment should be installed with lightning rods as direct lightning overvoltage protection facilities.

In addition, the noise generated by the heat pump units and circulating water pumps operating in the exploration and development of the project may cause hearing damage to the staff. Therefore, the Group provides effective personal protection measures for the staff working in noisy operation positions and also requires them to wear ear plugs, ear muffs, etc. while patrolling or operating, so as to minimize the exposure to high intensity noise environment and reduce the risk to human body as far as possible.

In addition, there was no circumstance of significant fines or sanctions as a result of non-compliance with the relevant laws and regulations for the Year 2021/22.

### Labor Standards

The Group from time to time reviews its employment practice and the Group's guidelines on staff recruitment to ensure that it is in full compliance with the relevant laws and regulations on the prevention of child labor and forced labor in the PRC and Hong Kong.

The Group adopted stringent requirements in selecting employees. We require job applicants to provide information such as identity cards, proof of highest academic qualifications, professional certificates and proof of separation from previous employment for identity verification during recruitment. In the event that child labor or forced labor is employed within the Group in violation of regulations, the Group will immediately terminate the labor contract and, after identifying the reasons, impose appropriate penalties on the non-compliant employees.

For the Year 2021/22, the Group was not aware of any material non-compliance of the laws and regulations relating to the prevention of child labor or forced labor. The Group strictly complies with the local laws and regulations related to labor standards, such as the Labor Law of the People's Republic of China and the Provisions on Prohibition of Child Labor. In addition, there was no circumstance of significant fines or sanctions as a result of non-compliance with the relevant laws and regulations for the Year 2021/22.

### Supply Chain Management

The Group has established internal control procedures for the selection of suppliers. The Group requires that: (i) environmental certificates shall be verified before the shortlisting of suppliers and environmental ratings shall be approved by professionals; (ii) only those suppliers who have been shortlisted in the resource pool are allowed to participate in the bidding process; and (iii) during the bidding process, assuming that all suppliers meet the technical requirements, the expert panel shall rate their environmental ratings and environmental solutions, with the supplier with the highest rating being the preferred supplier and the supplier with the second highest rating being its reserve supplier (selected only if the preferred supplier waives to continue to perform the bid).

"Energy saving and environmental protection" is our highlight in rendering services and selling products, which also echoes with the environmental protection concept of our customers. Therefore, the Group will give priority to those suppliers with eco-friendly products to differentiate our products from those of other competitors, so as to achieve differentiated marketing.

While the Group has established good relationships with its suppliers, the Group also offers equal opportunity to all potential business partners. Selection criteria such as quality and price of products, supplier's reputation, background and experience are key factors to the Group's procurement decisions. Furthermore, the Group expects its suppliers to strictly comply with relevant laws and regulations.

### 供應鏈管理

本集團已訂立供應商篩選的內控程序，本集團要求：(i) 供應商入圍需要核驗環保證書，並經專業人員核定環保等級；(ii) 只容許入圍資源庫的供應商參與投標；(iii) 在投標過程中，假設供應商均在同等滿足技術要求的前提下，專家組須對彼等環保等級及環保方案進行評分，評分最高的供應商為首選供應商，評分第二名的供應商則作為其備選供應商（僅在首選供應商放棄繼續履行該投標的情況下選用）。

本集團在提供服務及銷售產品對外宣傳的亮點是「節能、環保」，符合廣大客戶的環保理念。因此，本集團選擇供應商時會優先考慮使用環保產品，造成與其他競爭商的產品差異，從而達到差異化銷售之目的。

### Product Responsibility

The Group is responsible for its products and services and does not engage in unfair business activities of any kind. Fraud, misleading information, or any acts that destroy customer confidence or infringe customer rights are strictly prohibited. The Group has also strictly complied with relevant products and services related regulations.

For the commodity trading business, the Group has established procedures for the recycling of products. After recycling, the Group tests the products for environmental attributes and assesses whether the products meet the future technical conditions for recycling purposes as far as possible. For the Year 2021/22, the Group has not received any products subject to recycling for safety and health reasons from our customers.

For customers' complaints, the Group will conduct corresponding follow-up procedures in accordance with internal procedures and guidelines. Upon receiving a customer's complaint, we will promptly contact the customer to understand the cause and discuss the solution with the customer, conduct on-site and telephone communication for preliminary resolution of the customer's request and take relevant investigation accordingly. In addition, we will carry out technical updates or renovations based on environmental conditions for problems that arise. The Group believes that complaints are a valuable opportunity for it to obtain feedback from the community and customers, so as to identify the need for service and policy improvement. The Group has not received any complaint about its products and services for the Year 2021/22.

The Company's data protection and privacy policy is that while collecting, processing and using personal data of the Group's customers in its financial service sector, appropriate measures are taken to protect such data from unauthorized access and abuse. Personal data is collected only for lawful and relevant purposes. Employment contracts stipulate employees' duty in safeguarding confidential or sensitive information that they have had access to during their employment.

The Group is committed to protecting intellectual property rights which are of great importance to its business. The Group has developed a method for the management of computer software copyrights to strictly regulate its copyright application procedures. The Group has also established a copyright list to record information such as application numbers, application dates and deadlines of its software copyrights.

### 產品責任

對於客戶之投訴，本集團會依照內部程序及指導方針進行相應之跟進程序，接到客戶投訴後會迅速與客戶聯繫，了解被投訴的原因及與客戶商討解決方案，針對客戶訴求，進行現場及電話溝通進行初步解決，並會依此開展相關之調查。此外，對於出現的問題進行技術更新或者以環保條件為基礎進行改造。本集團認為投訴是其獲得社區及客戶反饋之一個寶貴機會，以便確定是否需要對服務及政策作出改進。本集團於2021/22年度內未有接獲關於產品及服務的投訴。

本公司之數據保護及私隱政策為當本集團於收集、處理及使用金融服務部門客戶的個人資料時，採取適當的措施，保護該等資料遭受未獲授權訪問及濫用。個人資料僅可於合法及相關目的予以收集。僱傭合約規定員工負有保護其於受僱期間有權訪問的機密或敏感資料的責任。

知識產權對本集團的業務極為重要，本集團致力保護知識產權。本集團已訂立有關電腦軟件著作權的管理方法，以嚴格規管其著作權的申請程序。本集團亦建立了著作權清單記錄其軟件著作權的申請號碼、申請日期及期限等資料。

For the Year 2021/22, the Group was not aware of any material non-compliance with the laws and regulations relating to the health and safety, advertising, labelling and privacy matters relating to the products and methods of redemption. The Group strictly abides by the local laws and regulations related to product liability, such as the Personal Data (Privacy) Ordinance, the Advertising Law of the People's Republic of China, the Trademark Law of the People's Republic of China and the Patent Law of the People's Republic of China. In addition, no significant fines or sanctions have been reported for the Year 2021/22.

### Anti-corruption

The Group is committed to uphold high standards on anti-corruption. Adequate guidelines are implemented to ensure that all employees (including directors) adhere to high standards of business and professional and ethical conduct. All employees are encouraged to raise any related concerns to the senior management in a strictly confidential manner. Any matters of genuine concern are to be thoroughly investigated and actions will be taken accordingly.

For the Year 2021/22, the Group provides its directors, senior management members and relevant employees with training packages for directors and professionals prepared by the Independent Commission Against Corruption (ICAC). The training packages cover the corruption risks faced by directors, senior management and professionals of a company during the preparation for listing, ordinary business operation and takeovers and mergers, and dissect issues such as corruption, fraud, conflicts of interest, cross-border bribery, backdoor listing and insider trading.

To the best knowledge of the Company, the Group has been compliant with all relevant anti-money laundering laws. The risk of establishing relationships with individuals or organizations engaged in money laundering or terrorism activities are minimized by the implementation of "know your customer" and assessment processes. The Group has robust internal control procedures in place to provide reasonable assurance against fraud. For the Year 2021/22, the Group has not been involved in any corruption lawsuits.

The Group holds license or approval required for the provision of money lending services, finance leasing services and regulated activities under the Securities and Futures Ordinance. The management supports a culture of integrity, zero tolerance for bribery and ensures that business is conducted in accordance with the applicable laws and regulations.

For the Year 2021/22, the Group was not aware of any material non-compliance with the laws and regulations relating to bribery, extortion, fraud and money laundering. The Group strictly abides by the local laws and regulations related to anti-corruption, such as the Prevention of Bribery Ordinance, the Criminal Law of the People's Republic of China and the Anti-Money Laundering Law of the People's Republic of China. In addition, no significant fines or sanctions have been reported for the Year 2021/22.

Where any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their respective associates (as defined under the Listing Rules) would result in the Company's shares issued and to be issued upon exercise of all options already granted and to be granted (including options exercised, cancelled and outstanding) to such person(s) in the 12-month period up to and including the date of such grant (a) representing in aggregate over 0.10 per cent of the Company's shares in issue; and (b) having an aggregate value, based on the closing price of the Company's shares at the date of each grant, in excess of HK\$5 million, such further grant of options is subject to approval by the shareholders of the Company in compliance with the Listing Rules.

The offer of a grant of share options may be accepted in writing by a participant within 21 days from the date of offer upon payment of a nominal consideration of HK\$1 by the grantee. The exercise period for the share options granted is determined by the Board, which period shall not be more than 10 years from the date of acceptance.

These impairment tests are significant to our audit because the balances of loans and interests receivables, finance lease receivables, trade and other receivables, other loans and interest receivable, promissory note receivable and contract assets of approximately HK\$399,230,000, HK\$4,914,000, HK\$624,359,000, HK\$9,252,000, HK\$90,000,000 and HK\$370,760,000 respectively as at 31 March 2022 and the impairment losses on loan and interest receivables, finance lease receivables and trade and other receivables for the year ended 31 March 2022 of approximately HK\$22,987,000, HK\$10,296,000 and HK\$548,000, respectively are material to the consolidated financial statements. In addition, the Group's impairment test involves application of judgement and is based on estimates.

Note i: The contributed surplus of the Group represents (i) the difference between the nominal value of the shares of the subsidiaries acquired pursuant to the reorganisation prior to the listing of the Company's shares on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") in 1996 and the nominal value of the Company's shares issued in exchange and (ii) the credit arising from the capital reduction by cancelling the par value of the paid-up capital of the Company on 2 September 2020.

Note ii: In accordance with the People's Republic of China (the "PRC") Company Law and the PRC subsidiaries' Articles of Association, a subsidiary registered in the PRC, prior to any dividend distribution, is required to appropriate 10% of its annual statutory net profit as determined in accordance with relevant statutory rules and regulations applicable to enterprises established in the PRC (after offsetting any prior years' losses) to the statutory reserve. When the balance of such reserve fund reaches 50% of the entity's capital, any further appropriation is optional. The statutory reserve can be utilised to offset prior years' losses or to increase capital. However, such balance of the statutory reserve must be maintained at a minimum of 25% of the capital after such usages. The balance is reclassified to retained earnings at the date of disposal of the subsidiary.

附註i: 本集團之繳入盈餘指(i)本公司股份於一九九六年在香港聯合交易所有限公司(「聯交所」)主板上市前,根據重組所收購附屬公司之股份面值與作為交換而發行之本公司股份面值之差額及(ii)於二零二零年九月二日透過註銷本公司繳足股本面值的股本削減所產生的進賬。

附註ii: 根據中華人民共和國(「中國」)公司法及中國附屬公司之組織章程細則,於中國註冊之附屬公司應當於分派任何股息前提取每年法定純利的10%列入法定儲備。每年法定純利乃根據對於中國成立之企業適用之有關法定規則及法規釐定(已抵銷任何先前年度虧損)。倘該法定儲備餘額達實體資本的50%,則可選擇是否作出任何進一步劃撥。法定儲備可用於抵銷先前年度之虧損或增加股本。然而,運用法定儲備後之餘額最低須維持在資本之25%。結餘於出售附屬公司當日重新分類至保留盈利。

### 1. GENERAL

China Best Group Holding Limited (the “Company”) is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on the Stock Exchange.

The addresses of the registered office and principal place of business of the Company are disclosed in the “Corporate Information” of the annual report.

The principal activity of the Company is investment holding. The activities of its principal subsidiaries (together with the Company referred to as the “Group”) are set out in note 48.

Pursuant to a resolution of the board dated 19 June 2020, the Company’s financial year end date has been changed from 31 December to 31 March commencing from financial year of 2020/2021. Accordingly, the consolidated financial statement for the current year is from 1 April 2021 to 31 March 2022. The corresponding comparative amounts shown for the consolidated statement for profit or loss and other comprehensive income, consolidated statement of changes in equity, consolidated statement of cash flows and related notes cover a fifteen months period from 1 January 2020 to 31 March 2021 and therefore may not be comparable with amounts shown for the current year.

The consolidated financial statements are presented in Hong Kong dollars (“HK\$”), which is also the functional currency of the Company.

### 3. SIGNIFICANT ACCOUNTING POLICIES

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis, except for certain financial instruments and investment properties that are measured at fair values at the end of each reporting period.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants in the principal (or most advantageous) market at the measurement date under current market conditions (i.e. an exit price) regardless of whether that price is directly observable or estimated using another valuation technique. Details of fair value measurement are explained in the accounting policies set out below.

The preparation of the consolidated financial statements in conformity with HKFRSs requires the use of certain key assumptions and estimates. It also requires the directors of the Company (the “Directors”) to exercise its judgements in the process of applying the accounting policies. The areas involving critical judgements and areas where assumptions and estimates are significant to these consolidated financial statements, are disclosed in note 4 to the consolidated financial statements.

The principal accounting policies are set out below.

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company (i.e. its subsidiaries). If a subsidiary prepares its financial statements using accounting policies other than those adopted in the consolidated financial statements for like transaction and events in similar circumstances, appropriate adjustments are made to that subsidiary’s financial statement in preparing the consolidated financial statements to ensure conformity with the Group’s accounting policies.

Control is achieved when the Group has: (i) the power over the investee; (ii) exposure, or rights, to variable returns from its involvement with the investee; and (iii) the ability to use its power over the investee to affect the amount of the Group’s return.

The Company reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Company obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Income and expenses of a subsidiary are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

#### 綜合賬目基準

綜合財務報表包括本公司及本公司控制之實體（即其附屬公司）之財務報表。倘附屬公司編製其財務報表時使用的會計政策就類似交易及於類似情況下之事件有別於其在綜合財務報表所採用者，則在編製綜合財務報表時，會對該附屬公司之財務報表作出適當調整，以確保符合本集團之會計政策。

本集團在以下情況下取得控制權：(i) 擁有對接受投資實體之權力；(ii) 因參與接受投資實體而獲得可變回報之風險或權利；及(iii) 有能力運用其對接受投資實體之權力影響本集團之回報金額。

倘有事實及情況顯示上述三項控制權要素有一項或以上出現變動，本公司會重新評估其是否對接受投資實體擁有控制權。

附屬公司於本公司取得對附屬公司控制權時開始綜合入賬，並於本集團失去對附屬公司控制權時終止綜合入賬。附屬公司之收益及開支，會由本集團取得控制權之日期直至本集團對附屬公司控制權終止之日期計入綜合損益及其他全面收益表內。

Profit or loss and each component of other comprehensive income of subsidiaries are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the result of the Group are presented on the face of the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company.

#### Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

有關本集團成員公司間交易的一切集團內公司間資產及負債、權益、收支及現金流量於綜合賬目時悉數對銷。

非控股權益於綜合財務狀況表之權益中與本公司權益股東應佔權益分開呈列。本集團業績之非控股權益乃於綜合損益及其他全面收益表列作本公司非控股權益與權益股東之間本年度溢利或虧損總額及全面收益總額之分配結果。

When the Group loses control of a subsidiary, it (i) derecognises the assets (including any goodwill) and liabilities of the subsidiary at their carrying amounts at the date when control is lost, (ii) derecognises the carrying amount of any non-controlling interests in the former subsidiary at the date when control is lost (including any components of other comprehensive income attributable to them), and (iii) recognises the aggregate of the fair value of the consideration received and the fair value of any retained interest, with any resulting difference being recognised as a gain or loss in profit or loss attributable to the Group. When assets and liabilities of the subsidiary are carried at revalued amounts or fair values and the related cumulative gain or loss has been recognised in other comprehensive income and accumulated in equity, the amounts previously recognised in other comprehensive income and accumulated in equity are accounted for as if the Group had directly disposed of the related assets and liabilities (i.e. reclassified to profit or loss or transferred directly to retained earnings as specified by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9 Financial Instruments or, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

#### Business combinations

Business combinations are accounted for by applying the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs incurred to effect a business combination are recognised in profit or loss as incurred.

- assets or liabilities related to the acquiree's employee benefit arrangements are recognised and measured in accordance with HKAS 19 Employee Benefits;

Goodwill is measured as the excess of the aggregate of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the Group's previously held equity interest in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and the liabilities assumed. If, after re-assessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the aggregate of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a gain on bargain purchase.

#### Business combinations (Continued)

Non-controlling interests, unless as required by another standards, are measured at acquisition-date fair value except for non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation are measured either at fair value or at the present ownership instruments' proportionate share in the recognised amounts of the acquiree's identifiable net assets on a transaction-by-transaction basis.

When the consideration transferred by the Group in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments made against goodwill. Measurement period adjustments are adjustments that arise from additional information obtained during the "measurement period" (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Other contingent consideration that is within the scope of HKFRS 9 is measured at fair value at each reporting date, and changes in fair value are recognised in profit or loss in accordance with HKFRS 9. Other contingent consideration that is not within the scope of HKFRS 9 is measured at fair value at each reporting date and changes in fair value are recognised in profit or loss.

倘本集團於業務合併中轉讓之代價包括或然代價安排產生之資產或負債，或然代價按其收購日期公平值計量，並計入為於業務合併中所轉讓代價之一部分。屬於計量期間調整之或然代價公平值變動會進行追溯調整，而就商譽作出相應調整。計量期間調整乃於「計量期間」(其不可超過自收購日期起計一年)內所獲得之有關於收購日期存在之事實及情況之額外資料所產生之調整。

#### Business combinations (Continued)

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control), and the resulting gain or loss, if any, is recognised in profit or loss. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income are reclassified to profit or loss where such treatment would be appropriate if that interest were disposed of.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. During the measurement period (see above), the provisional amounts recognised at the acquisition date are adjusted retrospectively or additional assets or liabilities are recognised as of that date, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

#### Associates

Associates are entities over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of an entity but is not control or joint control over those policies. The existence and effect of potential voting rights that are currently exercisable or convertible, including potential voting rights held by other entities, are considered when assessing whether the Group has significant influence. In assessing whether a potential voting right contributes to significant influence, the holder's intention and financial ability to exercise or convert that right is not considered.

Investment in an associate is accounted for in the consolidated financial statements by the equity method and is initially recognised at cost. Identifiable assets and liabilities of the associate in an acquisition are measured at their fair values at the acquisition date. The excess of the cost of acquisition over the Group's share of the net fair value of the associate's identifiable assets and liabilities is recorded as goodwill. The goodwill is included in the carrying amount of the investment and is tested for impairment together with the investment at the end of each reporting period when there is objective evidence that the investment is impaired. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss.

倘業務合併分階段完成，本集團先前於被收購方持有的股權按收購日期（即本集團獲得控制權當日）的公平值進行重新計量，而所產生的收益或虧損（如有）於損益中確認。先前在其他全面收益中確認的於收購日期前於被收購方的權益所產生款額重新分類至損益（倘有關處理方法適用於出售權益）。

倘業務合併的初步會計處理於合併發生的報告期末尚未完成，則本集團會呈報未完成會計處理的項目的臨時數額。於計量期間（見上文），於收購日期確認之臨時數額會進行追溯調整或就截至該日確認額外資產或負債，以反映所取得有關於收購日期已存在而若本來知悉會影響於該日所確認數額的事實與情況之新資料。

#### 聯營公司

聯營公司為本集團對其有重大影響力的實體。重大影響力指參與某實體財務及經營政策決策的權力，而非對該等政策的控制權或共同控制權。於評估本集團是否有重大影響力時，會考慮現時可行使或可轉換的潛在投票權（包括其他實體所持有的潛在投票權）的存在及影響。於評估潛在投票權會否產生重大影響力時，不會考慮持有人行使或轉換該權利的意向及財務能力。

於一間聯營公司的投資按權益法於綜合財務報表入賬，並初步按成本確認。所收購聯營公司的可識別資產及負債按其於收購日期的公平值計量。倘收購成本超過本集團分佔聯營公司可識別資產及負債的公平值淨額，則差額入賬列作商譽。商譽計入該投資賬面值，並於有客觀證據顯示該投資發生減值時，於各報告期末連同該投資進行減值測試。倘任何本集團分佔可識別資產及負債的公平值淨額超過收購成本，則有關差額於綜合損益確認。

#### Associates (Continued)

The Group's share of an associate's post-acquisition profits or losses is recognised in consolidated profit or loss, and its share of the post-acquisition movements in reserves is recognised in the consolidated reserves. The cumulative post-acquisition movements are adjusted against the carrying amount of the investment. When the Group's share of losses in an associate equals or exceeds its interest in the associate, including any other unsecured receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the associate. If the associate subsequently reports profits, the Group resumes recognising its share of those profits only after its share of the profits equals the share of losses not recognised.

The gain or loss on the disposal of an associate that results in a loss of significant influence represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that associate and (ii) the Group's share of the net assets of that associate plus any remaining goodwill relating to that associate and any related accumulated foreign currency translation reserve. If an investment in an associate becomes an investment in a joint venture, the Group continues to apply the equity method and does not remeasure the retained interest.

Unrealised profits on transactions between the Group and its associates are eliminated to the extent of the Group's interests in the associates. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the Group.

#### Joint Ventures

A joint venture is a contractual arrangement whereby the Group and other parties undertake an economic activity through an entity that is separate from the parties and subject to joint control. Investment in a joint venture is stated at cost less impairment losses.

本集團分佔一間聯營公司收購後溢利或虧損於綜合損益確認，而其分佔收購後儲備變動則於綜合儲備確認。收購後的累計變動於該投資的賬面值作出調整。倘本集團分佔一間聯營公司虧損等於或超過其於該聯營公司的權益（包括任何其他無抵押應收款項），本集團不會進一步確認虧損，除非其已產生責任或代聯營公司作出付款。倘聯營公司其後錄得溢利，則本集團僅於其分佔溢利等於其分佔未確認虧損後，恢復確認其分佔的該等溢利。

導致失去重大影響力之出售一間聯營公司之盈虧為(i)出售代價公平值加上於該聯營公司保留的任何投資的公平值及(ii)本集團分佔該聯營公司的資產淨值加上任何有關該聯營公司的餘下商譽以及任何有關關聯計外幣匯兌儲備兩者之間的差額。倘一項於一間聯營公司的投資變為於一間合營公司的投資，本集團繼續應用權益法並不再重新計量保留權益。

本集團與其聯營公司之間的交易的未變現溢利，以本集團於聯營公司的權益為限予以對銷。除非該交易提供證據證明所轉讓資產出現減值，否則未變現虧損亦予以對銷。聯營公司的會計政策已於必要時作出變動，以確保與本集團所採納政策貫徹一致。

#### 合營公司

合營公司為本集團與其他訂約方通過獨立於訂約方並受共同控制之實體從事經濟活動之一種合約安排。於合營公司之投資按成本減減值虧損列賬。

#### Joint Ventures (Continued)

Investment in a joint venture is accounted for in the consolidated financial statements under the equity method. The investment is initially recorded at the transaction price (including transaction costs) and is subsequently adjusted to reflect the Group's share of profit or loss after the date of acquisition. The Group's share of the profit or loss of the joint venture is recognised in the consolidated profit or loss. Distributions received from a joint venture reduce the carrying amount of the investment.

Identifiable assets and liabilities of a joint venture in an acquisition are measured at their acquisition date fair values. The excess of the cost of acquisition over the Group's share of the net fair value of the joint venture's identifiable assets and liabilities is recorded as goodwill. Goodwill relating to a joint venture is included in the carrying amount of the investment unless fully amortised or impaired. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss.

When the Group's share of losses exceeds its interest in the joint venture, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the joint venture.

The difference between the proceeds from the disposal of a joint venture and its carrying amount as of the date of disposal is recognised in the consolidated profit or loss as the gain or loss on disposal of the joint venture.

Unrealised profits and losses resulting from upstream and downstream transactions are eliminated to the extent of the Group's interests in joint ventures. Accounting policies of joint ventures have been changed where necessary to ensure consistency with the policies adopted by the Group.

#### Goodwill

Goodwill arising from a business combination is carried at cost less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (or groups of cash-generating units) that is expected to benefit from the synergies of the combination.

於合營公司之投資乃按權益法於綜合財務報表入賬。該投資最初按交易價格（包括交易成本）入賬，隨後進行調整以反映本集團分佔於收購日期後之損益。本集團分佔合營公司之損益於綜合損益中確認。從合營公司收取之分派減少投資之賬面值。

收購中合營公司的可識別資產及負債按其收購日期之公平值計量。收購成本超過本集團分佔合營公司可識別資產及負債公平值淨值的部分入賬列作商譽。除非已全數攤銷或減值，否則與合營公司有關的商譽計入投資的賬面值。任何本集團分佔可識別資產及負債的公平值淨值超過收購成本的部分均於綜合損益中確認。

倘本集團分佔虧損超過其於合營公司的權益，本集團的權益會削減至零並不再確認進一步虧損，惟倘本集團已產生法定或推定責任或代表合營公司作出付款則除外。

出售合營公司的所得款項與其截至出售日期的賬面值之間的差額於綜合損益中確認為出售合營公司的收益或虧損。

上游及下游交易所產生的未實現損益以本集團於合營公司的權益為限予以抵銷。合營公司之會計政策已於必要時作出更改，以確保與本集團所採納之政策貫徹一致。

#### 商譽

業務合併所產生之商譽按成本值減累計減值虧損（如有）列賬。

就減值測試而言，商譽會分配至預期會因合併之協同效益而受惠之各個本集團現金產生單位（或現金產生單位組別）。

#### Goodwill (Continued)

A cash-generating unit to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the cash-generating unit to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount of the cash-generating unit is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit on a pro rata basis based on the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant cash-generating unit, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal.

#### Revenue from contracts with customers

Revenue is measured based on the consideration specified in a contract with a customer with reference to the customary business practices and excludes amounts collected on behalf of third parties. For a contract where the period between the payment by the customer and the transfer of the promised product or service exceeds one year, the consideration is adjusted for the effect of a significant financing component.

The Group recognises revenue when it satisfies a performance obligation by transferring control over a product or service to a customer. Depending on the terms of a contract and the laws that apply to that contract, a performance obligation can be satisfied over time or at a point in time. A performance obligation is satisfied over time if:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance;
- the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

#### 商譽 (續)

獲分配商譽之現金產生單位每年會進行減值測試，當該單位出現可能減值之跡象時，則會更加頻繁地進行減值測試。就於報告期間因收購產生之商譽而言，已獲分配商譽之現金產生單位乃於報告期間結束前進行減值測試。倘現金產生單位之可收回金額低於其賬面值，則先將有關減值虧損分配以減低該單位獲分配之任何商譽之賬面值，再根據該單位每項資產之賬面值按比例分配至該單位之其他資產。商譽之任何減值虧損直接於損益中確認。就商譽確認之減值虧損不會於往後期間撥回。

於出售相關現金產生單位時，商譽應佔金額計入釐定出售損益金額內。

#### 來自客戶合約之收益

收益乃根據與客戶訂立之合約所指明之代價參考慣常業務慣例計量，並不包括代表第三方收取之金額。就客戶付款與承諾產品或服務轉移期間超過一年之合約而言，代價須就重大融資組成部分之影響作出調整。

本集團於透過將產品或服務之控制權轉移予客戶而達成履約義務時確認收益。視乎合約條款及適用於該合約之法律而定，履約義務可隨時間推移或於某一時間點達成。倘符合以下情況，則履約義務屬隨時間推移達成：

- 客戶同時接收及消耗本集團履約所提供之利益；
- 本集團履約產生或增強一項於產生或增強時由客戶控制之資產；或
- 本集團履約並無產生對本集團而言具其他用途之資產，且本集團對迄今完成之履約付款具有可強制執行權利。

#### Revenue from contracts with customers

(Continued)

If a performance obligation is satisfied over time, revenue is recognised by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the product or service.

#### Other revenue

Interest income is recognised using the effective interest method.

Dividend income is recognised when the shareholders' rights to receive payment are established.

#### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

To the extent that funds are borrowed generally and used for the purpose of obtaining a qualifying asset, the amount of borrowing costs eligible for capitalisation is determined by applying a capitalisation rate to the expenditures on that asset. The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### 借貸成本

因收購、興建或生產合資格資產（即需要一段頗長時間準備才能投入作擬訂用途或出售之資產）直接產生之借貸成本撥充資本為該等資產成本之一部分，直至該等資產大致上可投入作擬訂用途或出售時為止。特定借貸用於合資格資產支出之前用作暫時投資所賺取之投資收入於合資格撥充資本之借貸成本中扣除。

就於一般情況下借入及用作獲取合資格資產之資金而言，合資格撥充資本之借貸成本金額乃按對該資產之支出應用資本化比率釐定。資本化比率為適用於本集團於該期間內尚未償還借貸（不包括就獲取合資格資產而借入之特定借貸）之借貸成本加權平均值。

所有其他借貸成本於產生期間在損益確認。

#### Related Parties

A related party is a person or entity that is related to the Group.

(A) A person or a close member of that person's family is related to the Group if that person:

- i. has control or joint control over the Group;
- ii. has significant influence over the Group; or
- iii. is a member of the key management personnel of the Company or of a parent of the Company.

(B) An entity is related to the Group if any of the following conditions applies:

- i. The entity and the Company are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others).
- ii. One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
- iii. Both entities are joint ventures of the same third party.
- iv. One entity is a joint venture of a third entity and the other entity is an associate of the third entity.

  - vii. A person identified in (A)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).
  - viii. The entity, or any member of a group of which it is a part, provides key management personnel services to the Company or to a parent of the Company.

#### Fiduciary activities

The Group maintains segregated accounts with authorised institutions to hold clients' monies arising from its normal course of the regulated business activities. The Group has classified the bank balances—trust and segregated accounts within the current assets in the consolidated statement of financial position and recognised the corresponding account payables to respective clients and other institutions on the grounds that it is liable for any loss or misappropriation of clients' monies. The Group is not allowed to use the clients' monies to settle its own obligations. The cash held on behalf of customers is restricted and governed by the Securities and Futures (Client Money) Rules under the Securities and Futures Ordinance.

#### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

#### 外幣

編製各個別集團實體之財務報表時，以該實體功能貨幣以外貨幣(即外幣)進行之交易乃按於交易日期當時之匯率以各自之功能貨幣(即實體經營所在主要經濟環境之貨幣)入賬。於報告期末，以外幣列值之貨幣項目以該日之匯率重新換算。以外幣歷史成本計算之非貨幣項目不予重新換算。

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise, except for exchange differences arising on a monetary item that forms part of the Company's net investment in a foreign operation, in which case, such exchange differences are recognised in other comprehensive income and accumulated in equity and will be reclassified from equity to profit or loss on disposal of the foreign operation.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the year. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, a disposal involving loss of joint control over a joint arrangement that includes a foreign operation, or a disposal involving loss of significant influence over an associate that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss. In addition, in relation to a partial disposal of a subsidiary that does not result in the Group losing control over the subsidiary, the proportionate share of accumulated exchange differences are reattributed to non-controlling interests and are not recognised in profit or loss. For all other partial disposals (i.e. partial disposals of associates or joint arrangements that do not result in the Group losing significant influence or joint control), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

於出售海外業務（即出售本集團於海外業務之全部權益或涉及失去對一間包含海外業務之附屬公司控制權之出售、或涉及失去對包含海外業務之合營安排共同控制權之出售、或涉及失去對包含海外業務之聯營公司重大影響力之出售）時，就本公司擁有人應佔該業務而於權益內累計之所有匯兌差額，重新分類至損益。此外，倘屬部分出售而不導致本集團失去附屬公司之控制權，則按比例應佔之累計匯兌差額重新歸於非控股權益，且不會於損益確認。就所有其他部分出售（即本集團部分出售聯營公司或合營安排而不導致本集團失去重大影響力或共同控制權）而言，按比例應佔之累計匯兌差額重新分類至損益。

#### Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

#### Retirement benefits scheme

Payments to defined contribution retirement benefit plans, the Mandatory Provident Fund ("MPF") Scheme, Central Provident Fund ("CPF") Scheme and state-managed retirement benefit schemes are recognised as an expense when employees have rendered service entitling them to the contributions.

#### Short-term employee benefits

A liability is recognised for benefits accruing to employees in respect of wages and salaries, annual leaves and sick leave in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

Liabilities recognised in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service.

#### Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the period. Taxable profit differs from (loss) profit before tax as reported in the consolidated statement of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

政府補助在本集團將補助擬補償之相關成本確認為開支之期間內，按系統化基準於損益中確認。

作為已產生開支或虧損補償，或給予本集團即時財政支援（並無附帶未來相關成本）而應收之政府補助，於其成為應收之期間內在損益中確認。

#### 退休福利計劃

定額供款退休福利計劃、強制性公積金（「強積金」）計劃、中央公積金（「中央公積金」）計劃及國家管理之退休福利計劃之供款於僱員因提供服務而享有供款時確認為開支。

#### 短期僱員福利

有關工資及薪金、年假及病假的僱員應計福利於提供相關服務期間按預期為換取有關服務而應支付之僱員福利未貼現金額確認為負債。

就短期僱員福利確認的負債按預期為換取有關服務而應支付之僱員福利未貼現金額計量。

#### 稅項

所得稅開支指當期應付稅項及遞延稅項之總和。

當期應付稅項根據期內應課稅溢利計算。由於應課稅溢利不計算其他年度應課稅收入或可抵扣稅開支項目，亦不計算根本無須課稅或不可抵扣稅之項目，故此與綜合損益及其他全面收益表所列除稅前（虧損）溢利數額不同。本集團之當期稅項負債乃按報告期末前已頒佈或實際上頒佈之稅率計算。

#### Taxation (Continued)

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

#### Plant and equipment

Plant and equipment (classified as finance leases) held for use in the production or supply of goods or services, or for administrative purpose are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and accumulated impairment losses, if any.

Depreciation is recognised so as to allocate the cost of items of plant and equipment less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of plant and equipment is determined as the difference between the sale proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### Lease

##### The Group as lessee

Leases are recognised as right-of-use assets and corresponding lease liabilities when the leased assets are available for use by the Group. Right-of-use assets are stated at cost less accumulated depreciation and impairment losses. Depreciation of right-of-use assets is calculated at rates to write off their cost over the shorter of the asset's useful life and the lease term on a straight-line basis. The principal useful lives are as follows:

Right-of-use assets are measured at cost comprising the amount of the initial measurement of the lease liabilities, lease payments prepaid, initial direct costs and the restoration costs. Lease liabilities include the net present value of the lease payments discounted using the interest rate implicit in the lease if that rate can be determined, or otherwise the Group's incremental borrowing rate. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to profit or loss over the lease term so as to produce a constant periodic rate of interest on the remaining balance of the lease liability.

持作生產貨品或提供服務之用或作行政用途之廠房及設備(分類為融資租賃)於綜合財務狀況表按成本值減其後累計折舊及累計減值虧損(如有)列賬。

廠房及設備項目乃於估計可用年期內以直線法確認折舊以分配其成本減剩餘價值。本集團會於各報告期末檢討估計可用年期、剩餘價值及折舊方法，而估計有變之影響則按未來基準入賬。

廠房及設備項目於出售後或當預期持續使用該資產將不會產生未來經濟利益時終止確認。出售或報廢廠房及設備項目所產生之任何盈虧按銷售所得款項與該資產之賬面值之差額釐定，並於損益內確認。

#### 租賃

##### 本集團作為承租人

租賃於租賃資產可供本集團使用當日確認為使用權資產及相應租賃負債。使用權資產按成本減累計折舊及減值虧損列賬。使用權資產於資產可使用年期與租賃期間之較短者內按撇銷成本之比率以直線基準計算折舊。主要可使用年期如下：

Payments associated with short-term leases and leases of low-value assets are recognised as expenses in profit or loss on a straight-line basis over the lease terms. Short-term leases are leases with an initial lease term of 12 months or less. Low-value assets are assets of value below US\$5,000.

**The Group as lessor**

(i) *Operating leases*

Leases that do not substantially transfer to the lessees all the risks and rewards of ownership of assets are accounted for as operating leases. Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease.

(ii) *Finance leases*

Leases that substantially transfer to the lessees all the risks and rewards of ownership of assets are accounted for as finance leases. Amounts due from lessees under finance leases are recognised as receivables at the amount of the Group's net investment in the leases. Finance lease income is allocated to accounting periods so as to reflect a constant periodic rate of return on the Group's net investment in the leases.

**Investment properties**

Investment properties are land and/or buildings held to earn rentals and/or for capital appreciation. An investment property is measured initially at its cost including all direct costs attributable to the property.

After initial recognition, the investment property is stated at its fair value based on valuation by an external independent valuer. Gains or losses arising from changes in fair value of the investment property are recognised in profit or loss for the period in which they arise.

The gain or loss on disposal of an investment property is the difference between the net sales proceeds and the carrying amount of the property, and is recognised in profit or loss.

**本集團作為出租人**

(i) *經營租賃*

經營租賃與資產擁有權相關的所有風險及回報實質上並無轉移至承租人的租賃入賬列為經營租賃。經營租賃之租金收入於相關租賃期內以直線法確認。

(ii) *融資租賃*

與資產擁有權相關的所有風險及回報實質上已轉移至承租人的租賃入賬列為融資租賃。根據融資租賃應收承租人之款項乃按本集團於租賃之淨投資金額確認為應收款項。融資租賃收入可按反映有關本集團就租賃作出之淨投資帶來之持續定期回報率的方式分配至會計期間。

**投資物業**

投資物業是指為賺取租金及／或資本增值而持有的土地及／或樓宇。投資物業以其成本(包括歸屬於該物業的所有直接成本)作初始計量。

經初步確認後，投資物業根據外部獨立估值師進行之估值按其公平值列賬。投資物業公平值變動產生之盈虧在其產生期間於損益內確認。

出售投資物業之盈虧為出售所得款項淨額與該物業賬面值間的差額，並於損益中確認。

#### Intangible asset

##### *Intangible asset acquired separately*

Intangible asset with indefinite useful life that is acquired separately is carried at cost less any subsequent accumulated impairment losses.

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset are measured at the difference between the net disposal proceeds and the carrying amount of the asset and are recognised in profit or loss in the period when the asset is derecognised.

#### Regulatory deposits

Regulatory deposits are stated at cost less subsequent accumulated impairment losses, if any.

#### Investments in subsidiaries

Investments in subsidiaries are stated on the statement of financial position of the Company at cost less accumulated impairment loss.

#### Financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets are derecognised when the contractual rights to receive cash flows from the assets expire; the Group transfers substantially all the risks and rewards of ownership of the assets; or the Group neither transfers nor retains substantially all the risks and rewards of ownership of the assets but has not retained control on the assets. On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received is recognised in profit or loss.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires. The difference between the carrying amount of the financial liability derecognised and the consideration paid is recognised in profit or loss.

#### 法定按金

法定按金乃按成本減其後累計減值虧損 (如有) 列賬。

#### 於附屬公司之投資

於附屬公司之投資於本公司之財務狀況表內按成本值減累計減值虧損列賬。

#### 金融工具

當某一集團實體成為工具合約條文之訂約方時，會於綜合財務狀況表中確認金融資產及金融負債。

於收取資產現金流量之合約權利屆滿、本集團轉讓資產擁有權之絕大部分風險及回報，或本集團既無轉讓亦不保留資產擁有權之絕大部分風險及回報，但不保留資產之控制權時，本集團會終止確認金融資產。終止確認金融資產時，資產賬面值與已收代價總和間之差額於損益確認。

金融負債在相關合約訂明之責任解除、撤銷或屆滿時終止確認。已終止確認之金融負債賬面值與已付代價間之差額於損益確認。

#### Financial assets

Financial assets are recognised and derecognised on a trade date basis where the purchase or sale of an asset is under a contract whose terms require delivery of the asset within the timeframe established by the market concerned, and are initially recognised at fair value, plus directly attributable transaction costs except in the case of investments at fair value through profit or loss. Transaction costs directly attributable to the acquisition of investments at fair value through profit or loss are recognised immediately in profit or loss.

Financial assets of the Group are classified under the following categories:

- Financial assets at amortised cost;
- Financial assets at fair value through other comprehensive income; and
- Financial assets at fair value through profit or loss.

#### (i) Financial assets at amortised cost

Financial assets (including trade and other receivables) are classified under this category if they satisfy both of the following conditions:

- the assets are held within a business model whose objective is to hold assets in order to collect contractual cash flows; and
- the contractual terms of the assets give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

They are subsequently measured at amortised cost using the effective interest method less loss allowance for expected credit losses.

##### (ii) Financial assets at fair value through other comprehensive income

On initial recognition, the Group can make an irrevocable election (on an instrument-by-instrument basis) to designate investments in equity instruments that are not held for trading as at fair value through other comprehensive income.

Financial assets at fair value through other comprehensive income are subsequently measured at fair value with gains and losses arising from changes in fair values recognised in other comprehensive income and accumulated in the investment revaluation reserve. On derecognition of an investment, the cumulative gains or losses previously accumulated in the investment revaluation reserve are not reclassified to profit or loss.

Dividends on these investments are recognised in profit or loss, unless the dividends clearly represent a recovery of part of the cost of the investment.

##### (iii) Financial assets at fair value through profit or loss

Financial assets are classified under this category if they do not meet the conditions to be measured at amortised cost and the conditions of debt investments at fair value through other comprehensive income unless the Group designates an equity investment that is not held for trading as at fair value through other comprehensive income on initial recognition.

Investments at fair value through profit or loss are subsequently measured at fair value with any gains or losses arising from changes in fair values recognised in profit or loss. The fair value gains or losses recognised in profit or loss are net of any interest income and dividend income. Interest income and dividend income are recognised in profit or loss.

#### Loss allowances for expected credit losses

The Group recognises loss allowances for expected credit losses on financial assets at amortised cost and lease receivables. Expected credit losses are the weighted average of credit losses with the respective risks of a default occurring as the weights.

At the end of each reporting period, the Group measures the loss allowance for a financial instrument at an amount equal to the expected credit losses that result from all possible default events over the expected life of that financial instrument (“lifetime expected credit losses”) for trade receivables, or if the credit risk on that financial instrument has increased significantly since initial recognition.

If, at the end of the reporting period, the credit risk on a financial instrument (other than trade receivables) has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to the portion of lifetime expected credit losses that represents the expected credit losses that result from default events on that financial instrument that are possible within 12 months after the reporting period.

The amount of expected credit losses or reversal to adjust the loss allowance at the end of the reporting period to the required amount is recognised in profit or loss as an impairment gain or loss.

#### Cash and cash equivalents

Cash and short-term deposits in the consolidated statement of financial position comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents consist of cash and short-term deposits as defined above.

#### Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

#### Borrowings

Borrowings are initially recognised at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

#### Trade and other payables

Trade and other payables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

#### Share-based payment transactions

At the end of the reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the original estimates during the vesting period, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share options reserve.

When share options are exercised, the amount previously recognised in share options reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share options reserve will be transferred to accumulated losses.

###### *Share options granted to consultants*

Share options issued in exchange for goods or services are measured at the fair values of the goods or services received, unless that fair value cannot be reliably measured, in which case the goods or services received are measured by reference to the fair value of the share options granted. The fair values of the goods or services received are recognised as expenses, with a corresponding increase in equity (share options reserve), when the Group obtains the goods or when the counterparties render services, unless the goods or services qualify for recognition as assets.

##### **Impairment losses on tangible and intangible assets (other than impairment of goodwill set out in accounting policy of goodwill above)**

At the end of the reporting period, the Group reviews the carrying amounts of its tangible and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating unit, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Intangible asset with indefinite useful life is tested for impairment at least annually, and whenever there is an indication that it may be impaired.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or the cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or the cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or the cash-generating unit) in prior years. A reversal of an impairment loss is recognised as income immediately.

#### Fair value measurement

When measuring fair value, except for the Group's share-based payment transactions, leasing transactions, value in use of property, plant and equipment and intangible asset for the purpose of impairment assessment, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

倘若估計資產 (或現金產生單位) 之可收回金額低於其賬面值，則該資產 (或現金產生單位) 之賬面值將調低至其可收回金額。減值虧損即時於損益確認。

倘其後撥回減值虧損，該資產 (或現金產生單位) 之賬面值將增至可收回金額之經修訂估計，惟增加後之賬面值不得超過資產 (或現金產生單位) 倘於過往年度並無確認減值虧損時釐定之賬面值。減值虧損之撥回即時確認為收入。

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs. Specifically, the Group categorised the fair value measurements into three levels, based on the characteristics of inputs, as follow:

- Level 1 – Quoted (unadjusted) market prices in active markets for identical assets or liabilities.
- Level 2 – Valuation technique for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable.
- Level 3 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable.

At the end of the reporting period, the Group determines whether transfer occur between levels of the fair value hierarchy for assets and liabilities which are measured at fair value on recurring basis by reviewing their respective fair value measurement.

#### Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

於報告期末，本集團通過審閱資產及負債各自的公平值計量，釐定按經常性基準以公平值計量的資產及負債的公平值層級之間是否有轉撥。

#### 撥備及或然負債

當本集團因已發生的事件須承擔現有法定或推定責任，而履行責任有可能導致經濟利益流出，並可準確估計責任金額的情況下，須對該等時間或金額不確定之負債確認撥備。倘貨幣時間價值重大，則撥備之金額乃按預期用於解除該責任之支出之現值列賬。

倘需要流出經濟利益的機會不大，或責任金額無法可靠估計，則責任乃披露為或然負債，除非經濟利益流出之可能性極低則另作別論。可能出現之責任，即是否存在將僅取決於日後是否會發生一宗或多宗事件，除非經濟利益流出之可能性極低，否則該等責任亦披露為或然負債。

#### Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

### 4. KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3, the Directors are required to make judgments, estimates and assumptions about the amounts of assets, liabilities, revenue and expenses reported and disclosures made in the consolidated financial statements. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current and future periods.

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Fair value of investment properties

The Group appointed an independent professional valuer to assess the fair values of the investment properties. In determining the fair values, the valuer has utilised a method of valuation which involves certain estimates. The Directors have exercised their judgements and are satisfied that the method of valuation is reflective of the current market conditions.

##### Impairment of trade receivables, finance lease receivables, loans and interest receivables, other loans and interest receivables, promissory note receivable and contract assets.

The policy for impairment of trade receivables, finance lease receivables, loans and interest receivables, other loans and interest receivables, promissory note receivable and contract assets of the Group are based on the evaluation of collectability and aging analysis of accounts and on management's judgment. A considerable amount of judgment is required in assessing the ultimate realisation of these receivables, including the current creditworthiness and the past collection history of each customer. If the financial conditions of customers of the Group were to deteriorate, resulting in an impairment of their ability to make payments, additional allowances may be required. At 31 March 2022, the carrying amounts of trade receivables, finance lease receivables, loans and interest receivables, other loans and interest receivables, promissory note receivable and contract assets were approximately HK\$265,365,000 (2021: HK\$225,524,000), HK\$4,914,000 (2021: HK\$15,947,000), HK\$399,230,000 (2021: HK\$410,898,000), HK\$9,252,000 (2021: HK\$83,102,000), HK\$90,000,000 (2021: HK\$90,000,000) and HK\$370,760,000 (2021: HK\$296,061,000) respectively, and net of allowance for impairment of approximately HK\$2,019,000 (2021: HK\$1,453,000), HK\$46,855,000 (2021: HK\$34,988,000), HK\$66,453,000 (2021: HK\$43,466,000), nil (2021: nil), nil (2021: nil) and nil (2021: nil) respectively.

##### Impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the value in use of the cash-generating units to which goodwill has been allocated. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate the present value. Where the actual future cash flows are less than expected, a material impairment loss may arise. As at 31 March 2022, the carrying amount of goodwill is HK\$273,707,000 (2021: HK\$148,886,000), net of accumulated impairment loss of HK\$66,604,000 (2021: HK\$52,604,000). Details of the recoverable amount calculation are disclosed in note 21.

本集團應收賬款、應收融資租賃款項、應收貸款及利息、其他應收貸款及利息、應收承兌票據以及合約資產之減值政策以可收回性、賬項之賬齡分析及管理層之判斷為基礎來評估。於評估最終變現此等應收款項之可能性時須作出大量判斷，包括每名客戶之現有信用狀況及過往之還款記錄。倘本集團客戶之財務狀況轉差導致其還款能力受到影響，則可能須作出額外撥備。於二零二二年三月三十一日，應收賬款、應收融資租賃款項、應收貸款及利息、其他應收貸款及利息、應收承兌票據以及合約資產之賬面值分別約為265,365,000港元（二零二一年：225,524,000港元）、4,914,000港元（二零二一年：15,947,000港元）、399,230,000港元（二零二一年：410,898,000港元）、9,252,000港元（二零二一年：83,102,000港元）、90,000,000港元（二零二一年：90,000,000港元）及370,760,000港元（二零二一年：296,061,000港元），已分別扣除減值撥備約2,019,000元（二零二一年：1,453,000港元）、46,855,000港元（二零二一年：34,988,000港元）、66,453,000港元（二零二一年：43,466,000港元）、零（二零二一年：零）、零（二零二一年：零）及零（二零二一年：零）。

##### 商譽減值

釐定商譽是否減值需要對獲分配商譽的現金產生單位的使用價值作出估計。計算使用價值需要本集團估計現金產生單位預期將產生的未來現金流量及用於計算現值的適當折現率。倘實際未來現金流量少於預期，則可能產生重大減值虧損。於二零二二年三月三十一日，商譽的賬面值為273,707,000港元（二零二一年：148,886,000港元），其中已扣除累計減值虧損66,604,000港元（二零二一年：52,604,000港元）。可收回金額計算之詳情於附註21披露。

#### Provision for current and deferred taxation

The Group is subject to taxation in various jurisdictions. Significant judgment is required in determining the provision for taxation and the timing of payment of the related taxation. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax in the period in which such determination is made.

At 31 March 2022, the Group has estimated unutilised tax losses of approximately HK\$539,676,000 (2021: HK\$483,804,000) available for offset against future profits. The Directors make estimates on the future profit streams of the Group entities of which tax losses are not utilised. No deferred tax asset has been recognised of the remaining tax losses due to the unpredictability of future profit streams for the year ended 31 March 2022 and period ended 31 March 2021 (note 36).

#### Depreciation and useful lives of property, plant and equipment

Property, plant and equipment are depreciated on a straight-line basis over their estimated useful lives, after taking into account the estimated residual value. The Group assesses annually the residual value and the useful life of the property, plant and equipment with reference to the estimated periods that the Group intends to derive future economic benefits from the use of these assets and if the expectation differs from the carrying amount, such differences from the carrying amount will impact the depreciation charges in the year in which the estimates change. At 31 March 2022, the carrying amount of property, plant and equipment was approximately HK\$286,958,000 (2021: HK\$274,640,000), net of accumulated depreciation and impairment loss of approximately HK\$34,610,000 (2021: HK\$23,213,000).

#### 當期及遞延稅項之撥備

本集團須繳納多個司法權區之稅項。於釐定相關稅項之稅項撥備金額及支付時間時須作出重大判斷。於日常業務過程中有頗多未能確定最終稅項之交易及計算。倘該等事宜之最終稅務結果與初步記錄之金額不同，有關差異將影響作出釐定之期間內之所得稅及遞延稅項。

於二零二二年三月三十一日，本集團有估計未使用稅項虧損約539,676,000港元（二零二一年：483,804,000港元），可用於抵銷未來溢利。董事估計本集團實體之未來溢利流，而稅項虧損並未就此使用。截至二零二二年三月三十一日止年度及截至二零二一年三月三十一日止期間，由於難以預測未來溢利流，並無就剩餘稅項虧損確認遞延稅項資產（附註36）。

#### 物業、廠房及設備折舊及可使用年期

物業、廠房及設備之折舊乃於估計可使用年期內以直線法計算，當中已計及估計剩餘價值。本集團會參考本集團擬透過使用該等資產獲得未來經濟利益之估計期間每年評估物業、廠房及設備之剩餘價值及可使用年期，倘預期之數額有別於賬面值，則與賬面值出現之差額將影響估計有變當年之折舊支出。於二零二二年三月三十一日，物業、廠房及設備之賬面值約為286,958,000港元（二零二一年：274,640,000港元），其中已扣除累計折舊及減值虧損約34,610,000港元（二零二一年：23,213,000港元）。

### 5. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of cash and cash equivalents and equity attributable to owners of the Company, comprising issued share capital and reserves.

The Directors review the capital structure on a regular basis. As part of this review, the Directors consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the Directors, the Group will balance its overall capital structure through new share issues as well as the issue of new debt.

#### Categories of financial instruments

本集團管理其資本以確保本集團實體能夠持續經營，同時透過優化債務及股本結餘為股東創造最大回報。本集團整體策略較去年維持不變。

本集團資本架構包括現金及現金等值項目以及本公司擁有人應佔權益（包括已發行股本及儲備）。

The Group's major financial instruments include regulatory deposits, trade and other receivables, finance lease receivables, loans and interest receivables, other loans and interest receivables, promissory note receivable, financial assets at fair value through profit or loss, financial assets at fair value through other comprehensive income, amounts due from a joint venture, bank balances and cash, trade and other payables, trust loans, short term loans, bank loans, amount due to a joint venture and amount due to an associate. Details of the financial instruments are disclosed in respective notes. The risks associated with these financial instruments include market risk (currency risk, interest rate risk and other price risk), credit risk and liquidity risk. The policies on how to mitigate these risks are set out below. The management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

#### Market risk

##### (i) Currency risk

Other than the subsidiaries established in the PRC, Singapore and the United States of America of which functional currency is Renminbi ("RMB"), Singapore dollars ("SGD") and United States dollars ("USD") respectively, the functional currency of the Company and other subsidiaries is HK\$. Certain bank balances and cash are denominated in currencies other than the functional currencies of the group entities to which they relate. Foreign currencies are also used to settle expenses for overseas operations, which expose the Group to foreign currency risk.

The Group currently does not have a foreign currency hedging policy but the management monitors foreign exchange exposure and will consider hedging significant foreign currency exposure should the need arise.

No sensitivity analysis was prepared for USD as HK\$ is pegged to USD.

##### *Sensitivity analysis*

The Group is currently exposed to RMB and GBP foreign currency risk.

The following table details the Group's sensitivity to a 10% (2021: 10%) increase and decrease in functional currencies of the relevant group entities, HK\$ or RMB, against the relevant foreign currencies. 10% (2021: 10%) is the sensitivity rate used when reporting foreign currency risk internally to key management personnel and represents management's assessment of the reasonably possible change in foreign exchange rates. The sensitivity analysis includes only outstanding foreign currency denominated monetary items and adjusts their translation at the end of the reporting period for a 10% (2021: 10%) change in foreign currency rates.

A negative number below indicates an increase in loss (2021: increase in loss) for the period where the respective functional currency (HK\$ or RMB) strengthens 10% (2021: 10%) against the relevant foreign currency (RMB, GBP, or HK\$). For a 10% (2021: 10%) weakening of respective functional currency (HK\$ or RMB) against the relevant foreign currency (RMB, GBP or HK\$), there would be an equal and opposite impact on the loss (2021: loss) for the year and the balances below would be positive.

The Directors consider that the interest rate risk in relation to variable rate bank balances is insignificant due to these balances are either within short maturity period or the outstanding balances are not significant.

##### (iii) Other price risk

As at 31 March 2022, the Group is exposed to other price risk through its investment in unlisted equity securities. The Group has appointed a special team to monitor the price risk and will consider hedging the risk exposure should the need arise.

##### Sensitivity analysis

The sensitivity analysis below have been determined based on the exposure to other price risk at the end of the reporting period.

If the value of the financial assets at fair value through other comprehensive income had been 20% (2021: 20%) higher/lower, the investment revaluation reserve for the year ended 31 March 2022 would increase/decrease by approximately HK\$1,728,000 (fifteen months ended 31 March 2021: HK\$1,728,000) as a result of the changes in fair value of these investments.

In management's opinion, the sensitivity analysis is not representative of the other price risk for the investments in listed equity securities as the year end exposure does not reflect the exposure during the year.

#### Credit risk

As at 31 March 2022 and 2021, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to a failure to discharge an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

In respect of finance lease receivables, representing loan advances to customers with pledged assets, individual credit evaluations are performed on all customers. These evaluations focus on the customer's financial background, current ability to pay and the financial status of the guarantor, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. At 31 March 2022 and 2021, the finance lease receivables are secured with the leased assets. All the finance lease receivables are aroused in the PRC.

In respect of loans and interest receivables, representing financing advances to customers under the Group's money lending business, individual credit evaluations are performed on all customers. These evaluations focus on the customer's financial background and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer. The default risk of the industry in which customers operate also has an influence on credit risk but to a lesser extent. The Directors consider the credit risk under control since the management exercise due care in granting credit and check the financial background of these customers on a regular basis.

For loan and interest receivables, the Group has a high concentration of credit risk on loans and interest receivables as 13% (2021: 13%) and 58% (2021: 55%) of the total loans and interest receivables was due from the single largest customer and the five largest customers in the money lending segment respectively.

就應收融資租賃款項（指墊付予有抵押資產客戶之貸款）而言，須對所有客戶進行個別信貸評估。該等評估專注於客戶之財務背景、現時支付能力及擔保人之財務狀況，並計及客戶之特別資料及其營運之經濟環境。於二零二二年及二零二一年三月三十一日，應收融資租賃款項由租賃資產抵押。所有應收融資租賃款項均產生於中國。

就應收貸款及利息（指墊付予本集團借貸業務客戶之資金）而言，須對所有客戶進行個別信貸評估。該等評估專注於客戶之財務背景及現時支付能力，並計及客戶之特別資料及其營運之經濟環境。

本集團的信貸風險主要受各客戶的個別情況影響。客戶經營所在行業的違約風險對信貸風險亦有影響，但程度相對較小。由於管理層已適當審慎地批授信貸並定期查核有關客戶之財務背景，故董事認為信貸風險已受到控制。

就應收貸款及利息而言，本集團應收貸款及利息之信貸風險高度集中於借貸分部的單一最大客戶及五大客戶，分別佔應收貸款及利息總額13%（二零二一年：13%）及58%（二零二一年：55%）。

For finance lease receivables, the Group has a high concentration of credit risk on finance lease receivables as 100% (2021: 70%) and 100% (2021: 100%) of the total finance lease receivables was due from the single largest customer and the five largest customers in the finance leasing segment respectively.

The credit risk on liquid funds is limited because the counterparties are banks with high credit ratings assigned by international credit-rating agencies. The Group's concentration of credit risk by geographical locations are mainly in the PRC, which accounted for 99% (2021: 99%) of the total trade receivables as at 31 March 2022. The Group has concentration of credit risk as 38% (2021: 40%) and 88% (2021: 97%) of the total trade receivables were due from the Group's largest customer and the five largest customers respectively.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual debtor at the end of the reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the Directors consider that the Group's credit risk is significantly reduced.

The Group considers whether there has been a significant increase in credit risk of financial assets on an ongoing basis throughout each reporting period by comparing the risk of a default occurring as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportive forwarding-looking information. Especially the following information is used:

- actual or expected significant adverse changes in business, financial or economic conditions that are expected to cause a significant change to the borrower's ability to meet its obligations;
- actual or expected significant changes in the operating results of the borrower;

就應收融資租賃款項而言，本集團應收融資租賃之信貸風險高度集中於融資租賃分部的單一最大客戶及五大客戶，分別佔應收融資租賃總額之100% (二零二一年：70%) 及100% (二零二一年：100%)。

由於對手方為具有由國際信貸評級機構給予高信貸評級之銀行，故流動資金之信貸風險有限。於二零二二年三月三十一日，本集團之信貸風險在地理位置上主要集中於中國，佔應收賬款總額之99% (二零二一年：99%)。本集團之信貸風險亦集中於其最大客戶及五大客戶，分別佔應收賬款總額之38% (二零二一年：40%) 及88% (二零二一年：97%)。

為減低信貸風險，本集團之管理層已委派一小組，負責釐定信貸限額、信貸批核及進行其他監察程序，以確保已採取跟進措施，收回逾期債項。此外，本集團審閱各個別債務人於報告期末之可收回金額，以確保已就不能收回金額提撥充足減值虧損。就此而言，董事認為本集團之信貸風險已大幅減低。

A significant increase in credit risk is presumed if a debtor is more than 30 days past due in making a contractual payment, unless the Group has supportable information which can demonstrate otherwise. A default on a financial asset occurs when a debtor fails to make contractual payments within 90 days when they fall due and this debtor is unlikely to repay the amount due.

Financial assets are written off when there is no reasonable expectation of recovery, such as a debtor failing to engage in a repayment plan with the Group. The Group normally categorises a receivable for write off when the Group determine that the debtor does not have assets or source of income that could generate sufficient cash flow to repay the amounts subject to write-off. Where receivables have been written off, the Group, if practicable and economical, continues to engage in enforcement activity to attempt to recover the receivable due.

The Group uses two categories for loans and interest receivables, finance lease receivables, promissory note receivable, other loans and interest receivables and amounts due from a joint venture which reflect their credit risk and how the loss provision is determined for each of the categories. In calculating the expected credit loss rates, the Group considers historical loss rates for each category and adjusts for forward looking data.

#### Liquidity risk

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of its bank balances and cash and considers the risk is minimal.

The maturity dates of all financial liabilities are repayable on demand or within one year as at the end of each of the reporting periods.

The Directors consider that the carrying amounts of financial assets and financial liabilities recorded at amortised cost in the consolidated financial statements approximate their fair values due to short-term or immediate maturities.

#### Trading of goods

Revenue from the trading of goods is recognised when the goods are delivered and titles have passed, at which time all the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Sales to customers are normally made with credit terms of 90 days.

#### Finance leasing

Consultancy income from finance leasing is recognised in the accounting period in which the services are rendered. The customers pay the consultancy service fee to the Group according to the payment schedules as stipulated in the contracts.

#### Securities and futures brokerage

Commission income on dealing in securities and futures contract is recognised on a trade date basis when the services are rendered, the amount for which can be reliably estimated and it is probable that the income will be received. The commission income is due on the settlement date of their respective trade dates, normally two or three business days after the respective trade date.

Consultancy income from securities and future brokerage related services is recognised in the accounting period in which the services are rendered. The customers pay the consultancy service fee to the Group according to the payment schedules as stipulated in the contracts.

#### International air and sea freight forwarding

Income from provision of freight forwarding services is recognised when the services are provided. The Group normally allow credit period of 90 days.

#### Property brokerage

Commission income on dealing in property agency contract is recognised when the services are rendered, the amount for which can be reliably estimated and it is probable that the income will be received. The customers pay the commission income to the Group upon the sales of property is completed.

#### Heating and cooling supply by geothermal energy

Income from heating and cooling supply by geothermal energy is recognised when the services are rendered. The customers pay the fee according to the heating and cooling supply actually consumed.

#### Building construction contracting

The Group provides construction contracting services to the customers. When the progress towards complete satisfaction of the performance obligations of a construction contract can be measured reasonably, revenue from the contract and the contract costs are recognised using the percentage of completion method, measured by reference to the percentage of contract costs incurred to date to the estimated total contract costs for the contract. This method provides the most reliable estimate of the percentage of completion.

When the progress towards complete satisfaction of the performance obligations of a construction contract cannot be measured reasonably, revenue is recognised only to the extent of contract costs incurred that is expected to be recoverable.

The customers pay the contract prices to the Group according to the payment schedules as stipulated in the contracts. If the service rendered by the Group exceeds the payments, a contract asset is recognised. If the payments exceed the service rendered, a contract liability is recognised.

#### Customised technical support

The Group provides customised technical support services which include building architecture and interior design services and data analytical services to the customer. Building architecture and interior design services income and data analytical services income are recognised when the services are rendered, the amount for which can be reliably estimated and they are probable that the income will be received. The customers pay the services income to the Group according to the payment schedules as stipulated in the contracts.

Revenue from the Group's property development and project management business derived from entrusted construction agreements and management services. Project management service income is recognised when the services are rendered, the amount for which can be reliably estimated and it is probable that the income will be received. The customers pay the service income to the Group according to the payment schedules as stipulated in the contracts.

#### Centralised heating

Heating supply and industrial steam income is recognised when the services are rendered. The customers pay the fee according to the heating and industrial steam actually consumed.

### 11. SEGMENT INFORMATION

Information reported to the Directors, being the chief operating decision maker, for the purpose of resource allocation and assessment of segment performance focuses on the type of goods sold or services delivered or provided. The Directors have chosen to organise the Group around difference in products and services. No operating segments identified by the chief operating decision maker have been aggregated in arriving at the reportable segments of the Group.

Specifically, the Group's reportable segments are as follows:

- (a) Trading of goods segment engages in trading of products including but not limited to electronic appliance in the PRC;
- (b) Finance leasing segment engages in finance leasing of plant and machinery as well as providing consultancy services with respect of finance leasing in the PRC;
- (c) Money lending segment engages in money lending in Hong Kong;
- (d) Securities and futures brokerage segment engages in securities and futures dealing services as well as providing consultancy services with respect of securities and futures brokerage in Hong Kong;

The recoverable amounts of the CGUs have been determined based on the value-in-use calculation with reference to a valuation performed by independent professional qualified valuers not connected to the Group. That calculation uses cash flow projections based on financial budgets approved by management of the Group covering a 10-year period for geothermal energy business and a 5-year period for other businesses. Cash flows beyond 5-year or 10-year period are projected using 2% growth rate. Other key assumptions for the value-in-use calculations relate to the estimation of cash inflows/outflows which include budgeted revenue, such estimations are based on the CGU's past performance and management's expectations for the market development.

Due to unsatisfactory market sentiment and keen competition, in particular uncertainties in the financial market, the carrying amount of the CGU of regulated financial services business exceed its recoverable amount. As a result, an impairment of HK\$14,000,000 for the goodwill was recognised in profit or loss for the year ended 31 March 2022 (fifteen months ended 31 March 2021: HK\$13,000,000).

No impairment for the goodwill of other businesses was recognised in profit or loss for the year ended 31 March 2022 (fifteen months ended 31 March 2021: approximately HK\$10,622,000 was recognised for geothermal energy business).

The discount rates used are pre-tax and reflect specific risks relating to the relevant CGU and are summarized as follows:

As at 31 March 2022 and 2021, finance lease receivables are secured over the motor vehicles and plant and machinery leased and for certain corporate lessees, equity interest of the lessees are required as additional security.

Before accepting any finance lease arrangement, the Group assesses the financial strength of the lessee and considers the credit limit granted to the lessee. In addition, the Group may request for the guarantor with strong financial status where necessary.

As at 31 March 2022, finance lease receivables before allowance for impairment of approximately RMB41,928,000, equivalent to approximately HK\$51,769,000 (2021: approximately RMB39,448,000, equivalent to approximately HK\$46,805,000) was past due. Included in the carrying amount of the above finance lease receivables as at 31 March 2022 are three individually impaired receivables of approximately RMB37,948,000, equivalent to approximately HK\$46,855,000 (2021: approximately RMB29,489,000, equivalent to approximately HK\$34,988,000) which impairment was made due to customers' default in payment. The Group has either taken legal actions or assessed the latest operating and financial position by site visit against these customers and considered the legal opinion from independent legal advisers during impairment assessment. For the remaining past due amount of approximately RMB3,980,000, equivalent to approximately HK\$4,914,000 (2021: approximately RMB9,959,000, equivalent to approximately HK\$11,817,000), the Group is still negotiating practicable repayment terms and schedules subsequent to the end of the reporting period. Accordingly, the Directors considered no further impairment loss needs to be recognised.

Management closely monitors the credit quality of finance lease receivables. As at 31 March 2022, the age of the finance lease receivables was over three years (2021: over three years) based on the effective dates of the relevant lease contracts.

As at 31 March 2022, secured loans before allowance for impairment of HK\$40,000,000 (2021: HK\$40,000,000) were secured by assets charges provided by borrowers. The Group does not hold any collateral over the unsecured loans. The remaining loans amount before allowance for impairment of approximately HK\$365,249,000 (2021: approximately HK\$372,215,000) represents unsecured loans certain of which are accompanied by personal or corporate guarantee. The loans advanced to the borrowers under the Group's money lending business normally had loan periods from 6 to 54 months (2021: 6 to 54 months). The loans provided to borrowers bore interest rate ranging from 8%–15% per annum (2021: 8%–15% per annum), depending on the individual credit evaluations of the borrowers. These evaluations focus on the borrowers' financial background, individual credit rating, current ability to pay, and take into account information specific to the borrowers as well as the guarantees and/or security from the borrowers (where necessary). The loans provided to borrowers are repayable in accordance with the loan agreements, in which the principal amounts are repayable on maturity and the interests are repayable half-yearly, yearly or on maturity.

The following is an aged analysis of loans and interest receivables (net of allowance for impairment), presented based on the dates which loans are granted to borrowers and interests are accrued.

As at 31 March 2022, loans and interest receivables before allowance for impairment of approximately HK\$420,558,000 (2021: approximately HK\$322,986,000) were past due. Included in the carrying amount of the above loans and interest receivables as at 31 March 2022 is four individually impaired receivables of approximately HK\$66,453,000 (2021: HK\$43,466,000) which impairment was made due to borrower's default in payment. Subsequent to the end of the reporting period, approximately HK\$8,898,000 were settled. The remaining past due amount of approximately HK\$345,207,000 are due from several borrowers with whom the Group is negotiating practicable repayment terms and schedules. The Directors assessed their creditworthiness and financial position. The Group's neither past due nor impaired loan receivables mainly represented loans granted to creditworthy customers for whom there was no recent history of default. Accordingly, the Directors considered that no further impairment loss is necessary. Saved for the aforesaid secured loans, the Group does not hold collateral over other balances.

- (i) On 1 March 2019, Rongjinda Finance Lease Company Limited\* (“Rongjinda Finance”), a wholly-owned subsidiary of the Company, entered into a debt settlement agreement with Heyuan City Dongjiangyuan Hot Spring Resort Limited\* (河源市東江源溫泉度假村有限公司) (“Heyuan Dongjiangyuan”) and Beijing Kaiyitong Enterprise Management Limited Company\* (北京凱意通企業管理有限公司) (“Beijing Kaiyitong”) pursuant to which the parties agreed that Heyuan Dongjiangyuan shall repay the outstanding principal lease cost, interest and service fees of approximately RMB6,979,000 in total while the remain outstanding balance of approximately RMB76,764,000 is assumed by Beijing Kaiyitong. The Group's trade payables arising from securities and futures brokerage business include margin clients and cash clients with carrying amounts of approximately HK\$4,062,000 and HK\$20,000 respectively (2021: approximately HK\$4,234,000 and HK\$35,000 respectively).

For trade payables arising from the securities and futures brokerage business, no aging analysis is disclosed for the Group's margin and cash clients as these clients were carried on an open account basis, the aging analysis does not give additional value in the view of the nature of business of securities brokerage.

For trade payables arising from property brokerage business, no aging analysis is disclosed as the Group is yet to receive invoices at the end of the reporting period. The payables is accrued based on the monthly statements agreed with the respective agents. According to the relevant agency contracts, the invoices will be billed in the following month and the settlement terms is within 3 business days from the invoices date.

The average credit period on international air and sea freight forwarding services is normally ranging from 30 days to 90 days (2021: 30 days to 90 days). For trade payables arising from geothermal energy business, centralised heating business and building construction contracting business, they are mainly accrued and settled based on the progress of performance and the settlement obligation as stipulated in the respective contracts. The Group has financial risk management policies in place to ensure that all payables are settled within the credit timeframe.

### 37. TRUST LOANS

On 19 February 2020, the Group entered into the trust loan agreements with an independent third party to obtain loans with principal amounts of RMB200,000,000 in aggregate which carry a fixed interest rate of 12% per annum and is repayable by March 2022. Subsequent to the end of the reporting period, the Group entered into the supplemental agreements to extend the loan repayment date of the trust loans to March 2023. The Group received loan proceeds of RMB198,000,000 in March 2020, net of 1% of loan principal amounts (i.e. RMB2,000,000) which is required by the relevant rules and regulations to be invested in the trust protection fund in the PRC. The loan proceeds were intended to be used for the acquisition of the entire equity interest in Beijing Yuehai and enhancing the general working capital. Pursuant to the trust loan agreements (as amended and supplemented), the trust loans are secured by pledging of (i) 100% shareholding of Jiangsu Meili Kongjian Construction Design Development Co., Ltd\* (江蘇美麗空間建築設計產業發展有限公司) (“Jiangsu Meili Kongjian”) and 70% shareholding of Baoshihua Geothermal Energy Development Co., Ltd.\* (寶石花地熱能開發有限公司) (“Baoshihua Geothermal Energy”), and (ii) the land use right held by Jiangsu Meili Kongjian and any constructions thereon; and are guaranteed by Jiangsu Meili Kongjian.

All the secured short term loans are repayable within one year.
- (ii) The Group entered into unsecured short term loan agreements with independent third parties to obtain loans with principal amounts of RMB5,300,000 (approximately HK\$6,544,000) in aggregate, for which loan amounts of RMB2,300,000 (approximately HK\$2,840,000) is interest-free and repayable on demand, while loan amounts of RMB3,000,000 (approximately HK\$3,704,000) is carried a fixed interest rate of 6% per annum and repayable in June 2022 (2021: RMB17,000,000 (approximately HK\$20,170,000) which carry a fixed interest rate of 16.8% per annum and repayable within one year).

The 2021 Scheme does not contain any requirement of a minimum period and the Board may in its absolute discretion impose a minimum period requirement for each option granted on a case by case basis.

The 2012 Scheme was terminated after passing the resolution by the shareholders on 1 September 2021. As at 31 March 2022 and 2021, the carrying amount of the promissory note receivable with principal amount of HK\$90,000,000, formed part of the Group’s consideration receivables in relation to the disposal of East Favor Global Investment Limited (“East Favor”) to Honghu Group Limited in 2017.

The promissory note is secured by 9,608 shares of East Favor, representing 49% of the equity interests of East Favor at the issuance date. The promissory note bears interest at a rate of 6% per annum and the sole shareholder of Honghu Group Limited, Mr. Deng Junjie (“the Guarantor”), has provided guarantee in favour of the Group for the payment of all sums payable under the promissory note. On 20 March 2018, 20 March 2019, 20 March 2020 and 18 June 2021, the Group and Honghu Group Limited entered into a first supplementary deed, second supplemental deed, third supplemental deed and fourth supplemental deed to extend the repayment date of the promissory note to 20 March 2019, 20 March 2020, 20 March 2021 and 20 March 2022 respectively with other terms remaining unchanged.

Subsequent to the end of the reporting period, in April 2022, the principal amount of HK\$16,000,000 and interest amount of HK\$5,400,000 were settled. On 27 May 2022, the Group and Honghu Group Limited entered into a fifth supplemental deed pursuant to which (i) the repayment date of the promissory note of HK\$74,000,000 was further extended to 20 March 2023; (ii) the Group agreed to waive default interests resulting from the default on payment by Honghu Group Limited on 20 March 2022; and (iii) other terms shall remain unchanged.

### 43. RETIREMENT BENEFIT SCHEMES

The Group enrolled all Hong Kong employees in the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group, in funds under the control of trustees. The Group contributes 5% of relevant payroll costs, capped at HK\$1,500 (31 March 2021: HK\$1,500) per month, to the MPF Scheme, in which the contribution is matched by employees.

The Group's subsidiaries operating in the PRC and Singapore participate in defined contribution retirement schemes and CPF Scheme organised by the relevant local government authorities in the PRC and Singapore respectively. These subsidiaries are required to contribute a specified percentage of its payroll costs to the retirement benefit schemes to fund the benefits. The only obligation of the Group with respect to the retirement benefit schemes is to make the specified contributions under these schemes.

The total cost charged to consolidated statement of profit or loss and other comprehensive income of approximately HK\$11,504,000 (fifteen months ended 31 March 2021: HK\$9,285,000) represents contributions payable to these schemes by the Group in respect of the current accounting period.

#### Step acquisition from associates to subsidiaries

On 10 August 2021, China Best Financial Holdings Limited ("China Best Financial"), a wholly owned subsidiary of the Company, entered into share transfer agreement with Giant Win Holdings Limited ("Giant Win", as the vendor) and Mr. He Zhenyu (as the guarantor), both are independent third parties, pursuant to which China Best Financial conditionally agreed to acquire, and Giant Win conditionally agreed to sell, the 42% equity interest in Treasure Cart at a consideration of HK\$90,000,000. The major subsidiaries of Treasure Cart are principally engaged in the provision of financial information, solutions and data analytical services to customers in finance and property related field in the PRC. Prior to the acquisition, the Group already held 25% equity interest in Treasure Cart, which was accounted for by equity accounting. After the completion of the acquisition on 12 August 2021, the Group held 67% equity interest in Treasure Cart and Treasure Cart Group has become non-wholly owned subsidiaries of the Company since then.

### 50. EVENT AFTER THE REPORTING PERIOD

- (i) On 28 April 2022, the Company has resolved to grant share options to certain eligible participants to subscribe for a total of 90,000,000 ordinary shares of HK\$0.10 each in the share capital of the Company, pursuant to the share option scheme adopted by the Company on 1 September 2021. The exercise price is HK\$0.80 per ordinary share.
- (ii) On 27 May 2022, the Group entered into a fifth supplemental deed in relation to the promissory note of remaining principal amount of HK\$74 million held by the Group after the principal amount of HK\$16 million and the interest amount of HK\$5.4 million of the promissory note had been settled in aggregate on 11 April 2022, 13 April 2022 and 26 April 2022 respectively, whereby (i) the parties agreed to further extend the maturity date of the promissory note by one (1) year, from 20 March 2022 to 20 March 2023; and (ii) the Group agreed to waive default interests which were resulted from the issuer's default payment on 20 March 2022.
