

**VOLUNTARY ANNOUNCEMENT  
INCREASE IN SHAREHOLDING BY DR. DENNIS LAM**

This announcement is made by C-MER Eye Care Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis in relation to the increase in the shareholding in the Company held by Dr. LAM Shun Chiu Dennis (“**Dr. Lam**”), the Company’s Chairman, chief executive officer and executive Director.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company was informed by Dr. Lam that, in addition to his purchase of 300,000 shares of the Company (the “**Shares**”) on 26 September 2022 (as announced in the announcement dated 26 September 2022), from 27 September 2022 to 30 September 2022, he has further purchased a total of 1,150,000 Shares on market for an aggregate consideration of HK\$4,005,840, representing an average price of approximately HK\$3.48 per Share (the “**27/9 – 30/9 Purchase**”) and approximately 0.093% of the issued share capital of the Company, with details as follows.

Immediately before the 27/9 – 30/9 Purchase, Dr. Lam together with C-MER Group Limited (the controlling shareholder of the Company that is owned as to 70% by Dr. Lam and 30% by Ms LI Xiaoting, his spouse and an executive Director of the Company) hold approximately 55.17% of the issued share capital of Company. After the 27/9 – 30/9 Purchase, Dr. Lam together with C-MER Group Limited now hold approximately 55.27% of the Company.

Dr. Lam has informed the Company that he is confident about the future prospects of the Group and its business, and his decision for making the Purchase also took into account the recent prices of the Shares.

Based on information available to the Company and to the best knowledge of the Board, the Company's public float continues to comply with the requirements under The Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited after the Purchase.
