### **Profit Warning**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “Board”) of Lee Kee Holdings Limited (the “Company”, and together with its subsidiaries, the “Group”) wishes to inform the shareholders of the Company and investors that based on the preliminary assessment of the Group’s latest unaudited management accounts, the Group is expected to record a loss attributed to equity holders of the Company for the year ended 31st March 2023 (the “Financial Year”) in the range between HK\$38.5 million and HK\$57.7 million, compared to the profit of approximately HK\$18.7 million for the year ended 31st March 2022, which was mainly attributable to a drop in metal prices, particularly zinc, which lowered the overall gross profit of the sale transactions made during the Financial Year. The unfavourable global (including PRC) macro-economic environment also adversely impacted the Group’s performance during the Financial Year. The Group recorded an approximate 17.4% decrease in tonnage sold during the Financial Year, as compared to the same period in 2022.

The information contained in this announcement is only based on the preliminary assessment made by the Company and has not been reviewed or audited by the auditors of the Company. Further details of the results of the Group for the Financial Year (the “Annual Results”) will be provided in the Company’s Annual Results announcement.
