MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

BUSINESS REVIEW

The shares of the Company (the “Shares”) were listed on GEM of the Stock Exchange (the “Listing”) on 13 December 2018 (the “Listing Date”) by way of share offer of 100,000,000 new shares (“Share Offer”) offered by the Company at HK\$0.5 per share and on 6 September 2022 by way of placing of 14,472,000 new Shares to not less than six independent places at the placing price of HK\$0.180 per share (the “Placing”).

Biological Reagents and Auxiliary Reproductive Supplies and Equipment Segment

Our Group specialises in the research and development, manufacturing and sales of a wide range of In-Vitro Diagnostic (“IVD”) reagents in the PRC, particularly focusing on the PRC male fertility IVD reagent market. As at the date of this Report, the Group’s product portfolio offers 30 biological reagents, including 27 male fertility IVD reagents, 2 parasite antibody detection reagents and 1 Epstein-Barr virus antibody detection reagent.

For the three months ended 31 March 2023 (the “Reporting Period”), the IVD reagents business operated by the Company’s principal subsidiary in the PRC experienced an increase of approximately Renminbi (“RMB”) 721,000, or 14.4% in revenue from the sales of biological reagents and auxiliary reproductive supplies and equipment.

業務回顧

本公司股份(「股份」)於二零一八年十二月十三日(「上市日期」)於聯交所GEM上市(「上市」)，本公司按每股0.5港元提呈發售100,000,000股新股份(「股份發售」)及於二零二二年九月六日按配售價每股0.180港元配售14,472,000股新股份給不少於六名獨立承配人(「配售」)。

生物製劑及輔助生育用品和設備分部

本集團專注於在中國研發、生產及銷售各種體外診斷(「體外診斷」)試劑，尤其專注於中國男性不育體外診斷試劑市場。於本報告日，本集團產品組合有30種生物製劑，包括27種男性不育體外診斷試劑，2種寄生蟲系列檢測試劑和1種EB病毒檢測試劑。

於截至二零二三年三月三十一日止三個月(「報告期間」)，體外診斷試劑業務由本公司之主要中國附屬公司營運，其銷售生物製劑及輔助生育用品和設備的收益增加約人民幣(「人民幣」)721,000元，增幅達14.4%。



Healthcare Products and Supplements Segment

Our Group has diversified its business to healthcare products and supplements in the PRC, Hong Kong and Canada. As at the date of this Report, our Group has a total of 24 natural health product licences granted by the Natural Health Product Directorate of Health Canada under our registered brand “Nutronic” and our Group has already launched 12 products in the market.

During the Reporting Period, our major customer of the healthcare products and supplements segment, Smartronic Limited (“Smartronic”) have not place new order. Thus, the sales for this segment dropped significantly to contribute less than 1% of the Group’s total revenue, as compared to approximately 15.4% in the Corresponding Period.

FUTURE PROSPECTS

Despite the difficulties arising from the Epidemic, our Group are still continuous the research and testing on rapid Point-Of-Care diagnostic testing (“POCT”) under immunoassay techniques, and polymerase chain reaction testing (“PCR testing”) on male urinary tract infection, and the Group intends to apply for medical devices registration after satisfactory results.

For healthcare products and supplements segment, our Group will continue to seek for partners and distributors who have sufficient sales channel and financial resources to promote the brand of “Nutronic” and distribute our products in a more efficient and cost effective way.

To bring additional sources of income, our Group entered into investment project of anoectochillus formosanus extractive (“AFE”). Ultimately, we would like to commercialization of certain AFE products of the healthcare market.

健康產品及保健品分部

本集團將其業務多元化至銷售健康產品及保健品產品到中國、香港及加拿大。於本報告日，本集團註冊品牌「Nutronic」已獲得合共24份加拿大衛生部天然健康產品管理委員會授予的天然保健產品牌照及本集團已有12種產品推出市場。

於報告期間，我們於健康產品及保健品分部的主要客戶，智能創力有限公司（「智能創力」）沒有下新訂單。因此，在該分部的銷售額大幅下降至佔本集團總收入少於1%，相對去年同期約15.4%。

未來前景

儘管疫情帶來諸多困難，我們集團仍在研發及測試基於免疫測定技術的快速即時檢驗（「即時檢驗」），及針對男性尿路感染的聚合酶鏈式反應檢查（「鏈式反應檢查」）。本集團擬於取得滿意結果後申請醫療器械註冊。

就健康產品及保健品分部，我們集團將會繼續尋找擁有足夠銷售渠道及財力資源的合作夥伴及分銷商推廣「Nutronic」品牌及以更有效及高成本效益的方法分銷我們的產品。

為帶來額外的收入來源。本集團進入了金線蓮提取物（「金線蓮提取物」）的投資項目。最終，我們希望商業化在保健市場的若干金線蓮提取物產品。

FINANCIAL REVIEW

Revenue

The Group's revenue slightly decreased by approximately Renminbi ("RMB") 139,000, or approximately 2.4%, from approximately RMB5.9 million for the Corresponding Period to approximately RMB5.8 million for the Reporting Period. The decrease in revenue was mainly due to a decrease in the sales of healthcare products and supplements by our Group during the Reporting Period.

Sales of male fertility IVD reagents products remained to be our major products which accounted for approximately 82.1% of our total revenue generated from our sales of biological reagents and auxiliary reproductive supplies and equipment segment for the Reporting Period. Revenue from sales of male fertility IVD reagents products during the Reporting Period was approximately RMB4.7 million, which represented an increase of approximately RMB519,000 or approximately 12.4% from approximately RMB4.2 million during the Corresponding Period.

Sales of healthcare products and supplements generated revenue of approximately RMB49,000 during the Reporting Period, which represented a decrease of approximately RMB860,000 or approximately 94.6% from approximately RMB909,000 for the Corresponding Period.

財務回顧

收益

於報告期間，本集團錄得的收益較去年同期的約人民幣（「人民幣」）5.9百萬元輕微減少約人民幣139,000元或約2.4%至約人民幣5.8百萬元。收入減少主要來自於報告期間本集團健康產品及保健品的銷售減少。

男性不育體外診斷試劑產品仍為我們的主要產品，其於報告期間之銷售額佔本集團生物製劑及輔助生育用品和設備分部總銷售額約82.1%。男性不育體外診斷試劑產品於報告期間之收益約為人民幣4.7百萬元，較去年同期的約人民幣4.2百萬元增加約人民幣519,000元或約12.4%。

銷售健康產品及保健品於報告期間產生之收益約為人民幣49,000元，較去年同期的約人民幣909,000元減少約人民幣860,000元或約94.6%。



Gross Profit and Gross Profit Margin

The Group recorded a gross profit of approximately RMB3.9 million during the Reporting Period, representing an increase of approximately RMB36,000, or approximately 0.9%, from approximately RMB3.8 million during the Corresponding Period.

The Group's gross profit margin increased from approximately 65.1% during the Corresponding Period to approximately 67.3% during the Reporting Period. Such increase was mainly attributable to the improvement in profit margin of the sales of the biological reagents and auxiliary reproductive supplies and equipment.

Other Income and Other Gains and Losses

Other income significantly decreased by approximately RMB82,000 or approximately 45.6%, from approximately RMB180,000 during the Corresponding Period to approximately RMB98,000 during the Reporting Period, primarily because the Group received grants for high-tech Enterprise cultivation from the PRC Government authorities in Corresponding Period, whereas there was no such subsidies during the Reporting Period.

We recorded other losses of approximately RMB2,000 during the Reporting Period, representing a decrease of approximately RMB1,000, or approximately 33.3%, from approximately RMB3,000 during the Corresponding Period. Such decrease was mainly attributable to the fluctuations in foreign exchange rate between foreign currency and RMB, the majority of which was unrealised foreign exchange difference.

Impairment Losses

The Group did not have impairment losses on trade receivables (net of reversal) during the Reporting Period, as compared to approximately RMB2,000 during the Corresponding Period.

毛利及毛利率

本集團報告期間錄得毛利約人民幣3.9萬元，較去年同期之約人民幣3.8百萬元增加約人民幣36,000元或約0.9%。

本集團的毛利率由去年同期約65.1%增加至報告期間約67.3%。該增加主要由於銷售生物製劑及輔助生育用品和設備之毛利率有所改善。

其他收入及其他收益及虧損

其他收入由去年同期約人民幣180,000元大幅減少約人民幣82,000元或約45.6%至報告期間約人民幣98,000元，此乃主要由於去年同期本集團收到中國政府機構有關高新技術企業培育補助，相對報告期間並無有關補貼。

我們於本報告期間錄得其他虧損約人民幣2,000元，較去年同期之約人民幣3,000元減少約人民幣1,000元或約33.3%。有關減少主要由於外幣與人民幣的匯率波動，其中大部分為未變現匯兌差異。

減值虧損

本集團於報告期間並無貿易應收款項減值虧損(扣除撥回)，比較去年同期約人民幣2,000元。

Expenses

Selling and distribution expenses decreased by approximately RMB297,000 or approximately 13.7%, from approximately RMB2.2 million during the Corresponding Period to approximately RMB1.9 million during the Reporting Period. The decrease was primarily attributable to a decrease in the cost of sales and marketing activities after the lifting of majority of the epidemic prevention and containment measures.

Administrative expenses remained relatively stable during the Reporting Period and Corresponding Period in amount of approximately RMB1.8 million.

Research and development expenses increased from approximately RMB666,000 during the Corresponding Period to approximately RMB743,000 during the Reporting Period which represented an increase of approximately RMB77,000 or approximately 11.6%.

During the Reporting Period, finance costs representing the interest on lease liabilities under application of Hong Kong Financial Reporting Standard 16 was approximately RMB7,000 as compared to approximately RMB18,000 during the Corresponding Period.

Loss for the Period

During the Reporting Period, the loss for the period attributable to owners of the Company was approximately RMB514,000, as compared to approximately RMB681,000 during the Corresponding Period. The decrease in loss was mainly attributable to decrease in selling and distribution expenses during the Reporting Period.

Basic loss per share during the Reporting Period was RMB0.12 cents, as compared to RMB0.17 cents during the Corresponding Period.

開支

銷售及分銷開支由去年同期約人民幣2.2百萬元減少約人民幣297,000元或約13.7%至報告期間約人民幣1.9百萬元。該減少乃主要歸因於減少了銷售和營銷活動成本自解除大部分疫情防控措施。

行政開支於報告期間及去年同期保持相對穩定，約人民幣1.8百萬元。

研發開支由去年同期約為人民幣666,000元增加約人民幣77,000元或約11.6%至報告期間約為人民幣743,000元。

報告期間，融資成本指於應用香港財務報告準則第16號後租賃負債的利息約為人民幣7,000元，而去年同期則約為人民幣18,000元。

期內虧損

報告期間，期內本公司擁有人應佔虧損約人民幣514,000元，比較去年同期約人民幣681,000元。虧損減少乃主要有關報告期間銷售及分銷開支減少。

報告期間每股基本虧損為人民幣0.12分，比較去年同期人民幣0.17分。



Taxation

The PRC enterprise income tax rate applicable to the Group's subsidiaries is 15% (during the Corresponding Period: 15%), whereas no assessable profit arising from Hong Kong during the Reporting Period (during the Corresponding Period: Nil).

SHARE OPTION SCHEME

The Company has adopted the Share Option Scheme pursuant to an ordinary resolution passed by the shareholders in the extraordinary general meeting on 13 January 2020 (the "Share Option Scheme"). The Share Option Scheme is a long-term incentive scheme of the Company to reward its employees, Directors and other eligible participants for their contributions to the Group and to assist the Group in its recruitment and retention of high calibre employees and other eligible participants who are instrumental to the growth and development of the Group.

On 9 April 2020, the Company announced the granting of an aggregate of 26,008,000 share options, subject to the acceptance by the grantees, at an exercise price of HK\$0.125 per share of the Company to the eligible persons under the Share Option Scheme. The market price of the Company's shares at the date of grant was HK\$0.125 per share. All of the share options are exercisable from the date of acceptance by a grantee to 8 April 2030 (both days inclusive). Each of the grantees has paid HK\$1 to the Company on acceptance of the offer of share option. Details are set out in the Company's announcement dated 9 April 2020.

稅項

本集團附屬公司適用之中國企業所得稅率為15% (去年同期：15%)，而報告期間並無在香港產生應課稅溢利(去年同期：無)。

購股權計劃

本公司已根據股東於二零二零年一月十三日的股東特別大會上通過的一項普通決議案採納購股權計劃(「購股權計劃」)。購股權計劃乃本公司的長期激勵計劃，旨在獎勵其僱員、董事及其他合資格參與者對本集團作出貢獻，同時協助本集團招聘及挽留高素質僱員及其他對本集團成長及發展至關重要的合資格參與者。

於二零二零年四月九日，本公司公佈根據購股權計劃向合資格人士授出合共26,008,000份購股權，惟受限於承授人接納，行使價為每股本公司股份0.125港元。於授出日期，本公司股份的市價為每股股份0.125港元。全部購股權可由承授人接納日至二零二零年四月八日行使(包括首尾兩日)。各承授人已於接納購股權要約時向本公司支付1港元。有關詳情載於本公司日期為二零二零年四月九日的公告。

The binomial model has been used to estimate the fair value of the share options. The value of the share options is subject to the limitations of the binomial model and a number of assumptions which are subjective and difficult to ascertain. Changes in the subjective input assumptions could materially affect the fair value estimate.

The Group did not engage in any derivatives agreements and did not commit to any financial instruments to hedge its foreign exchange exposure throughout the Reporting Period. The management will closely monitor our Group's foreign currency exposure and will consider hedging significant foreign currency exposure should the need arises.

TREASURY POLICIES

The Group will continue to employ a prudent treasury policy in managing the Group's cash balances and maintain strong and healthy liquidity to ensure that the Group is well placed to take advantage of future growth opportunities.

MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES AND AFFILIATED COMPANIES

On 19 December 2022, Shenzhen Huakang Bio-Medical Engineering Limited* (“**Shenzhen Huakang**”), an indirect wholly-owned subsidiary of the Company, entered into a sale and purchase agreement with the vendor, pursuant to which the vendor agreed to sell, and Shenzhen Huakang agreed to purchase, 19% equity interest in Hainan Jinnuosai Medical Technology Company Limited* (“**Hainan Jinnuosai**”), a company incorporated in the PRC with limited liability and is principally engaged in the manufacturing and sale of AFE products and related supplements in the PRC, at a cash consideration of RMB1.9 million.

On 9 February 2023, Shenzhen Huakang and the vendor entered into a supplemental agreement to the sale and purchase agreement to amend and supplement certain conditions of the sale and purchase agreement, pursuant to which if the conditions are not fulfilled on or before 30 June 2023, the vendor shall refund to Shenzhen Huakang the consideration of RMB1.9 million and Shenzhen Huakang shall return to the vendor the 19% equity interest in Hainan Jinnuosai.

The transaction of the 19% equity interest has not been completed as at 31 March 2023 and up to the date of this Report. Details of the transaction were set out in the Company's announcements dated 6 January 2023, 7 February 2023 and 9 February 2023.

For the Reporting Period, save as disclosed above, the Group did not make any material acquisitions and disposals of subsidiaries and affiliated companies.

No incident of non-compliance of the Required Standard by the relevant employees was noted by the Company.

The Audit Committee consists of three independent non-executive Directors, namely Dr. Cheng Faat Ting Gary (Chairman), Dr. Chow Kwok Fai Joseph and Mr. Chan Kin Sang.

The main duties of the Audit Committee are to assist the Board in reviewing the financial information and reporting process, risk management and internal control systems, effectiveness of the internal audit function, scope of audit and appointment of external auditors, and arrangements to enable employees of the Company to raise concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

The financial information in this Report has not been reviewed nor audited by the Company’s auditor, but the Audit Committee has reviewed the unaudited condensed consolidated financial results of the Group for the Reporting Period and is of the opinion that the preparation of such statements complied with the applicable accounting standards, the requirements under the GEM Listing Rules and other applicable legal requirements, and that adequate disclosures have been made.

1. GENERAL

Huakang Biomedical Holdings Company Limited was incorporated in the Cayman Islands as an exempted company under the laws of the Cayman Islands with limited liability on 3 August 2017 and its shares are listed on the GEM of The Stock Exchange of Hong Kong Limited on 13 December 2018. The Company is controlled by Mr. Zhang Shuguang and Mr. Chang Yim Yang, who act in concert and hold equity interests in the Company indirectly through Crystal Grant Limited (wholly owned by Mr. Zhang Shuguang), a limited liability company incorporated in the British Virgin Islands (“BVI”) and Ever Charming Inc. (wholly owned by Mr. Chang Yim Yang), a limited liability company incorporated in the BVI, respectively. The addresses of the registered office and principal place of business of the Company are set out in the section headed “Corporate Information” to this Report.

The Group is principally engaged in research and development, manufacture, marketing and sale of biological reagents and auxiliary reproductive supplies and equipment in the PRC through its subsidiary, 深圳華康生物醫學工程有限公司 (Shenzhen Huakang Bio-Medical Engineering Limited*) (“**Shenzhen Huakang**”), a limited liability company established in the PRC on 26 June 1992.

The consolidated financial statements are presented in RMB, which is the same as the functional currency of the Company and rounded to the nearest thousand unless otherwise stated.

2. BASIS OF PRESENTATION

The unaudited condensed consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”), which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance. The unaudited condensed consolidated financial statements also comply with the applicable disclosure requirements of the Rules Governing the Listing of Securities on GEM of the Stock Exchange.

The accounting policies adopted in the preparation of the unaudited condensed consolidated financial statement are consistent with those applied in the preparation of the Group’s annual consolidated financial statements for the year ended 31 December 2022, except for the adoption of the new and revised HKFRSs issued by the HKICPA that are adopted for the first time for the Group financial period beginning on 1 January 2023.

The adoption of the new and revised HKFRSs has had no significant effect on the unaudited condensed consolidated financial statements and there have been no significant changes to the accounting policies applied in the unaudited condensed consolidated financial statements.

The unaudited condensed consolidated financial statements have been prepared under the historical cost basis.

The unaudited condensed consolidated financial statements have not been audited by the Company’s auditor, but have been reviewed by the Audit Committee.

3. USE OF JUDGEMENTS AND ESTIMATES

In preparing this unaudited condensed consolidated interim financial statements, the significant judgements made by the management in applying the Group’s accounting policies and the key sources of estimation uncertainty were the same as those that applied to 2022 annual financial statements.

The Company and the subsidiaries incorporated in the BVI are tax-exempted. Entity established in the PRC is subject to PRC Enterprise Income Tax at a statutory rate of 25%. Since the Group's PRC subsidiary, Shenzhen Huakang is recognised as "New and High Technology Enterprise" and therefore is entitled to a concessional tax rate of 15%. The entitlement of this tax benefit is subject to renewal by respective tax bureau in the PRC every three years. The latest approval for Shenzhen Huakang enjoying this tax benefit was obtained in December 2020 for the three years ending 31 December 2023.

Hong Kong Profits Tax has not been provided as the Group had no assessable profit arising from Hong Kong for the three months ended 31 March 2023 and 2022.

No provision for deferred taxation has been made in the unaudited condensed consolidated financial statements as there were no significant temporary differences arising during the three months ended 31 March 2023 and 2022 or at the end of each reporting period.
