CHANGE OF COMPANY NAME, STOCK SHORT NAME AND COMPANY WEBSITE

Reference is made to the announcements of Volcano Spring International Holdings Limited (formerly known as Miji International Holdings Limited) (the “**Company**”) dated 15 February 2023 and 31 May 2023 and the circular of the Company dated 19 April 2023 (the “**Circular**”) in relation to the proposed change of name of the Company (the “**Change of Company Name**”).

Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the proposed change of the English name of the Company from “Miji International Holdings Limited” to “Volcano Spring International Holdings Limited” and the Chinese name of “火山邑動國際控股有限公司” to replace its existing Chinese name of “米技國際控股有限公司” have become effective from 6 June 2023 pursuant to the Certificate of Incorporation on Change of Name issued by the Registrar of Companies in the Cayman Islands. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 3 July 2023 confirming the registration of the new names of the Company in Hong Kong under Part XVI of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “MIJI INTL HLDGS” to “VOLCANO SPRING” in English and from “米技國際控股” to “火山邑動國際控股” in Chinese with effect from 9:00 a.m. on 11 July 2023.

The stock code of the Company on the Stock Exchange remains unchanged as “1715”.

EFFECTS OF CHANGE OF COMPANY NAME AND STOCK SHORT NAME

The Change of Company Name and change of stock short name of the Company will not affect any rights of the existing Shareholders. All existing share certificates of the Company in issue bearing the former name of the Company shall continue to be evidence of title to such Shares and valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for the exchange of the existing share certificates for new certificates bearing the new names of the Company. Any issue of share certificates thereafter will be in the new names of the Company.

CHANGE OF COMPANY WEBSITE

The website of the Company has been changed to “www.volcanospring.com” to reflect the Change of Company Name.
