INTRODUCTION

Reference is made to the prospectus of Tasty Concepts Holding Limited dated 3 October 2023 in relation to the Rights Issue (the “**Prospectus**”). Terms defined in the Prospectus shall have the same meanings when used herein unless the context otherwise requires. In accordance with the terms set out in the Prospectus, the Directors have provisionally allotted to you a number of Rights Shares on the basis of five (5) Rights Shares for every two (2) Shares held on the Record Date and registered in your name(s) as at the Record Date (i.e. Friday, 29 September 2023) at a subscription price of HK\$0.2 per Rights Share.
