**POLL RESULTS OF
THE ANNUAL GENERAL MEETING
HELD ON 2 FEBRUARY 2024**

The Board is pleased to announce that all the Proposed Resolutions set out in the notice of 2024 AGM were duly passed by way of poll at the 2024 AGM held on 2 February 2024.

At the annual general meeting of Water Oasis Group Limited (the “**Company**”) held on 2 February 2024 (the “**2024 AGM**”), all the proposed resolutions as set out in the notice of the 2024 AGM dated 2 January 2024 (the “**Proposed Resolutions**”) were duly passed by holders of the Company’s ordinary shares (the “**Shares**” and the “**Shareholders**”, respectively) by way of poll.

As at the date of the 2024 AGM, there were a total of 680,552,764 issued Shares entitling the Shareholders to attend and vote for or against all the Proposed Resolutions at the 2024 AGM. There were no Shares entitling the Shareholders to attend but abstain from voting in favour of the Proposed Resolutions at the 2024 AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

There were no Shares requiring the Shareholders to abstain from voting on the Proposed Resolutions at the 2024 AGM under the Listing Rules. No Shareholders have stated his/her/its intention in the Company’s circular dated 2 January 2024 to vote against or to abstain from voting on any of the Proposed Resolutions at the 2024 AGM.

All directors of the Company attended the 2024 AGM in person.

The Company’s branch share registrar in Hong Kong, Tricor Standard Limited, was appointed and acted as the scrutineer for the vote-taking at the 2024 AGM.
