

CHAIRMAN'S STATEMENT 董事長報告

On behalf of the board of directors (the "Board") of the Company, I am pleased to present the audited consolidated financial results of the Group for the year ended 31 December 2023 to all shareholders.

本人謹代表本公司董事會(「董事會」) 欣然提呈本集團截至2023年12月31日止年度經審核之合併財務業績,敬請各位股東省覽。

RESULTS FOR THE YEAR

For the year ended 31 December 2023 (the "Year"), the Group's operating income was approximately RMB3,649,930,000 (2022: RMB3,301,143,000), representing an increase of approximately 10.57% as compared with the corresponding period of the previous year. Profit for the year attributable to the equity holders of the Company amounted to approximately RMB29,778,000 (2022: RMB29,623,000 (restated)). Total comprehensive income attributable to the equity holders of the Company amounted to approximately RMB23,794,000 (2022: RMB27,113,000 (restated)). Earnings per share were approximately RMB0.08 (2022: RMB0.08).

As at 31 December 2023, the Group's total assets and current assets were approximately RMB1,820,788,000 (2022: RMB2,236,137,000 (restated)) and approximately RMB824,963,000 (2022: RMB1,184,549,000) respectively, representing a decrease of RMB415,349,000 and RMB359,586,000 respectively as compared with 31 December 2022. Net assets attributable to the parent company and net assets per share at the end of the period were approximately RMB887,279,000 (2022: RMB874,273,000 (restated)) and approximately RMB2.50 (2022: RMB2.47) respectively, representing an increase of 1.49% and 1.21% as compared with 31 December 2022.

本年度業績

截至2023年12月31日,本集團的總資產及流動資產分別為約人民幣1,820,788,000元(2022年:人民幣2,236,137,000元(經重列))及約人民幣824,963,000元(2022年:人民幣1,184,549,000元),較截至2022年12月31日分別減少了人民幣415,349,000元和人民幣359,586,000元:歸屬母公司的淨資產及每股期末淨資產分別為約人民幣887,279,000元(2022年:人民幣874,273,000元(經重列))及約人民幣2.50元(2022年:人民幣2.47元),較截至2022年12月31日分別增長了1,49%和1,21%。

REVIEW FOR THE YEAR

In 2023, buoyed by an upward trend in China's economy, gross domestic product (the "GDP") increased 5.2% year-on-year. Competition pattern of logistics industry has intensified despite continued improvement of operational environment with overall industrial rebound. In particular, the decline of fuel vehicles market has a crucial impact on relevant industries. Adhered to the principle of high-quality development, the Group made steady progress in all aspect orienting at revitalization of existing stock, cultivation of additional stock and improvement of quality.

During the reporting period, a sharp fall on the segment performance of the Group's automotive logistics, which was affected by the decline of fuel vehicles market. At the same time, the Group further strengthened business expansion of warehousing logistics and materials procurement, resulting in increase in performance. Such increase offsets the impact of automotive logistics segment to a considerable extent. Considering various operational factors, the overall net profit attributable to the parent company of the Group recorded a slight increase year-on-year.

Consolidating major businesses

During the Year, in the automobile logistics sector, the Group actively responded to the impacts of capacity compression in main engine plants of upstream commodity vehicles resulting from the decline in fuel vehicle market, and minimized the adverse impacts through team simplification, process optimization and cost control. In the material procurement sector, the Group continued to expand its business scale on the basis of reasonable management and control of business risks, and both business income and profitability increased during the year. In the electronic component logistics sector, the Group extensively searched for stock customers, expanded business opportunities including multimodal transportation of domestic shipping and international railways as well as bonded logistics warehouse. In the cold chain logistics sector, the Group constantly expanded one-stop cold chain logistics and supervision services. In other warehousing and logistics businesses, the Group actively expanded, by virtue of its facilities and resources such as railway routes and heavy container yards, the logistics businesses of third parties, thus improving its multimodal transportation capability.

至年回顧

本報告期內,受燃油車市場下滑影響,本 集團汽車物流板塊業績大幅收縮,同時, 本集團加強倉儲物流及物資採購業務拓 展,業績有所上升,一定程度上抵消了汽 車物流板塊的影響,綜合各項經營因素, 本集團整體歸母淨利潤同比小幅上升。

夯實主業

Reserving projects

During the Year, the Group has completed the preparation and approval work of the Teda Industrial Park of Green and Intelligent Logistics Supply Chain (泰達綠色智慧物流供應鏈產業園) project, which is not only the improvement and renovation for low-efficient stock assets, but also an important shot of the Company for operation result improvement by deeply engaging its major business of warehouse logistics area.

Solidifying safety

During the Year, the Group continuously strives to manage and control the whole process of materials procurement business, and always implemented the principle of "safety first, prevention focused" for safe production work, so as to ensure the Company's steady and safe operation and firmly safeguard the interests of its shareholders.

PROSPECT AND VISION

Looking ahead to 2024, the environment for China's development is still full of strategic opportunities and risks and challenges. The favorable conditions outweigh the unfavorable factors. The basic trend of economic recovery and long-term improvement has not changed. The Group will continue to strengthen its confidence, make full use of internal and external resource endowments, seize opportunities and respond to challenges, continuously enhance its independent operating capabilities and core competitiveness, and strive to improve the quality and efficiency of the Group's overall operation and management.

The Group will integrate physical logistics resources, enhance the scale of sea-rail combined transportation business, focus on the core resources of special railway freight lines and storage yards, extend to the upstream and downstream industrial chains, and improve comprehensive service income. The Group will improve the asset efficiency of special railway freight lines, seize major industry opportunities for commercial vehicle exports, and promote the construction of integrated transport hub for commercial vehicles and spare parts.

BUSINESS HIGHLIGHTS

The principal businesses of the Group are logistics and supply chain services for finished automobiles and components, supply chain and logistics services for electronic components, materials procurement and related logistics services, cold chain logistics services and other services such as warehouse, container yard, supervision, agency and transportation services. The major customers of the Group include: Fujian Zhanglong Group Co., Ltd. (福建漳龍集團有限公司), FAW Toyota Logistics (Tianjin) Co., Ltd. (一汽豐田(天津)物流有限公司), Tangshan Donghua Steel Group Co., Ltd. (唐山東華鋼鐵企業集團有限公司), Tong Fang Global (Tianjin) Logistics Co., Ltd. (同方環球(天津)物流有限公司) and China Commerce & Logistics Co., Ltd. (中物華商集團股份有限公司).

During the reporting period, the operating income and segment results of the supply chain and logistics services for finished automobiles and components decreased as compared with the corresponding period of last year, mainly due to the decrease in income and segment results of Fengtian Logistics, a key enterprise of the Group, driven by the dual effects of the weak fuel vehicle market, and the significant decrease in the unit price of logistics service fees per imported vehicles as a result of the logistic costs reduction of customer. During the reporting period, as for the materials procurement and related logistics services business of the Group, the operating income and the segment results increased compared to the corresponding period of last year, mainly due to the increase in business volume. The operating income of the warehouse, transportation supervision businesses increased as compared to the corresponding period of last year while the segment results increased as compared to the corresponding period of last year, mainly due to the increase in results caused by the improvement of management level, cost reduction and efficiency improvement of the bonded warehouses of the Company's subsidiaries. The operating income and operating profit from supply chain and logistics services for electronic components business

recorded a decrease as compared to the corresponding period of last year, mainly because of a decrease in business volume this year as a result of the intensified market competition. The operating income and operating profit from cold chain logistics services business recorded a decrease as compared to the corresponding period of last year, mainly due to the influence of the policy change on pandemic prevention and control, the disinfection and testing business of the Class A inspection warehouse with high gross profit margin stopped, and at the same time, the regional market competition became more intense, resulting in a continuous decline in business volume and profit margin.

Supply Chain and Logistics Services for Finished Automobiles and Components

During the reporting period, the operating income of supply chain and logistics services for finished automobiles and components amounted to approximately RMB1,222,058,000, representing a decrease of RMB115,603,000 or 8.64% as compared with the corresponding period of last year, while the operating results amounted to approximately RMB18,430,000, representing a decrease of RMB64,895,000 or 77.88% as compared with the corresponding period of last year.

Materials Procurement and Related Logistics Services

During the reporting period, the operating income from the materials procurement and related logistics services amounted to approximately RMB2,350,624,000, representing an increase of RMB442,766,000 or 23.21% as compared with the corresponding period of last year, while the loss of operating results amounted to approximately RMB18,537,000, representing a decrease of RMB4,448,000 or 19.35% as compared with the corresponding period of last year.

汽車整車及零部件供應鏈物流服務

報告期內,汽車整車及零部件供應 鏈物流服務實現營業收入約人民幣 1,222,058,000元,較上年同期減少人民 幣115,603,000元,降幅為8.64%;營 業業績約人民幣18,430,000元,較上年 同期減少人民幣64,895,000元,降幅為 77.88%。

物資採購及相關物流服務

報告期內,物資採購及相關物流服務業務實現營業收入約人民幣2,350,624,000元,較上年同期增加人民幣442,766,000元,增幅為23.21%:營業業績虧損約人民幣18,537,000元,較上年同期減虧人民幣4,448,000元,虧損降幅為19.35%.

Warehouse, Supervision, Agency and Other Services

During the reporting period, other services such as warehouse, container yard, supervision, agency and transportation services recorded an operating income of approximately RMB77,248,000, representing an increase of RMB21,624,000 or 38.88% as compared with the corresponding period of last year, while the operating results amounted to approximately RMB19,904,000, representing an increase of RMB5,822,000 or 41.34% as compared with the corresponding period of last year.

Supply Chain and Logistics Services for Electronic Components (Conducted Through Investments in Joint Ventures)

During the reporting period, the performance of supply chain and logistics services for electronic components business of the Group's joint ventures recorded a decrease as compared with the corresponding period of last year. During the reporting period, the business recorded a net operating profit of approximately RMB47,535,000, representing a decrease of RMB21,852,000 or 31.49% as compared with the corresponding period of last year, while the profit contribution was approximately RMB23,333,400, representing a decrease of RMB11,001,000 or 32.04% as compared with the corresponding period of last year.

Cold Chain Logistics Services (Conducted Through Investments in Joint Ventures)

During the reporting period, the performance of cold chain logistics services of the Group's joint ventures recorded a decrease as compared with the corresponding period of last year. The business recorded a net operating profit of approximately RMB17,897,000, representing a decrease of RMB12,450,000 or 41.03% as compared with the corresponding period of last year, while the profit contribution was approximately RMB10,738,000, representing a decrease of RMB7,470,000 or 41.03% as compared with the corresponding period of last year.

電子零部件供應鏈物流服務業務(通過投資合營公司來進行)

報告期內,本集團合營公司之電子零部件 供應鏈物流服務業務業績較上年同期有 所下降,報告期內實現營業淨利潤約人 民幣47,535,000元,較上年同期下降人 民幣21,852,000元,降幅為31.49%。利 潤貢獻約人民幣23,333,400元,較上年 同期下降人民幣11,001,000元,降幅為 32.04%。

冷鏈物流服務(通過投資合營公司來進行)

報告期內,本集團合營公司之冷鏈物流服務業務業績較上年同期有所下降,報告期內實現營業淨利潤約人民幣17,897,000元,較上年同期下降人民幣12,450,000元,降幅為41.03%。利潤貢獻約人民幣10,738,000元,較上年同期下降人民幣7,470,000元,降幅為41.03%。

FINANCIAL REVIEW

Operating income

For the year ended 31 December 2023, operating income of the Group was RMB3,650 million, representing an increase of RMB349 million or 10.57% as compared to RMB3,301 million for the corresponding period of last year. The increase in operating income is mainly attributable to an increase in operating income of materials procurement and related logistics services as compared to the corresponding period of last year.

Cost of sales and gross profit

For the year ended 31 December 2023, the cost of sales of the Group was RMB3,589 million, representing an increase of RMB420 million or 13.25% as compared to RMB3,169 million in the corresponding period of last year. For the year ended 31 December 2023, overall gross profit margin of the Group was 1.67% which was 2.32 percentage points lower than the corresponding period of last year. The main reason for the decrease in gross profit margin was lower gross profit from the Company's automotive logistics segment as a result of the impact of the market environment.

Administrative expenses

The administrative expenses of the Group for 2023 amounted to RMB52,436,000, representing a decrease of RMB4,021,000 or 7.12% as compared to RMB56,457,000 in the corresponding period of last year.

Finance costs

The Group's finance costs during 2023 amounted to RMB21,339,000, representing an increase of RMB637,000 or 3.08% as compared to RMB20,702,000 in the corresponding period of last year. The Group will improve the efficiency of capital utilisation and reduce the overall finance costs.

Taxation expenses

The taxation expenses of the Group for 2023 were RMB4,633,000, representing a decrease of RMB16,482,000 or 78.06% as compared to RMB21,115,000 (restated) in the corresponding period of last year.

財務回顧

營業收入

截至2023年12月31日止年度,本集團之營業收入為人民幣36.50億元,較上年同期人民幣33.01億元增加人民幣3.49億元,增幅為10.57%。營業收入增長的主要原因是物資採購及相關物流服務業務營業收入較上年同期有所增長。

銷售成本及毛利

截至2023年12月31日止年度,本集團銷售成本為人民幣35.89億元,較上年同期人民幣31.69億元增加人民幣4.20億元,增幅為13.25%,截至2023年12月31日止年度,本集團之整體毛利率為1.67%,較上年同期下降2.32個百分點。毛利下降的主要原因是受市場環境影響,公司汽車物流板塊業務毛利下降。

行政開支

本集團2023年度行政開支為人民幣52,436,000元,較上年同期人民幣56,457,000元減少人民幣4,021,000元,降幅為7,12%。

融資成本

本集團2023年度融資成本為人民幣21,339,000元,較上年同期人民幣20,702,000元增加人民幣637,000元,增幅為3.08%。本集團將提高資金使用效率,降低總體財務費用。

税務開支

本集團2023年度税務開支為人民幣4,633,000元,較上年同期人民幣21,115,000元(經重列)減少人民幣16,482,000元,降幅為78.06%。

Net change in fair value of equity investments through comprehensive income

The net change in fair value of equity investment of the Group for 2023 was RMB-5,984,000, representing a decrease of RMB3,474,000 as compared to RMB-2,510,000 in the corresponding period of last year, which was mainly attributable to the significant decrease of the net financial assets measured at fair value through other comprehensive income of the Group.

Share of results of joint ventures and associates

The share of results of joint ventures and associates of the Group for 2023 was RMB26,592,000, representing a decrease of RMB28,343,000 or 51.59% as compared to RMB54,935,000 in the corresponding period of last year, which was mainly due to the significant decrease in the operating results of Tianjin TEDA Alps, Tedahang, Tianxin Inspection, and especially Gangwan Automobile, as compared to the corresponding period of last year.

Profit for the year and profit and total comprehensive income attributable to the equity holders of the Company

For the year ended 31 December 2023, total profit for the period amounted to RMB30,362,000, representing a decrease of RMB 26,808,000 or 46.89% as compared to RMB57,170,000 (restated) in the corresponding period of last year. Profit for the year attributable to the equity holders of the Company amounted to RMB29,778,000, representing an increase of RMB155,000 or 0.52% as compared to RMB29,623,000 (restated) in the corresponding period of last year. Total comprehensive income attributable to the equity holders of the Company was RMB23,794,000, decreased by RMB3,319,000 or 12.24% as compared to RMB27,113,000 (restated) in the corresponding period of last year.

本集團2023年度應佔合營、聯營公司 業績為人民幣26,592,000元,較上年 同期人民幣54,935,000元減少人民幣 28,343,000元,降幅為51.59%,主要原 因是天津泰達阿爾卑斯、泰達行、天鑫檢 測、特別是港灣汽車經營業績較上年同期 大幅下降。

年度溢利及本公司權益持有人應佔溢利及 全面收入總額

The Company completed the conversion of 256,068,800 domestic unlisted shares into H shares on 26 October 2023. Save as disclosed above, for the year ended 31 December 2023, there was no change in the capital structure of the Group. The share capital of the Company comprised only ordinary shares.

Borrowings

As at 31 December 2023, the balance of borrowings of the Group was RMB351,909,000 (31 December 2022: RMB285,175,000).

Gearing ratio

As at 31 December 2023, the ratio of total liabilities to total assets of the Group was 45.56% (31 December 2022: 55.28% (restated)). The gearing ratio (ratio of loans (including borrowings and lease liabilities) to total equity) of the Group was 39% (31 December 2022: 34%).

Charge on assets

As at 31 December 2023, the Group's investment properties of RMB315,000,000, property, plant and equipment of RMB6,308,000 and bank deposits of RMB56,015,000 were pledged to secure borrowings and bills payables granted to the Group.

Exchange loss or gain

All operating revenues and expenses of the Group are denominated in Renminbi.

ABOUT THIS ENVIRONMENTAL, SOCIAL AND GOVERNANCE REPORT

Tianjin Binhai Teda Logistics (Group) Corporation Limited (the "Company") and its subsidiaries (collectively, "the Group" or "we" and "us") are principally engaged in the provision of logistics and supply chain services for finished automobiles and components materials procurement and related logistics services, cold chain logistics and other services in the People's Republic of China (the "PRC"). As an enterprise that strives to operate its business with the purpose of creating long-term value for all, the Group remains committed to adopting environmental, social, and economic perspectives in strategy planning and policy execution, in constant pursuit of harnessing technology evolution, eco-friendly measures and responsible practices to respond to the challenges that abound in business landscapes.

The Group is pleased to present this environmental, social and governance report (the "Report"), which demonstrates the Group's approach and performance in terms of environmental, social and governance ("ESG") and sustainable development for the year ended 31 December 2023 ("2023"). For the corporate governance section, please refer to the "Corporate Governance Report" in the Group's annual report 2023.

As for now, multiple nations pledged for a series of environmental protection commitments, including but not limited to the carbon neutrality targets. In line with the calls of the central government of the PRC, the Group swiftly responded and implemented effective policies to integrate the concepts of ESG into its day-to-day operations.

In order to better manage the Group's ESG performance, related issues and potential risks, the Board shall hold meeting at least once a year to review and identify the materiality, risks and opportunities of the Group's ESG issues, and review their performance and progress against ESG-related targets. In addition to regular inspection and evaluation of the implementation of the Group's environmental and social responsibility system, the Board is also responsible for ensuring the effectiveness of the risk management and internal control systems, as well as approving disclosures in the Report.

The Working Group is required to hold a meeting at least once a year to assess the effectiveness of existing policies and procedures and develop appropriate solutions to improve the overall performance of ESG policies. It is also required to report its findings, decisions and recommendations to the Board at least once a year.

Management Approach and Strategy

Risk management is an essential part in ESG issues, especially for those risks related to climate change and environmental regulations established by the government. Committed to integrating its ESG management approach into enterprise risk management system, the Group has carefully studied and implemented the measures and emergency plans built by local governments, aiming to better identify and address any potential, unknown or actual risks.

To identify and better understand the Group's ESG-related risks, as well as the latest update on ESG laws and regulations that may have significant impact on the Group's business, the Board maintains stable connection with the authorities, engages external experts and holds regular communication with internal advisory groups to ensure that important information is shared and passed around the organization. Meanwhile, when setting up and deciding the longterm development strategy for its business, the Group is particularly concerned and prioritized considerations including the government support, requirements and restrictions on the logistic industry, market environment for its main business segment, and most importantly, the environmental impacts caused during the logistics operations. In addition, the Group also integrates the concerns and interests of stakeholders reflected in the result of its materiality assessment, when creating, reviewing and modifying its strategy to ensure a comprehensive and balanced business plan that is inclusive of opinions from different perspectives.

管理方針及策略

風險管理是環境、社會及管治事宜的重要 一環,尤其針對有關政府制定的氣候變化 及環境法規的風險。本集團致力於將環 境、社會及管治管理方針融入企業風險管 理體系,認真研究並落實地方政府制定的 措施和應急預案,以求更好地識別及應對 任何潛在、未知或實際的風險。

環境、社會與企業管治報告

Goals and Targets

To steadily advance various tasks and stay in line with the overall planning of the regional and national units, the Group formulates long-term plans attentively in undertaking its corporate social responsibilities. Recognizing that energy consumption, including but not limited to the fossil fuels consumed for vehicle transportation and electricity consumed for warehouse storage, is one of the most significant environmental impacts of the logistic industry, the Group is dedicated to control its energy consumption per thousand square meter, while reducing the dependence of business operation on resources consumption.

The Group sets internal ESG KPIs to reduce its negative environmental impacts to the greatest extent. In particular, KPIs include the electricity consumption per thousand square meter and the fuel consumption for vehicles transportation per thousand square meter etc. These KPIs are reviewed and monitored by the Board through the supervision and the regular report of the Management, while they are also disclosed in the annual ESG report of the Group to let its stakeholders scrutinize the performance and progress of the Group.

We will also endeavor to overcome all operational difficulties in order to cater and maintain our service reliability. In addition to the exploration of alternative logistics solutions including the sea-rail combined transportation, we have also been enhancing our support to the subsidiaries in developing new businesses and building new facilities and upgrading to intelligent transformation.

Materiality Assessment

The Group conducts regular materiality assessment, to identify its stakeholders' main concerns and material interests for response and reporting. The Group believes that the goal and direction of sustainable development should be long-term and continuous, while the implementation of relevant policies should be sustained over time to ensure their effectiveness. As such, the Board decided to continue its efforts on addressing the risks and opportunities under the material topics that were reflected in its materiality assessment, so as to lead the Group to move towards sustainable development in a consistently effective manner.

To ensure the accuracy and objectivity of evaluation, the Group engaged an independent third party in conducting an online materiality assessment survey. Taking a stepwise approach, a list of ESG issues were first identified through taking reference of domestic and foreign reporting guidelines as well as the market concerns of sustainable development. Relevant internal and external key stakeholders were then invited to provide inputs for evaluation and formulation of the materiality matrix as below, which was submitted to the Board for subsequent review.

A. ENVIRONMENTAL SUSTAINABILITY

The Group believes that green operation is essential for the corporate and crucial for creating long-term value for the community in which it operates. This section mainly discloses the Group's policies, practices and quantitative data on emissions, use of resources, environment and natural resources, and climate change in 2023. The Group has formulated the "Environmental Policy" (《環境政策》) to achieve its goals in reducing emissions and conserving resources.

Environmental Targets

In order to ensure that we can effectively implement a sustainable business model, the Group has set a number of environmental targets based on its development direction and strategic guidelines, and closely monitors and regularly reviews progress of the targets. In order to manage environmental targets more efficiently and review their progress regularly, with 2022 as the base year, the Group set new targets in 2022 which to be achieved by the year ending 31 December 2027 ("2027"), details are as follows:

Air and GHG Emissions

The exhaust gas generated by the Group included SO_x , NO_x and PM, mainly from the fuel consumption of vehicles used for transportation purposes and the fuel consumption of forklifts in workplaces. In 2023, the Group's total air emissions slightly decreased compared to 2022.

The Group's GHG emissions mainly came from the diesel and gasoline consumption of automobiles and forklifts, natural gas consumption for heating (Scope 1), purchased electricity and steam consumption (Scope 2), waste paper landfills and business air travel (Scope 3). The total GHG emissions of the Group decreased by about 22.4% as compared with 2022. In response to the country's goal of achieving carbon neutrality in 2060 and in order to achieve internal environmental targets, the Group is dedicated to monitoring and controlling its direct emissions from vehicle use for transportation through relevant approaches, including but not limited to avoid unnecessary transportation by utilizing appropriate logistical planning, arranging transportation time schedule, maximizing loading rates and transportation efficiency; adopt more environmentally smart transportation modes and develop new transportation combinations in support of the reformation of emission reduction standards and fuel efficiency standards; and improve and develop innovative technologies for transportation such as more efficient alternative energy sources and upgraded modern fleet.

Further, drivers are encouraged and required to maintain good driving habits, including turning off idling engines when stopping and not rushing to brake and accelerate, so as to reduce fuel loss, thereby lowering air emissions. Drivers are also required to ensure all vehicles are in good conditions in order to improve energy efficiency and reduce fuel consumption. Other measures to save electricity and heat energy will be further explained in the section headed "Use of Resources". In order to reduce GHG emissions from business travel, the Group advised its employees to reduce unnecessary business air travel and work together through online communication software as much as possible.

廢氣及溫室氣體排放

本集團產生的廢氣包括硫氧化物、 氮氧化物及顆粒物,主要來自用於 運輸目的之汽車燃料消耗及作業場 所內叉車的燃料消耗。於2023年, 本集團的廢氣排放總量較2022年輕 微下降。

本集團的溫室氣體排放主要來自汽 車及叉車的柴油及汽油消耗以及 用於供暖之天然氣消耗(範圍1)、 外購電力及蒸汽消耗(範圍2), 以及廢紙填埋及商務航空旅行(範 圍3)。本集團溫室氣體排放總量 較2022年減少約22.4%。為響應 2060年國家實現碳中和的目標及實 現內部環境目標,本集團致力透過 相關方法以監測及控制其運輸車輛 所產生的直接排放,包括但不限於 合理規劃物流、安排運輸時間並儘 量提高裝載率及運輸效益,以避免 不必要的運輸;採用更加環保智能 的運輸方式, 開發新的運輸組合, 支持減排標準及燃油效率標準的改 革; 以及改進及開發創新的運輸技 術,例如更高效的替代能源和升級 的現代化車隊。

Understanding that refrigerants used in cold storage (such as CFCs and HCFCs) will impose threat to ozone depletion and global warming, the Group adopts liquid ammonia as an alternative refrigerant and makes certain the proper preservation of refrigerant in storage tanks, compressors, evaporative condensers and other refrigeration equipment, and purposely separates the refrigerating station from other zones, so as to reduce the hazard caused by refrigerant leakage.

Wastewater and Solid Waste

The wastewater discharged by the Group mainly included household sewage generated from daily operations, and no large amount of hazardous wastewater was discharged. In 2023, the wastewater discharge of the Group decreased by approximately 56.7% compared with 2022.

To better manage its wastewater and prevent the contamination of natural water bodies from its potential leakage, the Group installs professional containers for grease separation and storage. Meanwhile, a professional agency that is approved by the local environmental protection bureau is appointed for examining and supporting sewage treatment on an annual basis, thus minimizing the Group's environmental impact. The Group has also taken effective measures to reduce water consumption in daily operations, the details are further explained in the section headed "Use of Resources".

The solid waste generated by the Group was mainly general household waste and a small amount of hazardous solid waste generated from daily operations. In 2023, the discharge of non-hazardous waste of the Group increased as compared to 2022, while hazardous waste decreased as compared to 2022. The non-hazardous waste generated by the Group was collected and disposed of by a professional third party after classification. Meanwhile, the hazardous waste arose from operation was properly handled according to the Group's internal procedure, and qualified third parties were assigned for collection and disposal. In realizing its targets, the Group embraces the concept of "3R Principle – Reduce, Reuse and Recycle" and actively instils the recycling principle into its daily operations.

本集團了解到冷庫中使用的製冷劑 (如氟氯化碳及氟氯烴)會構成臭氧 層消耗及全球暖化的威脅,因此本 集團採用液氨作為替代製冷劑,本 保儲罐、壓縮機、蒸發式冷凝器等 製冷設備中的製冷劑妥善保存, 特別將製冷站與其他區域分開,以 降低冷劑洩漏帶來的危害。

廢水及固體廢棄物

本集團排放的廢水主要包括日常營 運產生的生活污水,並無排放大量 危險廢水。於2023年,本集團的廢 水排放量較2022年下降約56.7%。

Noise

In 2023, the noise of the business activities of the Group were mainly from the operations of machinery in the warehouse operating zone, vehicle transportation and loading and unloading practices, as well as other engineering construction sources. Geared toward lowering its noise impacts, the Group establishes internal policies and assigns dedicated personnel to carry out daily inspections of the equipment, in order to spot and repair any irregularities timely. Meanwhile, the Group also installs noise barriers and explosion-proof doors as well as windows between the refrigerating station and the control room in accordance with the "Law of the People's Republic of China on Prevention and Control of Pollution from Environmental Noise" (《中華人民共和國環境噪聲污染防治法》) and other relevant national regulations.

Use of Resources

To effectively manage resource consumption, the Group has established and monitored reasonable KPIs to regulate procurement behavior and resource consumption, so as to continuously improve the efficiency of resource use.

In 2023, the primary resources consumed by the Group were diesel, gasoline, natural gas, electricity, steam, water, packaging materials and paper. The Group's total use of resources by category is set out as follows:

Direct energy

The Group mainly uses gasoline and diesel for vehicle transportation and loading and unloading practices, while natural gas is used for heating in daily operations. Due to the decrease in reach stacker operations as a result of lower demand for storage yard cooling, the diesel, gasoline and natural gas consumption decreased in 2023 as compared to 2022. To better monitor and control its energy consumption performance, the Group will put more focus on the sustainable solutions by upgrading its vehicle fleet in terms of energy efficiency improvement and grasping any opportunities for the use of renewable energy sources and the wide application of electric vehicles.

Electricity

The Group's consumption of electricity mainly comes from the daily operation of warehouses. In 2023, the electricity consumption of the Group decreased as compared to 2022. which was mainly due to the Company's improvement in refrigerating of the cold warehouse by adopting more energy saving operation methods. Geared toward lowering the electricity consumption and bettering the performance in decarbonization, the Group improved the rules and regulations and formulated specific measures for energy saving and consumption reduction for equipment in office zone, including but not limited to fully utilize the natural light whenever applicable; switch off all idling electricity appliances including lights and air conditioners; improve the operation methods of refrigerating facilities in warehouse; maintain and replace the equipment regularly to improve the performance of equipment; replace power-intensive lightings by energy efficient LED lights; encourage employees to adopt natural ventilation or ventilation fans for areas instead of air-conditioning when applicable; and actively introduce new technology for energy saving, explore the feasibility on the use of renewable energy in operations. The Group requires all of its subsidiaries to stringently comply with the energy saving policy.

電力

本集團的用電量主要用於倉庫的日 常營運。於2023年,本集團的用電 量較2022年減少,主要原因為本公 司在冷庫製冷方面進行改善,採取 了更加節約電力的操作方式。為降 低耗電量並改善低碳表現, 本集團 已完善規章制度並制定辦公區域設 備節能降耗具體措施,包括但不限 於在適用情況下充分利用自然光; 關閉所有閒置電器設備(包括電燈及 空調),改善倉庫製冷設備操作方 式,對設備定期維護保養和校驗更 換,提高設備效能,用節能的LED 燈取代高功率照明,鼓勵員工在適 用情況下以自然通風或換氣扇代替 空調,以及積極引入節能新技術, 探索在業務中使用可再生能源的可 行性。本集團要求其所有附屬公司 嚴格遵守節能政策。

Case sharing: Energy-saving and consumption-reducing measures for refrigeration of cold storage

案例分享:冷庫設備製冷節能降耗措施

We have adopted a series of measures to improve energy efficiency. Firstly, all evaporators installed cameras for real-time observation and are shuttled down once defrosting is done. Employees from different teams or floors shall shoulder different responsibilities. We have set a unified defrosting standard and run the evaporator in round robin manner. This can decrease the number of times the evaporator is turned on and can also evenly release cold air, resulting in a 25% year-on-year duction in energy consumption and a drop of approximately 2.2 million kWh in electricity consumption. Secondly, we have improved operational process for the start and stop of compressor. Different shifting schedules, minimum temperature standards setting and daily record of electricity consumption have been adopted to select the process with the lowest power consumption as the standard, requiring night shifting staff to manually start and stop the running of compressor. In order to enhance the overheating capacity of evaporative cooler, we descaled it and adjusted the high-power cooling fan by variable frequency technology to cope with different weather conditions. We also upgraded the water tray heating equipment to prevent winter freeze-ups, and changed the winter cooling mode by using cooling water to cool the refrigeration unit, thereby significantly reducing power consumption.

為了提高能源效率,我們採取了一系列措施。首先,我們在所有蒸發器上安裝了攝像頭進行實時觀測,並採用即溶即關的方式。通過分班組和分樓層責任的方式壓實責任。我們設定統一融霜標準,並採用循環開啟蒸發器的方式運行。這既減少蒸發器的開啟次數,也能均匀地釋冷氣,從而使能耗同比下降了25%,用電量下降約220萬千瓦時。其次,針對壓縮機的啟停問題,我們改善了操作流程。通過分班組、設定溫度下限標準和每天記錄用電情況的方式,選擇耗能最低的作為標準流程,要求夜間值守人員進行人工啟停壓縮機運行時間。為了提高蒸發冷凝器過熱能力,我們對蒸發冷進行了清理除垢,並利用變頻技術調整大功率散熱風扇以應對不同天氣條件。我們還升級了水盤加熱設備以防止冬季結冰,並改變了冬季降溫模式,利用冷卻水降溫來為製冷機組提供降溫效果,從而大幅減少電能消耗。

In addition, we have adjusted the shift schedule to standardize the work content. For evaporator defrosting, we adjusted the operation procedure to ensure short time and high efficiency of defrosting. At the same time, we developed compressor and evaporative cooling operations procedures to reduce energy consumption and unify operation standards. A performance evaluation mechanism was introduced to quantify the work and reward the team with the lowest monthly energy consumption. Thanks to the implementation of these improvement measures, the Group's energy consumption has been reduced.

此外,我們調整了班次安排,實現了工作內容的標準化。針對蒸發器融霜,我們調整了操作流程,確保融霜時間短且效率高。同時,我們制定了壓縮機和蒸發冷操作流程,以降低能耗並統一操作標準。引入績效評估機制,將工作內容量化,並獎勵每月最低能耗的班組。通過實施這些改進措施,本集團的能源消耗量有所降低。

Steam

The steam consumption of the Group is mainly used for indoor heating in winter. In 2023, The steam consumption of Group has decreased as compared to 2022, which was due to the Group strictly controls the temperature of heat supply to save the amount of steam. The Group has implemented relevant measures to reduce steam consumption, including but not limited to clean heating radiator to increase its heat efficiency and repair heating pipes to save energy and reduce consumption.

Water

The Group's main sources of water consumption are the daily operation and living. Based on the geographical location of the Group's operation scope, the Group's water is sourced from municipal water supply, and did not experience any difficulty in obtaining suitable water source in 2023. The consumption of water in 2023 decreased as compared to 2022. Following its internal policies, the Group provides water awareness training to its employees and accesses the conservation performance among employees regularly. The Group also posted signs in prominent places to disseminate water saving concept throughout the organization.

Packaging materials

In 2023, the amount of packaging materials used by the Group maintained the similar level as in 2022. While the consumption of packaging materials is inevitable to its logistic business activities, the Group takes the responsibility for being conscious about the use of packaging materials. As such, the Group will continue to research and apply alternative packaging materials made of recyclable content, striving to minimize its environmental footprint to the largest extent.

蒸汽

本集團的蒸汽消耗主要用於冬季室內供暖。於2023年,本集團的蒸汽 使用量較2022年減少,乃因為本集 團嚴格控制供暖溫度,以節約蒸汽 量。本集團已實施相關措施以減少 蒸汽消耗,包括但不限於清洗暖氣 片,加大暖氣片熱效率,以及維修 暖氣管路,節能降耗。

7K

本集團主要耗水來源為日常經營及生活。基於本集團作業範圍用水均之2023年,本集團用水均均於市政供水,就求取適用水水源於有任何問題。於2023年,本集團用水量較2022年有所下降工具實,本本集團為其內部政策,本集團為其計學,本集團,並完實,以於整個組織宣傳的水理。

包裝材料

於2023年,本集團包裝材料使用量與2022年維持相似水平。儘管物流業務活動不可避免地會消耗包裝材料,但本集團有責任重視包裝材料的環境危害。因此,本集團將繼續研究及應用由可回收材料製成的替代包裝材料,努力將環境足跡減至最低。

Paper

Paper was mostly used in the Group for its administrative work. In 2023, the amount of paper consumed by the Group decreased as compared to 2022. To keep up its effort in driving down the consumption of paper and other paper-made products, the Group rents more energy-efficient printing equipment, promotes a paperless office and continues to implement a series of effective internal measures to regulate its employees' practices and business operations, including but not limited to set double-side printing as the default mode of the printers, collect single-sided paper for reuse and recycling, and improve the utilization rate of platforms such as corporate mailboxes, and collaborative workspace applications, enhance employees' awareness of conservation and environmental protection.

The Environment and Natural Resources

As a leading logistics group that moves goods across countries and provides a wide range of logistics solutions and services, the Group deeply understands its impact on the environment. Throughout the organization, employees are encouraged to follow the Group's sustainability strategies and reminded to achieve its environmental targets. The Group believes that behavioural change starts with knowledge, and thus it equips its employees who play a key role in daily business actions with internal programmes to advance their environmental awareness and encourage them to make continuous changes. The Group is accredited with ISO 14001 Environmental Management System certification.

According to the analysis of its business practices, the relatively significant environmental impacts of the Group were mainly the air and GHG emissions arose from the consumption of fossil fuels and electricity during operations in 2023. In light of these, the Group is determined to control its procurement process of vehicles and refrigerators to ensure that the priority can be given to the products with better environmental performance. Meanwhile, the Group has also been active in exploring the possibility of tapping into the application of renewable energy and acquiring vehicles fuelled by cleaner new energy instead of fossil fuels.

紙張

環境及天然資源

根據業務實踐分析,本集團在2023 年對環境較大的影響主要為營運期 間消耗化石燃料及電力而產生的 氣及溫室氣體排放。因此此的經 完控制其車輛及製冷機的更要 程,確保優先採購環保性能更好 產品。同時,本集團亦積極探 所可再生能源的可能性,並購 到 較潔淨的新能源替代化石燃料的車 輛。 The Group resolutely puts an end to extravagance and waste, and actively responds to the "Work Plan for Anti-Food Waste and Food Conservation in Teda Holding System" (《泰達控股系統反食品浪費與糧食節約減損工作方案》). The Group makes full use of the official website and other publicity media to disseminate public service advertisements, and vigorously advocates the concept of cherishing food. The Group has also established an implementation mechanism for anti-food waste and food conservation, using scientific and technological means to strengthen supervision and inspection, and makes prompt reminders when problems are found.

本集團堅決杜絕鋪張浪費,積極響應《泰達控股系統反食品浪費與糧食節約減損工作方案》。本集團充分利用官方網站等宣傳媒體傳播公益廣告,大力提倡愛惜糧食的理念。本集團亦建立反食品浪費與糧食節約減損工作落實機制,利用科技手段加強監督檢查力度,發現問題及時提醒。

Climate Change

As the impact of climate change gradually emerges, it has become an urgent need and common expectation of all countries to reduce carbon emissions. In support of the national carbon goal and in response to the gradually increasing demand from investors and the wider society, the Group has formulated the "Climate Change Policy" (《氣候變化政策》), and also integrated climate change into its internal controls and enterprise risk management procedure. The Group made a view of different climate scenarios and transition pathways, and identified several physical and transition risks related to its business that may cause significant impact according to the international recommendations of the Task Force on Climate-related Financial Disclosures.

Physical risks

The increase in frequency of extreme weather events such as storms, flooding, heat and cold wave, etc., may significantly affect the transport conditions no matter on ground, air or water, and subsequently the Group's supply chain and operation safety. In response to the above risks, the Group has formulated the "Emergency Management Measures" (《應急管理辦法》), organized the formulation of emergency response plans, and provided its management and drivers comprehensive training regularly on how to cope with emergencies and protect its personal and property safety and also pay close attention to the early warning notices issued by government meteorological departments and emergency management departments for extreme weather events and make corresponding business adjustments in coordination with them. The Group has also purchased insurance for its staff and assets to minimize or avoid property damage in the event of extreme weather affecting the Group's premises. Meanwhile, the Group maintains close communications with customers to ensure flexible and resilient transport solutions when Group's supply chain is affected.

Transition risks

Regulations and laws on environmental protection are also becoming more stringent. The PRC government has made a commitment to achieve carbon emission peak by 2030 and carbon neutral by 2060. The Group may be subject to the mandatory disclosure of its full scope of carbon emissions. In addition, the enactment of carbon pricing or carbon tax may also lead to the rise in price of raw materials or the replacement of more expensive alternatives. As these transition risks are potentially going to cause increasing operating cost and lower revenue, the Group is aware of the significance and urgency to pay particular attention decarbonizing its operations and to grasp the opportunity to master some new low-carbon technologies which can greatly enhance its competitive advantage and industry leading position. The Group has set energy saving and emission reduction targets in accordance with relevant national programs and implemented corresponding measures to reduce greenhouse gas emissions, integrating the transformation targets into its ESG strategies.

實體風險

暴風雨、洪水、熱浪、寒潮等極端 天氣事件發生頻率的增加可能極大 影響陸運、空運或水運等交通狀 況,進而影響本集團的供應鏈及營 運安全。為應對以上風險,本集團 已制定《應急管理辦法》,組織開 展應急預案編製工作, 定期為其管 理層及司機提供全面培訓,讓彼等 瞭解如何應對緊急情況,保護人身 財產安全,並積極關注政府氣象部 門及應急管理部門針對極端天氣事 件的預警通知,並配合其做相應業 務調整。本集團亦已為其員工及資 產購置保險,以在極端天氣影響本 集團經營場所時減少或避免財產損 失。同時,本集團與客戶保持密切 溝通,以確保在供應鏈受到影響時 提供靈活彈性的運輸解決方案。

轉型風險

對環境保護的監管與法律也越來越 嚴格。中國政府已經承諾於2030年 碳達峰,2060年碳中和。本集團可 能須遵守強制披露其全範圍碳排放 的規定。此外,碳定價或碳税行動 亦可能導致原材料價格上升或以更 昂貴的替代品代替。由於這些轉型 風險可能導致營運成本增加和收入 下降,本集團意識到低碳營運並抓 住機會掌握一些新型低碳技術的重 要性及緊迫性,此將大大提升其競 爭優勢和行業領先地位。本集團根 據國家相關的計劃制定了節能減排 目標,並實施相應措施以減少溫室 氣體排放量,將轉型目標融入其環 境、社會及管制策略中。

B. SOCIAL SUSTAINABILITY

The Group is committed to building a strong relationship with various stakeholders, and incorporating sustainable practices into our value chain. This section primarily discloses the Group's policy, practices and quantitative data regarding employment and labour practices, operating practices as well as community investment in 2023.

Employment and Labour Practices

The Group is committed to the empowerment and care for all, especially its employees. The Group believes that it has the responsibility to support and enhance the well-being of its employees and bring about positive shared value to them. To this end, the Group has been endeavouring to create a sound working environment, in which the OHS of employees, diversity and inclusion in the workplace, as well as the overall well-being of all its workers are respected and promoted.

Employment

The Group views talents as its most valuable assets and the key driving factor in ensuring the success and sustainable development of the Group. In 2023, the Group has 1,208 employees within the reporting scope (2022:1,265 on-the-job employees). More details can be found in Table 1 in "APPENDIX – PERFORMANCE TABLE".

B. 社會可持續性

本集團致力與各持份者建立穩建的關係,並在價值鏈中融入可持續發展實務。本節主要披露本集團在2023年有關僱傭及勞工常規、營運慣例以及社區投資的政策、慣例及量化數據。

僱傭及勞工常規

本集團致力向所有人(尤其是員工) 賦能並向彼等提供關懷。本集員團認為,其有責任支持及增進員工會 祉,並為彼等帶來積極的共同價值。為此,本集團一直致力營造良 好的工作環境,尊重及促進員可 戰業健康與安全、工作場所的多元 共融以及所有職工的整體福祉。

僱傭

本集團將人才視為最具價值的資產及獲得成功和可持續發展的主要驅動因素。於2023年,本集團於報告範圍內有1,208名僱員(2022年:1,265名在職僱員)。更多詳情載於「附錄一績效表」表1。

環境、社會與企業管治報告

The Group's human resources department is responsible for reviewing and updating relevant policies regularly in accordance with the latest laws and regulations. In 2023, the Group abided by the applicable laws and regulations in the PRC that were material to the Group's business, including but not limited to "Labour Law of the People's Republic of China" (《中華人民共和國勞動法》), "Labour Contract Law of the People's Republic of China" (《中華人民共和國勞動合同法》), "Employment Promotion Law of the People's Republic of China" (《中華人民共和國就業促進法》) and "Insurance Law of the People's Republic of China" (《中華人民共和國社會保險法》).

本集團的人力資源部門負責根據最新法律及法規定期審查及更新相關政策。於2023年,本集團遵守對本集團業務而言屬重大的中國適用法律及法規,包括但不限於《中華人民共和國勞動法》、《中華人民共和國勞動合同法》、《中華人民共和國就業促進法》及《中華人民共和國社會保險法》。

Recruitment and promotion

The Group has stated the labour and personnel system in its Employee Handbook (《真工手冊》), which specifies the detailed recruitment procedures and promotion requirements of the Group. To attract talents who are in sync with the core culture of the Group, the Group selects applicants through a rigorous selection process, including written examination of professional skills, comprehensive ability tests and supervisor interviews.

Besides, the Group has plans and budgets to conduct performance appraisals. Recognizing the employees who have demonstrated consistently strong performance and became the role models, the Group takes proactive initiatives to offer them management positions. Concerning the career growth of junior employees, the Group provides a clear career development path, offering promotion and pay raise for the outstanding employees who have served the Group for over three years.

招聘及晉升

本集團已於《員工手冊》列明勞動人 事制度,詳細規定本集團的招聘程 序及晉升要求。為吸引與本集團核 心文化契合的人才,本集團通過 格的甄選過程篩選求職者,包括專 業技能筆試、綜合能力測試和主管 面試。

此外,本集團已為開展績效評估制 定計劃及預算。對於表現持續優 秀、成為工作典範的員工,本集團 積極主動為其提供管理職位。本集 團為初級員工提供明確的職業發展 階梯,為效力本集團三年以上的優 秀員工提供晉升機會和加薪。

Compensation and dismissal

According to the Group's "salary management system", the salary composition is divided into monthly basic salary, monthly bonus and performance bonus. "Annual salary system" is implemented for the senior management, in which salary standards are approved by the Board. Meanwhile, a "job performance-based salary system" is implemented for middle-management and general employees, of which salaries are based on employees' performances and determined by the general manager. To motivate, reward, and recognize the existing employees who have made significant contributions to the Group, compensation reviews and salary adjustments are conducted regularly with reference to the overall market levels, inflation rate, profitability of the Group and employee's past performance.

Meanwhile, any termination of employment contract is strictly based on reasonable and lawful grounds according to the "labour and personnel system" of the Group, and relevant laws and regulations. The Group prohibits any kinds of unlawful or unreasonable dismissals. In 2023, the Group has a loss of 102 employees in total within the reporting scope, the employee turnover rate is approximately 8.44% (2022: a loss of 76 employees in total, the employee turnover rate is approximately 6.01%). More details about the employee turnover rate can be found in Table 2 in "APPENDIX – PERFORMANCE TABLE".

Working hours and rest periods

Reasonable working hours and rest periods are arranged for the employees of the Group in accordance with the "Regulations of the State Council on the Hours of Work of Employees" (《國務院關於職工工作時間的規定》). The Group details policies in relation to business trips, leave, compensation leave and overtime working through "Attendance Management Measures (Revised)"(《考勤管理辦法 (修訂)》). Overtime working is not encouraged by the Group, yet if employees need to work overtime to finish their tasks, corresponding compensation such as overtime pay or extra leave will be made. According to the "Detailed Implementation Rules of Leave" (《休假實施細則》), in addition to basic paid annual leave and statutory holidays stipulated by the local governments, employees are also entitled to additional leave benefits such as sick leave, marriage leave, maternity leave and compassionate leave.

賠償及解僱

同時,任何僱傭合約將嚴格依照本集團勞動人事制度及相關法律法規按合理和合法理由予以終止不合理團禁止任何形式的非法或不合理解僱。於2023年,本集團於報告範圍內共計流失102名僱員,流失率約為6.01%)。更多屬於僱員流失率的詳情載於「附錄一績效表」表2。

工作時數及休息時間

環境、社會與企業管治報告

Equal-opportunity, diversity and anti-discrimination

As an equal opportunity employer, the Group is dedicated to developing a diverse and inclusive workforce of engaged employees. The "guidance on professional conducts" in the Group's "Employee Handbook" (《員工手冊》) promotes anti-discrimination, diversity and equal opportunity in all human resources and employment decisions. Equal opportunity policies are formulated in accordance with the relevant laws and regulations. The human resources department is responsible for managing the relevant internal policies and monitoring the compliance with applicable laws and regulations, as well as addressing any incidences that arise.

The Group has zero tolerance for any form of discrimination which can hinder the Group's development by damaging its diverse teams and inclusive cultures. Training and promotion opportunities, dismissals and retirement policies are determined irrespective of employees' gender, race, age, disability, family status, marital status, sexual orientation, religion beliefs, nationality or any other non-job-related factors in all business units. Employees are encouraged to voice out and report any discrimination or harassment during work.

Benefits and welfare

The Group provides its employees with mandatory social insurance to support their quality of life in accordance with the relevant national laws and regulations. To enable its people to thrive in the workplace, the Group also strives to strengthen the sense of belonging of its employees by providing them with pension insurance, unemployment insurance, labour injury insurance, medical insurance, housing fund, housing subsidies, annual physical examination and special holidays subsidies.

In 2023, the Group distributed festive gifts to employees at important festivals such as the Spring Festival and the Midautumn Festival, and organized activities such as archery competition, writing Fu characters and sending Spring couplets and purchasing billiard cases, movie tickets to enrich the spare time of its employees.

平等機會、多元化及反歧視

福利及待遇

本集團根據國家相關法律法規為其 員工提供強制性社會保險員員高被制性社會。為讓員過 提高被手生活,本集團亦通過、工 提供養老保險、住房公積。 工提供醫療保險、住房公積。 保險、 管補貼、 年度體檢和特殊假期 等方式, 著力增強員工的歸屬感。

於2023年,本集團在春節、中秋 等重要節日,向員工發放節日慰問 品,組織射箭比賽、寫福字、送春 聯等活動,以及購買檯球案子、電 影票等,豐富其員工業餘生活。

Health and Safety

As a logistic business enterprise, keeping its employees safe is the highest priority and an ethical responsibility for the Group. In 2023, the Group was in compliance with relevant laws and regulations in relation to providing a safe working environment and protecting the employees from occupational hazards that have a significant impact on the Group, including but not limited to "Production Safety Law of the People's Republic of China" (《中華人民共和國安全生產法》), "Law of the People's Republic of China on Prevention and Control of Occupational Diseases" (《中華人民共和國職業病防治法》), "Regulations of Tianjin Municipality on Work Safety" (《天津市安全生產條例》), "Interim Provisions on the Investigation and Control of Safety Accidents (SAWS Order No. 16)" (《安全生產事故隱患排查治理暫行規 定》 (總局16號令)), "Guideline of China Occupational Safety and Health Management System"(《企業安全生產標準化基 本規範》) and "Regulation on Work-Related Injury Insurance" (《工傷保險條例》). In February 2023, the Group also prepared for the review of production safety standardization. During the review period, two rounds of inspection by the reassessment agency and the evaluation agency has been conducted and rectification completed. In November 2023, the Group obtained the certificate of production safety standardization (Level 2) issued by Tianjin Work Safety Management Association. Through the establishment of a "production safety responsibility system", the development of safety management methods, carrying out a "level-specific management and control system" and potential risks identification to strengthen the on-site standardization management and the standard, scientific, systematic and legal safety production of the Company. We set up and maintain the "safety production management system" to comprehensively control the safety production in all aspects of operational activities, and continuously improve the safety management level to further highlight our excellent performance in safety production.

健康與安全

作為物流企業,保障員工安全是本 集團的首要任務及道德責任。於 2023年,本集團遵守對本集團構成 重大影響的有關提供安全工作環境 及保障僱員免受職業危害的相關法 律法規,包括但不限於《中華人民共 和國安全生產法》、《中華人民共和 國職業病防治法》、《天津市安全生 產條例》、《安全生產事故隱患排查 治理暫行規定》(總局16號令)、《企 業安全生產標準化基本規範》及《工 傷保險條例》。本集團亦於2023年 2月準備安全生產標準化複審事宜, 複審期間經過複評機構和評審機構 共計二輪檢查,並完成整改後,同 年11月取得天津市安全生產管理協 會頒發的安全生產標準化(二級)證 書。通過建立安全生產責任制,制 定安全管理辦法, 開展風險分級管 控體系和隱患排查治理,持續加強 現場標準化管理,不斷規範本單位 安全生產工作的規範化、科學化、 系統化和法制化,建立並保持安全 生產管理體系,全面管控經營活動 各環節的安全生產工作,不斷提升 安全管理水平,以進一步證明我們 在安全生產方面的卓越表現。

環境、社會與企業管治報告

The Group formulates a comprehensive mechanism and stringent safety and labour practice standards, namely "occupational health management system" in "Employee Handbook" (《員工手冊》), to minimize the risk of accidents at workplace and enhance employees' health and safety awareness. We review relevant policies and the necessity of health and safety practices regularly to ensure continuous improvements of our health and safety standards. A 24-hour emergency hotline and the "Emergency Response Plan" (《突發事件應急預案》), which covers a wide range of incidents and calamities, are also set up to ensure the coordination among all functional departments in case of any emergencies.

Focusing on embedding a zero harm culture through proactive leadership, the Group establishes its internal health and safety management committee to protect the occupational safety of employees. The safety management committee formed by the managers of various departments is responsible for the prevention and control of occupational diseases, managing work-related health issues, organizing safety training courses and reporting to the directors of the Group regularly on occupational safety related issues. Meanwhile, the Group has obtained certification of ISO 45001 Occupational Health and Safety Management System, which showcases the Group's achievements in the aspects of occupational health and management.

To ensure the safety of workers during daily operations, the Group has established "Rules for the Screening and Elimination of Hidden Risks of Accidents"(《事故隱患排查治理辦法》), clarifying the forms, cycles, contents and standards that need to be in accordance with the screening of hidden risks. The Group has also established a series of standard operating procedures to provide guidance for safe operation in the business of logistics and warehousing services. For instance, water tanks, storage batteries, engine oil, fuel oil and tires of the vehicles are checked by the Group in advance every day to ensure that all vehicles are absolutely safe. Regular inspections and maintenance of vehicles for transportation are carried out on a weekly, monthly and quarterly basis. Through daily morning assemblies, the Group assesses its employees' physiological and mental state. In the meantime, to ensure the safe use of working trolleys and improve operation efficiency, clean paths are kept at both ends of the goods racks to maintain smooth passage between the working area and the storage area.

為保障員工於日常營運的安全,本 集團已設立《事故隱患排查治理辦 法》,明確排查隱患需遵守的形式、 週期、內容和標準。本集團亦於物 流倉儲服務業務中制定了一系列標 準操作流程,以指導安全作業。例 如,本集團每天提前檢查車輛的水 箱、蓄電池、機油、燃油及輪胎, 確保所有車輛安全無虞。本集團每 週、每月及每季度對運輸車輛進行 定期檢查及維護。透過每天的早晨 例會,本集團會評估僱員的生理及 心理狀態。同時,為了確保作業台 車使用安全並提高操作效率,貨架 的兩端設有清潔通道,保持作業區 與儲存區之間暢通。

Aiming to achieve an accident-free workplace, the Group has established "Safety Production System Management Measures" (《安全生產制度管理辦法》), and it is committed to continuing to upskill the managers to integrate critical control measures in business operations. The Group also conducts safety trainings for employees at least once a year through "Management Measures on Safety Education and Training" (《安全教育培訓管理辦法》), which are suitable for their positions, and organizes reviews on accident cases to enhance the safety awareness of employees and prevent accidents from happening. In the past three years, including 2023, the Group recorded zero work-related fatalities, so the percentage of work-related deaths was 0%. In 2023, the Group recorded 1 work-related injury case with 1 employee injured, causing 53 workdays lost (2022: 4 work-related injury cases with 4 employees injured, causing 397 workdays lost).

Development and Training

Facilitating its employees to thrive, the Group sees training as a strategic investment which benefits the mutual growth of employees as well as the Group itself. To this end, the Group has established "Recruitment and Employment Management Measures (Trial)"(《培訓管理辦法 (試行)》), which details training contents and forms, and provides guidance for each department to conduct training activities effectively. The human resources department is the originator of the training, other departments are responsible for assisting the human resources department to implement the training programme.

The Group's training system is divided into pre-job training, skill training, special training and external training. Normally, a complete induction training (introducing the corporate culture, organizational structure and knowledge related to OHS) is provided to the new hires, while non-scheduled profession-oriented courses are offered to the experienced employees according to corporate and individual needs. To further enhance the professional skills of its employees and meet the Group's development goal, employees are highly motivated to attend external training courses and take professional qualification examinations. The training results will be included in the training file of each employee as important evidence for employee performance assessment, formal employment, promotion etc.

為儘量實現零意外的工作場所,本 集團已設立《安全生產制度管理辦 法》,其致力於持續提高管理人員的 技能,將關鍵控制措施融入業務營 運。本集團亦通過《安全教育培訓管 理辦法》每年至少一次對員工進行與 其從事崗位相適應的安全培訓,並 組織事故案例回顧,以提高僱員的 安全意識,預防事故發生。於包括 2023年在內的過去三年內,本集團 錄得0宗因工死亡個案,故因工亡 故的比率為0%。於2023年,本集 團錄得1宗工傷個案,其中1名員工 受傷,造成53個工作日損失(2022 年:4宗工傷個案,其中4名員工受 傷,造成397個工作日損失)。

發展及培訓

為促進員工茁壯成長,本集團視培訓為一項利於員工與本集團共同到於員工與本集團共團的策略性投資。為此,本集團可建立《培訓管理辦法(試行)》,指導各部門高效培訓活動。人力資源部門為協助人力資源部門實施培訓方案。

環境、社會與企業管治報告

In 2023, a total of 199 employees of the Group received 2,408.5 hours of training (2022: 216 employees, 4,305 hours of training), including but not limited to courses of induction training, promotion training, quality control training, health and safety training and systems management training. There was a decrease in the number of trained employees and training hours in 2023 as compared to 2022. More details regarding the employees receiving training can be found in Table 3 in "APPENDIX – PERFORMANCE TABLE".

Labour Standards

The Group has zero tolerance to the illegal employment of child labour, underage workers and forced labour. In 2023, the Group was in compliance with applicable laws and regulations in relation to the prevention of child and forced labour that have a significant impact on the Group, including but not limited to "Labour Law of the People's Republic of China" (《中華人民共和國勞動法》) and "Provisions on the Prohibition of Using Child Labour" (《禁止使用童工規定》).

According to its internal policies, the human resources department is responsible for requiring all job applicants to provide valid identity documents to ensure that they are lawfully employable prior to confirmation of any employment. The human resources department is also responsible for maintaining and reviewing the employee records. To avoid any violation of the labour standards and protect employees' legal rights and interests, the Group's employees strictly regulate practices in relation to working hours and rest periods. More details can be found in the section headed "Employment – Working hours and rest periods" above. Once the Group identifies any case which violates the relevant labour laws, regulations or standards, the relevant employment contract will be terminated at once and the relevant employees responsible for the management of human resources will be disciplined accordingly.

於2023年,本集團共199名僱員接 受2,408.5小時培訓(2022年:216 名僱員,4,305小時培訓),包括但 不限於入職培訓、晉升培訓、恆質 控制培訓、健康與安全培訓以及及 理制度培訓,2023年培訓人數及時 長較2022年減少。有關僱員接受培 訓的更多詳情載於「附錄一績效表」 表3。

勞工準則

本集團對非法僱用童工、未成年工人及強制勞工採取零容忍態度。於2023年,本集團遵守對本集團構成重大影響的有關禁止童工及強制勞工的適用法律及法規,包括但不限於《中華人民共和國勞動法》及《禁止使用童工規定》。

Operating Practices

Supply Chain Management

The Group collaborates with a wide range of suppliers and purchases products including vehicles and its parts, as well as raw materials for steel production and frozen meat. The Group recognizes that its procurement decisions can cause significant environmental and social impacts, therefore the Group strives to uphold its high standards of business conduct along its supply chain. The Group mainly maintains stable, secure and effective partnership with suppliers by strictly aligning them with the Group's "Supplier Conduct Code" (《供應商行為準則》). This code provides clear guidance about the Group's commitments and expectations on sustainability, including the respect for human rights especially for their employees and the compliance with local environmental protection laws and regulations.

The Group has established "Procurement Management Measures"(《採購管理辦法》), in which the designated personnel take responsibility for procurement, and the principles, ways and procedures are standardized to ensure the normal supply of materials and services. The Group's general office selects based on the result of the Preliminary Investigation Report of each candidate's suppliers prepared by the Operation Department. listing the potential partners' basic business information, licences, operational and financial performances, as well as the involved non-compliance or legal cases. Besides, the Group has a qualified supplier list that will be reviewed annually against four main aspects, namely regulatory compliance, employee rights, health and safety and environmental protection, to ensure all suppliers' performances meet the Group's standards. In promotion of green and sustainable procurement practices, the Group prioritizes goods with origins that are conforming to the international production safety standards during procurement, while putting the collaboration with suppliers with green and ecofriendly awareness in the first place during suppliers selection.

營運慣例

供應鏈管理

本集團已設立《採購管理辦法》, 由專人負責採購事宜,規範採購原 則、方式及程序,確保物資與服務 的正常供應。本集團綜合辦公室根 據營運部編製的每位候選供應商的 初步調查報告結果進行篩選,列出 潛在合作夥伴的基本業務資料、執 照、經營和財務業績,以及所涉及 的不合規或法律案件。另外,本集 團備有合資格供應商名單,每年通 過四個主要方面檢討該名單,即監 管合規、僱員權利、健康與安全以 及環境保護,以確保所有供應商的 表現符合本集團的標準。在推動綠 色可持續採購工作的過程中,本集 團於採購時優先選擇原產地符合國 際安全生產標準的貨物,並於篩選 供應商時優先考慮與具有綠色環保 意識的供應商合作。

環境、社會與企業管治報告

To manage the potential environmental and social risks along the supply chain, the Group implements a differentiated management strategy for its suppliers to identify their latent risks and ensure they operate in accordance with the "Supplier Code Conduct" (《供應商行為準則》). In particular, a detailed list of risk and prevention and control measures are constructed in managing the potential significant risks of the cold chain logistic business from three perspectives: procurement, storage and sales. In the meantime, audits and evaluations are conducted by the Group's legal department jointly with the finance department to ensure no illegal activities are involved in the partnership. Information of suppliers who provide products or services to the Group is reviewed regularly to monitor the effectiveness of the "Supplier Code Conduct".

The Group maintained a stable business relationship with all its suppliers. In 2023, the Group has 119 suppliers totally, of which 112 suppliers from the PRC, 7 suppliers from Hong Kong (2022: 113 suppliers in the PRC), representing an increase as compared to 2022, to which the aforementioned suppliers' management policies are applied.

To keep up the stable communication with its suppliers, the Group signs the memorandum with its suppliers and actively communicates with them through digital means such as phone calls, emails, instant messages and video conference. Meanwhile, regular on-site visits are also conducted by the operation department for more efficient communication.

Product Responsibility

As a national 5A-level integrated service logistics company, the Group has been invariably committed to providing its customers with people-oriented, tailor-made and professional services. The Group has formulated relevant policies, kept reviewing its services and making corresponding improvements from the ESG perspectives, which allows the Group to refine its operations on a continuous basis and serve its customers politely and compliantly in compliance with the strict regulations in various national jurisdictions.

本集團與其所有供應商保持穩定的 業務關係。2023年本集團供應商 數目共計有119名供應商,當中有 112名來自中國內地,7名來自中國 香港(2022年:113名中國內地供 應商),較2022年增加。本集團已 對該等供應商實施上述供應商管理 政策。

為保持與供應商的穩定溝通,本集 團與供應商簽訂備忘錄,並通過電 話、電子郵件、短信及視頻會議等 數字工具積極與供應商溝通。同 時,營運部亦定期進行實地考察, 以提高溝通效率。

產品責任

作為國家5A級綜合服務物流企業, 本集團始終致力於為其客戶提供務 人為本、量身定制的專業服務 境、社會及管治角色審視自 療,並作出相應改善,藉以持 務,並作出相應改善,藉以 持 養業務,以 禮貌、 合規 方 司 法權 區 的 嚴格 法規。

Adhering to the reporting principle of materiality, policies and approaches regarding product recalls, advertising and labelling, which are not material to the Group given its business nature, are not disclosed in this section. In 2023, the Group was in compliance with the relevant laws and regulations regarding health and safety, advertising, intellectual property, labelling and privacy matters of its products and services that are material to the Group, including but not limited to "Law of the People's Republic of China on Protection of Consumer Rights and Interests" (《中華人民共和國消費者權益保護法》) and "Advertising Law of the People's Republic of China" (《中華人民共和國廣告法》).

Quality of Service

In order to enhance the safety and high quality of its logistics and warehouse services during operations and aftersales, all logistics and warehousing work before the official delivery to end customers must be operated by designated supporting service providers approved by the management. The Group upholds the concept of precautionary principle during its daily operations, with the potential risks prejudged beforehand, whole process supervision during projects and the active review afterwards as its main responsibility concepts. The Group has obtained the certification of ISO9001 Quality Management System. The Group mainly provides services and does not manufacture goods. In 2023, the Group did not have any recalls due to safety and health related matters (2022: no recalls).

In order to maintain stable service quality, the Group actively explores multiple logistics solutions such as railway, road and searail combined transportation etc. to preserve the continuous supply of goods. Meanwhile, the Group also expands the diversity of its supplier-client network and explores a new supply chain model with the adaptation of digital storage technologies in response to the fast-changing market demand.

服務質量

為保持穩定的服務質量,本集團積極探索鐵路、公路、海鐵聯運等多種物流解決方案,保障貨物的持續 供應。同時,本集團亦擴大供應的與客戶網絡的多元化,探索採用數字存儲技術的新型供應鏈模式,應對瞬息萬變的市場需求。

Transportation and Safety of Storage

To track the location of vehicles and goods in real time, the Group has built the monitoring system and cargo tracking system, which enables the Group to have timely access to the status of cargo transportation. To ensure the safety of goods during transportation, dash cams are set up to inspect and record the condition of the transporting vehicles, while devices are adopted to prevent accidents such as the dropout of head and trailer as well as forgetting to close the flying wing.

To ensure the safety and strengthen the security of goods, an all-day security inspection system is established within the warehouse area, while special inspections are carried out on a quarterly basis. More than 60 sets of cameras and ancillary equipment were installed and renewed to ensure that all areas in the general bonded warehouse of the Group are under surveillance. To ensure the safety of goods in the warehouse, written documents such as packing list and inspection report of the goods are required and strictly regulated by the Group. Unpacking inspections are performed as well to identify and manage any incoming goods with hazardous substances.

Complaints

Dedicating to its customer service optimization, the Group values customer feedback and formulates a series of customer service management systems and maintains continuous dialogues with its customers. Once any substantiated complaint is received, specific departments of the Group are responsible for dealing with the case and responding to the customer with clear plans for product return, exchange or compensation in a timely manner. In 2023, the Group did not receive any substantial complaints about the service quality (2022: no complaints), and the customer satisfaction remained at a high level according to the results of customer surveys.

Privacy Matters

It is crucial for the Group to safeguard the security of its business data and the privacy of its customers to prevent any potential losses. Striving to protect all sensitive data, the Group abides by the relevant laws and regulations such as the "Law of the People's Republic of China on Protection of Consumer Rights and Interests"(《中華人民共和國消費者權益保護法》). The information management department formulates and monitors the implementation of the strict policies to safeguard clients' privacy and the internal information of the Group. A network data centre is established to ensure the cyber security of the Group. while risk management and technical incident recovery plans are developed to protect personal data and mitigate losses in case of any accidents. Meanwhile, a confidentially agreement is normally signed with relevant parties for business that ensures no disclosure of any sensitive data to the third-party without authorization.

Intellectual Property Rights

In order to prevent infringement, the Group has established the "Software Legalization Responsibility System" (《軟件正版化工作責任制度》). Employees shall sign the "Letter of Commitment to Use the Legitimate Software" (《使用正版軟件承諾書》) for using the software, strictly abide by the relevant regulations regarding the software legalization, and shall not install or uninstall the software on the computer without permission. The corresponding punishment shall be given according to the circumstances if an employee is found to be using pirated software.

為防止侵權,本集團已建立《軟件正版化工作責任制度》。使用軟件的員工應簽署《使用正版軟件承諾書》,嚴格遵守軟件正版化工作相關規定,不得私自在電腦上安裝或卸載軟件。若發現員工使用盜版軟件,視情節給予相應懲罰。

Anti-corruption

The Group believes that the continued success of a business is built on the stakeholders' trust and confidence. To conduct its business with the highest standards of ethics and integrity, the Group strictly adheres to the local laws and regulations relating to bribery, extortion, fraud and money laundering which have a material impact on the Group, including but not limited to "Anti-Corruption Law of the People's Republic of China" (《中華人民 共和國反腐敗法》), "Anti-money Laundering Law of the People's Republic of China" (《中華人民共和國反洗錢法》), "Interim Provisions on Banning Commercial Bribery" (《關於禁止商業 賄賂行為的暫行規定》). "Anti-Unfair Competition Law of the People's Republic of China" (《中華人民共和國反不正當競爭 法》), "Prevention of Bribery Ordinance" (Cap. 201 of the Laws of Hong Kong) and "Anti-Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance" (Cap. 615 of the Laws of Hong Kong).

In 2023, the Group had no concluded legal cases regarding corrupt practices brought against the Group or its employees (2022: no cases).

The Group strictly regulates its business processes and employee behaviour based on the code of conduct as clearly listed in its "Employee Handbook" (《員工手冊》). The Business Department is responsible for conducting risk prevention measures including monthly self-inspection, legal and financial control of all business units involved in lawsuits and the use of funds to prevent any suspicious deals or transactions. Meanwhile, the Group sets up a "Whistleblowing System" (《舉報制度》) and assigns specific discipline employees for the investigation and handling of suspected activities. Employees can report directly to their supervisors or the discipline employees, who will then investigate and verify the related evidence and report to the Group's discipline department and the management. Where any crime is substantiated by the Group, a report will be submitted promptly to relevant regulators or law enforcement authorities when the management considers it necessary. To monitor the effectiveness of the whistleblowing policy, all complaints are reviewed regularly to identify any pattern of alleged improprieties that need to be addressed.

To raise their awareness on business ethics from time to time, the Group organizes training activities at least once a year for its employees, and arranges them to learn and refresh their memories on the national anti-corruption policies and the Group's internal code of conduct. The Company also developed an integrity risk prevention and control handbook in 2023 and made a presentation of it to all. In 2023, 66 employees of the Group received a total of approximately 86 hours of anti-corruption training, including but not limited to learning about the discipline ordinance and watching anti-corruption warnings and records on videos.

Community

Community Investment

As a good corporate citizen, the Group still focuses on its support of the local communities as this is an important part of its social license to operate. The Group has formulated the "Social Welfare Management Policy" (《社會公益事業管理政策》) to focus on the poverty alleviation of the local population and the building of capacity of local communities. As such, the Group's support came in the form of creating local job opportunities and prioritizing local suppliers in 2023. Meanwhile, the Group attaches great importance to fostering a sense of social responsibility among its employees and encouraging them to better serve the community both in work and their personal time. We actively seek opportunities to focus on supporting the local community.

In 2023, the Group has been committed to fulfilling its social responsibilities. Looking forward, the Group will keep its original intention and mission in mind, and will be committed to carrying out more charitable activities which align with its philosophy.

A training was provided for each new Director of the Company after his/her appointment, to ensure he/she would understand the operation and business of the Group and be fully aware of his/her responsibilities and obligations as a Director. During the reporting year, the newly appointed Directors Ms. Sun Jing and Ms. Meng Jun had obtained the legal advice referred to in Rule 5.02D of the GEM Listing Rules on 15 May 2023 and 4 July 2023 respectively, and confirmed that they understood their obligations as a director of the Company. The Group provides briefings and seminars to all Directors, so as to enhance his/her awareness of the relevant GEM Listing Rules and other applicable regulatory requirements as well as the latest developments in the business of the Group. During the reporting year, the Directors complied with Code Provision A.6.5 in the following ways:

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The Company has complied with the code provisions in the Corporate Governance Code as set out in Part 2 of Appendix 15 (renamed as Appendix C1 since 31 December 2023) of the GEM Listing Rules. Pursuant to the Code Provision C.2.1, the roles of the chairman of the Board (the "Chairman") and the chief executive should be separate and should not be performed by the same individual. The division of responsibilities between the Chairman and the chief executive should be clearly established and set out in writing.

Except for the following deviation:

At the fourth meeting of the fourth session of the Board of the Company held on 20 March 2018, Mr. Yang Weihong was appointed as the president (the "President", equivalent to the "chief executive") of the Company, and at the 2017 annual general meeting of the Company convened on 11 May 2018, he was elected as an executive director of the Company and appointed as the Chairman.

At the 2019 annual general meeting of the Company convened on 19 June 2020 and the 2022 annual general meeting of the Company convened on 12 May 2023, Mr. Yang Weihong was re-elected as an executive Director of the fifth and sixth session of the Board of the Company and appointed as the Chairman respectively.

As a result, from 11 May 2018 to 13 July 2023, the roles of Chairman and President were assumed by Mr. Yang Weihong.

The Board has been continuously reviewing the effectiveness of the corporate governance structure of the Group, and identifying suitable candidates according to the needs of business development of the Company. At the fourth (temporary) meeting of the sixth session of the Board of the Company held on 13 July 2023, Mr. Yang Weihong resigned as the general manager of the Company due to work arrangements, and Ms. Ma Xin was appointed as the deputy general manager (presiding work) of the Company at the fourth (temporary) meeting of the sixth session of the Board of the Company convened on the same date. Her position is equivalent to that of chief executive. On 25 January 2024, Ms. Ma Xin was appointed as the general manager of the Company, which position is equivalent to that of chief executive. Mr. Yang Weihong remains the executive Director and Chairman of the Board. Accordingly, the Company has complied with the requirements of code provision C.2.1.

TERM OF OFFICE AND RE-ELECTION

The terms of office of the Directors of the Company (including independent non-executive Directors) are three years. All current Directors will hold office until the expiry of the sixth session of the Board. The Directors shall retire upon expiry of their terms of office and shall be eligible for re-election.

THE COMMITTEES OF THE BOARD

Each of the audit committee, remuneration committee and nomination committee of the Company has specific terms of reference in place, with the authorities and responsibilities of each committee clearly defined which have been published on the websites of the Stock Exchange and the Company.

(1) Audit committee

The Company has set up an audit committee pursuant to the requirements under Rule 5.28 of the GEM Listing Rules and the "Guidelines for the Establishment of Audit Committees" prepared by the Hong Kong Institute of Certified Public Accountants, and its duties and responsibilities have been properly laid down in writing under the requirements of Rule 5.29 of the GEM Listing Rules. The audit committee currently comprises Prof. Cheng Xinsheng (chairman), Mr. He Yongjun and Prof. Japhet Sebastian Law (all being independent non-executive Directors), among which Prof. Cheng Xinsheng has the relevant professional qualification and financial experience. The members of the audit committee convene meetings regularly with the management and external auditors and review the internal audit report and the quarterly, interim and annual results of the Group. The audit committee reviewed the audited financial statements for the year ended 31 December 2023 and recommended approval to the Board. In 2023, the audit committee held a total of four meetings to review the financial information and the risk management and internal control system etc. of the Company. For the year ended 31 December 2023, the Company complied with the requirements of Rule 5.28 of the GEM Listing Rules in respect of the audit committee.

(1) 審核委員會

本公司已根據GEM 上市規則第5.28 條之規定及香港會計師公會編撰之 「成立審核委員會指引」成立審核委 員會, 遵照GEM 上市規則第5.29 條之規定書面列明其職權及職責。 審核委員會現由獨立非執行董事程 新生教授(主席)、何勇軍先生及羅 文鈺教授組成,其中程新生教授具 備合適的專業資格和財務經驗。審 核委員會成員定期與管理人員及外 聘核數師舉行會議,並審閱本集團 內部審核報告以及季度、半年度及 年度業績。審核委員會已審閱截至 2023年12月31日止年度的經審 核財務報表,並建議董事會採納。 於2023年,審核委員會共舉行4次 會議,審閱本公司之財務資料、檢 討本公司風險管理及內部監控系統 等。 截至2023年12月31日止年 度,本公司一直符合GEM上市規則 第5.28條關於審核委員會的規定。

(2) Remuneration committee

The Company has set up a remuneration committee in accordance with the requirements of Rule 5.34 of the GEM Listing Rules and its duties and responsibilities have been properly laid down in writing under the requirements of Rule 5.35 of the GEM Listing Rules. The remuneration committee currently comprises Prof. Japhet Sebastian Law (Chairman), Prof. Cheng Xinsheng and Mr. Peng Zuowen (all being independent non-executive Directors). The remuneration committee is mainly responsible for making recommendations to the Board on the remuneration policy and structure for all Directors. supervisors and senior management of the Company and on the establishment of a formal and transparent procedure for developing remuneration policy, reviewing and approving the management's remuneration proposals with reference to the Board's corporate goals and objectives, and making recommendations to the Board on the remuneration packages (which include benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment) of individual executive Directors and senior management. In 2023, the remuneration committee held six meetings to review the remuneration of Directors, supervisors and senior management of the Company, the withdrawal of annual performance-based bonus of the Company, administrative measures for the remuneration of all management officers and the total annual remuneration of the all management officers, and the performance-managed methods for managers appointment of the Company and the targets responsibility letter, and recommend to the Board. For the year ended 31 December 2023, the Company has complied with the requirements of Rule 5.34 of the GEM Listing Rules in respect of the remuneration committee.

(2) 薪酬委員會

本公司已根據GEM 上市規則第5.34 條之規定成立薪酬委員會,遵照 GEM上市規則第5.35條之規定書 面列明其職權及職責。薪酬委員會 現由獨立非執行董事羅文鈺教授(主 席)、程新生教授及彭作文先生組 成。薪酬委員會主要負責就本公司 董事、監事及高級管理人員之全體 薪酬政策及架構,及就設立正規而 具透明度的程序制訂薪酬政策向董 事會提出建議,參照董事會所訂企 業方針及目標而檢討及批准管理層 的薪酬建議,向董事會建議個別執 行董事及高級管理人員的薪酬待遇 (包括非金錢利益、退休金權利及賠 償金額(包括喪失或終止職務或委任 的賠償))等工作。於2023年,薪酬 委員會共舉行6次會議,並對本公 司董事、監事及高級管理人員之薪 酬,公司年度績效獎勵金提取、公 司企業負責人薪酬管理辦法及企業 負責人年薪總量,以及公司聘任制 經理層績效管理辦法及目標責任書 進行審議並向董事會提出建議。截 至2023年12月31日止年度,本公 司一直符合 GEM 上市規則第5.34 條 關於薪酬委員會的規定。

(3) Nomination committee

The Company has also set up a nomination committee which is responsible for reviewing the structure, size and composition of the Board and making recommendations on any proposed changes to the Board to complement the Company's corporate strategy, identifying individuals suitably qualified as a director or member and selecting or making recommendations to the Board on the selection of individuals nominated for directorships, assessing the independence of independent non-executive Directors and making recommendations to the Board on the appointment, re-appointment and succession of Directors. The nomination committee currently comprises three members. with Mr. Yang Weihong (Chairman) being the chairman and Prof. Japhet Sebastian Law and Mr. Peng Zuowen being the members. Mr. Yang Weihong is the executive Director of the Company, and the other members of the nomination committee are independent non-executive Directors of the Company. In 2023, the nomination committee held two meetings to review the Board of the Company for the year 2023 and execute the provisions on the nomination of the Directors under the Articles and the policies, procedures and criteria of the "Procedures for Shareholders to Propose a Person for Election as a Director (《股 東提名人選參選董事的程序》)".

After the resignation of Ms. Peng Bo on 15 September 2022, all the members on the Board of the Company are male members, therefore the Company failed to comply with the requirements set out in the Rule 17.104 of the GEM Listing Rules. Accordingly, the Company has been identifying female candidate who was suitable to qualify as director or member to meet the gender diversity requirements of the Board.

(3) 提名委員會

董事會亦成立提名委員會,負責檢 討董事會的架構、人員及構成並就 任何配合公司策略而擬對董事會作 出的變動提出建議,物色具備合適 資格可擔任董事或成員的人士並挑 選或提名有關人士出任董事或就此 向董事會提供意見,評核獨立非執 行董事的獨立性,以及負責就董事 委任、重新委任及繼任等事宜向董 事會提出建議。提名委員會現有三 名成員,主席楊衛紅先生(主席), 委員為羅文鈺教授及彭作文先生。 楊衛紅先生為本公司執行董事,而 其他提名委員會成員為本公司獨立 非執行董事。於2023年,提名委員 會舉行2次會議,審視公司2023年 度董事會,並執行本公司章程中關 於董事提名的規定以及《股東提名人 選參選董事的程序》等政策、程序及 準則。

於2022年9月15日彭渤女士辭任後,本公司董事會成員全部為男性成員,因此本公司未能符合GEM上市規則第17.104條所載規定。故此,本公司一直在物色具備合適資格可擔任董事或成員的女性人士,以滿足董事會性別多元化的要求。

The Company appointed 2 new directors in 2023, namely Ms. Sun Jing and Ms. Meng Jun. The nomination committee's involvement process and its considerations are as follow:

- 1. The nomination committee learned from industry research that Ms. Sun Jing has extensive experience in asset management, project investment and believed that Ms. Sun Jing's skills and knowledge can complement the professional background of the composition of the Board in these areas. This could bring a new perspective to the business development of the Company and enhance the diversity of the Board.
- 2. Mr. Jo Shibin resigned as a non-executive director of the Company on 21 June 2023. According to the recommendation of Chia Tai Company, a shareholder of the Company, Ms. Meng Jun was recommended as candidate of non-executive Director of the Company. The nomination committee has considered the unique experience and backgrounds of Ms. Meng Jun in areas of project investment, financial and corporation management in accordance with the Company's business needs, and considers that she is qualified to serve as non-executive Director of the Company.

Further, the addition of Ms. Sun Jing and Ms. Meng Jun will increase the proportion of female members on the Board, increase the number of Directors under the age of 50 and increase the proportion of Directors with a term of 0-3 years, which are in line with the board diversity policy of the Company.

此外,孫靜女士和孟雋女士的加入 將提高董事會女性成員佔比,增加 50歲以下年齡組董事的人數,增加 0-3年任期董事的比重,符合本公司 董事會多元化政策。

The Board has adopted a nomination policy (the "Nomination Policy") on 26 March 2019, which sets out the selection criteria and procedure when considering candidates to be appointed or re-appointed as a Director. The nomination committee shall consider the following criteria in evaluating and selecting candidates for directorship:

- 1. Character and integrity;
- Qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy;
- 3. Willingness to devote adequate time to discharge duties as a member of the Board;
- 4. Board diversity policy and any measurable objectives adopted for achieving diversity on the Board;
- Requirement for the Board to have independent directors in accordance with the GEM Listing Rules applicable to the Company and whether the candidates would be considered independent with reference to the independence guidelines set out in the GEM Listing Rules; and
- 6. Other views that are appropriate to the Company's business or as suggested by the Board.

董事會於2019年3月26日已採納一項提名政策(「提名政策」),其載列在考慮委任或重新委任為董事的候選人時應採用的標準和程序。提名委員會在評估及甄選董事職能候選人時,應考慮以下準則:

- 1. 品格和誠信;
- 資格,包括與本公司業務和企業戰略相關的專業資格、技能、知識和經驗;
- 3. 作為董事會成員,願意投入足 夠的時間履行職責;
- 董事會多元化政策以及為實現 董事會多元化而採取的任何可 計量的目標;
- 5. 要求董事會根據適用於本公司 的 GEM 上市規則設立獨立董 事,以及參考 GEM 上市規則 載列獨立指引以考慮候選人是 否被視為獨立董事;及
- 6. 適用於本公司業務或董事會建 議的其他觀點。

The procedure of nomination by the nomination committee is summarised as follows:

- The nomination committee reviews the structure, size and composition (including the skills, knowledge and experience) of the Board periodically and make recommendation on any proposed changes to the Board to complement the Company's corporate strategy;
- When it is necessary to fill a casual vacancy or appoint an additional Director, the nomination committee identifies or selects candidates as recommended to it, with or without assistance from external agencies or the Company, pursuant to the criteria set out above;
- If the process yields one or more desirable candidates, the nomination committee shall rank them by order of preference based on the needs of the Company and reference check of each candidate (where applicable);
- 4. The nomination committee makes recommendation to the Board including the terms and conditions of the appointment; and
- The Board deliberates and decides on the appointment based upon the recommendation of the nomination committee.

- 當需要填補臨時空缺或委任額 外董事時,提名委員會根據以 上的準則,在有或沒有外部機 構或本公司協助的情況下,識 別或選擇已向彼推薦的候選 人;
- 3. 如果該流程產生一個或多個理想的候選人,提名委員會應根據本公司的需要及每個候選人的參考檢查(如適用)按優先順序對其進行排名:
- 4. 提名委員會向董事會提出建 議,包括委任的條款及條件; 及
- 董事會根據提名委員會的建議 審議並決定任命。

The procedure of re-appointment of Director at general meeting is summarised as follows:

- In accordance with the Articles, every Director shall be subject to retirement by rotation at least once every three years and shall be eligible for re-election at the shareholders' general meeting;
- 2. The nomination committee shall review the overall contribution and service to the Company of the retiring Director. The nomination committee shall also review the expertise and professional qualifications of the retiring Director, who offered himself/herself for re-appointment at the shareholders' general meeting, to determine whether such Director continues to meet the criteria as set out above; and
- 3. Based on the review made by nomination committee, the Board shall make recommendations to shareholders on candidates standing for reappointment at the shareholders' general meeting of the Company, and provide the available biographical information of the retiring Director in accordance with the GEM Listing Rules to enable shareholders to make the informed decision on the reappointment of such candidates at shareholders' general meeting of the Company.

According to the Articles, shareholders who individually or in aggregate holding 5% or more of the total number of voting shares issued by the Company may make a written proposal to the shareholders' general meeting to nominate the candidates for the Board, but the number of the candidates shall comply with the Articles and shall not exceed the number of candidates to be selected.

The Board will from time to time review the Nomination Policy and monitor its implementation to ensure its continued effectiveness and compliance with regulatory requirements and good corporate governance practice.

在股東大會上重新委任董事程序概 述如下:

- 根據公司章程,每名董事須最少每三年輪值退任一次,並有資格於股東大會上膺選連任;
- 2. 提名委員會應審閱退任董事對本公司的整體貢獻及服務。提名委員會亦須檢討退任董事的專業知識及專業資格,並在股東大會上膺選連任,以確定該董事是否繼續符合以上的準則;及
- 3. 根據提名委員會的審閱,董事會應就本公司股東大會上重新委任的候選人向股東提出建議,並根據GEM上市規則的規定,提供退任董事的履歷資料,使股東能夠在本公司股東週年大會上就重新委任候選人作出知情決定。

根據公司章程,單獨持有或合併持 有本公司發行在外的有表決權股份 總數百分之五以上的股東可以 面提案方式向股東大會提出 實理人,但提名的人數必須符合 與 司章程的規定,並且不得多於擬選 人數。


董事會將不時檢討及監察提名政策 之實施,以確保政策行之有效並遵 照監管規定及良好企業管治實務。

BOARD DIVERSITY POLICY

In order to enhance the efficiency of the Board and corporate governance, the Company considers diversity at the Board level as an important element to maintain a competitive advantage. In accordance with the Corporate Governance Code, the Board adopted a board diversity policy (the "Board Diversity Policy") on 10 May 2019. The Company's Board Diversity Policy will have significant benefits in enhancing the performance of the Company. Under the Board Diversity Policy, selection to the Board will be based on a range of diversity areas, including but not limited to age, cultural and educational background, ethnicity, professional experience, skills and knowledge. All appointments to the Board will be made on the basis of merit and the benefits of diversity on the Board will be objectively taken into account when considering candidates. During the year ended 31 December 2023, there are two female members on the Board of the Company. The following chart shows the the profile of diversity on the Board as at 31 December 2023:

董事會多元化政策

為提升董事會的效率及企業管治,本公司 視於董事會層面的多元化為維持競爭優勢 的重要元素。根據企業管治守則,董事會 於2019年5月10日採納董事會多元化政 策(「董事會多元化政策」)。本公司之董 事會多元化政策將對提升本公司的表現益 處良多。根據董事會多元化政策,甄選董 事會人選將按一系列多元化範疇為基準, 包括但不限於年齡、文化及教育背景、種 族、專業經驗、技能及知識。董事會所有 委任均以用人唯才為原則,並在考慮人 選時客觀地顧及董事會成員多元化的益 處。截至2023年12月31日止年度,本 公司董事會有兩位女性成員,下圖顯示於 2023年12月31日董事會成員多元化的 概況:



For the year ended 31 December 2023, the Group's workforce generally follows a diversity philosophy that includes gender diversity. The gender composition of the Group's workforce is set out in the Environmental, Social and Governance Report. As at the date of this report, over 20% of the Group's employees are female and two of the three senior management of the Company are female. As the Company already has a higher proportion of females in the same industry, the Company plans to maintain the same level of female representation over the next three years or increase female representation where appropriate.

LIABILITY INSURANCE FOR DIRECTORS AND SENIOR MANAGEMENT

The Company has arranged appropriate liability insurance coverage for the Directors and senior management since May 2023.

SUPERVISORY COMMITTEE

As at 31 December 2023, the supervisory committee comprised six members, of whom three are shareholder representative supervisors and three are employee representative supervisors. The responsibility of the supervisory committee is to monitor the Board and its members and senior management so as to protect the interests of the shareholders. In 2023, the supervisory committee had monitored the financial position and the legal compliance of the operations of the Company and has conducted due diligence review of the senior management by convening meetings of supervisory committee and attending Board meetings and general meetings. It has duly performed its duties in a detailed and prudent manner.

截至2023年12月31日止年度,本集團 之員工普遍遵循包括性別多元化在內之多 元化理念。環境、社會及管治報告中載有 本集團的員工性別構成。於本報告日期, 超過20%的本集團員工為女性,而在本 公司3位高級管理人員中,有2名是女 性。由於本公司在相同行業中已有較高的 女性比例,本公司計劃在未來三年保持同 樣水平的女性比例,或在適當時候增加女 性代表。

董事及高級管理人員之責任保險

本公司已於2023年5月起為董事及高級 管理人員投購合適董事及高級管理人員責 任保險。

監事會

於2023年12月31日,監事會由6名成員組成,其中3名為股東代表監事,3名為僱員代表監事。監事會負責監察董事會及其成員與高級管理人員,以保障股東的利益。於2023年,監事會已監督本公司的財務狀況及業務的合法性,並透過召開監事會會議及出席董事會會議與股東大會,對高級管理人員進行盡職審查,按審慎的原則仔細周詳地履行職責。

INTERNAL CONTROL

Internal control and risk management

The Board has overall responsibility for the establishment, maintenance and review of the Group's internal control system to safeguard shareholder investments and the assets of the Group. The internal control system of the Group aims to facilitate effective and efficient management which in turn minimizes the risks to which the Group is exposed. The system can only provide reasonable but not absolute assurance against misstatement or loss.

The Group recognises that good risk management is essential for the long-term development of the Group's business. Management is responsible for the establishment, implementation, review and assessment of the sound and effective internal control system underpinning the risk management framework. After taking into full account of the relevant requirements under the GEM Listing Rules relating to risk management and internal control, the management continued to improve its existing control and risk management framework. All employees are committed to implementing the risk management framework into the daily operation.

The Company has established a dedicated legal affairs and internal audit department and engaged an external professional legal agency to assist the audit committee and the Board in determining the effectiveness of the risk management and internal control systems on an annual and ongoing basis. In 2023, the Company further standardized the audit work process. In accordance with the annual audit plan, the Company carried out a special audit on the maintenance and reinforcement project of Bei Gang Depot Transit Warehouse to standardize the management of the project, and check the compliance and economy of the maintenance and renovation project of such warehouse. Meanwhile, the Company carried out two economic responsibility audits and an operational performance audit of wholly-owned subsidiaries to promote compliance management and enhance operational management of wholly-owned subsidiaries. With the targets of standardizing management, improving internal control and preventing risks, the Company has completed the first internal audit of Tianjin TEDA Alps and Gangwan Automobile, which both are our investee companies. For the problems found in the audit, the Company supervised the rectification of audited departments, carefully reviewed the rectification plans and the rectification results, timely communication and confirmation of key issues to ensure that the rectification is in place.

內部控制

內部監控及風險管理

董事會全權負責建立、維持及檢討本集團 的內部監控體系,以保障股東的投資及本 集團資產。本集團的內部監控系統旨在促 成有效及高效管理,盡可能降低本集團面 對的風險。有關系統盡可能就錯誤陳述或 損失提供合理而並非絕對的保障。

本集團深明良好風險管理對業務的長期發展至為重要。管理層負責設立、執行、檢討及評估健全有效的內部監控系統,並以之為風險管理框架的基礎。在全面考慮GEM上市規則項下的風險管理及內部監控相關規定後,管理層不斷完善已有的監控架構及風險管理。全體僱員致力於實施風險管理框架,使之融入日常營運中。

本公司已設立專門的法務內審部並聘請外 部專業法律機構,協助審核委員會及董事 會,每年持續地確定風險管理及內部監控 系統的有效性。2023年,進一步規範審 計工作流程,按照年度審計計劃,開展本 公司北港堆場中轉倉庫維修加固工程項目 專項審計1項,規範工程項目管理,檢查 中轉倉庫維修改造工程項目合規性、經濟 性。同時,開展全資附屬公司經濟責任審 計2項及經營績效審計1項,促進全資子 公司合規管理、提升經營管理水平;以規 範管理、完善內控、防範風險為目標首次 完成對天津泰達阿爾卑斯及港灣汽車的內 部審計工作。對於審計發現的問題,督促 被審計單位整改,認真審核整改方案及整 改結果,針對重點問題及時溝通確認,確 保整改合規到位。

In 2023, the Board highly emphasized on internal control and risk management, the Company continuously improved and consolidated the achievements of the risk system development based on the development of the "risk management and control quality project" system established in 2021. During the reporting period, it strives to achieve the objective of monitoring risks, implementing standards, and supervising processes so as to prevent potential risks in the business of the Company and its subsidiaries in an all-round manner.

在2023年,董事會高度重視內部監控及 風險管理的工作,在2021年建立的「風險 管控品質工程」體系建設工作基礎上,持 續完善和鞏固風險體系建設的成果。本報 告期內,努力達到風險有監測、執行有標 準、過程有監督的目標,以全面的防範本 公司及附屬公司業務的潛在風險。

Objectives of risk management and internal control

The objectives of establishing the risk management and internal control framework of the Group are to identify, assess and manage the risk of the Group and achieve the Group's strategic objectives within the acceptable safety standards. The Group has further promoted digitalisation of its internal control management while improving its systems. The "smart operational management platform" for the integration of business and finance developed by the Company will automatically consolidate business information and match it with financial data to avoid isolation of business and financial information; deliver real-time monitoring of capital through funding plans and cash management; enable coordination and verification, grading and preparation, screening and conclusion, monitoring and early warning through budget management; improve corporate capital control through deeper integration of capital planning and budget management. The establishment of the smart operational management platform, with "uniform financial accounting, uniform capital control, uniform business and financial integration, and uniform digital resources", will facilitate in-depth integration of business and finance, enhance the timeliness and accuracy of business data acquisition, and deliver smart reform in the management of the Company. The smart operational management platform, together with the Company's OA system, will establish and reinforce the logical relationship of the internal authorization system so as to control and mitigate risks.

Meanwhile, a three-line risk management approach has been adopted to identify, analyze, assess, mitigate and handle risks.

The first line of defence is that our department staff/frontline employees must understand that their roles and responsibilities to identify, assess and monitor risks associated with transactions.

風險管理及內部監控的目標

本集團的風險管理及內部監控框架建設的 目標為識別、評估及管理本集團的風險, 在可接受的安全水平下實現本集團的戰 略目標。本集團在完善制度建設的同時, 進一步提高內控管理的信息化程度。本公 司建立的業財一體化的「智慧運營管理平 台」,將自動整合處理業務信息並與財務 數據相匹配,避免出現業務、財務信息孤 島;通過資金計劃與現金管理對資金實時 監控;通過預算管理進行統籌核查、分級 編製、篩選總結、監督預警;通過資金計 劃、預算管理的深層次融合,全方位提升 企業資金管控水平。通過建立「財務核算 統一、資金管控的統一、業財一體化統 一、信息化資源統一」的智慧運營管理平 台,推動業務和財務的深度融合,提升業 務數據獲取的及時性、準確性,實現公司 管理的智慧化變革。智慧運營管理平台與 本公司OA系統共同建立並固定內部授權 體系的邏輯關係,實現控制並降低風險。

同時,本集團採納三級風險管理方法以識別、分析、評估、降低及應對風險。

在第一道防線,部門員工/前線員工必須 明白他們的角色及職責為負責識別、評估 及監察與交易有關的風險。

企業管治報告

The second line of defence is the Group's management that provides independent oversight of the risk management activities of the first line of defence. It ensures that risks are within the Group's risk capacity and that the control of the first line of defence is effective.

As the final line of defence, the audit committee of the Company, with the advices and opinions from the external professional party (such as the external auditor) on one hand and annual review by the audit department on the other hand, ensures that the first and second lines of defence are effective internally and externally.

Procedures and internal control for handling and dissemination of inside information

The Company has adopted the GEM Listing Rules and the Securities and Futures Ordinance (the "SFO") (Chapter 571 of the Laws of Hong Kong) to handle and disseminate inside information. The Company ensured compliance in respect of the handling and dissemination of inside information by adopting a series of measures including enhancing identification and confidentiality awareness of inside information, prohibiting unauthorized use of inside information and giving notice of lock-up period and securities dealing restrictions to the Directors and employees. During the year ended 31 December 2023, the Company has made announcements on inside information in accordance with the GEM Listing Rules and the applicable laws and regulations.

In light of the above, the Board is of the view that the existing risk management and internal control systems are effective and adequate for the Group.

SHAREHOLDERS' RIGHTS

Procedures for shareholders to convene an extraordinary general meeting:

The shareholder(s) (either independently or jointly) holding 3% or more of the Company's voting shares shall be entitled to propose temporary proposal(s) 10 days before the convening of the shareholders' meeting and in writing to the Company. The Company shall notify other shareholders within 2 days upon receipt of such proposal(s), and include in the agenda for the meeting the matters in the proposal(s) that fall within the scope of functions and rights of the shareholders' general meeting and with a clear topic of discussion and a specific matter to be resolved.

第二道防線是本集團的管理層,對第一道 防線的風險管理活動提供獨立的監管。其 確保風險在本集團風險承受能力範圍內及 對第一道防線的控制行之有效。

作為最後一道防線,本公司審核委員會會一方面獲取外聘專業人士(如外聘核數師)的建議及意見,另一方面通過審計部每年進行審核,從內外兩方面確保第一道防線及第二道防線行之有效。

處理及發佈內幕消息之程序及內部監控

本公司已採納GEM上市規則及香港法例第571章《證券及期貨條例》(「證券及期貨條例」)以處理及發佈內幕消息,採取包括提高內幕消息識別和保密意識、嚴格禁止未經授權使用內幕消息、向董事和僱員發送禁售期和證券交易限制的通知等一系列措施,保證合規處理發佈內幕消息。截至2023年12月31日止年度,本公司內幕消息乃根據GEM上市規則及適用法律及法規發佈。

鑒於以上所述,董事會認為現有風險管理 及內部監控系統對本集團而言屬有效及充 足。

股東權利

股東召開股東特別大會之方式:

(單獨或者合計)持有3%或以上本公司有表決權的股份(包括3%)的股東,有權在股東大會召開十日前提出臨時提案並以書面形式向本公司提出,本公司應當在收到提案後二日內通知其他股東,並將提案中屬於股東大會職權範圍內及有明確議題和具體決議的事項,列入該次會議的議程。

Shareholders requesting the convening of an extraordinary general meeting or a meeting of shareholders of different classes shall proceed in accordance with the procedures set forth below:

股東要求召集股東特別大會或者類別股東 會議,應當按照下列方式辦理:

- (1) two or more shareholders holding a total of 10% or more of the shares carrying the right to vote at the meeting sought to be held may sign one or more written requests of identical form and substance requesting the Board to convene an extraordinary general meeting or a meeting of shareholders of different classes and stating the subject of the meeting. The Board shall convene the extraordinary general meeting or the meeting of shareholders of different classes as soon as possible after having received the above-mentioned written request. The shareholding referred to above shall be calculated as of the day on which the written request is made.
- (一) 合計持有10%或以上在該擬舉行的 會議上有表決權的股份(包括10%) 的兩個或兩個以上的股東,可以簽 署一份或者數份同樣格式及內容的 書面要求,提請董事會召集股東特 別大會或者類別股東會議,並闡明 會議的議題。董事會收到前述書面 要求後應當盡快召集股東特別大會 或者類別股東會議。前述持股數按 股東提出書面要求日計算。
- (2) if the Board fails to issue a notice of such a meeting within thirty days after having received the above-mentioned written request, the shareholders who made such request may themselves convene the meeting within four months after the Board received the request. The procedures according to which they convene such meeting shall, to the extent possible, be identical to the procedures according to which general meetings are to be convened by the Board.
- (二)如果董事會在收到前述書面要求後 三十日內沒有發出召集會議的通 告,提出該要求的股東可以在董事 會收到該要求後四個月內自行召集 會議。召集的方式應當盡可能與董 事會召集股東會議的方式相同。

DIVIDEND POLICY

The Board has approved and adopted a dividend policy (the "Dividend Policy"). The Company endeavours to maintain sufficient operating capital to develop and operate the Group's business, and to provide stable and sustainable returns to its shareholders.

In deciding whether to recommend dividends and determining the amount of dividends, the Board will consider the performance, working capital, cash position of the Group and other factors that the Directors deem relevant at the time.

The declaration and payment of dividends of the Company are also subject to restrictions of the "PRC Company Law (《中國公司法》)" and the Articles and any other applicable laws and regulations. The Board will also constantly review the Dividend Policy and reserves the discretion to update, revise, modify and/or cancel the Dividend Policy at any time. The Dividend Policy will not in any way constitute a legally binding commitment of the Group in relation to its future dividends and/or will not in any way render the Company obligated to declare dividends at any time or from time to time.

INVESTOR RELATIONS AND COMMUNICATION WITH THE SHAREHOLDERS

The Board is committed to encouraging and maintaining an ongoing dialogue with shareholders through the dynamic implementation of a shareholder's communication policy through various channels. The Company's annual general meeting provides a good opportunity for the Directors to meet and communicate with shareholders. All Directors make their best efforts to attend the Annual General Meeting in order to answer questions from the Company's shareholders. In accordance with the disclosure requirements of the GEM Listing Rules, the Company makes timely, accurate and complete disclosure of any discloseable and material matters in newspapers and websites designated by the relevant regulatory authorities to protect the shareholders' right to information and participation. The Company also has a dedicated department responsible for investor relations, the contact details of which are set out in the section headed "Shareholders' Rights" above. The Company attaches great importance to communication with investors and has hosted individual shareholders at various shareholder meetings and answered their telephone enquiries on a number of occasions to enhance investors' understanding of and confidence in the Company.

ACCOUNTABILITY AND AUDIT

The Directors are responsible for overseeing the preparation of accounts for each financial period by the management, and issuing appropriate announcements in accordance with the GEM Listing Rules for disclosure of all information necessary for the shareholders to assess the financial performance and other matters of the Company.

The Company has appointed HLB Hodgson Impey Cheng Limited as the international auditor of the Company for the year 2023. Fees for audit and non-audit service provided to the Group by the above-mentioned auditor for the year ended 31 December 2023 amounted to RMB1,194,000 and RMB0 (there was no non-audit service provided) respectively.

The Directors of the Company are responsible for preparation of the financial statements which can truthfully and fairly reflect financial positions of the Company and its subsidiaries pursuant to the International Financial Reporting Standards and the disclosure requirements of the "Companies Ordinance (《公司條例》)" in Hong Kong.

The statements made by the independent auditors of the Company on their responsibilities for the financial statements are set out in the independent auditors' report in this report.

COMPANY SECRETARY

The Company engages an external service provider to provide secretarial service and has appointed Mr. Lo Tai On ("Mr. Lo") as company secretary. Mr. Lo is a member of the Hong Kong Institute of Certified Public Accountants. Mr. Lo has confirmed that for the reporting period, he has attended not less than 15 hours of relevant professional training, and will continue to perform and discharge the duties of a company secretary under the GEM Listing Rules. Mr. Lo is not an employee of the Group, and Ms. Zhao Chunyan, the Vice General Manager of the Company, is the person whom Mr. Lo contacts for the purpose of Code Provision C.6.1.

CONSTITUTIONAL DOCUMENTS

During the reporting period, the Company proposed to amend the Articles and such amendments were set out in the circular of the Company dated 12 April 2023. Such amendments to the Articles were approved by the shareholders of the Company at the annual general meeting held on 12 May 2023.

The new Articles is available on the websites of the Stock Exchange and the Company.

GENERAL MEETINGS

The general meeting of the Company has the highest authority. A total of 2 general meetings were held in 2023. The Company convened an annual general meeting on 12 May 2023 to consider and approve the resolutions relating to Directors' Report for 2022 and Report of the Supervisory Committee for 2022. The Chairman of the Board and the members of each committee attended the annual general meeting held in 2023, so as to answer questions raised by shareholders. In addition, chairman of the audit committee has attended the annual general meeting held in 2023 to answer questions raised by shareholders. The Company highly values the functions of the general meeting as it is considered to be a direct and effective communication channel between the Board and investors of the Company, and thus encourages all shareholders to attend the general meetings. The Articles have laid out provisions in respect of the rights of the shareholders including the rights to attend, to receive notices of, and to vote at general meetings.

OPINION

We have audited the consolidated financial statements of Tianjin Binhai Teda Logistics (Group) Corporation Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") set out on pages 126 to 287, which comprise the consolidated statement of financial position as at 31 December 2023, and the consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information and other explanatory information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board ("IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Consolidated Financial Statements sections of our report. We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key audit matter

How our audit addressed the key audit matter

Impairment assessment of trade, bills and other receivables

Refer to note 4.1(b) and note 18 to the consolidated financial statements

As at 31 December 2023, the Group had net trade, bills and other receivables of approximately RMB482,087,000 (2022: approximately RMB776,927,000) and aggregated provision for impairment of approximately RMB298,993,000 (2022: approximately RMB304,202,000).

In general, the credit terms granted by the Group to the customers ranged between 30 to 180 days (2022: 30 to 180 days). Management applied judgement in assessing the expected credit losses ("ECL"). Receivables with known financial difficulties or significant doubt on collection are assessed individually for provision for impairment allowance. ECL are also estimated by grouping the remaining trade, bills and other receivables based on shared credit risk characteristics and collectively assessed for likelihood of recovery, taking into account the nature of the customer, its business and its ageing category, and applying expected credit loss rates to the respective gross carrying amounts of the trade, bills and other receivables. The ECL rates are determined based on historical credit losses experienced and are adjusted to reflect current and forward-looking information such as macroeconomic factors affecting the ability of the customers to settle the trade, bills and other receivables.

We focused on this area due to the impairment assessment of trade, bills and other receivables under the expected credit losses model involved the use of significant management judgements and estimates.

Our procedures in relation to ECL assessment on trade, bills and other receivables included:

- Understanding the key controls that the Group has implemented to manage and monitor its credit risk, and validating the control effectiveness on a sample basis;
- Checking, on a sample basis, the ageing profile
 of the trade, bills and other receivables as at 31
 December 2023 to the underlying financial records
 and post year-end settlements to bank receipts;
- Inquiring of management for the status of each of the material trade, bills and other receivables past due as at year end and corroborating explanations from management with supporting evidence, understanding on-going business relationship with the customers based on trade records, checking historical and subsequent settlement records of and other correspondence with the customers; and
- Assessing the appropriateness of the ECL provisioning methodology, examining the key data inputs on a sample basis to assess their accuracy and completeness, and challenging the assumptions, including both historical and forward-looking information, used to determine the expected credit losses.

We found that the management judgment and estimates used to assess the recoverability of the trade, bills and other receivables and determine the impairment provision to be supportable by available evidence.

As at 31 December 2023, management has estimated the fair value of the Group's investment properties of approximately RMB412,200,000 (2022: approximately RMB408,500,000) with a net loss on fair value changes of approximately RMB2,183,000 (2022: approximately RMB4,400,000) was recognised in the consolidated statements of profit or loss and other comprehensive income for the year ended 31 December 2023. Independent external valuations in respect of all of the portfolio of the investment properties in order to support the management's estimation.

The valuations are dependent on certain key assumptions that require significant management judgement, including reversionary yield and rental income from future reversion leases in light of current market condition.

Our procedures in relation to management's valuation of investment properties included:

- Evaluation of the independent valuer's competence, capabilities and objectivity;
- Assessing the appropriateness of the methodologies used and the key assumptions based on our knowledge of the property industry and using our valuation experts; and
- Checking on a sample basis, the accuracy and relevance of the input data used.

We found the valuation of investment properties were supported by the available evidence.

於2023年12月31日,貴集團貿易應收款項、應收票據及其他應收款項淨值總額約為人民幣482,087,000元(2022年:約人民幣776,927,000元)其中減值撥備總額約為人民幣298,993,000元(2022年:約人民幣304,202,000元)。

一般而言,貴集團授予客戶的信貸期介乎30至180日。 (2022年:30至180日)。管理層在評估預期信貸虧損 (「預期信貸虧損」)時應用判斷。對已知財務困難或對收 款構成重大疑慮的應收款項之減值撥備予以個別評估。 另外,預期信貸虧損乃透過根據共同信貸風險特徵對 其餘貿易應收款項、應收票據及其他應收款項分組而予 以估計,並共同評估收回的可能性,當中考慮客戶的性 質、其業務及賬齡類別,並對貿易應收款項、應收票據 及其他應收款項各自的總賬面值應用預期信貸虧損率。 預期信貸虧損率乃根據歷史信貸虧損釐定,並經調整以 反映當前及前瞻性資料,例如影響客戶清償貿易應收款 項、應收票據及其他應收款項能力的宏觀經濟因素。

我們專注於此範疇乃因預期信貸虧損模式項下的貿易應 收款項、應收票據及其他應收款項減值評估涉及運用重 大管理層判斷和估計。

投資物業估值

於2023年12月31日,管理層已估計 貴集團投資物業之公允價值約人民幣412,200,000元(2022年:約人民幣408,500,000元),公允價值變動虧損淨額約人民幣2,183,000元(2022年:約人民幣4,400,000元)已於截至2023年12月31日止年度的合併損益及其他全面收入表中確認。以就所有投資物業組合進行獨立外部估值,以支持管理層之估計。

估值取決於需要重大管理層判斷之若干主要假設,包括 根據當前市場狀況確定的複歸收益率及未來復歸租賃的 租金收入。 我們對貿易應收款項、應收票據及其他應收款項預期信 貸虧損進行評估的程序包括:

- 了解貴集團已實施的關鍵控制措施,以管理及監控 其信貸風險,並以抽樣方式驗證控制的有效性;
- 抽樣檢查於2023年12月31日有關財務記錄內的貿易應收款項、應收票據及其他應收款項的賬齡情況及年底後的銀行賬戶結算收據;
- 詢問管理層於年底的每份重大貿易應收款項、應收票據及其他應收款項的狀況及管理層提供佐證其解釋證據支持,根據交易記錄了解與客戶的持續交易關係、檢查客戶及客戶其他通信往來的過往及其後的結算記錄;及
- 評估預期信貸虧損撥備方法的適當性、按抽樣方式 檢視關鍵數據輸入以評估其準確性和完整性、及挑 選用於釐定預期信貸虧損的過往及前瞻性資料的假 設。

我們發現管理層用以評估貿易應收款項、應收票據及其 他應收款項的可收回性及釐定減值撥備作出的判斷及估 計有可得證據支持。

管理層對投資物業進行估值的程序包括:

- 評估獨立估值師的資格、能力及客觀性;
- 根據我們對物業行業的認識及任用估值專家,評估所採用的方法及主要假設是否合適;及
- 抽樣檢查了所使用輸入資料之準確性及相關性。

我們發現,對投資物業進行的估值乃有據可依。

1. GENERAL INFORMATION

Tianjin Binhai Teda Logistics (Group) Corporation Limited (the "Company") and its subsidiaries (collectively refer to as, "the Group") are principally engaged in provision of logistics and supply chain solutions services and trading and related logistics services in the People's Republic of China (the "PRC").

The Company was established as an investment holding company in the PRC by its promoters, Tianjin Teda Investment Holding Co., Ltd. (天津泰達投資控股有限公司) ("TEDA Holding") and Tianjin Economic and Technological Development Area State Asset Operation Company (天津經濟技術開發區國有資產經營公司) ("TEDA Asset Company") as a joint stock limited company on 26 June 2006. Both TEDA Holding and TEDA Asset Company are controlled by Tianjin Economic and Technological Development Area Administrative Commission ("TEDA Administrative Commission").

Pursuant to the Group reorganisation (the "Reorganisation") in preparation for the listing of the Company's overseas listed foreign shares ("H shares") on the Growth Enterprises Market (the "GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), the Company became the holding company of the Group in June 2006. The Company's H shares were listed on the GEM of the Stock Exchange on 30 April 2008.

On 18 November 2011, TEDA Holding entered into a share transfer agreement with Chia Tai Land Company Limited ("Chia Tai Company"), while TEDA Asset Company entered into a share transfer agreement with Chia Tai Pharmaceutical Investment (Beijing) Co., Ltd. ("Chia Tai Pharmaceutical Company"). Accordingly, TEDA Holding and TEDA Asset Company agreed to transfer 28,344,960 (8% of ordinary shares) and 77,303,789 (21.82% of ordinary shares) domestic shares of the Company to Chia Tai Company and Chia Tai Pharmaceutical Company respectively. In 2012, the two aforementioned domestic share transfers were approved by the relevant state-owned assets supervision and administration authorities of the PRC. The registration procedures of the related transfers have been completed on 7 June 2013.

本公司由其發起人天津泰達投資控股有限公司(「泰達控股」)及天津經濟技術開發區國有資產經營公司(「天津開發區資產公司」)於2006年6月26日在中國成立為投資控股股份有限公司。泰達控股及天津開發區資產公司由天津經濟技術開發區管理委員會(「天津開發區管理委員會」)控制。

根據為籌備本公司海外上市外資股(「H股」)在香港聯合交易所有限公司(「聯交所」)GEM(「GEM」)上市而進行的集團重組(「重組」),本公司於2006年6月成為本集團的控股公司。本公司的H股於2008年4月30日在聯交所GEM上市。

泰達控股與正大置地有限公司(「正大置地」)於2011年11月18日簽署一項股份轉讓協議,而天津開發區資產公司與正大製藥投資(北京)有限公司(「正大製藥」)簽署一一與股份轉讓協議。據此,泰達控股口,一次宣佈及正大製藥轉讓本公司同意分別內內,一次2012年,上述兩項內資股轉讓機構批准,於2013年6月7日有關轉讓的登記程序已經全部完成。

These consolidated financial statements are presented in Renminbi ("RMB"), which is also the functional currency of the Company unless otherwise stated. These consolidated financial statements have been approved for issue by the Board of Directors on 18 March 2024.

2. BASIS OF PREPARATION

(a) Statement of compliance

The consolidated financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs"), which is a collective term that includes all applicable individual IFRSs, International Accounting Standards ("IASs") and Interpretations promulgated by the International Accounting Standards Board (the "IASB"), and accounting principles generally accepted in Hong Kong. For the propose of preparation of the consolidated financial statements is considered material if such information is reasonably expected to influence decision made by primary users. In addition, the consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the GEM of the Stock Exchange of Hong Kong Limited (the "GEM Listing Rules") and by the Hong Kong Companies Ordinance.

The IASB has issued certain new and revised IFRSs that are first effective or available for early adoption for the current accounting period of the Group and the Company. Note 2 provides information on any changes in accounting policies resulting from initial application relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

The consolidated financial statements have been prepared on the historical cost basis except for equity instruments at fair value through other comprehensive income and investment properties that are measured at fair values at the end of each reporting period, as explained in the accounting policies below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of IFRS 2, leasing transactions that are within the scope of IFRS 16, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in IAS 2 Inventories or value in use in IAS 36 Impairment of Assets.

In preparing the financial statements of each individual group entity, transactions in currencies other than the entity's functional currency (foreign currencies) are recognized at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise except for exchange differences on monetary items receivable from or payable to a foreign operation for which settlement is neither planned nor likely to occur, which are recognised initially in other comprehensive income and reclassified from equity to profit or loss on disposal or partial disposal of the Group's interests in associates/joint ventures.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. RMB) using exchange rates prevailing at the end of each reporting period. Income and expense items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forwardlooking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights. The Group uses a practical expedient in estimating ECL on trade receivables using a provision matrix taking into consideration historical credit loss experience and forward looking information that is available without undue cost or effort.

Financial liabilities (including borrowings, lease liabilities, and trade and other payables) are subsequently measured at amortised cost, using the effective interest method.

Derecognition of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in the profit or loss.

(i) Provision

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows.

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Contingent liabilities

A contingent liability is a present obligation arising from past events but is not recognised because it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation or the amount of the obligation cannot be measured with sufficient reliability.

Where the Group is jointly and severally liable for an obligation, the part of the obligation that is expected to be met by other parties is treated as a contingent liability and it is not recognised in the consolidated financial statements.

The Group assesses continually to determine whether an outflow of resources embodying economic benefits has become probable. If it becomes probable that an outflow of future economic benefits will be required for an item previously dealt with as a contingent liability, a provision is recognised in the consolidated financial statements in the reporting period in which the change in probability occurs, except in the extremely rare circumstances where no reliable estimate can be made.

(j) Inventories

Inventories which consist of cargos are stated at the lower of cost and net realisable value. Cost of inventories are is determined using on a first-in-first out method. Net realisable value is the estimated selling price in the ordinary course of business, less all estimated costs of completion and costs necessary to make the sale. Costs necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale.

For the purposes of the consolidated statement of cash flows, cash and cash equivalents consist of cash and cash equivalents as defined above, net of outstanding bank overdrafts which are repayable on demand and form an integral part of the Group's cash management. Income tax expense represents the sum of current and deferred income tax expense.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before tax because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

The Group's major financial assets and liabilities include trade, bills and other receivables, pledged bank deposits, cash and cash equivalents, trade and other payables, borrowings and lease liabilities. The risks associated with these financial assets and liabilities include market risk (interest rate risk and foreign currency risk), credit risk and liquidity risk. The policies on how to mitigate these risks are set out below. The management of the Group manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

(a) Market risks

(i) Foreign exchange risk

The Group mainly operates in the PRC and is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to RMB, Japanese Yen ("Yen") and USD Dollars ("USD"). Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities and net investments in foreign operations. The management do not expect the net foreign currency risk from these activities to be significant and hence, the Group do not presently hedge the foreign exchange risks. The Group periodically review liquid assets and liabilities held in currencies other than the functional currencies of the respective subsidiaries to evaluate its foreign exchange risk exposure and will consider hedging significant foreign currency exposure should the need arise.

The Group currently does not use any derivative contracts to hedge its exposure to interest rate risk. However, management will consider hedging significant interest rate risk should the need arise.

Majority of the Group's revenue is received from individual customers in relation to logistics and supply chain service for finished automobiles and materials procurement and related logistic services and are transacted in cash or credit. The Group's trade receivables arise from logistics and supply chain service for finished automobiles and materials procurement and related logistic services. The Group has concentration of credit risk as 18% (2022: 20%) and 43% (2022: 50%) of the total trade receivables was due from the Group's largest customer and five largest customers, respectively. The management of the Group makes periodic assessment on the recoverability of the trade and other receivables based on historical payment records, the length of overdue period, the financial strength of the debtors and whether there are any disputes with the debtors.

Credit risk refer to the risk that the Group's counterparties default in their contractual obligations resulting in financial losses to the Group.

The Group's maximum exposure to credit risk in relation to financial assets is the carrying amounts of trade, bills and other receivables, pledged bank deposits and cash and cash equivalents.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits and credit approvals. Other monitoring procedures are in place to ensure that follow-up action is taken to recover overdue debts. In addition, the Group performs impairment assessment under ECL model upon application of IFRS 9 on trade balances individually or based on provision matrix. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

The Group established ECL model based on historical settlement records, past experience and available forwardlooking information which include GDP and other macro-economic factors affecting the ability of the customers to settle the receivables. The Group's other receivables are deposits or receivables arose from normal operations, which based on management's assessment, the credit risk is not significant. In this regard, the directors are satisfied that the risks of impairment are monitored and adequate provision, if any, has been made in the consolidated financial statements. The Group manages its capital to ensure that the entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The directors of the Company review the capital structure regularly. As part of this review, the directors consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors, the Group will balance its overall capital structure through the payment of dividends, new share issues as well as bank borrowings.

The Group monitors it capital structure on the basis of gearing ratio. The Group's gearing ratio (ratio of borrowings (including borrowings and lease liabilities) to total equity) is approximately 39% (2022: 34%). There were no changes in the Group's approach to capital management during the year.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

For bills and other receivables, the management makes periodic individual assessment on the recoverability of other receivables based on historical settlement records, past experience, and also quantitative and qualitative information that is reasonable and supportive forward-looking information. The provision of ECL is sensitive to changes in estimates.

38. LITIGATION

As at 31 December 2022, the Group were involved in litigation or arbitration of material importance and litigation or claim of material importance was pending or threatened against the Company and its subsidiaries. Details are as follows:

In the case of contractual disputes that Guofu (Shanghai) Asset Management Co., Ltd. ("Guofu Shanghai") suing Guoben (Xiamen) Supply Chain Management Co., Ltd. ("Guoben Xiamen"), the Company and Guoben Holdings Co., Ltd., which was heard on 4 February 2021, the Company received the judgment from the Shanghai Financial Court on 26 September 2021 (the "Judgment"). The Company has lodged an appeal against the Judgment to the Shanghai Financial Court on 8 October 2021. On 13 January 2022, the Shanghai High People's Court accepted the appeal case. Due to the Pandemic situation, the case was tried in the second instance on 27 July 2022. On 13 September 2022, the Shanghai High People's Court made a final judgment and upheld the original judgment that Guoben Xiamen shall pay Guofu Shanghai the repurchase fee of RMB56.55 million and the corresponding repurchase premium within ten days from the effective date of the judgment. The repurchase premium is calculated based on RMB56.55 million at an annual interest rate of 10% (from 2 July 2019 to actual settlement date). The Company will bear 50% of the above-mentioned part of debt that Guoben Xiamen in unable to pay off, with a limit of RMB60 million. The Company has the right to ask reimbursement from Guoben Xiamen upon its settlement. On 29 November 2022, the case has entered the enforcement process. On

於2021年2月4日開庭審理的 (a) 國釜(上海)資產管理有限公 司(「國釜上海」)起訴國本 (廈門) 供應鏈管理有限公司 (「國本廈門」)、本公司 及國本控股有限公司的合同 糾紛案件,本公司於2021年 9月26日收到上海金融法院判 決書(「該判決」)。本公 司已就該判決於2021年10月8 日向上海金融法院提出上訴。 於2022年1月13日,上海市高 級人民法院受理上訴案件。因 疫情原因,該案於2022年7月 27日進行了二審庭審工作。 2022年9月13日,上海市高級 人民法院作出終審判決,維持 原判,即國本廈門應於判決生 效之日起十日內向國釜上海支 付回購款人民幣5,655萬元及 相應的溢價回購款。溢價回 購款以人民幣5,655萬元為基 數,按年利率10%計算(自 2019年7月2日至實際清償之 日止),對國本廈門上述債務

7 February 2023, the Company received an enforcement notice from the Shanghai Financial Court, requesting the Company to fulfill the obligation of compensation of RMB38,632,171.20 for the part of Guoben Xiamen's debt that could not be paid off, and to bear the cost of execution in amount of RMB123,950.00. The Company has fulfilled its obligations under the judgment on 28 February 2023. The Company has lodged an application to the Shanghai Financial Court on 10 March 2023 to claim compensation from Guoben Xiamen. Depending on the subsequent situation, other measures to claim for its rights may be taken by the Company against the principal.

(b) The Company filed a case in the Tianjin Binhai New Area Court on 18 February 2022, suing Tedahang, for repayment of the Company's guaranteed loan of approximately RMB170 million. People's Court of Binhai New District, Tianjin issued a civil judgment on preservation on 22 February 2022, and seized the real estate under the name of Tedahang to provide property preservation for the Company. The case was heard on 18 March 2022 and 20 July 2022. On 26 August 2022, the People's Court of Binhai New District, Tianjin made a first instance judgment, supporting the Company's claim of full amount. The judgment is currently in effect.

(b) 本公司於2022年2月18日在天津濱海新區法院立案,起訴泰達行要求償還本公司擔保借款約人民幣1.7億元,天津市濱海新區人民法院於2022年2月22日發出保全民事裁定書,查封泰達行名下不動產為本公司提供財產保全。該案件於2022年3月18日、2022年7月20日開庭審理,2022年8月26日,天津市濱海新區人民法院作出一審判決,全額支持本公司訴請。目前該判決已生效。

39. RETIRMENT BENEFITS SCHEMES

The Company and its PRC subsidiaries participate in defined contribution retirement benefit schemes (the "Schemes") organised by the PRC municipal and provincial government authorities whereby the Company and its PRC subsidiaries are required to make contributions at the rate of 14% to 16% of the eligible employees' salaries to the Schemes. The Group has accrued for the required contributions which are remitted to the respective local government authorities when the contributions become due. The local government authorities are responsible for the pension obligations payable to the retired employees covered under the Schemes.

The Group has no other material obligation for the payment of pension benefits beyond the contributions described above.

As at 31 December 2023 and 2022, there were no forfeited contributions available to reduce future obligations. The total contribution made by the Group to the Schemes for the year ended 31 December 2023 are RMB33,985,000 (2022: RMB43,790,000).
