This announcement is made by the Company pursuant to Rule 13.09(2)(a) of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

The Board wishes to inform the Shareholders and potential investors that based on preliminary assessment of the management accounts of the Group by the Company's management (which have not been audited by the auditor of the Company), it is expected that the Group will record loss attributable to owners of the Company in the range of approximately HK\$95.0 million to HK\$105.0 million for the year ended 31 December 2023, as compared to the audited profit attributable to owners of the Company of approximately HK\$6.2 million for the year ended 31 December 2022.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Strong Petrochemical Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**SFO**”).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the information currently available from the Group’s management accounts (which have not been audited by the auditor of the Company), it is expected that the Group will record loss attributable to owners of the Company in the range of approximately Hong Kong dollar (“**HK\$**”) 95.0 million to HK\$105.0 million for the year ended 31 December 2023, as compared to the audited profit attributable to owners of the Company of approximately HK\$6.2 million for the year ended 31 December 2022, which is primarily attributable to (i) the increase in impairment loss on unlisted equity investment; (ii) the decrease in dividend income from unlisted equity investment; (iii) the decrease in interest income from trade receivables; and (iv) the decrease in gain on debt modification. Yet, it has been partially offset by the decrease in salaries, bonus and other allowances.

As the Company is still in the process of finalising the results for the year ended 31 December 2023, the information contained in this announcement is only based on the preliminary assessment by the Company’s management according to the unaudited management accounts of the Group, which are subject to finalisation and other potential adjustments, if any, and have not been reviewed or confirmed by the auditors of the Group or the audit committee of the Company. The financial results of the Group for the year ended 31 December 2023 will only be ascertained when all the relevant results and accounting treatments are finalised.

The annual results announcement of the Group for the year ended 31 December 2023 is expected to be published in late March 2024.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
