# Chairman's Statement 主席報告

Dear Shareholders.

On behalf of the Board of Directors (the "Board") of the Company, I am pleased to present the annual results of the Company and its subsidiaries (collectively the "Group") for the year ended 31 December 2023 (the "Year").

In 2023, the pharmaceutical industry has gradually returned to the normal track of development following the end of COVID-19 pandemic. Under the impact of factors such as prevention and control of COVID-19 pandemic and decrease in sales of relevant products, coupled with the enlarging scope of procurement of "centralized procurement of drugs organized by the State" and "centralized procurement of drugs by local alliances", the overall prices of pharmaceutical products and high-value medical consumables continued to fall, and the pharmaceutical industry experienced negative growth as a whole. In terms of categories, year-on-year decreases were recorded in the sales of pandemic prevention medical devices, hygiene products, biological products and chemical drugs, while sales of Chinese medicines, non-pandemic prevention medical devices and healthcare products were on an upward trend.

#### 致各位股東:

本人謹代表本公司董事會(「董事會」)欣然提呈本公司及其附屬公司(統稱「本集團」)截至二零二三年十二月三十一日止年度(「本年度」)之業績。

於二零二三年度,隨著新冠疫情結束,醫藥行業的發展逐步回歸了正常軌道。受新冠疫情防控及相關產品銷量減少等因素的影響,同時隨著「國家組織藥品集中帶量採購」及「地方聯盟集中帶量採購」的集採範圍持續擴大,藥品及高價值醫用耗材的整體價格繼續走低,醫藥工業亦出現整體負增長。就類別而言,防疫類醫療器械、衛生用品、生物製品及化藥等產品的銷量均出現同比下降,而中藥、非防疫類醫療器械及保健品等產品的銷量則呈現增長趨勢。

# **Chairman's Statement** 主席報告

In the face of the complex and volatile macro-environment and numerous challenges, the Group has taken "stabilizing growth, controlling expenses, highlighting new business and strengthening execution" as the main management keynote to further cultivate a modernized corporate governance structure and improve corporate efficiency. During the Year, the principal business of the Group included research and development, manufacturing and selling of medicines and medical devices and the purchase and sales of medicines, medical devices and healthcare food products. In response to the impact of factors such as market environment, policy changes and prospects of the industry, the Group has continuously adjusted and optimized its operation strategies. Firstly, the Group vigorously developed the healthcare food product market with the combination of multiple sales modes to enhance the sales performance of key products and to gradually cultivate new flagship products. Secondly, the Group focused on the production of fine Chinese medicines as the main direction of the traditional Chinese medicine business and upheld the philosophy of "safeguarding the integrity of inheritance, being stable and innovative, and producing fine Chinese medicines". Thirdly, the Group continued to expand the business of manufacturing, purchasing and selling of medical devices, and increased the proportion of such business in the Group's operations. Fourthly, the Group screened products in loss-making subsidiaries to facilitate the shift of products from low to high gross margins, expanded the consignment and contracted processing business model, leveraged the collaboration advantage of the industry structure and business structure of the Neptunus Headquarters, laying a solid foundation for the upcoming turnover from loss to profit. Overall, in the Year, the Group has basically effectively implemented the strategic plans formulated in the beginning of the Year and steadily realized the annual sales performance target. However, profits declined to a considerable extent due to the impact of goodwill impairment of loss-making subsidiaries.

面對複雜多變的宏觀環境及和諸多挑戰,本集團 以「穩增長、控費用、突出新業務、強執行」為主 要管理基調,進一步深耕現代化企業治理結構, 提高企業效益。於本年度,本集團主要業務是藥 品及醫療器械的研發、生產與銷售,以及藥品、 醫療器械及保健品的購銷。根據市場環境、政策 變化及行業前景等影響因素,本集團對經營策略 不斷進行調整及優化,其一,大力開發保健食品 市場,結合多種銷售模式,提升重點產品的銷售 業績,逐步培育新的明星產品;其二,以生產精 品中藥為中藥業務的主線,貫徹「傳承守正、穩固 創新、做精品中藥」的理念;其三,繼續拓展醫療 器械生產及購銷業務,提升此類業務在集團業務 中所佔比重; 其四, 在處於虧損狀態的附屬公司 中篩選產品,推動產品由低毛利向高毛利進行轉 變,擴展受托及來料加工業務模式,發揮海王總 部工業體系和商貿體系聯動優勢,為後續扭虧為 盈夯實基礎。從整體來看,本集團於本年度基本 有效地落實了年初戰略規劃,穩步實現了全年銷 售業績目標,但利潤因受虧損附屬公司商譽減值 影響,出現了較大幅度下降。

In the future, the Group will continue to adhere to the overarching principle of seeking progress amidst stability, insist on sustainable high-quality development, implement the guiding principles of "effective expenditure, multi-channel marketing, focus on growth categories and enhanced gross profit levels" in an intensive manner, and continue to promote the optimization of its business structure. The Board will also lead the management of the Group to continue to improve its governance, enhance standardized management and the internal control system. We believe that under the leadership of the Board and the management and with the persistent efforts of our staff, the Group's operating business and profit will resume its growth trend.

#### **BUSINESS REVIEW**

During the Year, the Group was principally engaged in the research and development, manufacturing and selling of medicines and medical devices, and the purchase and sales of medicines, healthcare food products and medical devices in the PRC. The medicines being sold by the Group mainly cover several therapeutic areas which are oncology, cardiovascular system, respiratory system, digestive system and mental disorders.

# Research and Development, Manufacturing and Selling of Medicines and Medical Devices

The Group has two pharmaceutical production bases, which are respectively located in Jin'an District, Fuzhou, Fujian Province, the PRC ("Fuzhou Production Base") and Miyun Economic Development Zone, Beijing Municipality, the PRC ("Beijing Production Base"). The Fuzhou Production Base possesses 366 Guo Yao Zhun Zi approval documents for Chinese medicines (including more than a dozen of dosage forms such as tablets. capsules, granules, oral solutions and tinctures) and chemical medicines (which include various dosage forms namely tablets, capsules, granules, small volume injections and large volume injections) in total, of which 235 varieties are included in the "Catalogue of Drugs for Basic National Medical Insurance" (國家基本醫療保險藥品目錄), and 146 products are included in the "National Essential Drug List" (國家基本藥品目錄). In addition, the Fuzhou Production Base is the only narcotic combination drugs production base in Fujian Province designated by the State. The Beijing Production Base mainly produces chemical medicines (tablets, hard capsules and powders) and holds 137 Guo Yao Zhun Zi approval documents, of which 89 products are included in the "Catalogue of Drugs for Basic National Medical Insurance" (國家基本醫療保險藥品目錄) (64 Basic Medical Insurance Category A drugs and 25 Basic Medical Insurance Category B drugs), 60 products are included in the "National Essential Drug List", and 31 OTC products (23 in Category A and 8 in Category B).

The Group's research and development work mainly fulfills the internal development demands of the Group through conducting independent research and development and cooperation with external research and development institutions. Three pharmaceutical manufacturing subsidiaries of the Company are recognized as high-tech enterprises and all of them are entitled to enjoy preferential corporate income tax treatment for high-tech enterprises. Over the years, the Group has consistently promoted its research and development innovation strategy and continued to invest in the consistency evaluation of generic medicine and the research and development of new medicines. Currently, the Group owns a total of 35 patents for inventions. In respect of consistency evaluation, four of the Group's products

# 業務回顧

本集團於本年度主要在中國從事藥品及醫療器械 的研發、生產及銷售,以及藥品、保健食品及 醫療器械的購銷。本集團銷售的藥品主要涵蓋腫 瘤、心血管系統、呼吸系統、消化系統、精神障 礙等多個治療領域。

#### 藥品及醫療器械研發、生產及銷售

本集團擁有兩個藥品生產基地,分別位於中國福 建省福州市晉安區(「福州生產基地」)及中國北京 市密雲經濟開發區(「北京生產基地」)。福州生產 基地擁有中成藥(含片劑、膠囊劑、顆粒劑、口 服液、酊劑等十幾個劑型)和化藥(含片劑、膠囊 劑、顆粒劑、小容量注射劑、大容量注射劑等多 個劑型)共366個國藥准字批准文號,其中有235 個品規入選了國家基本醫療保險藥品目錄,有146 個品規入選了國家基本藥品目錄。同時,福州生 產基地是國家在福建省唯一指定的含麻醉品複方 製劑生產基地。北京生產基地主要生產化藥(含片 劑、硬膠囊劑、散劑),持有137個國藥准字批准 文號,其中有89個產品入選了國家基本醫療保險 藥品目錄(醫保甲類64個、醫保乙類25個),有60 個產品入選了國家基本藥品目錄,OTC產品31個 (甲類23個、乙類8個)。

本集團研發工作主要通過自主研發和與外部研發機構合作的方式滿足本集團的內部發展需求。本公司旗下現有三家製藥附屬公司,均為國家家新技術企業,可享受高新技術企業所得稅優惠政策。多年來,本集團始終堅持推進研發創新戰略,持續投入仿製藥一致性評價及新藥研發。目前本集團一共擁有35項發明專利。在一致性評價方面,本集團有4個品種已通過一致性評價,包括碳酸氫鈉片、諾氟沙星膠囊、鹽酸二甲雙胍片及鹽酸普萘洛爾片。另有數個品種的一致性評價工作正在有序推進中,其中維生素86片已完成評

have passed the consistency evaluation, including Sodium Bicarbonate Tablets (碳酸氫鈉片), Norfloxacin Capsules (諾氟沙星膠囊), Metformin Hydrochloride Tablets (鹽酸二甲雙胍片) and Propranolol Hydrochloride Tablets (鹽酸普萘 洛爾片). The consistency evaluation of several other products is being carried out in an orderly manner, including Vitamin B6 Tablets (維生素 B6片), which evaluation has been completed and are still pending approval, and Vitamin B1 Tablets (維生素 B1片) and Benzhexol Hydrochloride Tablets (鹽酸苯海 索片) have completed the consistency evaluation and process validation. In the aspect of research and development of new medicines, Doxofylline Injection (多索茶碱注射液), which was commissioned by the Company's pharmaceutical subsidiary, and Concentrated Sodium Potassium Magnesium Calcium Injection (鈉鎂鉀鈣注射用濃溶液) have both obtained approval. Both generic Sildenafil Citrate Orodispersible Tablets (枸櫞酸西地那非口 崩片), a self-developed variety, and generic Sodium Bicarbonate Ringer's Injection (碳酸氫鈉林格注射液), a holder variety, have received notification of additional studies from the Drug Evaluation Center, and are expected to receive manufacturing approval in 2024. The Group also possesses various new drugs and exclusive products with self-owned intellectual property rights, including Tegafur, Gimeracil and Oteracil Potassium Tablets (the "TGOP Tablets" or 替吉奥片, a drug for anti-gastric cancer), Xiaozheng Yigan Tablets (消症益肝片, an anti-liver-cancer drug), Proteoglycan Tablets (多糖蛋白片, for enhancing the immune system), Biyuan Capsules (鼻淵膠 囊, an anti-rhinitis medicine), Amaranth Berberine Capsules (莧菜黃連素膠 囊, a drug for acute diarrhea), Disodium Glycyrrhizinate (甘草酸二鈉, a drug for anti-inflammatory and liver protection), Spironolactone Tablets (螺內酯 片, a drug for auxiliary diuresis), Ligustrazine Phosphate Tablets (磷酸川芎嗪 片, a drug for ischemic cerebrovascular disease), Pre-filled Catheter Flusher (預充式導管沖洗器, a Class III medical device) and HTK Myocardial Protection Cardioplegic Solution (HTK 心肌保護停跳液, a Class III medical device).

During the year, two pharmaceutical subsidiaries of the Group located in Fujian followed the current acting strategy to unify sales policy, complemented strengths, allocated resource, cross-holding, integrated development to fully expand the market of key products. At the provincial level, the Group utilized the home advantages and resources to sort out and adjust the price of some varieties on the network, proactively develop the unoccupied market shares within the province and increase the share of products in the province's medical institutions; while outside the province, the Group utilized the national market resources and customer resources of Neptunus Headquarters, and give full play to the advantages of the linkage between the industrial system and trade system of Neptunus Headquarters to continue to expand the market, and actively participate in the alliance band purchasing of the expiring varieties of the national collection and procurement in each region to seize the market and drive the sales of other products. Meanwhile, according to the characteristics of the products, the

distribution channels are divided into three major channels, namely, omnichannel sales, controlled sales and e-commerce sales, so as to continuously open up the sales channels and adopt a complementary approach between the medical institutions and the distribution market, so as to consolidate and develop the original advantageous products' share in the medical institutions. Among the subsidiaries, Fuzhou Neptunus Fuyao Pharmaceutical Company Limited ("Neptunus Fuyao") insisted on solid focus as the foundation, and continued to steadily improve its operating results by expanding the market through multiple channels and cultivating new growth points in product sales under the premise of implementing key work in the areas of quality, safety and standardization; while Fuzhou Neptunus Jinxiang Chinese Pharmaceutical Company Limited ("Neptunus Jinxiang") continued to focus on the production of fine Chinese medicines, implementing the philosophy of "safeguarding the integrity of inheritance, securing and innovative, and producing fine Chinese medicines", and actively upgrading product positioning. The continuous efforts made by these pharmaceutical subsidiaries in the areas of production, product quality, sales, inventory and pricing have not only ensured the steady development of their businesses, but also contributed significantly to the Group's profitability.

Beijing Neptunus Zhongxin Pharmaceutical Co., Ltd.\* (北京海王中新藥業股份 有限公司, "Neptunus Zhongxin"), a pharmaceutical manufacturing subsidiary of the Group located in Beijing, actively responded to the difficult and tense development situation and the tremendous challenges brought about faced by the domestic chemical raw materials pharmaceuticals during the Reporting Period, and promptly followed the industry policies and the market changes by means of expanding production capacity, increasing products, strictly enforcing quality control, adjusting the portfolio structure, transforming the marketing model and the team, etc., closely focusing on the strategic layout of "shifting products from low gross profit to high gross profit, shifting the sales team from regional to national, and expansion of consignment and contract processing business model", strengthening budget and compliance management, reducing costs and increasing efficiency, and further refining risk control, the operating condition improved over the corresponding period of last year. During the year, sales of Neptunus Zhongxin existing products were sluggish and the introduction of new products by the Group was delayed as compared to the original plan, as a result of which Neptunus Zhongxin remained in a loss-making position. In accordance with the results of the impairment test, the Group has impaired the goodwill related to the merge and acquisition of Neptunus Zhongxin. In 2024, Neptunus Zhongxin intends to carry out operational adjustment programs such as transformation of marketing model, change of organizational structure, conversion of remuneration model and staffing, and deepening development of target markets, as well as optimize pricing, channel and competition strategies of products, intensify its efforts in budgets control, paybacks focus, receivables reduction, and winning bids, and strive to turn the business around to profitability as soon as possible.

公司(「海王福藥」)堅持以穩固重點為基礎,在落實質量、安全、規範等關鍵工作的前提下,多渠道拓展市場,培育產品銷售新增長點,繼續穩步提升經營業績;而福州海王金象中藥製藥有限公司(「海王金象」)則繼續以生產精品中藥為主線,貫徹「傳承守正、穩固創新、做精品中藥」的理念,積極提升產品定位。該等製藥附屬公司在生產、產品質量、銷售、庫存及價格等方面的做出的不斷努力,不僅保證了業務的穩健發展,也為本集團的盈利作出了較大貢獻。

本集團位於北京的製藥附屬公司北京海王中新 藥業股份有限公司(「海王中新」),於報告期間積 極應對國內化學原料藥面臨的發展形勢及帶來的 艱巨挑戰,適時通過擴產能、增產品、嚴把質量 關、調整產品結構、營銷模式及隊伍轉型等方 式,緊跟行業政策及市場變化,緊緊圍繞「產品由 低毛利向高毛利轉變、銷售隊伍由區域向全國轉 變、擴展受托及來料加工業務模式」的戰略佈局, 強化預算及合規管理、降本增效,進一步完善風 險管控,經營質量較去年同期得到提升。於本年 度,海王中新現有產品銷售乏力,而本集團引入 新產品較原計劃推遲,以致海王中新仍處於虧損 狀態。按照減值測試結果,本集團對併購海王中 新時相關商譽進行了減值。2024年,海王中新擬 進行營銷模式轉型、組織架構變革、薪酬模式及 人員編製轉換、目標市場深耕等經營調整方案, 以及優化產品的定價、渠道及競爭策略,在抓預 算、重回款、降應收、爭中標等方面加大工作力 度,併力爭盡快實現扭虧為盈。

# Purchase and Sales of Medicines, Healthcare Food Products and Medical Device

Currently, the main products distributed and sold by the Group are medicines and healthcare food products manufactured by the Group and its parent company group, which include the well-known product series of the Neptunus Ginkgo Leaves Tablets (海王銀杏葉片) and Neptunus Jinzun (海王金樽). Meanwhile, the Group initiated the distribution of medical device. Such products are mainly distributed to the end medical institutions through professional sales promotion companies and to the end users through large and medium-sized chain pharmacies.

During the Reporting Period, the implementation of the policies of the new healthcare reform adversely affected the sales of retail pharmacies, which in turn affected the business of the Group's medicines and healthcare food purchase and sales division to a certain extent, and it is expected that such impact may increase in the future. In order to stabilize its business and safeguard its long-term development, the Group's medicines and healthcare food products division will continue to focus on integrated planning and timely adjusted its sales strategies, focusing on the sales of key products and vigorously developing the healthcare food products market. Through selfmedia to strengthen the advertisement for the product and the promotion of the brands, cultivating new flagship products while increasing the sales result of the key products to actively address adverse impacts to drive continuous results growth.

Starting from 2022, Fuzhou Fuyao Medical Company Limited ("Fuyao Medical"), the purchasing and selling subsidiary of the Group located in Fuzhou, is committed to the rapid development of the relevant business by focusing on the expansion of the purchasing and selling business of medical devices and the optimization of the distribution service process. During the year, Fuyao Medical has significantly improved its performance by distributing products such as microcatheters, which are peripheral vascular medical consumables. In 2024, Fuyao Medical plans to introduce products such as parenteral nutritional supplements to continue to broaden its business categories, and will also add new distribution agents in some provinces and cities to ensure steady growth.

During the Reporting Period, the results of the Group's medicines and healthcare food purchases and sales division increased as compared with the corresponding period of last year.

#### 藥品、保健食品及醫療器械購銷

目前,本集團主要代理和銷售本集團及母公司集團自產的藥品及保健食品,其中包括著名的海王銀杏葉片系列產品和海王金樽系列產品。同時,本集團也開始代理醫療器械類產品,代理產品主要通過專業銷售推廣公司分銷至終端醫療機構以及通過大中型連鎖藥店銷售給終端客戶。

於報告期間,新醫保改革政策的落實,對零售藥店的銷售帶來不利影響,繼而在一定程度上影響了本集團藥品與保健食品購銷分部的業務,保障長遠發展,本集團藥品及保健食品購銷分部將繼續著眼統籌規劃,及時調整銷售策略,著重於憲續著眼統籌規劃,及時調整銷售策略,著重於劃資產品的銷售,並大力開發保健食品市場,通過自媒體加大產品宣傳及品牌推廣、在進一步提升重點產品的銷售業績同時,著手培育新的明星產品,積極消除不利影響,從而帶動業績的不斷增長。

從二零二二年度開始,本集團位於福州的購銷型附屬公司福州福藥醫藥有限公司(「福藥醫藥」)以拓展醫療器械購銷業務為主線,優化配送服務流程,致力於實現相關業務的快速發展。於本年度,福藥醫藥通過代理外周血管類醫用耗材微導管等產品,業績得到顯著提升。於2024年度,福藥醫藥計劃引進腸外營養補充藥等產品,繼續拓寬經營品類,同時還將新增部分省市的配送代理權,確保業績穩健增長。

於報告期間,本集團藥品與保健食品購銷分部之 業績較去年同期有所增長。

管理層討論及分析

#### **Environmental, Social and Governance**

The Group has been placing emphasis and taking actions in the aspects of environment, society and governance, including: constantly improving production efficiency, conserving resources and enhancing employees' awareness of environmental protection. Regarding production, the output corresponding to unit carbon emission increased, the pollution and the emission of hazardous substances which are in violation of laws and regulations were banned, and old equipment was replaced to reduce energy consumption and enhance production efficiency. Regarding office management, office supplies and energy consumption were conserved, the office is gradually transforming into a paperless office. Also, the Group actively improves the working environment and is committed to social responsibility by actively taking part in charitable activities.

During the Year, the Company engaged a professional third-party institution to assist in conducting comprehensive communication (from various dimensions) with stakeholders by way of face-to-face communication, telephone interviews, questionnaires and surveys. The relevant results not only serve as an important reference for the Company to review and promote the sustainability agenda of the Group, but also provide a solid basis for the content selection and preparation of our environmental, social and governance report. The environmental, social and governance report prepared by the Company pursuant to Appendix C2 of the GEM Listing Rules will be published at the same time as the publication of this report.

# PROSPECTS AND OUTLOOK

The Group continuously adjust and improve development strategies in accordance with the innovation trend of the pharmaceutical industry and its own characteristics, to gradually utilise the collaboration advantage of the industry structure and business structure of the Neptunus Headquarters, committing to the development of traditional Chinese medicine prescriptions and enhance the internal value of the brands to cultivate star products under the key elements of stabilised quality, safety and regulation. In addition, the Group will continue to strengthen the promotion of food supplements by the marketing model of combination of various sales channels, to drive the sales increase of key food supplement products. At the same time, the Group proactively introduced the commissioned production of external varieties to supplement operating results and protect against undesirable risks. We believe that through the overall layout of the Group, the research and development of new drugs can progress in stable and development of various business shall be long lasting.

#### 環境、社會及管治

在本年度,本公司聘請第三方專業機構,協助本 公司以面對面溝通、電話訪談、問卷調查等多種 形式,從各個角度與各持份者進行全面溝通。相 關的結果既是本公司審視及推進本集團的可持續 發展議程的重要參考,也為本公司的環境、社會 及管治報告的選材及籌備提供了有力的依據。本 公司按GEM 上市規則附錄C2編製的環境、社會及 管治報告將與本報告同時刊發。

# 前景及展望

根據醫藥行業變革趨勢及其自身特點,本集團不 斷調整和完善發展策略,逐步發揮海王總部工業 體系和商貿體系聯動優勢,在穩固質量、安全、 規範等關鍵工作的前提下,致力於開發中醫藥經 典名方和提升品種內在價值,以培育明星產品。 此外,本集團亦將持續加大保健食品的推廣力 度,通過多種銷售渠道相結合的營銷模式,推動 重點保健產品的銷量增長,同時積極引入外部品 種受托生產,補充經營業績,抵禦不良風險。我 們相信,通過本集團的整體佈局,新藥研發可以 穩步推進,各項業務也一定可以長足發展。

### FINANCIAL REVIEW

The Group's total revenue for the Year was approximately RMB1,064,861,000 (2022: approximately RMB986,691,000), representing an increase of approximately 7.92% as compared with the corresponding period of last year. In relation to the revenue, approximately RMB576,679,000, which accounted for approximately 54.16% of the Group's total revenue, was derived from the manufacturing and selling of medicines segment, while approximately RMB488,182,000, which accounted for approximately 45.84% of the Group's total revenue, was derived from the sales and distribution of medicines and healthcare products segment.

During the Year, the Group's gross profit margin was approximately 42% (2022: approximately 45%), representing a decrease of approximately 3% as compared with the corresponding period of last year, which mainly accounted for the greater drop in the sales proportion of high gross profit products in hospital segment.

The Group's gross profit during the Year was approximately RMB447,511,000 (2022: approximately RMB444,142,000), representing an increase of approximately 0.76% as compared with the corresponding period of last year. The increase in gross profit was mainly attributable to the increase in the overall revenue of the Group.

During the Year, the Group's selling and distribution expenses were approximately RMB252,826,000 (2022: approximately RMB244,231,000), representing an increase of approximately 3.52% from the corresponding period of last year. The increase in selling and distribution expenses was mainly due to the corresponding increase in selling and distribution expenses with the increase in general revenue of the Group.

The Group's administrative expenses for the Year were approximately RMB90,433,000 (2022: approximately RMB93,733,000), representing a decrease of approximately 3.52% from the corresponding period of last year. The decrease in administrative expenses was mainly attributable to the decrease in staff costs and the decrease of legal fee and rental fee.

# 財務回顧

本集團於本年度之收入約為人民幣1,064,861,000 元(二零二二年:約人民幣986,691,000元),較 去年同期上升約7.92%。於該收入中,約人民幣 576.679.000元來自於生產和銷售藥品分部,佔本 集團總收入約54.16%;約人民幣488,182,000元 來自於銷售及分銷藥品及保健品分部,佔本集團 總收入約45.84%。

本集團於本年度之毛利率約為42%(二零二二年: 約45%),較去年同期下降約3個百分點,主要是 由於醫院線高毛利產品銷售比重下降幅度較大。

本集團於本年度之毛利約為人民幣447,511,000元 (二零二二年:約人民幣444,142,000元),較去年 同期上升約0.76%。毛利的上升主要是因為本集 **團整體收入有所上升。** 

本集團於本年度之銷售及分銷開支約為人民 幣252,826,000元(二零二二年:約人民幣 244,231,000元),較去年同期上升約3.52%。銷 售及分銷開支上升主要由於隨本集團整體收入的 增長,銷售及分銷開支相應增加。

本集團於本年度之行政開支約為人民幣 90,433,000元(二零二二年:約人民幣93,733,000 元),較去年同期下約3.52%。行政開支減少主要 是員工成本有所下降,律師費及租賃費等減少。

管理層討論及分析

During the Year, the Group's other operating expenses (including impairment losses on trade and other receivables, net) amounted to approximately RMB96,873,000 (2022: approximately RMB40,927,000), representing an increase of approximately 136.70% as compared with the corresponding period of last year. The increase in other operating expenses was mainly attributed to the RMB33,102,000 impairment of goodwill of Neptunus Zhongxin and the increase of approximately RMB17,480,000 in research and development fee.

The Group's finance costs for the Year amounted to approximately RMB5,574,000 (2022: approximately RMB7,032,000), representing a decrease of approximately 20.73% as compared with the corresponding period of last year. The decrease in finance costs was mainly due to the decrease in interest expenses incurred from the banking loans of Neptunus Zhongxin.

For the reasons above, the Group's profit after tax decreased from approximately RMB63,830,000 for the corresponding period of last year to approximately RMB14,526,000 for the Year, representing a decrease of approximately 77.24%. Profit attributable to the owners of the Company decreased from approximately RMB54,346,000 for the corresponding period of last year to approximately RMB24,127,000 for the Year, representing a decrease of approximately 55.60%.

# LIQUIDITY AND FINANCIAL RESOURCES

The Group usually finances its operating and investing activities with its internal financial resources and bank loans. The Group's transactions are mainly denominated in Renminbi and the Group reviews its working capital and finance requirements on a regular basis.

# **Banking Facilities**

As at 31 December 2023, the Group had short-term bank borrowings of RMB82,105,000. For details of banking facilities, please refer to note 23 to the consolidated financial statements.

本集團於本年度之財務成本約為人民幣5,574,000 元(二零二二年:約人民幣7,032,000元),較去年 同期下降約20.73%。財務成本減少的主要由於海 王中新銀行借款利息支出有所減少。

由於上述原因,本集團稅後溢利由去年同期約 人民幣63,830,000元,下降至本年度約人民幣 14,526,000元,税後溢利較去年同期下降約 77.24%;本公司擁有人應佔溢利由去年同期約 人民幣54,346,000元,下降至本年度約為人民幣 24,127,000元,下降約55.60%。

# 流動資金及財務資源

本集團一般以內部財務資源及銀行借貸作為其經 營及投資活動之資金。本集團之買賣交易主要以 人民幣列值,並定期檢討對流動資金及融資的需 要。

### **NET CURRENT ASSETS**

As at 31 December 2023, the Group had net current assets of approximately RMB554,404,000. Current assets comprised bank balances and cash of approximately RMB372,206,000, short-term bank deposits of approximately RMB10,000,000, inventories of approximately RMB205,424,000 and trade and other receivables of approximately RMB332,954,000. Current liabilities comprised trade and other payables of approximately RMB260,527,000, current taxation of approximately RMB3,703,000, contract liabilities of approximately RMB16,034,000, lease liabilities of approximately RMB499,000, interest bearing borrowings of approximately RMB85,417,000. The net current assets increased approximately by RMB72,038,000 as compared with that of approximately RMB482,366,000 as at 31 December 2022. The increase in net current assets as compared to that on 31 December 2022 was mainly due to the fact that bank balances and cash increased by approximately RMB82,108,000, short-term bank deposits decreased by approximately RMB50,000,000 and contract liabilities decreased by approximately RMB27,544,000.

### **PLEDGE OF ASSETS**

As at 31 December 2023, the utilized banking facilities of RMB57,070,000 and the available banking facilities of RMBnil of the Group were secured by pledge of its buildings and the pledged buildings were stated at an aggregate value of approximately RMB24,099,000.

At 31 December 2023, the Group's future, fixtures and equipment with a carrying amount of RMB3,928,000 (2022: RMB1,822,000) were pledged to secure the Group's other borrowings.

### **FOREIGN CURRENCY RISK**

During the Year, the Group's operating revenue, major selling costs and capital expenditure were denominated in RMB. As at 31 December 2023, the Group's cash and cash equivalents were mainly denominated in RMB. As such, the foreign currency risk facing the Group is limited. Currently, the Group has not adopted any financial instrument for hedging purposes.

#### **GEARING RATIO**

As at 31 December 2023, the gearing ratio of the Group, calculated by dividing the total liabilities by total equity and multiplied by 100%, was approximately 39.31% (2022: 44.06%).

### Neptunus Yidianyao Distribution Agreement

On 28 December 2023, the Company and Neptunus Yidianyao (being indirectly held as to 57.82% by Mr. Zhang Si Min, the brother of one of Mr. Zhang Feng. Neptunus Yidianyao is an associate of Mr. Zhang Feng and thus a connected person of the Company) entered into the distribution agreement (the "Neptunus Yidianyao Distribution Agreement"), pursuant to which the Group will provide pharmaceutical products, food, healthcare food products and medical devices to Neptunus Yidianyao and its subsidiaries (the "Neptunus Yidianyao Group") for it to distribute within the PRC for the period from 1 January 2024 to 31 December 2026 (both days inclusive). The annual caps of such transactions for the year of 2024, 2025 and 2026 would not exceed RMB10,000,000, RMB10,000,000 and RMB10,000,000 respectively. Upon the commencement of the term of the Neptunus Yidianyao Distribution Agreement, the Nepstar Distribution Agreement shall be terminated with immediate effect. For details of the transaction, please refer to the announcement of the Company dated 28 December 2023.

- it will not, and will procure its associates not to, whether within or outside the PRC, directly or indirectly (other than those indirectly held as a result of the equity interest in any listed company or its subsidiaries), participate in or operate any business in whatever form, or produce any products (the usage of which is the same as or similar to that of the products of the Company) which may constitute direct or indirect competition to the business operated by the Company from time to time; and
- 2. it will not, and will procure its associates not to, hold any interest, whether within or outside the PRC, in any company or organization (directly or indirectly, other than those indirectly held as a result of its equity interest in any listed company or its subsidiaries) when the business of such company or entity will (or may) compete directly or indirectly with the business of the Company.

Pursuant to the Non-Competition Undertakings, at a time when the Non-Competition Undertakings are subsisting, whenever Neptunus Bioengineering or any its associates enters into any negotiations, within or outside the PRC, in relation to any new investment projects which may compete with the existing and future business of the Company, the Company shall have preferential rights of investments in such new investment projects.

Neptunus Bio-engineering has confirmed with the Company that it has complied with the Non-Competition Undertakings during the Year.

The Company strives to attain a high standard of corporate governance. The principles of corporate governance adopted by the Company emphasize a quality board, sound internal control transparency and accountability to all stakeholders.

### (A) Corporate Governance Practices

The Corporate Governance Code was effective for accounting periods commencing on or after 1 January 2005. The Company puts strong emphasis on the superiority, steadiness and rationality of corporate governance. The Board is of the view that the Company has complied with the requirements set out in the then applicable Appendix C1 "Corporate Governance Code" of the GEM Listing Rules throughout the Year.

# (B) Code of Conduct Regarding Securities **Transactions by Directors**

During the Year, the Company has adopted a code of conduct regarding securities transactions by the Directors on terms no less exacting than the "required standard of dealings" as set out in Rules 5.48 to 5.67 of the GEM Listing Rules. Having made specific enquiry of all the Directors, all the Directors have confirmed that they have complied with the "required standard of dealings" and the Company's internal code of conduct regarding securities transactions by the Directors during the Year.

# (C) Responsibilities, Accountabilities and Contributions of the Board and the Management

The Board is responsible for planning and overseeing the overall development and management of the Company with the objective of enhancing shareholders' value. The Board, led by the Chairman, is responsible for the approval and monitoring of the overall strategies and policies of the Company, approval of annual budgets and business plans, evaluation of the Company's performance and oversight of the management. During the Year, the Board at all times met the requirements of the GEM Listing Rules relating to the appointment of at least three independent non-executive Directors, representing at least one-third of the Board with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

The Company has established a Board Independence Evaluation Mechanism during the Year which sets out the processes and procedures to ensure a strong independent element on the Board, which allows the Board to effectively exercise independent judgement to better safeguard shareholders' interests.

The objectives of the evaluation are to improve Board effectiveness, maximise strengths, and identify the areas that need improvement or further development. The evaluation process also clarifies what actions of the Company need to be taken to maintain and improve the Board performance, for instance, addressing individual training and development needs of each Director.

Pursuant to the Board Independence Evaluation Mechanism, the Board will conduct annual review on its independence. The Board Independence Evaluation Report will be presented to the Board which will collectively discuss the results and the action plan for improvement, if appropriate.

During the year ended 31 December 2023, all Directors have completed the independence evaluation in the form of a questionnaire individually. The Board Independence Evaluation Report was presented to the Board and the evaluation results were satisfactory.

Mr. Yick Wing Fat, Simon is the chairman of the Audit Committee.

The primary duties of the Audit Committee are as follows:

- to consider, and to make recommendations to the Board on the appointment, reappointment and removal of the external auditors, and to approve the remuneration and terms of engagement of the external auditors, and to resolve any issues of resignation or dismissal of that auditor;
- to review and monitor the external auditors' independence and objectivity and the effectiveness of the auditing process in accordance with applicable accounting standards;
- (iii) to discuss the nature and scope of the audit and reporting obligations with the external auditors before the auditing commences, and to ensure co-ordination where more than one audit firm are involved;

Mr. Zhang Feng is the Chairman of the Nomination Committee.

The major duties of the Nomination Committee are as follows:

- to review the structure, size and composition (including the skills, knowledge and experience) and diversity of the Board and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy.
- to identify individuals suitably qualified to become members of the Board and select or make recommendations to the Board on the selection of individuals nominated for directorships.
- (iii) to assess the independence of independent non-executive Directors.
- (iv) to make recommendations to the Board on the appointment or re-appointment of Directors and succession planning for Directors, in particular the Chairman of the Board and the General Manager.

The Nomination Committee and the Board are of the view that the current composition of the Board has achieved the objectives set in the Policy.

The Nomination Committee will review the Policy, as appropriate, to ensure its effectiveness.

The Company values gender diversity across all levels of the Group. The male-to-female ratio in the workforce of the Group, including the Board and senior management as at the date of this annual report is 591:853.

The Board targeted to achieve and has achieved to have at least one female Director, and considers that the above current gender diversity is satisfactory.

Details on the gender ratio of the Group together with relevant data can be found in B1: Employment of Chapter Viii Social Aspect of the Environmental, Social and Governance Report of the Company for the Year.

The Company will also proactively provide trainings to our senior managements and will take into account the factor of gender diversity when recruiting suitable candidates for our senior management in the future, so to develop a pipeline of potential successors for the Board and enhance gender diversity in the Board in the coming years.

The Nomination Committee is primarily responsible for identifying qualified candidates to become members of the Board. The appointment of Directors will continue to be made on a merit basis, with the principle of candidates being considered against objective criteria (including but not limited to professional qualifications, skills, experience, independence, time available for performance of Director's duties and willingness) with due regard for the benefits of diversity of the Board. The nomination procedures of a Director can be divided into two categories, being the nomination procedure of a new Director and the re-election procedure of a retired Director. The nomination procedure of a new Director of the Nomination Committee is: 1) evaluate the candidate based on the abovementioned Director appointment principle to determine whether such candidate is qualified upon receipt of the proposal on appointment of new Director and the biographical information of the candidate; 2) rank the qualified candidates by order of preference based on the needs of the Company and reference check of candidates; 3) make recommendation to the Board on the proposal on appointment of new Director; and 4) make recommendation to the shareholders on the proposal on appointment of new Director at the general meeting. The re-election procedure of a retired Director of the Nomination Committee is: 1) review the overall contribution and services to the Company, participation in the Company's business and performance of the retired Director; 2) evaluate the retired Director based on the abovementioned Director appointment principle to determine whether such retired Director is still qualified; and 3) make recommendation to the shareholders on the proposal on re-election of retired Director at the general meeting. The Nomination Committee is also responsible for monitoring the implementation and reviewing the effectiveness of this Policy.

During the Year, the Nomination Committee has reviewed among other things, the Board composition and structure and the effectiveness of the Policy and the results were satisfactory. During the Year, the Nomination Committee held two meetings.

#### **Remuneration Committee**

The Remuneration Committee was established on 21 August 2005, comprising one executive Director and two independent non-executive Directors, namely Mr. Zhang Feng, Mr. Yick Wing Fat, Simon and Mr. Poon Ka Yeung. Mr. Poon Ka Yeung is the chairman of the Remuneration Committee.

The major duties of the Remuneration Committee include:

- pursuant to provision E.1.2(c)(ii) of the Corporate Governance Code, to make recommendations to the Board on the Company's policy and structure for all remuneration of the Directors and the senior management and on the establishment of a formal and transparent procedure for developing policy on such remuneration;
- to make recommendations to the Board on the remuneration of executive Directors and senior management, which shall include non-monetary benefits, pension rights and compensation payments (including compensation payable for loss or termination of their office or appointment), and to make recommendations to the Board on the remuneration of the non-executive Directors; and
- (iii) to review and approve the remuneration suggestions of the management according to the corporate goals and objectives made by the Board from time to time.

The Remuneration Committee determined the remuneration of the Directors according to their expertise, knowledge and commitment to the Company with reference to the Company's profitability and the prevailing market conditions. The Remuneration Committee should consult the executive Directors and the General Manager about its proposals relating to the remuneration of the senior management.

During the Year, the Remuneration Committee held three meetings to review and discuss the Directors' remuneration packages of the current session of the Board and the remuneration packages for the current session of the senior management of the Company.

### (G) Chairman and General Manager

The roles of the Chairman and General Manager are separate and should not be performed by the same individual as stipulated under provision C.2.1 of Corporate Governance Code. As the leader of the Board, the Chairman is responsible for the approval and supervision of the overall strategies and policies of the Company, approval of annual budgets and business plans, evaluation of the Company's performance and oversight of the management. Mr. Zhang Feng is the current Chairman of the Board. The General Manager (same role as the post of chief executive pursuant to the Corporate Governance Code) is responsible for the day-to-day operations of the Company and this position is temporarily vacant. The Company is identifying a suitable candidate to fulfill the vacancy of the General Manager. The Company's articles of association has set out the role and powers of the Chairman and General Manager.

## (H) Directors' Responsibility for Accounts

The Directors have confirmed and acknowledged their responsibility for the preparation of the Company's financial statements is in compliance with the relative regulations and applicable accounting standards. The Board has also warranted that the Company's financial statements would be distributed in due course.

The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

#### (I) Auditor's Remuneration

During the Year, approximately RMB1,437,000 (2022: approximately RMB1,331,000) and approximately RMB658,000 (2022: approximately 650,000) were charged to the Group's income statement for the external auditor's audit services and non-audit services (consultation on ESG and review of internal control system) respectively.

### (J) Risk Management and Internal Control

The Board is responsible for overseeing the internal control system and risk management of the Group and for reviewing its effectiveness. To facilitate the effectiveness and efficiency of business operations, to ensure the reliability of financial report, to safeguard the Group's assets and the interest of shareholders and to ensure compliance with relevant laws and regulations, the Company emphasizes the importance of a sound internal control system. The internal control system and risk management is designed to manage rather than to eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The risk management process includes several key steps, including the identification, evaluation, and implementation of measures to manage risks. Additionally, it involves reviewing the effectiveness of the internal control systems and addressing any significant internal control deficiencies.

As part of this process, the management of the Company conducted interviews with relevant staff members, thoroughly reviewed documentation related to the internal control system, and identified and evaluated any deficiencies in its design. Subsequently, recommendations for improvement were provided, and the implementation of these recommendations was closely monitored. These efforts were reported to and reviewed by the Audit Committee during the Year.

To ensure the safeguarding of assets against unauthorized use or disposition and to comply with applicable laws, rules, and regulations, the Company has put in place comprehensive procedure manuals and operational guidelines. These measures aim to maintain accurate accounting records and provide reliable financial information for both internal use and external publication.

The Board approved the Company in 2017 to perform the internal audit function by sharing the resources of the immediate parent company, Neptunus Bio-engineering. And the internal audit function is performed by an internal audit team, which comprises the personnel appointed by the Company and seconded personnel of Neptunus Bio-engineering. The internal audit team carried out comprehensive auditing of certain subsidiaries during the Year. Taking a risk-oriented approach, the team reviewed important control activities in respect of key operation procedures, identified defects, implemented defect rectification measures, organised and improved internal risk control and management system for the purpose of risk control. The audit result and rectification measures were submitted to the Audit Committee and the Board for review in the Year. During the Year, the management of the Company has also appointed an external consultant of internal control to conduct a review on the Group's internal control system and risk management system. Such external consultant of internal control has carried out the analysis and independent appraisal of the adequacy and the effectiveness of the internal control system and risk management of the Group and has submitted the results of the review and its recommendations and opinions for consideration to the Audit Committee and the Board. The review covers all material controls. including financial, operational and compliance and risk management functions. The Audit Committee and the Board have discussed the relevant results of the review and appropriate modifications will be made to the management system of the Group according to the findings and recommendations therein. Also during the Year, the Audit Committee and the Board has assessed whether the Group's resources in accounting and financial reporting functions are sufficient, whether the staff has sufficient qualification and experience and whether the trainings for staff and related budget are sufficient.

Based on the information supplied, coupled with its own observations and with the assistance of the Audit Committee, the Board believes that, in respect of the nature and size of the Group's operations and business, the present internal control system and monitoring process (including sufficiency of the resources in accounting and financial reporting functions, staff's qualification and experience and trainings for staff and related budget) are effective and adequate and have complied with the requirements under the provisions of the code.

The Board is committed to incorporating the ESG mindset into business operations. The Board accepts full responsibility for the sustainability of the Group, including formulating strategies, overseeing the Group's ESG related risks and opportunities, and approving the Environmental, Social and Governance Report. The Board is also required to keep abreast of and comply with the latest regulatory requirements before the approval of the Environmental, Social and Governance Report.

The Board believes that the management of ESG-related risks and opportunities is essential to the Group's efficient and effective operation. The risk management and internal control systems assure accuracy, reliability and timeliness of the data presented and sustainable development measures. The Board will also regularly review the implementation effectiveness of the systems and whether they cover major control measures on material ESG issues.

Based on the findings and recommendations of external consultant as well as the comments of the Audit Committee, the Board considered the internal control and risk management systems effective and adequate. The Company considers that sufficient risk management and internal control of the Group can be maintained with the abovementioned arrangements.

## (K) Procedures for Handling and Dissemination of **Inside Information**

At the reporting date, the Group had inventories of approximately RMB205,424,000. Inventories are carried at the lower of cost and net realisable value.

In determining the net realisable value of inventories, estimates and judgements are applied by the management, including the use of historical ageing statistics, projection of expected volume and price of future sales of inventories.

We have identified the valuation of inventories as a key audit matter considering the materiality of the balances and the involvement of management's estimation and judgement on the net realisable value of inventories.

Our audit procedures to the valuation of inventories included the following:

- Obtained an understanding of management's process for estimation of net realisable value of inventories.
- Selected inventory items on a sample basis and tested their net realisable value calculation.
- Compared, on a sample basis, subsequent sales prices and volumes against the management's projections.
- Considered the accuracy of historical provisions against actual inventory write-off.

At the reporting date, the Group had intangible assets with indefinite useful lives and goodwill of approximately RMB99,626,000 and RMB63,422,000 respectively.

Intangible assets with indefinite useful lives included anesthetic drug production and selling right and trade name. These intangible assets were individually assessed at year end for impairment. The valuation process involved significant estimates and judgement made by management over the cash flow forecasts, discount rates and growth rates of particular drug markets.

For impairment assessment of goodwill, the recoverable amount of the cash generating unit ("CGU") was determined based on value in use calculation which involves significant management judgement and estimations including the growth rates and discount rates applied in the value in use calculation

We have identified the impairment of intangible assets with indefinite useful lives and goodwill as a key audit matter considering the materiality of the balances and the use of estimates and judgement by the management in assessing their recoverable amounts.

Our audit procedures to impairment assessment of intangible assets with indefinite useful life and goodwill included the following:

- Obtained valuation reports from independent valuer employed by the Company and assessed its qualification and competence if applicable.

At the reporting date, the Group had trade receivables of approximately RMB174,252,000, net of expected credit loss ("ECL") allowance of approximately RMB22,771,000.

In calculating the ECL allowance, the ECL rates are estimated by taking into account the credit loss experience, ageing of overdue trade receivables, customers' repayment history, customers' financial position and an assessment of both the current and forecast general economic conditions, all of which involve significant degree of estimates and judgement made by the management.

We have identified the expected credit loss of trade receivables as a key audit matter considering the materiality of the balances and the involvement of management's estimation and judgement in assessing the ECL allowance of trade receivables.

Our audit procedures to the expected credit loss of trade receivables included the following:

- Obtained an understanding of how the loss allowance for trade receivables is estimated by the management.
- Tested the aging analysis of trade receivables, on a sample basis, to the source documents including goods delivery notes and sales invoices.
- Reviewed the aging analysis of trade receivables throughout the year to understand the settlement patterns of the customers.

#### 1. General Information

Shenzhen Neptunus Interlong Bio-technique Company Limited (the "Company") is a limited liability company incorporated and domiciled in the People's Republic of China (the "PRC"). The address of its registered office is Suite 1702, Neptunus Yinhe Technology Mansion, 1 Keji Middle 3rd Road, Maling Community, Yuehai Sub-district, Nanshan District, Shenzhen, Guangdong Province, the PRC and its principal place of business is the PRC. The Company's shares are listed on GEM of The Stock Exchange of Hong Kong Limited.

The Group is controlled by Neptunus Bio-engineering, a limited liability company incorporated and domiciled in the PRC and its shares are listed on the Shenzhen Stock Exchange. The ultimate parent company of the Group is Shenzhen Neptunus Holding Group Limited, a company incorporated in the PRC.

The Group include the development, production and sales of medicines and medical devices, the research and development of modern biological technology business and the purchase and sales of medicines, healthcare food products and medical devices. The Group's operations are based in the PRC.

The consolidated financial statements for the year ended 31 December 2023 were approved for issue by the board of directors on 27 March 2024.

# 2. Summary of Material Accounting Policies

#### 2.1 Basis of preparation

These annual consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the applicable disclosure requirements of the Hong Kong Companies Ordinance.

These consolidated financial statements also comply with the applicable disclosure requirements of the Rules Governing the Listing of Securities on GEM of the Stock Exchange of Hong Kong Limited ("GEM Listing Rules").

These consolidated financial statements are presented in Renminbi ("RMB") which is also the functional currency of the Company. All amounts are rounded to the nearest thousand except where otherwise indicated.

The Material Accounting Policies that have been used in the preparation of these consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented unless otherwise stated. The adoption of new or amended HKFRSs and the impacts on the Group's consolidated financial statements, if any, are disclosed in note 3.

The consolidated financial statements have been prepared on the historical cost basis. The measurement bases are fully described in the accounting policies below.

It should be noted that accounting estimates and assumptions are used in the preparation of the consolidated financial statements. Although these estimates are based on management's best knowledge and judgement of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 4.

#### 2.2 Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries make up to 31 December each year.

Subsidiaries are entities controlled by the Group. The Group controls an entity when the Group is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power over the entity, only substantive rights relating to the entity (held by the Group and others) are considered.

The Group includes the income and expenses of a subsidiary in the consolidated financial statements from the date it gains control until the date when the Group ceases to control the subsidiary.

Intra-group transactions, balances and unrealised gains and losses on transactions between group companies are eliminated in preparing the consolidated financial statements. Where unrealised losses on intra-group asset sales are reversed on consolidation, the underlying asset is also tested for impairment from the Group's perspective. Amounts reported in the financial statements of subsidiaries have been adjusted where necessary to ensure consistency with the accounting policies adopted by the Group.

Non-controlling interests represent the equity on a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at their proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from the equity attributable to the owners of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the owners of the Company.

In the Company's statement of financial position, subsidiaries are carried at cost less any impairment loss unless the subsidiary is held for sale or included in a disposal group. Cost also includes direct attributable costs of investment.

The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable at the reporting date. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

Business combinations are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are recognised in profit or loss as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets include an input and a substantive process that together significantly contribute to the ability to create outputs. The acquired process is considered substantive if it is critical to the ability to continue producing outputs, and the inputs acquired include an organised workforce with necessary skills, knowledge, or experience to perform that process or it significantly contributes to the ability to continue producing outputs and is considered unique or scarce or cannot be replaced without significant cost, effort, or delay in the ability to continue producing outputs.

Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are, with limited exceptions, measured initially at their fair values at the acquisition date.

Consideration transferred as part of a business combination does not include amounts related to the settlement of pre-existing relationships. The gain or loss on the settlement of any preexisting relationship is recognised in profit or loss.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed. If, after reassessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any noncontrolling interests in the acquiree and the fair value on the acquirer's previously held interest in the acquire (if any), the excess is recognised immediately in profit or loss as bargain purchase gain.

Where the consideration the Group transfers in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and considered as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments being made against goodwill or gain on bargain purchase. Measurement period adjustments are adjustments that arise from additional information obtained during the measurement period about facts and circumstances that existed as of the acquisition date. Measurement period does not exceed one year from the acquisition date. The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not subsequently remeasured and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as a financial liability is subsequently remeasured at each reporting dates at fair value with changes in fair value recognised in profit or loss.

Changes in the value of the previously held equity interest recognised in other comprehensive income and accumulated in equity before the acquisition date are reclassified to profit or loss when the Group obtains control over the acquiree.

#### 2.4 Property, plant and equipment

Property, plant and equipment (other than construction-inprogress as described below and cost of right-of-use assets as described in note 2.13) are initially recognised at acquisition cost and/or manufacturing cost (including any cost directly attributable to bringing the assets to the location and condition necessary for them to be capable of operating in the manner intended by the Group's management). They are subsequently stated at cost less accumulated depreciation and accumulated impairment losses, if any.

The carrying amount of the replaced part is derecognised. All other costs, such as repairs and maintenance, are charged to profit or loss during the financial period in which they are incurred.

#### 2.5 Prepaid lease payments

"Prepaid lease payments" (which meet the definition of right-ofuse assets) represent the upfront payment for long-term land lease in which the payment can be reliably measured. It is stated at cost less accumulated depreciation and any accumulated impairment losses. Depreciation is calculated on a straight line basis over the term of the lease/right-of-use except where an alternative basis is more representative of the time pattern of benefits to be derived by the Group from use of the land.

#### 2.6 Intangible assets (other than goodwill) and research and development activities

#### Intangible assets (other than goodwill)

Acquired intangible assets are recognised initially at cost. After initial recognition, intangible assets with finite useful lives are carried at cost less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is provided on straight-line basis over their estimated useful lives. Amortisation commences when the intangible assets are available for use. The following useful lives are applied:

The useful life of the anesthetic drug production and selling right and trade name are considered by the management of the Group as indefinite because the anesthetic drug production and selling right and trade name is expected to contribute to the Group's net cash inflows indefinitely.

Intangible assets with indefinite useful lives are carried at cost less any subsequent accumulated impairment losses.

The assets' amortisation methods and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

Intangible assets, with finite and indefinite useful lives, are tested for impairment as described below in note 2.18.

#### Research and development costs

Costs associated with research activities are expensed in profit or loss as they occur. Costs that are directly attributable to development activities are recognised as intangible assets provided they meet the following recognition requirements:

- demonstration of technical feasibility of the prospective product for internal use or sale;
- (ii) there is intention to complete the intangible asset and use or sell it;
- (iii) the Group's ability to use or sell the intangible asset is demonstrated:
- (iv) the intangible asset will generate probable economic benefits through internal use or sale;
- (v) sufficient technical, financial and other resources are available for completion; and
- (vi) the expenditure attributable to the intangible asset can be reliably measured.

Direct costs include employee costs incurred on development activities along with an appropriate portion of relevant overheads. The costs of development of internally generated software, products or knowhow that meet the above recognition criteria are recognised as intangible assets. They are subject to the same subsequent measurement method as acquired intangible assets.

All other development costs are expensed as incurred.

#### 2.7 Goodwill

Goodwill arising in a business combination is recognised as an asset at the date that control is acquired (the acquisition date). Goodwill is measured as the excess of the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the Group's interest in the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

If, after reassessment, the Group's interest in the fair value of the acquiree's identifiable net assets exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held equity interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Goodwill is stated at cost less accumulated impairment losses. Goodwill is allocated to cash-generating units and is tested annually for impairment (see note 2.18).

On subsequent disposal of a subsidiary, the attributable amount of goodwill capitalised is included in the determination of the amount of gain or loss on disposal.

#### Recognition and derecognition

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions of the financial instrument.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and substantially all of its risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

#### Financial assets

#### Classification and initial measurement of financial assets

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price in accordance with HKFRS 15 "Revenue from Contracts with Customers", all financial assets are initially measured at fair value, in case of a financial asset not at fair value through profit or loss ("FVTPL"), plus transaction costs that are directly attributable to the acquisition of the financial asset. Financial assets at amortised cost

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVTPL):

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows; and
- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method. Interest income from these financial assets is included in other revenue in profit or loss. Discounting is omitted where the effect of discounting is immaterial. The Group's time deposits, short-term bank deposits, bank balances and cash and trade and other receivables fall into this category of financial instruments.

#### Financial assets at FVTPL

Financial assets that are held within a difference business model other than "hold to collect" or "hold to collect and sell" are categorised at FVTPL. Further, irrespective of business model, financial assets whose contractual cash flows are not solely payments of principal and interest are accounted for at FVTPL. The Group's financial liabilities include trade and other payables, interest-bearing borrowings and lease liabilities.

Financial liabilities (other than lease liabilities) are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Group designated a financial liability at FVTPL.

Subsequently, financial liabilities (other than lease liabilities) are measured at amortised cost using the effective interest method except for derivatives which are not designated as hedging instruments in hedge relationships and financial liabilities designated at FVTPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss.

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs.

Accounting policies of lease liabilities are set out in note 2.13.

#### Interest-bearing borrowings

Interest-bearing borrowings are recognised initially at fair value, net of transaction costs incurred. Interest-bearing borrowings are subsequently stated at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in profit or loss over the period of the borrowings using the effective interest method.

Interest-bearing borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.

#### Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost, using the effective interest method.

HKFRS 9's impairment requirements use forward-looking information to recognise ECL – the "ECL model". Instruments within the scope included loans and other debt-type financial assets measured at amortised cost and trade and other receivables.

The Group considers a broader range of information when assessing credit risk and measuring ECL, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ("Stage 1") and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ("Stage 2").

"Stage 3" would cover financial assets that have objective evidence of impairment at the reporting date.

"12-month ECL" are recognised for the Stage 1 category while "lifetime ECL" are recognised for the Stage 2 category.

Measurement of the ECL is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

#### Trade receivables

The Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at each reporting date. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. In calculating the ECL, the Group has established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

To measure the ECL, trade receivables have been grouped based on shared credit risk characteristics and the days past due.

#### Other financial assets measured at amortised cost

The Group measures the loss allowance for other receivables equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial assets at the reporting date with the risk of default occurring on the financial assets at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;

- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in regulatory, business, financial, economic conditions, or technological environment that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations; and
- an actual or expected significant deterioration in the operating results of the debtor.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 90 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the aforegoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the end of each reporting period. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations.

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group).

Detailed analysis of the ECL assessment of trade receivables and other financial assets measured at amortised cost are set out in note 31.2

#### 2.10 Inventories

Inventories are carried at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business less the estimated cost of completion and applicable selling expenses.

Cost is determined using the weighted average basis, and in the case of work in progress and finished goods, comprise direct materials, direct labour and an appropriate proportion of overheads. It excludes borrowing costs.

#### 2.11 Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand, demand deposits with banks and short term highly liquid investments with original maturities of three months or less that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

#### 2.12 Contract liabilities

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised.

#### 2.13 Leases

#### Definition of a lease and the Group as a lessee

At inception of a contract, the Group considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an identified asset (the underlying asset) for a period of time in exchange for consideration'. To apply this definition, the Group assesses whether the contract meets three key evaluations which are whether:

the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Group;

- the Group has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract; and
- the Group has the right to direct the use of the identified asset throughout the period of use. The Group assesses whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

For contracts that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease and non-lease component on the basis of their relative stand-alone prices.

#### Measurement and recognition of leases as a lessee

At lease commencement date, the Group recognises a rightof-use asset and a lease liability on the consolidated statement of financial position. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Group, an estimate of any costs to dismantle and remove the underlying asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Group depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term unless the Group is reasonably certain to obtain ownership at the end of the lease term. The Group also assess the right-ofuse asset for impairment when such indicator exists.

At the commencement date, the Group measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, or the Group's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in-substance fixed payment) less any lease incentives receivable, variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee. The lease payments also included the exercise price of a purchase option reasonable certain to be exercised by the Group and payment of penalties for terminating a lease, if the lease term reflects the Group exercising the option to terminate.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest cost on the lease liability. It is remeasured to reflect any reassessment or lease modification, or if there are changes in in-substance fixed payments. The variable lease payments that do not depend on an index or a rate are recognised as expense in the period on which the event or condition that triggers the payment occurs.

The Group remeasures lease liabilities whenever:

- there are changes in lease term or in the assessment of exercise of a purchase option, in which case the related lease liability is remeasured by discounting the revised lease payments using a revised discount rate at the date of reassessment.
- the lease payments changes due to changes in market rental rates following a market rent review/expected payment under a guaranteed residual value, in which cases the related lease liability is remeasured by discounting the revised lease payments using the initial discount rate.

For lease modification that is not accounted for as a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of modification.

When the lease is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-ofuse asset is already reduced to zero.

The Group has elected to account for short-term leases using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these lease are recognised as an expense in profit or loss on a straight-line basis over the lease term. Short-term leases are leases with a lease term of 12 month or less.

The prepaid lease payments for leasehold land are included as "Right-of-use assets" under non-current assets.

#### 2.14 Provisions and contingent liabilities

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

#### 2.15 Share capital

Ordinary shares are classified as equity. Share capital is recognised at the amount of consideration of shares issued, after deducting any transaction costs associated with the issuing of shares (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction.

#### 2.16 Revenue recognition

Revenue arises mainly from manufacturing and selling of medicines and healthcare products.

To determine whether to recognise revenue, the Group follows a 5-step process:

- 1. Identifying the contract with a customer
- 2. Identifying the performance obligations
- 3. Determining the transaction price
- 4. Allocating the transaction price to the performance obligations
- 5. Recognising revenue when/as performance obligation(s) are satisfied

In all cases, the total transaction price for a contract is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue is recognised either at a point in time or over time, when (or as) the Group satisfies performance obligations by transferring the promised goods or services to its customers.

Further details of the Group's revenue and other income recognition policies are as follows:

#### Sales of goods

Revenue from manufacturing and selling of medicines and healthcare products and medical devices for which control of assets is transferred at a point in time is recognised when the goods are delivered to customers. The Group provides sales return policies to customers, and the amount of sales return was insignificant.

#### Interest income

Interest income is recognised on a time proportion basis using the effective interest method.

#### Licence fee income

Licence fee income is recognised on an accrual basis in accordance with the substance of the relevant agreement.

### 2.17 Government subsidies

Subsidies from the government are recognised at their fair value where there is a reasonable assurance that the subsidies will be received and the Group will comply with all attached conditions. Government subsidies are deferred and recognised in profit or loss over the period necessary to match them with the costs that the subsidies are intended to compensate. Government subsidies relating to the purchase of assets are deducted from the carrying amount of the asset and consequently are effectively recognised in profit or loss over the useful life of the asset by way of reduced depreciation expense.

Government subsidies relating to income is presented in gross under "Other revenue and other net income" in the consolidated statement of profit or loss and other comprehensive income.

#### 2.18 Impairment of non-financial assets

Intangible assets, property, plant and equipment, right-ofuse assets (including prepaid lease payments), goodwill arising on acquisition of a subsidiary and the Company's interests in subsidiaries are subject to impairment testing.

Goodwill and other intangible assets with indefinite useful life or those not yet available for use are tested for impairment at least annually, irrespective of whether there is any indication that they are impaired. All other assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e., a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cashgenerating unit level. Corporate assets are allocated to individual cash-generating units, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified. Goodwill in particular is allocated to those cash-generating units that are expected to benefit from synergies of the related business combination and represent the lowest level within the Group at which the goodwill is monitored for internal management purpose and not be larger than an operating segment.

Impairment losses recognised for cash-generating units, to which goodwill has been allocated, are credited initially to the carrying amount of goodwill. Any remaining impairment loss is charged pro rata to the other assets in the cash generating unit, except that the carrying value of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable.

An impairment loss on goodwill is not reversed in subsequent periods. In respect of other assets, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

#### 2.19 Employee benefits

# Short-term employee benefits and contributions to central pension scheme

The Group participates in the central pension scheme (the "CPS") operated by the local government authority for all of its employees in the PRC. The Group is required to contribute a certain percentage of their covered payroll to the CPS to fund the benefits. The only obligation of the Group with respect to the CPS is to pay the ongoing required contributions under the CPS. Contributions under the CPS are recognised in profit or loss as they become payable in accordance with the rules of the CPS.

Salaries, annual bonuses, paid annual leave and contributions to central pension scheme are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

薪金、年終花紅、年度有薪假期及中央 退休金計劃供款,均在本集團的僱員提 供服務的年度內以應計基準支銷。若支 出已遞延及有重大的影響,該數額則以 折現值報值。

#### 2.21 Foreign currency translation

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated (i.e. only translated using the exchange rates at the transaction date).

#### 2.22 Accounting for income taxes

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the consolidated financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss and does not give rise to equal taxable and deductible temporary differences.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly in equity.

Current tax assets and current tax liabilities are presented in net if, and only if:

- (a) the Group has the legally enforceable right to set off the recognised amounts; and
- (b) intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

The Group presents deferred tax assets and deferred tax liabilities in net if, and only if:

(a) the entity has a legally enforceable right to set off current tax assets against current tax liabilities; and

In March 2021, HKICPA issued HKFRS Practice Statement 2 "Making Materiality Judgements" to provide entities with non-mandatory guidance on how to make materiality judgements when preparing their general purpose financial statements in accordance with HKFRS. HKFRS Practice Statement 2 was subsequently revised to provide guidance and examples on how to apply the concept of materiality to accounting policy disclosures.

The amendments to HKAS 1 are applied by the Group on 1 January 2023 and are applied prospectively. The amendments have no impact on the Group's financial positions and performance but has affected the accounting policies disclosures as set out in note 2 to the consolidated financial statements.

#### Amendments to HKAS 8 "Definition of Accounting Estimates"

The amendments clarify how entities should distinguish changes in accounting policies from changes in accounting estimates by introducing a definition for accounting estimates, which is now defined as "monetary amounts in the financial statements that are subject to measurement uncertainty".

Besides, the amendments also clarify the relationship between accounting policies and accounting estimates by specifying that an entity develops an accounting estimate to achieve the objective set out by an accounting policy. Accounting estimates typically involve the use of judgements or assumptions based on latest available reliable information. A change in accounting estimate that results from new information or new development is not correction of an error. Therefore, the effects of a change in an input or a measurement technique used to develop an accounting estimate are changes in accounting estimates if they do not result from the correction of prior period errors. In addition, two illustrative examples are added to illustrate how to apply the new definition of accounting estimates.

The amendments are applied by the Group on 1 January 2023 and are applied prospectively. The amendments have no impact on the consolidated financial statements of the Group.

The amendments clarify that the initial recognition exemption of deferred tax in HKAS 12 "Income Taxes" does not apply to transactions that give rise to equal taxable and deductible temporary differences, such as lease contracts that give rise to the recognition of a lease liability and the corresponding right-of-use assets and contracts that give rise to the recognition of decommissioning obligations and corresponding amounts recognised as assets. Instead, entities are required to recognise the related deferred tax asset and liability on initial recognition, with the recognition of any deferred tax asset being subject to the recoverability criteria in HKAS 12 "Income Taxes".

The Group adopted the amendments from 1 January 2023 and are required to recognise the associated deferred tax assets and liabilities from leases that occurred on or after 1 January 2022, with any cumulative effect recognised as an adjustment to retained profits at that date.

Prior to the application of the amendments, the Group had recognised the deferred tax assets and liabilities arising from leases on a net basis. Following the requirements of the amendments, the Group has recognised a separate deferred tax asset in relation to its lease liabilities and a deferred tax liability in relation to its right-of-use assets as at 1 January 2022. As the balances are qualified for offset under paragraph 74 of HKAS 12, there is no material impact on the opening retained profits as at 1 January 2022 as a result of the amendments.

The amendments provide mandatory temporary relief from accounting for deferred tax arising from the Organisation for Economic Cooperation and Development's Pillar Two model rules (i.e. global minimum tax rules designed to ensure that large multinational business pay a minimum effective rate of tax of 15% on profits in all countries) ("Pillar Two Model Rules"). Entities shall apply this temporary exception immediately and retrospectively upon issuance of the amendments and disclose the fact of the application.

The amendments specify that, in subsequent measurement of the lease liability arising from a sale and leaseback transaction (where the transaction qualifies as a sale under HKFRS 15), a seller-lessee determines "lease payments" and "revised lease payments" in a way that does not result in the recognition of a gain or loss that relates to the right of use it retains. It would reduce the lease liability as if the "lease payments" estimated at the date of transaction had been paid. Any difference between those lease payments and the amounts actually paid is recognised in profit or loss. The amendments do not prescribe a particular method of subsequent measurement. The seller-lessee will need to develop and apply an accounting policy that results in relevant and reliable information in accordance with HKAS 8.

The illustrative examples to HKFRS 16 have also been amended. Example 24 now illustrates a sale and leaseback transaction with fixed payments and above-market terms. A new Example 25 illustrates a sale and leaseback transaction with variable lease payments that do not depend on an index or rate. The illustrative examples also clarify that the liability, that arise from a sale and leaseback transaction that qualifies as a sale applying HKFRS 15, is a lease liability.

Amendments to HKFRS 16 are effective for annual reporting period beginning on or after 1 January 2024 and are applied by seller-lessee retrospectively to sale and leaseback transactions entered into after the date of initial application of HKFRS 16). Earlier application is permitted. The directors of the Group expect that the amendments have no material impact on the consolidated financial statements.

- "Settlements" are newly defined as a transfer to the counterparty that results in the extinguishment of the liability. The transfer could be of cash, other economic resources (e.g. goods or services), or entity's own equity instruments. Thus, if the counterparty conversion option is classified as liability under HKAS 32 "Financial Instruments: Presentation", the transfer of equity instruments by exercising the conversion option constitute settlement of liability for the purpose of current or non-current classification of liabilities. One exception to the definition is that if the counterparty conversion option is classified as equity in accordance with HKAS 32, the transfer of equity instruments by exercising the conversion option does not constitute settlement of liability and would be disregarded when determining whether the liability is current or non-current.

2022 Amendments issued in 2022 clarified that only covenants of a liability arising from a loan arrangement, which an entity must comply with on or before the reporting date (even if the covenant is only assessed after the reporting date) affect the classification of that liability as current or non-current. Those covenants to be complied with after the reporting date do not affect such classification at the reporting date.

## 4. Critical Accounting Estimates and Judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

#### **Estimation uncertainty**

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

#### Impairment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable. The recoverable amount of an asset is the higher of its fair value less costs of disposal and its value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset, which requires significant judgement relating to the level of revenue and the amount of operating costs. The Group uses all readily available information in determining an amount that is a reasonable approximation of the recoverable amount, including estimates based on reasonable and supportable assumptions and projections of revenue and operating costs. Changes in these estimates could have a significant impact on the carrying amounts of the assets and could result in additional impairment charge or reversal of impairment in future periods. The carrying amounts of the property, plant and equipment and right-of-use assets as at the end of the reporting period are RMB203,570,000 (2022: RMB207,674,000) and RMB81,003,000 (2022: RMB91,830,000) respectively.

#### Expected credit loss on trade and other receivables

The Group makes allowances on items subjects to ECL (including trade and other receivables) based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period as set out in note 2.9.

As at 31 December 2023, the aggregate carrying amounts of trade receivables and other receivables (excluding prepayment and value-added tax recoverable) amounted to RMB227,217,000 (2022: RMB205,021,000) (net of ECL allowance of RMB22,771,000 (2022: RMB24,120,000)) and RMB65,008,000 (2022: RMB87,078,000) (net of ECL allowance of RMB2,090,000 (2022: RMB1,825,000)) respectively.

When the actual future cash flows are different from expected, such difference will impact the carrying amount of trade receivables and other items within the scope of ECL under HKFRS 9 and credit losses in the periods in which such estimate has been changed.

#### Write-down of inventories

The Group determines the write-down of inventories with reference to inventories ageing analysis, projections of expected future saleability of inventories and the management's experience and judgement. A write-down of inventories will be made when the carrying amounts of inventories decline below their estimated net realisable value. Due to changes in market conditions, actual saleability of goods may be different from estimation and profit or loss could be affected by differences in the estimation. The carrying amounts of inventories as at the end of the reporting period is RMB205,424,000 (2022: RMB203,023,000).

#### Impairment of intangible assets

The Group performs impairment test of intangible assets in accordance with the accounting policy stated in note 2.18. The recoverable amounts are the higher of fair value less cost of disposal and value in use. The calculations of value in use require the use of estimates and assumptions made by management on the future operation of the business, pretax discount rate and other assumptions underlying the value in use calculations. The carrying amounts of intangible assets as at the end of reporting period is RMB122,149,000 (2022: RMB110,400,000).

Impairment of goodwill

The Group tests annually whether goodwill has suffered any impairment in accordance with the accounting policy stated in note 2.18. The recoverable amounts of cash-generating units have been determined based on valuein-use calculations. These calculations require the use of estimates about future cash flows and discount rates. In the process of estimating expected future cash flows management makes assumptions about future revenue and profits. These assumptions relate to future events and circumstances. The actual results may vary and may cause a material adjustment to the carrying amount of goodwill within the next financial year.

Determining the appropriate discount rate involves estimating the appropriate adjustment for market risk and for asset specific risk factors and the estimated cash flows and discount rate are subject to higher degree of estimation uncertainties. Details of the estimates of the recoverable amounts of cash generating units containing goodwill are disclosed in note 17.

During the year ended 31 December 2023, the Group recognised impairment loss of RMB33,102,000 (2022: Nil) on goodwill to reduce the carrying amount of goodwill to its recoverable amount. It is estimated that if the discount rate for the Group's has increased by 1%, a further impairment loss of RMB7,294,000 would be recognised against goodwill.

#### (a) Anesthetic drug production and selling right and trade name

The anesthetic drug production and selling right and the trade name used to produce revenue to the segment of manufacturing and selling of medicines under Fuzhou Neptunus Fuyao Pharmaceutical Company Limited ("Neptunus Fuyao"). The anesthetic drug production and selling right carries a sole narcotic production and selling right in Fujian Province as designated by the State, and has no foreseeable limit to the period over which the Group can use to generate net cashflows. As a result, the anesthetic drug production and selling right and trade name was assessed by the management of the Group as having an indefinite useful life and is not amortised. It is tested for impairment annually and whenever there is an indication that it may be impaired.

As at 31 December 2023 and 2022, the recoverable amount of anesthetic drug production and selling right was assessed by reference to a valuation carried out by Verity Appraisals Company Limited, an independent qualified professional valuer with appropriate qualification and experience in the valuation of similar assets in the relevant industry. As the assessed value of anesthetic drug production and selling right is higher (2022: higher) than its carrying amount, a reversal of provision for impairment loss of RMB16,201,000 (2022: no provision for impairment loss or reversal) was made during the Year.

The recoverable amount of trade name was assessed by reference to the value-in-use calculations. As the assessed value is higher than its carrying amount as at 31 December 2023 and 2022, no provision for impairment loss is considered necessary

The recoverable amount of anesthetic drug production and selling right is determined based on value in use calculations. These calculations use cash flow projections based on financial budget approved by the executive directors covering a five-year period and the expected growth rate during this five years is 1.02% (2022: -1.12%). Cash flows beyond five-year period are extrapolated using an average growth rate of 2% (2022: 2%). The growth rates used do not exceed the long-term average growth rates of the medical industries. The cash flows are discounted using a discount rate of 21.66% (2022: 25.06%). The discount rates used are pre-tax and reflect specific risks relating to the relevant segments.

The recoverable amount of trade name is determined based on the fair value of trade name as measured using a royalty rate of 5.1% (2022: 5.1%) on sales and a discount rate of 21.41% (2022: 24.3%). The annual sales were projected based on financial budgets approved by the executive directors covering a five-year period and the expected growth rate during this five years is 8.17% (2022: 13.70%) and to growth rate beyond five years has been extrapolated using an average growth rate of 2% (2022: 2%). The average growth rate of 2% (2022: 2%) is based on the average of 10-year consumer price index in the PRC and does not exceed the long-term average growth rates of the pharmaceutical industries.

The forecast for the Group's income from manufacturing and selling of medicines business in Beijing was adjusted in 2023 for the decline of the Group's development plan according to the medicines market in PRC due to sales of existing products were sluggish and the introduction of new products by the Group was delayed as compared to the original plan, which result the manufacturing and selling of medicines business in Beijing remains in a loss-making position. Impairment testing considering these latest developments resulted in the impairment of goodwill associated with the cash generating unit of manufacturing and selling of medicines business.

As the carrying value of the goodwill has been reduced to its recoverable amount of RMB63,422,000 as at 31 December 2023, the related goodwill impairment loss of RMB33,102,000 (2022: Nil) was recognised and included under "other expenses" in the consolidated statement of profit or loss and other comprehensive income and attributed to the Group's manufacturing and selling of medicines segment.

Apart from the considerations described in determining the value in use of the cash generating units above, the Group's management is not currently aware of any other probable changes that would necessitate changes in its key estimates and could cause the cash generating units' carrying amounts to exceed their recoverable amounts. However, the estimate of recoverable amount is sensitive to the discount rate applied. The impact from a reasonable change in the discount rate is assessed in note 4 together with other critical accounting estimates and assumptions.

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern and to continue to provide returns for shareholders and benefits for other stakeholders by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

#### 31.2 Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Group. The Group has adopted a policy of only dealing with creditworthy counterparties and obtaining sufficient collateral, where appropriate, as a means of mitigating the risk of financial loss from defaults.

The Group's credit risk is primarily attributable to trade and other receivables. The Group's exposure to credit risk arising from time deposits, short-term bank deposits and bank balances is limited because the counterparties are the major banks in the PRC with established credit ratings, for which the Group considers to have low credit risk. Given the high credit ratings of the banks, the management does not expect any counterparties to fail to meet its obligations.

The Group's maximum exposure to credit risk for the components of the consolidated statement of financial position at 31 December 2023 and 2022 is the carrying amount as disclosed in note 31.1.

#### (i) Trade receivables

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers.

Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 30-180 days from the date of billing. Trade receivables are written off (i.e. derecognised) when there is no reasonable expectation of recovery. Normally, the Group does not obtain collaterals from customers.

Individual operating entities within the Group are responsible for their own cash management, including the short-term investment of cash surpluses and the raising of loans to cover expected cash demands, subject to parent company's board approval. The Group's policy is to regularly monitor current and expected liquidity requirements and its compliance with lending covenants to ensure that it maintains sufficient amounts of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term. The Group relies on operating cashflows as a significant source of liquid fund. As at 31 December 2023, the Group has available unutilised banking facilities of approximately RMBnil (2022: RMB3,930,000) for loan and issue of bills.

Analysed below is the Group's remaining contractual maturities for its non-derivative financial liabilities as at 31 December 2023 and 2022. When the creditor has a choice of when the liability is settled, the liability is included on the basis of the earliest date on when the Group can be required to pay. Where the settlement of the liability is in instalments, each instalment is allocated to the earliest period in which the Group is committed to pay.

#### 31.4 Foreign currency risk

Presently, there is no hedging policy with respect to the foreign exchange exposure. The Group's functional currency is Renminbi and the Group has no significant foreign currency risk because its business is principally in the PRC and most of the transactions are denominated in the Group's functional currency.

#### 31.5 Interest rate risk

Interest rate risk relates to the risk that the fair value or cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Group's interest rate risk arises primarily from short-term interest-bearing bank borrowings with variable rates expose the Group to cash flow interest rate risk. The exposure to interest rates for the Group's bank balances, time deposits and short-term bank deposits are considered immaterial.
