ANNOUNCEMENT POWER GENERATION FOR MARCH 2024

This announcement is made by China Datang Corporation Renewable Power Co., Limited* (the “**Company**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) for March 2024 on consolidated basis amounted to 3,322,264 MWh, representing an increase of 7.83% as compared with that of the corresponding period of 2023, of which, the wind power generation amounted to 2,971,428 MWh, representing an increase of 3.66% as compared with that of the corresponding period of 2023; and the photovoltaic power generation amounted to 350,836 MWh, representing an increase of 63.60% as compared with that of the corresponding period of 2023. As of 31 March 2024, the total power generation of the Group for 2024 amounted to 9,065,834 MWh, representing an increase of 3.78% as compared with that of the corresponding period of 2023, of which, the wind power generation amounted to 8,217,221 MWh, representing an increase of 0.11% as compared with that of the corresponding period of 2023; and the photovoltaic power generation amounted to 848,613 MWh, representing an increase of 60.92% as compared with that of the corresponding period of 2023.
