**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON THURSDAY, 23 MAY 2024**

Reference is made to the circular (the “**Circular**”) and the notice of annual general meeting (the “**Notice**”) issued by CHTC Fong’s International Company Limited (the “**Company**”) both dated 25 April 2024. Unless otherwise defined herein, capitalized terms used herein shall have the same meanings as those defined in the Circular.

POLL RESULTS OF THE AGM

Pursuant to Rule 13.39(5) of the Listing Rules, the Board is pleased to announce that at the AGM held on Thursday, 23 May 2024, all resolutions as set out in the Notice were duly passed by the Shareholders by way of poll.

As at the date of the AGM, there were a total of 1,100,216,570 issued Shares, being the number of shares entitling the Shareholders to attend and vote for or against the proposed resolutions at the AGM. There was no restriction on any Shareholders to cast votes on any of the proposed resolutions at the AGM and there was no Share entitling the Shareholders to attend and vote only against any of the proposed resolutions at the AGM.

As more than 50% of the valid votes were cast in favour of each of the resolutions numbered 1 to 10, all the following ordinary resolutions were duly passed by way of poll as ordinary resolutions of the Company:
