As more than 50% of the votes were cast in favor of the resolutions no. 1 to 6c, all these resolutions were duly passed as ordinary resolutions at the AGM.

As at the date of the AGM, the number of issued share capital of the Company was 26,040,504,786 shares, which was the total number of shares entitling the holders to attend and vote for or against all the resolutions proposed at the AGM. There was no restriction on any shareholders to cast votes on any of the proposed resolutions at the AGM.

The Company’s Hong Kong branch share registrar, Tricor Secretaries Limited, acted as scrutineers for the poll at the AGM.

Directors of the Company namely Mr. Zhang Hong Wei, Ms. Zhang Meiyong, Mr. Chau Siu Wai, Mr. San Fung and Ms. Wang Ying attended the AGM in person.
