Remarks:

As disclosed in the issuer's prospectus dated 28 June 2021 and the issuer's annual report for the year ended 31 December 2023, the issuer underwent share subdivision on 9 June 2021 whereby each issued and unissued share in the Company's share capital was subdivided into 10 shares, following which each grantee under the 2016 Pre-IPO Share Option Scheme or the Post-IPO Share Option Scheme shall receive 10 shares for exercising each outstanding option granted thereunder, accordingly:

- (1) as the exercise price of these outstanding options granted under the 2016 Pre-IPO Share Option Scheme was US\$1.2 per option, the issue price is US\$0.12 per share.
- (2) as the exercise price of these outstanding options granted under the 2016 Pre-IPO Share Option Scheme was US\$2.01 per option, the issue price is US\$0.201 per share.
- (3) as the exercise price of these outstanding options granted under the Post-IPO Share Option Scheme was HK\$11.6 per option, the issue price is HK\$1.16 per share.
- (4) as the exercise price of these outstanding options granted under the Post-IPO Share Option Scheme was HK\$5.8 per option, the issue price is HK\$0.58 per share.
- (5) as the exercise price of these outstanding options granted under the Post-IPO Share Option Scheme was HK\$5.1 per option, the issue price is HK\$0.51 per share.

Whereas the exercise price per option granted (and hence the issue price per share to be issued upon exercise of option) under the Post-IPO Share Option Scheme is denominated in HKD, the share capital of the Company is denominated in USD, which is also the Company's functional and presentation currency for accounting purpose. A conversion rate of USD1.00 = HKD7.75 is adopted for accounting purpose. Such conversion is for the purpose of illustration only and should not be construed as a representation that any currency has been, could have been, or may be exchanged at such rate.
