The board (the "**Board**") of directors (the "**Directors**") of the Company wishes to inform the shareholders of the Company (the "**Shareholders**") and potential investors of the Company that, based on a preliminary review of the unaudited consolidated management accounts of the Group (the "**Management Accounts**") for the six months ended 30 June 2024 (the "**Period**") and assessment of the information currently available to the Board, it is expected that the Group would record an increase in net loss for the Period to an amount in the range of approximately RMB38.0 million to RMB43.0 million as compared with that of approximately RMB19.3 million recorded for the six months ended 30 June 2023, primarily attributable to (i) the fair value loss of investment properties of approximately RMB14.9 million was recorded for the Period (six months ended 30 June 2023: nil) due to the dissatisfactory general market condition of the commercial property market in Hong Kong for the period under review; and (ii) the decline in revenue and gross profit for the Period resulted from the intense competition amongst the Mainland China's market and continued uncertainty across the global market. The fair value loss of the Group's cash flows and operations.
