This is a voluntary announcement made by China Gas Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”).

Zhongran Investment Limited Company (“**Zhongran Investment**”), a wholly-owned subsidiary of the Company, issued certain notes and bonds in the People’s Republic of China (the “**PRC**”). As at the date of this announcement, the total outstanding amount of notes and bonds issued by Zhongran Investment was RMB5.22 billion.
