NOTICE OF EXTRAORDINARY GENERAL MEETING

NOTICE IS HEREBY GIVEN that an extraordinary general meeting of Hebei Yichen Industrial Group Corporation Limited* (河北翼辰實業集團股份有限公司) (the “**Company**”) will be held at the meeting room of the Company, No. 1 Yichen North Street, Gaocheng District, Shijiazhuang City, Hebei Province, the People's Republic of China (“**the PRC**”) on Monday, 2 December 2024 at 10:30 a.m. to consider, and if thought fit, pass (with or without amendments or supplements) the following resolutions (unless the context requires otherwise, capitalised terms used herein shall have the same meanings as those defined in the circular of the Company dated 12 November 2024):

2. To consider and approve the resolutions in respect of the election of the fourth session of the Board of Supervisors (excluding staff representative Supervisor):
 - 2.1 the re-election of Mr. Guan En (管恩) as a shareholder representative Supervisor; and
 - 2.2 the re-election of Mr. Liu Jianbin (劉建賓) as a shareholder representative Supervisor.
3. Conditional upon resolutions 1 and 2 above being passed, to consider and approve the remuneration arrangements as set forth in the service agreement to be entered into between the Company and each of the executive Directors of the fourth session of the Board of Directors, the appointment letter to be issued by the Company to each of the non-executive Director and the independent non-executive Directors of the fourth session of the Board of Directors, and the service agreement to be entered into between the Company and each of the Supervisors of the fourth session of the Board of Supervisors (including both shareholder representative Supervisors and staff representative Supervisor).

All resolutions at the meeting will be taken by poll pursuant to the Listing Rules. The Chairman of the Board of Directors of the Company may demand poll for voting pursuant to the Articles of Association.

1. For determining the entitlement to attend and vote at the EGM, the register of members of the Company will be closed from Wednesday, 27 November 2024 to Monday, 2 December 2024, both dates inclusive, during which period no transfer of shares will be registered. In order to be eligible to attend and vote at the EGM, holders of the H Shares whose transfers have not been registered shall deposit all transfer documents accompanied by the relevant share certificates at the Company's H share registrar, Computershare Hong Kong Investor Services Limited not later than 4:30 p.m. on Tuesday, 26 November 2024 (Hong Kong time) for registration.
2. A shareholder entitled to attend and vote at the EGM may appoint one or more proxies to attend and vote on his behalf. A proxy need not be a shareholder of the Company. Where a shareholder appoints more than one proxy, his proxies can only vote on a poll.

3. The instrument appointing a proxy must be in writing under the hand of a shareholder or his attorney duly authorised. If the shareholder is a corporation, that instrument must be either under its common seal or under the hand of its director(s) or duly authorised executive officer(s) or duly authorised attorney(ies). If that instrument is signed by an attorney of a shareholder, the power of attorney or other document authorising that attorney to sign must be notarised.
4. In order to be valid, the form of proxy together with the notarised power of attorney or other authorisation document (if any) must be deposited at the Secretariat of the Board at the Company's principal place of business in the PRC (for holders of the Domestic Shares) or at the H share registrar of the Company, Computershare Hong Kong Investor Services Limited (for holders of the H Shares) not less than 24 hours before the time fixed for the meeting (i.e. not later than 10:30 a.m. on Sunday, 1 December 2024 (Hong Kong time)).
5. A vote given in accordance with the terms of an instrument of proxy shall be valid notwithstanding the death or loss of capacity of the appointer, or the revocation of the proxy or of the authority under which the form of proxy was executed, or the transfer of shares in respect of which the proxy is given, provided that no notice in writing of these matters shall have been received by the Company prior to the commencement of the EGM.
