- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

Please note that both the English and Chinese versions of all future Corporate Communications will be available electronically on the website of the Company at <http://electronics.byd.com> and the HKEXnews website at [www.hkexnews.hk](http://www.hkexnews.hk) in place of printed copies.
