### **PROFIT WARNING**

This announcement is made by PPS International (Holdings) Limited (the “**Company**”, and, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and Part XIVA of the Securities and Futures Ordinance, Chapter 571 of the Laws of Hong Kong.

The board (the “**Board**”) of the directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company and potential investors that, based on the information currently available to the management of the Group and the preliminary review of the unaudited consolidated management accounts of the Group, it is expected that a net loss between HK\$3 million and HK\$4 million attributable to the owners of the Company for the six months ended 31 December 2024 (the “**2025 Interim Results**”) will be recorded as compared to the net profit of approximately HK\$4.8 million attributable to the owners of the Company for the six months ended 31 December 2023. The decline in the consolidated financial performance of the 2025 Interim Results is primarily due to the net effect of the following factors:

- (i) no recognition of the reversal of impairment allowance for loan receivables (2023: approximately HK\$6.8 million) for the six months ended 31 December 2024; and
- (ii) increase in the revaluation loss on the Group’s self-owned properties in Hong Kong by approximately HK\$0.8 million for the six months ended 31 December 2024.

The Company is still in the course of finalising the 2025 Interim Results. The information contained in this announcement is based on the Board’s preliminary assessment after reviewing the unaudited consolidated management accounts of the Group for the six months ended 31 December 2024 and the information currently available to the management of the Group. Therefore, the actual 2025 Interim Results may differ from the information contained in this announcement. Shareholders and potential investors are advised to refer to the actual 2025 Interim Results which is to be released on 21 February 2025.
