Chairperson's Statement

Dear Shareholders.

On behalf of the Board of Directors of APT Electronics Co., Ltd., I am pleased to present to you the annual report of the Group for the year ended December 31, 2024.

The year of 2024 was a landmark year for APT Electronics. On November 8, 2024, the Company successfully listed on the Main Board of the Hong Kong Stock Exchange, setting a record for Hong Kong-listed technology companies with a public subscription rate of 5,678 times. This marks a significant milestone in the Group's journey towards internationalization. Moreover, 2024 was also a year that marked significant development for APT Electronics. The Company successfully completed its strategic transformation from a traditional LED manufacturer to a provider of intelligent vision products and system solutions, integrating advanced "LED+" technologies, and has been continuously leading the industry in intelligent automotive vision, high-end lighting, and advanced display business segments.

Amidst a complex and ever-changing economic environment and industry competitive landscape, we have consistently adhered to a customer-and market demand-driven approach, driven by continuous technological innovation. By fully leveraging the vertical integration advantages of the "LED device-modules-system" industry chain, we have achieved comprehensive breakthroughs in operating performance, with overall results exceeding expectations and reaching historically optimal levels.

For the year ended December 31, 2024, the Group achieved the revenue of RMB2,592 million, representing a year-on-year growth of 39.51%. The net profit of the Group reached RMB105 million, indicating a year-on-year growth of 45.56%, and its adjusted net profit amounted to RMB145 million, reflecting a year-on-year growth of 77.65%. The three core business segments of the Group demonstrated robust growth: the revenue generated from its intelligent automotive vision products reached RMB1,023 million, with a year-on-year growth of 33%, the revenue generated from its advanced display products amounted to RMB807 million, with a year-on-year growth of 85%, and the revenue generated from its high-end lighting products stood at RMB761 million, with a year-on-year growth of 17%.

In the intelligent automotive vision sector, we fully leveraged the Group's full industry chain layout and synergistic advantages, establishing strategic partnerships with more than 20 automotive OEMs and Tier-1 suppliers. Sales of the Group's intelligent automotive vision products including intelligent automotive lamps and automotive-grade LED devices and modules experienced rapid growth, among which automotive-grade LED devices gained recognition from the majority of domestic OEMs and lamp suppliers. Meanwhile, we planned to expand our production capacity and promote the construction of the headquarters base of Lynway Vision in the Greater Bay Area and the implementation of several new projects. We established in-depth cooperation with multiple well-known automakers, further consolidating the Company's leading position in the mid-to-high-end intelligent automotive lamps market.

The advanced display business achieved breakthrough progress, with further increases in the production and sales volumes of Mini LED backlight modules. Benefiting from the national "trade-in" subsidy policy in 2024, market demand for the business in advanced display segment continued to grow. We seized the opportunity and rose to the challenge. Throughout the intense production during the year, we actively responded to customer requirements, rapidly expanded our production capacity, and diligently sought out new partners. From R&D and supply chain to products and manufacturing centers, the teams of the Company worked together, overcame challenges, and achieved remarkable results.

In terms of the high-end lighting business, we adhered to a dual-drive strategy of technological advancement and quality enhancement. From intelligent lighting to horticultural lighting, and from special lighting to global customer services, we continuously improved product performance and reduced costs. Our consistent excellence in delivery earned us market recognition.

We remain committed to our corporate mission of "driving green and sustainable development with technological innovation and creating a better and more intelligent lifestyle with LED+ technologies." The promise of "going together with the IC for a colorful future" has been integrated into the development DNA of APT Electronics. BUSINESS REVIEW

I. The Industry where the Company Operates

LED intelligent vision employs LED technology to achieve intelligent lighting and display functions. Based on its applications, it can be categorized into three types, including intelligent automotive vision, high-end lighting and advanced display. Leveraging industry insights and proactive approaches to technological innovation, we integrate LED technologies with integrated circuits (ICs), electronic control, software, sensors, optics and others to form our core "LED+" technology. Our energy-efficient and rapidly evolving "LED+" technologies further empower our intelligent vision products and systems solutions, enabling us to penetrate high-value and high-growth markets, and realizing the successful strategic transformation from a traditional LED manufacturer to an intelligent vision product and system provider integrating advanced "LED+" technologies.

According to CIC, the market size of the global LED intelligent vision industry in terms of revenue reached USD192.0 billion in 2023 and is expected to grow at a CAGR of 8.4% to reach USD287.2 billion by 2028. China has the world's largest LED intelligent vision industry, accounting for 34.2% of the global market in terms of revenue in 2023. Driven by increasing consumer demand and supportive national policies, the size of China's LED intelligent vision market was RMB440.2 billion in 2023. It is expected to reach RMB679.2 billion in 2028, at a CAGR of 9.1% from 2023 to 2028.

Intelligent Automotive Vision Market

Intelligent automotive vision has become the core application scenario of LED intelligent vision, while LED technologies have currently become the mainstream solution in this field. Industry data shows that the penetration rate of LED in China's intelligent automotive vision market has exceeded 90%, which is attributable to its higher light intensity, longer life span, lower energy consumption, higher color gamut and intelligent features compared with traditional halogen and xenon lamps.

Driven by both policy and market forces, China's automotive industry demonstrated strong growth in 2024. According to statistics from the China Association of Automobile Manufacturers, the annual production and sales volumes of automobiles reached 31.282 million and 31.436 million, respectively, representing year-on-year increases of 3.7% and 4.5%, ranking No. 1 in the global market for 16 consecutive years; of which, the production and sales volumes of passenger vehicles surpassed 27.47 million and 27.563 million, representing year-on-year increases of 5.2% and 5.8%. The new energy sector performed particularly well, with production and sales volumes reaching 12.888 million and 12.866 million, respectively, representing year-on-year increases of 34.4% and 35.5%, respectively. The market penetration rate climbed to 40.9%, representing an increase of 9.3 percentage points as compared to 2023. Continuous support by industrial policies and expansion of export markets are expected to provide strong support for the industry's stable development in 2025.

Based on the strong performance of the new vehicle market, the demand for automotive vision systems continues to grow, and the industry is currently experiencing upgrading trends: firstly, the accelerated shifts towards intelligence and new energy are driving the iteration of LED automotive lamp products toward integration, intelligence and customization; secondly, the accelerated penetration of high-value-added products, such as adaptive driving beam (ADB) headlights, projection headlights, and interactive front and rear lights, etc., is driving up the value of automotive lamps per vehicle. These industry upgrades will significantly contribute to the further growth of the LED intelligent automotive vision industry.

China's High-End Lighting and Advanced Display Markets

According to CIC, China is the largest LED packaging market in the world. The market size of devices and modules for China's high-end lighting and LCD TV backlight display industries in terms of revenue reached RMB17.1 billion in 2023, which was attributed to the iteration of LED packaging technologies, increasing environment protection requirements and the expansion of application scenarios. The market size of devices and modules for China's high-end lighting and LCD TV backlight display industries in terms of revenue is expected to reach RMB26.2 billion in 2028, at a CAGR of 8.9%.

With the continuous enhancements in LED chip technologies, packaging structures and advanced materials, the performance of high-end lighting and LCD TV backlight display devices has significantly improved with respect to color performance, reliability and light efficiency, etc., which has been crucial in providing more development opportunities and application scenarios for high-end lighting and LCD TV backlight displays, resulting in a notable increase of demand for high-end LED devices and modules. Compared to traditional lighting technologies, the energy efficiency of LED technologies is more closely aligned with the requirements of environmental protection policies. Government policies and regulations promoting energy conservation and environmental protection, coupled with increasing societal environment protection awareness, have driven the wide adoption of high-performance, high CRI LED devices and modules. Meanwhile, the rapid development and expansion of downstream application scenarios such as indoor and outdoor lighting, horticultural lighting, intelligent lighting, special lighting, backlight display, commercial display, has surged the demand for diverse and customized lighting and display system. LED technology, leveraging its advantages of high luminous efficacy and long lifespan, has become the mainstream technology in the high-end lighting and LCD TV backlight display industries.

In terms of market demand, consumer demand for color saturation, authenticity and contrast on LCD TV continues to increase, promoting the rapid development of advanced backlight display products with high-contrast, high-resolution, high-color-gamut. Innovative technologies such as Mini LED and local dimming have become the core driving force of the iteration of the new display products by optimizing the display effect and have created development opportunities for enterprises with technology research and development capabilities. In the future, with technology maturity increase and commercial-use costs decrease, such technologies are expected to further promote industry upgrading, expanding the market growth of high-end lighting and advanced display.

II. Business Review and Outlook

The Group is a leading enterprise in China providing intelligent vision products and system solutions integrating "LED+" technologies, and our business encompass intelligent automotive vision, high-end lighting and advanced display. Leveraging industry insights and technological innovation, we develop a broad array of our core "LED+" technologies by integrating LED technologies with integrated circuits (ICs), electronic control, software, sensors, optics and others.

Leveraging our technological prowess, production capabilities, dedicated team, industry vertical integration strategy and customer resources, we completed our successful transformation from a traditional LED manufacturer to an intelligent vision products and system solutions provider that integrates "LED+" technologies, further optimized our revenue structure and enhanced our risk resilience, ensuring the sustainable development of the Company. Our rapidly evolving "LED+" technologies further empower our intelligent vision products and system solutions, enabling us to penetrate high-value, high-growth markets.

In 2024, under the macro environment of weak global economic recovery and pressured end-user demand, the Group seized opportunities in digital, green and intelligent transformation, achieving counter-cyclical growth through product upgrades and customer structure optimization. The three major business segments acted in synergy, achieving significant growths in all of intelligent automotive vision, high-end lighting, and advanced display segments, driving overall performance to a record high.

In 2024, we realized revenue of the year of RMB2,592 million, with a year-on-year growth of approximately 39.51%; net profit of the year of RMB105 million, with a year-on-year growth of 45.56%; and adjusted net profit of RMB145 million, with a year-on-year growth of approximately 77.65%. Our operational quality significantly outperformed the industry average level.

In intelligent automotive vision products segment, we have achieved the vertical integration lay out of industry value chain of LED devices-modules-systems, offering cost-effective, one-stop solutions for LED intelligent automotive vision products, including intelligent automotive lamp systems and automotive-grade LED devices and modules. Designed for automotive-grade applications, we developed a comprehensive range of automotive-grade LED devices and modules, which are characterized by their high brightness, high power, strong corrosion resistance and durability. In terms of automotive LED module technology, we developed LED electronic driver platform technology, headlamp lens module technology and electronic control and software control technology, providing key photoelectric control technologies for intelligent vehicle lighting systems. During the Reporting Period, the intelligent automotive vision business experienced rapid growth, showing a sign of scale effect, achieving revenue of the year of RMB1,023 million, with a year-on-year growth of 33%. Additionally, the construction of Guangzhou Lynway intelligent automotive lamps base is progressing steadily, and upon completion, it will reach an annual production capacity of 700,000 sets of intelligent automotive lamps and 200,000 vehicle-mounted HUDs, and it will become the headquarters for APT Electronics in terms of intelligent automotive vision products and system business segment, showing an acceleration in scale advantages.

In advanced display segment, our advanced display device and module products are primarily used in mid-to highend TVs. During the Reporting Period, the Company continued to invest in the Mini LED technology and products, constructed multiple industry leading Mini LED backlight production line, which have enabled the mass production and batch delivery of multiple advanced display products. In response to the development trends toward larger TV screens and higher contrast ratios, the Company continuously upgraded and iterated its traditional products, launching a range of new products, such as LED products integrating ICs with local dimming function, as well as Mini LED COB and POB backlight module products. Additionally, benefiting from the government's subsidy policies for home appliances, the Company achieved significant growth in sales revenue for its advanced display products in 2024, with revenue reaching RMB807 million, representing a year-on-year growth of 85%.

In high-end lighting segment, the Company's strategy of developing and selling high-value-added products has proven effective, and our products are distinguished by their high light quality and high luminous efficacy and can fulfill the requirements of special spectrums. For instance, the photoelectric conversion efficiency of our horticultural lighting products has reached the international leading level. During the Reporting Period, sales from high-end lighting products reached RMB761 million, representing an increase of 17% compared with the same period last year, with technological advantages continuously translating into market advantages.

APT Electronics is in its critical period of rapid development, and we will continue to uphold the innovation-driven, high-end manufacturing development philosophy, and committed to promoting the Company's sustainable development. In future business layouts, we will continue to focus on the intelligent automotive vision, high-end lighting, and advanced display business segments, actively exploring potential opportunities in new application areas.

The Group has successfully completed the establishment of a patent strategic layout system covering the entire industrial chain. As of the end of the Reporting Period, the Group has accumulated 430 authorized patents, including 109 invention patents. During the Reporting Period, the Group was successively honored with multiple prestigious awards: including the "2024 Top 30 High-Tech Enterprises (Nansha District)" awarded by the Guangdong High-Tech Enterprise Association, the title of "Top 10 Healthy Lighting Brands" granted by the Guangdong Illuminating Engineering Society, and the "Top 10 Outstanding Enterprises in Key Components of China's Biological Lighting Industry" recognized by the Shenzhen Facility Agriculture Association. Additionally, the Group received several industry accolades, such as: "10th Anniversary Best Outstanding Partner" from Signify Group, "Best External Affiliate" from Samsung Electronics, "2024 Best Partner" and "Quality Improvement Award" from Hisense Group.

The Company will always stay close to market dynamics. Through deepening vertical integration of the industrial value chain, intensifying technological innovation, reasonably expanding production capacity, and precisely targeting high-growth areas, we will focus on "LED+" innovation, striving to improve lean manufacturing and intelligent production system, aiming to become an industry-leading global tech company specializing in intelligent vision products and system solutions.

Future Key R&D Directions:

- (1) Intelligent automotive vision products: intelligent projection headlamps systems with ten-thousand-level pixel high definition (HD) capacity, interactive signal display devices, modules, and systems for automotive applications, high-power, high-brightness LED devices and modules for automotive headlamp applications and new automotive backlight LED devices and modules;
- (2) High-end lighting products: high-reliability, high-brightness, high-power LED packaging devices for outdoor and special lighting applications, LED modules and application solutions for special lighting and intelligent lighting;
- (3) Advanced display products: Mini LED backlight advanced display products and application solutions, LED backlight devices and module products with dynamic dimming function and new RGB backlight LED device and module technologies and products.

FINANCIAL REVIEW

Revenue Structure

During the Reporting Period, the Group's revenue was derived from intelligent automotive vision products, advanced display products and high-end lighting products. The Group achieved an overall revenue of RMB2,592.1 million in 2024, representing a year-on-year increase of 39.5%. The increase was primarily driven by the Group's active market and customer exploration, with significant contributions from advanced display products and intelligent automotive vision products.

Revenue from intelligent automotive vision products amounted to RMB1,023.5 million in 2024, representing a year-on-year increase of 32.8%, mainly due to the Company continuing to leverage its vertical integration advantages in the automotive-grade LED packaging-modules-automotive lamps industry value chain, promoting the collaborative integration of internal resources within the segment, and actively expanding business cooperation channels. With the increase in mass production projects, the sales amount has significantly increased.

Revenue from advanced display products amounted to RMB807.1 million in 2024, representing a year-on-year increase of 85.0%. The increase was primarily driven by favorable government policy to offer subsidies for customers on household appliances in 2024, as well as the substantial benefits brought by the application of large-size TV backlight modules and Mini LED display technologies, which contributed to a surge in orders for the Company's advanced display products, resulting in a significant increase in sales amount.

Revenue from high-end lighting products amounted to RMB761.5 million in 2024, representing a year-on-year increase of 17.0%, mainly due to the Company's continuous optimization of its market sales strategies, strengthened collaboration with key strategic clients, and enhanced product performance in the high-end lighting product segment, despite an increasingly challenging market environment, thereby further expanding its sales scale.

The Group's revenue from sales in Mainland China amounted to RMB2,138.0 million in 2024, representing a year-on-year increase of 35.6%. The increase was primarily driven by the significant increase of advanced display products and intelligent automotive vision products; the revenue from the sales overseas reached RMB454.0 million, representing a year-on-year increase of 61.4%. The increase was primarily driven by the continuous increase in demand for horticultural lighting orders from overseas markets.

Financial Condition

1) Assets

As of December 31, 2024, the total assets of the Group amounted to RMB3,101.5 million, representing a year-on-year increase of 29.2%. Among them: non-current assets were RMB1,060.0 million, representing a year-on-year increase of 2.7%. The increase was primarily due to the normal depreciation and amortization of non-current assets, increased investments in the module expansion by the Group, and the acquisition of land use rights for Lynway Vision's Greater Bay Area headquarters amounting to RMB57.2 million during the Reporting Period; current assets were RMB2,041.5 million, representing a year-on-year increase of 49.2%. The increase was primarily due to an increase in the balance of trade receivables by the end of the Reporting period, in line with the significant growth in sales revenue. Additionally, the growth in sales revenue resulted in higher cash collections, and the Company received the raised funds after the successful listing, contributing to an overall increase in available funds.

2) Liabilities

As of December 31, 2024, the total liabilities of the Group amounted to RMB1,806.7 million, representing a year-on-year increase of 31.5%. Among them: non-current liabilities were RMB38.3 million, representing a year-on-year decrease of 47.6%. The decrease was primarily due to the reclassification of some medium and long-term loans of the subsidiary, Linlux, which are due for repayment in 2025, to current liabilities. Meanwhile, current liabilities were RMB1,768.4 million, representing a year-on-year increase of 36.0%. The increase was mainly driven by the expansion of the Group's business scale, leading to higher material procurement needs. Additionally, our enhanced bargaining power in procurement led to an extension in the turnover days for trade and bills payables. Consequently, trade payables at the end of the Reporting Period increased significantly.

Liquidity and Financial Resources

In 2024, the Group's net operating cash inflow were RMB241.8 million, representing a year-on-year decrease of 44.0%. The decline was primarily due to two factors: on the one hand, the Group experienced a relatively high operating cash inflow in 2023, driven by increased bargaining power in procurement with the growth of sales scale in 2023, the extension of settlement period and the increased use of bills for payment by domestic suppliers, and the extension of turnover days of trade and bills payables; on the other hand, despite the expansion of sales scale and enhanced profitability in 2024, the Company significantly increased its investments in new R&D initiatives, resulting in higher personnel-related expenses and tax payments. Such factors collectively contributed to the reduction in operating cash inflow in 2024.

The bank and cash balances of the Group as at December 31, 2024 were approximately RMB588.8 million.

The total interest-bearing bank borrowings of the Group as at December 31, 2024 were approximately RMB95.3 million. The repayment terms of approximately RMB80.9 million of the interest-bearing bank borrowings are due within one year and approximately RMB14.4 million after one year, respectively.

The Group had sufficient liquidity to meet the requirements of its daily liquidity management and capital expenditure, and to control internal operating cash flows.

Capital Structure

The financial department under the Group is responsible for its financial risk management, aiming to ensure that the liquidity structure of the assets, liabilities and other commitments of the Group could meet its funding needs on an ongoing basis. The borrowings of the Group were mainly settled in RMB, while its cash and cash equivalents were mainly held in RMB, U.S. dollars and Hong Kong dollars. The Group maintained an appropriate portfolio of equity and debt during the period to ensure an effective capital structure. As of December 31, 2024, the outstanding loans of the Group were RMB-denominated loans. Our bank borrowings comprised both secured and unsecured bank loans, with effective interest rates ranging from 2.6% to 3.3% per annum. As of December 31, 2024, the gearing ratio of the Group was 7.4%, calculated as total bank borrowings divided by total equity as of the end of the year.

The Group monitored the capital structure by using the debt/asset ratio, with its policies to maintain financial stability and support the sustainable, healthy development of the Group's business. As of December 31, 2024, the debt/asset ratio of the Group was 58.3%. The slight increase in the debt/asset ratio was mainly due to the increase in capital investment from the Company's business expansion. The Group maintained its financial stability amidst rapid business development.

Contingent Liabilities

As of December 31, 2024, we did not have any contingent liabilities.

Foreign Exchange Risk

The business operations of our Group are primarily concentrated in Mainland China, with the majority of its assets and liabilities denominated in RMB, except for certain bank balances which are denominated in Euro, U.S. dollars, and Hong Kong dollars. During the Reporting Period, the Group did not experience any material difficulties or impact on its operations or liquidity as a result of fluctuations in currency exchange rates. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group believes that the Group will have sufficient foreign currencies to meet its foreign exchange needs and will take effective measures to prevent foreign exchange risks should the need arise.

Capital Expenditure

During the Reporting Period, the capital expenditures of the Group amounted to RMB249.3 million which were mainly used for the investment in equipment upgrades aimed at expanding production capacity and improving efficiency. The capital expenditures of the Group were mainly funded by the Group's own funds, bank borrowings as well as cash inflow from the operating activities of the Group.

Capital Commitments

During the Reporting Period, the capital commitments of the Group were mainly related to the acquisition of property, plant and equipment and intangible assets. The total of capital expenditures contracted but not incurred as at December 31, 2024 was RMB70.6 million.

Restricted Assets

As of December 31, 2024, the Group had restricted assets with a total carrying amount of RMB372.4 million for obtaining bank facilities. These assets include pledged and restricted bank deposits of RMB88.3 million, trade and bills receivables of RMB39.8 million and property, plant and equipment of RMB244.3 million.

Share Pledge

During the Reporting Period, Jingling Investment and Jingshi Investment, each being an employee shareholding platform and a member of the Controlling Shareholder Group of the Company, on December 5, 2024, have entered into share pledge agreements with China Merchants Bank Co., Ltd. Guangdong Pilot Free Trade Zone Nansha Branch (招商銀行股份有限公司廣東自貿試驗區南沙分行) ("CMB"), to pledge their 5,248,040 Shares and 6,441,700 Shares, respectively, as enhanced security in favour of CMB for an existing bona fide commercial loan. For further details, please refer to the announcement of the Company made in accordance with Note (3) to Rule 10.07(2) of the Listing Rules dated December 5, 2024.

Significant Investments Held

As at December 31, 2024, the Group did not make or hold any significant investments (including any investment in an investee company with a value of 5% or more of the Company's total assets).

Future Plans for Significant Investments and Capital Assets

As of December 31, 2024 and up to the date of this annual report, the Group did not have any plans for significant external investments and capital assets.

Mr. XIAO Guowei David (肖国偉), aged 56, is an executive Director, the chairperson of the Board and the chief strategic officer of our Company. Mr. Xiao co-founded Advanced Photoelectronic and our Group. He served as the chairperson of the Board and general manager of our Company from August 2006 to October 2015, and the chairperson of the Board and president of our Company from October 2015 to March 2023. Mr. Xiao currently holds directorship at other subsidiaries within our Group.

Mr. Xiao has more than 25 years of professional experience in advanced semiconductor packaging, microelectronics manufacturing process, optoelectronic semiconductors, materials and reliability analysis. Prior to establishment of our Company, he founded Advanced Photoelectronic in February 2003 and has since served as a director of Advanced Photoelectronic. Before that, he taught at the Faculty of Electronic and Information Engineering (電子與信息學部) (formerly known as the Department of Electronic Engineering (電子工程系)) of Xi'an Jiaotong University (西安交通大學) from July 1990 to February 1998, with his last position as a lecturer, and served as a senior technology officer in the Department of Electronic and Computer engineering at the Hong Kong University of Science and Technology from March 2002 to August 2004. He currently also serves as the chairperson of the board of AccoPower Semiconductor Co., Ltd. (廣東芯聚能半導體有限公司) ("AccoPower") and AscenPower Semiconductor Co., Ltd. (廣東芯粵能半導體有限公司) ("AscenPower"), both silicon carbide (SiC) and power semiconductor developers and manufacturers.

Mr. Xiao obtained his bachelor's degree in electronic engineering in 1990 and his master's degree of engineering in June 1997 from Xi'an Jiaotong University (西安交通大學) in the PRC, and obtained his doctorate degree of philosophy in electronical and electronic engineering from the Hong Kong University of Science and Technology in November 2002 in Hong Kong. Mr. WU Nan-Yang (吳南陽), aged 66, is a non-executive Director of our Company. He has served as a director of Advanced Photoelectronic since March 2010.

Mr. Wu has more than 40 years of experience in technologies and investment. From March 1984 to July 1986, he served as an associate engineer (副工程師) at Yulon Motor Co., Ltd. (裕隆汽車製造股份有限公司), a company listed on the Taiwan Stock Exchange (stock code: 2201). He worked at the Opto-Electronic and Systems Laboratory of Industrial Technologies Research Institute (工業技術研究院光電工業研究所) in Taiwan from October 1987 to July 1997, with his last position as an engineer (正工程師). CORPORATE GOVERNANCE PRACTICES

The Group is committed to maintaining a high standard of corporate governance which are crucial to our development and safeguard the interests of the Shareholders of the Company and to enhance corporate value and accountability. The Company has adopted the code provisions of the CG Code as set out in Appendix C1 to the Listing Rules (as in effect from time to time) as its own code of corporate governance.

To the best knowledge of the Directors, none of them has any personal relationship (including financial, business, family or other material/relevant relationship(s)) with any other Directors, the chairperson and the chief executive of the Company.

Independent Non-executive Directors

From the Listing Date to the end of the Reporting Period and up to the date of this annual report, the Board has at all times met the requirements of Rules 3.10(1), 3.10(2) and 3.10A of the Listing Rules relating to the appointment of at least three independent non-executive directors with at least one independent non-executive director possessing appropriate professional qualifications, or accounting or related financial management expertise, and independent non-executive directors representing at least one-third of the board of the directors.

With reference to the confirmation of independence from independent non-executive Directors, each of our independent non-executive Directors has confirmed (i) his or her independence as regards each of the factors referred to in Rules 3.13(1) to (8) of the Listing Rules, (ii) he or she has no past or present financial or other interest in the business of the Company or its subsidiaries or any connection with any core connected person of the Company under the Listing Rules as of December 31, 2024, and (iii) that there are no other factors that may affect his or her independence at the time of his or her appointments. Therefore, the Company is of the view that all independent non-executive Directors are independent.

Responsibilities of and Delegation by the Board

The major powers and functions of the Board include, but are not limited to, convening the general meetings, presenting reports to the general meetings, implementing the resolutions passed at the general meetings, determining the operational plans and investment plans of the Group, determining the annual financial budgets and final accounts of the Group, determining the fundamental management systems of the Group, formulating profit distribution plans and loss recovery plans of the Group, and exercising other powers and functions as conferred by the Articles of Association.

Our senior management consisting of an executive Director along with other senior executives is responsible for the management of day-to-day operations of the Group. The executive Director and senior executives meet regularly to review the performance of the businesses of the Group as a whole, co-ordinate overall resources and make financial and operational decisions. The Board also gives clear directions as to their powers of management including circumstances where management should report back and will review the delegation arrangements on a periodic basis to ensure that they remain appropriate to the needs of the Group. A memorandum on respective functions of the Board and management of the Company has been established in writing.

To oversee particular aspects of the Company's affairs, the Board has established four Board committees, including the Audit Committee, Nomination Committee, Remuneration and Appraisal Committee and Strategy Committee (together, the "Board Committees"). The Board has delegated responsibilities to the Board Committees as set out in their respective terms of reference.

All Directors carry out their duties in good faith, in compliance with applicable laws and regulations, and act in the interests of the Company and the Shareholders at all times.

Directors' Responsibilities for Financial Statements

The Directors acknowledge their responsibilities for preparing the financial statements of the Group in accordance with statutory requirements and applicable accounting standards. The Directors also acknowledge their responsibilities to ensure that the financial statements of the Group are published in a timely manner.

The Directors are not aware of any material uncertainties relating to events or conditions which may cast significant doubt upon the Company's ability to continue as a going concern.

Accordingly, the Directors have prepared the financial statements of the Company on a going concern basis. The reporting responsibilities of the Company's external auditor on the financial statements of the Group are set out in the section of "Independent Auditor's Report" in this annual report.

Board Meeting and General Meetings

The Board meets regularly to discuss and formulate the overall strategy as well as the operation and financial performance of the Group. The Directors may participate the Board meetings and general meetings of the Company either in person or through electronic means of communications.

The Board of Directors should meet regularly, with at least four meetings convened annually. All regular meetings of the Board should be notified to each Director no less than 14 days in advance, and extraordinary meetings should be notified no less than 5 days in advance (however, the aforementioned notice period for extraordinary meetings may be waived with the consent of all Directors of the Company), to allow Directors to include other matters in the agenda of meetings. Board papers together with all appropriate, complete and relevant information are dispatched to all Directors at least three days before each regular Board meeting to ensure that the Directors have sufficient time to review the related documents and be adequately prepared for the meeting.

During the Reporting Period, five Board meetings and two general meetings were held at which the Board and the Shareholders, respectively, considered and approved the Global Offering, the financial statements of the Group for the financial years ended December 31, 2021, 2022 and 2023 and the five months ended May 31, 2024, and other business affairs of the Group. The Company shall adopt the practice of holding Board meetings regularly, to be at least four times a year, and at approximately quarterly intervals. Apart from regular Board meetings, the chairperson of the Board shall at least annually hold meetings with the independent non-executive Directors without the presence of other Directors under the code provision C.2.7 of the CG Code.

Appointment, Re-Election and Removal of Directors

Pursuant to the requirements of the Articles of Association, all Directors (including non-executive Directors) shall be elected at the general meeting for a term of three years, which is renewable upon re-election. A Director shall be eligible for re-election on the expiry of each term at the general meeting for a term of three years. The Company has implemented a set of effective procedures for appointment of new Directors. The nomination of new Directors shall be first deliberated by the Nomination Committee and then submitted to the Board, subject to approval by election at the Shareholders' meeting.

Each Director has entered into a service contract with the Company with a specific term. The term of a Director shall be stipulated in the Articles of Association, provided that no term of office shall last for more than three years. A Director may serve consecutive terms if re-elected. A Director shall continue to perform his/her duties as a Director in accordance with the laws, administrative regulations and the Articles of Association until a duly re-elected Director takes office, if re-election is not conducted in a timely manner upon the expiry of his/her term of office or if the resignation of Director results in the number of Directors being less than the quorum.

Save as disclosed above, none of the Directors or Supervisors has entered into any service contract with any member of the Group other than the contracts expiring or determinable by the employer within one year without payment of compensation (other than statutory compensation).

The procedures and process of appointment, re-election and removal of Directors are set out in the Articles of Association. The Nomination Committee is responsible for reviewing the Board composition, and making recommendations to the Board on appointment, re-election, and succession planning of Directors.

The Shareholders may, at any general meetings convened and held in accordance with the Articles of Association, remove a Director by ordinary resolution at any time before the expiration of his/her term of office (but such removal does not prejudice the claim for damages pursuant to any contract).

With regards to the code provision of the CG Code requiring Directors to disclose the number and nature of offices held in public companies or organisations and other significant commitments, as well as their identities and the times involved in the issuer, the Directors agreed to disclose their commitments to the Company in a timely manner. The Directors, including independent non-executive Directors, have demonstrated strong commitment and the ability to devote sufficient time to discharge their responsibilities at the Board.

If any Director fails to attend in person or appoint other Directors as his/her representative to attend meetings of the Board for two consecutive times, such Director shall be deemed to have failed to perform his duties, and the Board shall propose to replace such Director at the general meeting.

Chairperson of the Board and the President

The Board recognizes the recommendation of code provision C.2.1 of part 2 of the CG Code that the chairperson of the Board (the "Chairperson") and the president of the Company (the "President") should be separate and performed by different individuals. The Chairperson is Mr. Xiao and the President is Mr. Hou Yu. The Chairperson bears the responsibility for the effective conduct of the Board whilst the President bears the executive responsibility for the operations of the Group's business. The Chairperson and the President are not related to each other. The division of responsibilities between the Chairperson and the President is defined and established in writing. The Board is of the view that there are sufficient safeguards and checks to ensure that the process of decision-making by the Board is independent and based on collective decisions without any individual exercising any considerable concentration of power or influence.

Continuous Professional Development of Directors

All Directors have been given relevant guideline materials regarding the responsibilities and obligations of being a Director, the relevant laws and regulations applicable to the Directors, duty of disclosure of interest and business of the Company on or before the Listing Date (November 8, 2024) and such induction materials will also be provided to newly appointed Directors shortly upon their appointment as Directors to ensure that he or she has a proper understanding of the operation and business of the Company and full awareness of Directors' responsibilities and obligation under the Listing Rules and relevant statutory requirements.

All Directors are also updated from time to time on the latest developments regarding the Listing Rules and other applicable regulatory requirements to ensure compliance and enhance their awareness of good corporate governance practices.

BOARD COMMITTEES

The Board has established four committees and has delegated various responsibilities to the committees including the Audit Committee, the Nomination Committee, the Remuneration and Appraisal Committee, and the Strategy Committee. All the Board Committees perform their distinct roles in accordance with their respective terms of reference which are available on the websites of the Company and the Stock Exchange. The Board Committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expense.

As the Company was listed on November 8, 2024, no meetings of the Strategy Committee, Audit Committee, Remuneration and Appraisal Committee, and Nomination Committee have been held from the Listing Date to the end of the Reporting Period. In accordance with the CG Code and the working rules of the respective Board Committees, the Company will hold at least one regular meeting of the Remuneration and Appraisal Committee and the Nomination Committee annually, and at least two regular meetings of the Audit Committee each year.

Audit Committee

The Company has established the Audit Committee with written terms of reference in compliance with Rule 3.21 of the Listing Rules and code provision D.3 of part 2 of the CG Code. The terms of reference of the Audit Committee has been published on the websites of the Stock Exchange and the Company, respectively.

The Audit Committee currently consists of three independent non-executive Directors, namely Ms. ZHANG He (Chairperson), Ms. LIN Nan and Mr. CHAN Chi Kong. Ms. ZHANG He currently serves as the Chairperson of the Audit Committee. Mr. CHAN Chi Kong has appropriate professional qualifications as required under Rule 3.10(2) of the Listing Rules.

The primary duties of the Audit Committee are as follows:

- (i) to review significant financial policies of the Company and their implementation, and supervise the financial activities of the Company;
- (ii) to review the financial information and relevant disclosures of the Company;
- (iii) to supervise and evaluate the risk management and internal control of the Company;
- (iv) to supervise and evaluate the work of internal audit of the Company and report to the Board;
- (v) to propose the appointment or dismissal of an external accounting firm;
- (vi) to facilitate communications and monitor the relationship between the internal audit department and the external accounting firm;
- (vii) to monitor the non-compliance of the Company in respect of the financial reports and the risk management and internal control; and
- (viii) other matters required by laws, regulations, regulatory documents, the rules of the securities regulatory authority of the place where the Shares are listed and the requirements of the Memorandum and the Articles of Association, and as authorized by the Board.

Remuneration and Appraisal Committee

The Company has established the Remuneration and Appraisal Committee with written terms of reference in compliance with code provision E.1 of the CG Code. The terms of reference of the Remuneration and Appraisal Committee has been published on the websites of the Stock Exchange and the Company, respectively.

The Remuneration and Appraisal Committee currently consists of two independent non-executive Directors, namely Ms. LIN Nan (Chairperson), and Ms. DING Hui and one executive Director, namely Mr. Xiao. Ms. LIN Nan currently serves as the Chairperson of the Remuneration and Appraisal Committee.

The primary duties of the Remuneration and Appraisal Committee are as follows:

- (i) to organize and formulate the remuneration policy and plan of Directors, Supervisors and senior management and submit to the Board for approval;
- (ii) reviewing and/or approving matters relating to the share scheme pursuant to Chapter 17 of the Listing Rules;
- (iii) to make recommendations to the Board on the remuneration packages of individual executive Directors, Supervisors and senior management members; and
- (iv) other matters required by laws, regulations, regulatory documents, the rules of the securities regulatory authority of the place where the Shares are listed and the requirements of the Memorandum and Articles of Association, and as authorized by the Board.

Nomination Committee

The Company has established the Nomination Committee with written terms of reference in compliance with code provision B.3 of the CG Code. The terms of reference of the Nomination Committee has been published on the websites of the Stock Exchange and the Company.

The Nomination Committee consists of two independent non-executive Directors, namely Ms. DING Hui (Chairperson) and Ms. ZHANG He and one executive Director, namely Mr. Xiao. Ms. DING Hui currently serves as the Chairperson of the Nomination Committee.

The primary duties of the Nomination Committee are as follows:

- (i) to formulate procedures and standards for the election of Directors, Supervisors and senior management and make recommendations to the Board on the proposed procedures and standards;
- (ii) to make recommendations to the Board on the nomination of candidates for Directors, Presidents and secretary of the Board;
- (iii) to preliminarily examine the eligibility of candidates for Directors and senior management;
- (iv) to make recommendations to the Board on the nomination of candidates for chairmen and members of the Board committees; and
- (v) other matters required by laws, regulations, regulatory documents, the rules of the securities regulatory authority of the place where the Shares are listed and the requirements of the Memorandum and the Articles of Association, and as authorized by the Board.

Strategy Committee

The Company has established the Strategy Committee with written terms of reference. The terms of reference of the Strategy Committee has been published on the websites of the Stock Exchange and the Company.

The Strategy Committee currently consists of one executive Director, namely Mr. Xiao (Chairperson), three non-executive Directors, namely Mr. Chan, Mr. Yuan, Mr. WU Nan-Yang and one independent non-executive Director, namely Ms. LIN Nan. Mr. Xiao currently serves as the Chairperson of the Strategy Committee.

The primary duties of the Strategy Committee are as follows:

- (i) studying and advising on our long-term development strategy;
- (ii) studying and advising on major investment and financing schemes that require Board approval according to the Articles of Association:
- (iii) studying and advising on major capital operation and assets management projects that require Board approval according to the Articles of Association:
- (iv) studying and advising on other material matters that may influence the development of the Company;
- (v) assessing and inspecting the implementation of the above issues after they have been approved by the Board and report back to the Board; and
- (vi) handling other matters required by laws, regulations, rules, normative documents, regulatory rules of the jurisdictions where the Shares are listed, the Articles of Association or as authorized by the Board.

Corporate Governance Functions

The Board recognizes the importance of corporate governance and is responsible for performing the following corporate governance duties:

- to develop and review the Company's policies and practices on corporate governance;
- to review and monitor the training and continuous professional development of Directors and senior management;
- to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and Directors; and
- to review the Company's compliance with the code provisions of the CG Code and disclosure in the corporate governance report.

The Board had performed the above duties from the Listing Date to the end of the Reporting Period.

The Company have adopted a board diversity policy (the "Board Diversity Policy") which sets out the objective and approach to achieve and maintain diversity of the Board in order to enhance the effectiveness of the Board. Pursuant to the Board Diversity Policy, selection of Board candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, industry experience, technical capabilities, professional qualifications and skills, knowledge, length of service and other related factors. We will also consider our own business model and special needs. The ultimate selection of Director candidates will be based on merits of the candidates and contribution that the candidates will bring to the Board.

The Board currently consists of three female Directors and six male Directors with a balanced mix of age, gender, knowledge and skills, including but not limited to overall management and strategic development, finance, accounting and risk management. The ages of our Directors range from 42 to 75 years old. The Company is of the view that the Board satisfies the Board Diversity Policy and complies with the requirements under Rule 13.92 of the Listing Rules.

The Nomination Committee is responsible for the implementation of our Board Diversity Policy. The Nomination Committee will review our Board Diversity Policy from time to time to ensure its continued effectiveness.

GENDER DIVERSITY

As at the date of this annual report, the Board currently has three female Directors and six male Directors. The Nomination Committee may consider the female representation on the Board (if appropriate) when selecting and recommending suitable candidates for Board appointments. The Group will continue to emphasize training of female talent and providing long-term development opportunities for female staff. As at December 31, 2024, the gender ratio in our workforce (including senior management) for male and female employees were 53.11% and 46.89%, respectively. For a discussion of the gender ratio in the workforce, please refer to the Environmental, Social and Governance Report, which will be published separately on the websites of the Company and the Stock Exchange on the same date.

NOMINATION POLICY AND PROCEDURES

The Company has adopted a Director nomination policy (the "**Director Nomination Policy**") which sets out the selection criteria and process and the Board succession planning considerations in relation to nomination and appointment of Directors and aims to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the Company and the continuity of the Board and appropriate leadership at Board level.

The Director Nomination Policy sets out the factors for assessing the suitability and the potential contribution to the Board of a proposed candidate or the continued service of existing Director, including but not limited to the following:

- Character and integrity;
- Qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy;
- Diversity in all aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service;
- Requirements on independent non-executive Directors on the Board and independence of the proposed independent non-executive Directors in accordance with the Listing Rules; and
- Commitment in respect of available time and relevant interest to discharge duties as a member of the Board and/or Board committee(s) of the Company.

The Nomination Committee may also consider such other factors as it may deem are in the best interests of the Company and the Shareholders as a whole. The Nomination Committee will review the structure, size and composition of the Board and the Director Nomination Policy on a regular basis.

The Director Nomination Policy also sets out the procedures for the selection and appointment of new Directors, Supervisors and senior management of the Company and re-election of Directors and/or Supervisors at general meetings of the Company. During the period from the Listing Date to December 31, 2024, there was no change in the composition of the Board.

MECHANISM TO ENSURE INDEPENDENT VIEWS OF DIRECTORS

The Company has established the mechanism to ensure independent views and input are available to the Board, whereby independent non-executive Directors can express their opinions in an open and candid manner, and in a confidential manner, should circumstances require.

Independent non-executive Directors provide constructive suggestions to the Board based on objective judgement through formal and informal channels to improve the efficiency and decision-making of the Board. According to the rules of proceedings of the Board, the views of independent non-executive Directors shall be recorded separately for resolutions which require independent non-executive Directors to express their special views. If the views of independent non-executive Directors are inconsistent, their views shall be recorded respectively. For resolutions which are required to be disclosed, the views of independent non-executive Directors shall be disclosed separately. The Board reviews the implementation and effectiveness of the aforementioned mechanism on an annual basis.

REMUNERATION POLICY

The Remuneration and Appraisal Committee conducts regular reviews of the Group's remuneration policies. Based on the primary scope, duties and responsibilities, significance of roles, and the remuneration level of the similar positions in other relevant enterprises, the committee formulates remuneration plans or proposals for Directors and senior management. These proposals are then recommended to the Board for review and approval.

The Company has also adopted the Share Incentive Scheme. The purpose of the Share Incentive Scheme I is to further establish and improve the Company's long-term incentive mechanism, attract and retain talents, fully promote the positivity of the Directors, senior management, middle-level management and core employees of the Company, and direct the focus of all parties to the Company's long-term development by effectively combining the interests of the Shareholders, the Company and core individuals.

In accordance with the requirements under Rule 3.29 of the Listing Rules, both Mr. Zheng and Mr. Chung confirmed that they have taken not less than 15 hours of relevant professional training during the Reporting Period.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code set out in Appendix C3 to the Listing Rules as its own code of conduct regarding Directors' dealings in securities of the Company since the Listing and having made specific enquiries of all the Directors and Supervisors, each of them has confirmed that he/she has complied with all the applicable code provisions under the Model Code from the Listing Date to the end of the Reporting Period.

As required by the Company, relevant officers and employees of the Company are also bound by the Model Code, which prohibits them to deal in securities of the Company at any time when he/she possesses insider information in relation to those securities. No incident of non-compliance with the Model Code by the Directors, Supervisors and the relevant employees of the Company were noted by the Company from the Listing Date to the end of the Reporting Period.

RISK MANAGEMENT AND INTERNAL CONTROL

We have formulated and implemented comprehensive risk management and internal control policies that span various aspects of our business operations to oversee and address a spectrum of operational, financial, legal and market risks that may be or have been identified in connection with our operations, and we review the effectiveness of these policies at least annually. These comprehensive risk management and internal control are supported by our specific monitoring and reporting procedures and systems as outlined in the relevant policies. Our Board bears the responsibility for overseeing our overall risk management, ensuring that our risk management policies are not only implemented but also regularly reviewed and updated to reflect the changing business environment. The Group's risk management and internal control systems are designed to provide reasonable, though not absolute, assurance against material misstatement or loss and to manage rather than eliminate the risk of failure to achieve business objectives.

We established a dedicated risk management and internal control team which takes responsibility for establishing risk management and internal control policies, conducting internal audit, providing internal control consultation and guiding any rectification.

The Board has established an on-going process for identifying, evaluating and managing the potential risks (including environmental, social and governance ("**ESG**") risks) faced by the Group and this process includes enhancing the systems of risk management and internal controls from time to time in response to the changes to the business environment or regulatory guidelines.

The Group's risk management and internal control team plays an important role in monitoring the internal governance of the Company. The major duties of the risk management and internal control team are to regulate and review the internal control and compliance related matters of the Company and conduct comprehensive audits of all branches and subsidiaries of the Group on a regular basis. The Group's internal audit function provides independent and objective assurance as to whether the design and effectiveness of the Group's framework of risk management, internal control and governance processes is adequate and issues an appraisal report which shall be submitted to our Audit Committee for approval.

From the Listing Date to the end of the Reporting Period, the Audit Committee, with reference to and based on the internal control review report issued by the risk management and internal control team, conducted a review on the effectiveness of the Group's risk management and internal control systems, including financial, operational and compliance controls as well as the process for the identification, evaluation and management of the significant risks (including ESG risks) faced by the Group. The Board has considered and discussed the internal audit report issued by the Group's risk management and internal control team and the independent auditor, the Audit Committee's view on the Group's risk management and internal control systems and their effectiveness.

With respect to procedures and internal controls for the handling and dissemination of inside information, the Company:

- is required to disclose inside information as soon as reasonably practicable in accordance with the SFO and the Listing Rules;
- conducts its affairs with close regard to the "Guidelines on Disclosure of Inside Information" issued by the Securities and Futures Commission;
- has included in the code of conduct of the Company a strict prohibition on the unauthorised use of confidential or inside information; and

Our internal audit department is responsible for investigating any reported incidents and taking appropriate measures. We also have regular training for employees regarding the anti-bribery policy to facilitate implementation of the policy. During the Reporting Period and up to the date of this annual report, we were not aware of any anti-bribery incident by our employees in relation to our customers.

The Anti-corruption Policy is reviewed and updated periodically to align with the applicable laws and regulations as well as the industry best practice.

DIVIDEND POLICY

The Company has adopted a dividend policy ("**Dividend Policy**") on payment of dividends pursuant to code provision F.1.1. of Part 2 of the CG Code to ensure that the Board maintains an appropriate procedure on declaring and recommending the dividend payment of our Group.

Any proposed distribution of dividends shall be formulated by the Board and will be subject to approval in our Shareholders' meeting. A decision to declare or to pay any dividends in the future, and the amount of any such dividends, will depend on a number of factors, including our results of operations, cash flows, financial condition, payments by our subsidiaries of cash dividends to us, business prospects, statutory, regulatory and contractual restrictions on our declaration and payment of dividends and other factors that the Board may consider important. Over the next three years, we intend to adopt a dividend payout ratio of no less than 30% of our net profit of the year of dividend payment, according to our business operations and cash flow position, which is subject to the approvals of the Board and the Shareholders' meeting. No dividend will be declared or payable except out of our profits and reserves lawfully available for distribution. There can be no assurance that dividends of any amount will be declared or distributed in any year.

According to the Articles of Association, the Company may distribute dividends in the form of:

- (i) cash;
- (ii) share certificates; or
- (iii) other manners permitted by laws, administrative regulations and regulatory rules of the place where the Shares are listed.

The Company shall pay cash dividends and other payments in RMB payable to the holders of unlisted domestic shares. Cash dividends and other payments payable to the holders of H Shares shall be calculated and declared in RMB by the Company, and such distribution shall be handled in accordance with applicable regulations on foreign exchange control of the PRC.

COMMUNICATION WITH SHAREHOLDERS

The Company believes that effective communication with Shareholders is essential for enhancing investor relations and investors' understanding of the Group's business performance and strategies. Information in relation to the Group is disseminated to the Shareholders in a timely manner through a number of formal channels, which include interim and annual reports, announcements and circulars.

SHAREHOLDERS' RIGHTS

Convening an extraordinary meeting and putting forward proposals

Pursuant to the Articles of Association, when Shareholders individually or jointly holding more than 10% (inclusive) of the Company's outstanding voting shares make request(s) in writing for the convening of an extraordinary meeting, such request shall be submitted in writing to the Board. The Board shall, in accordance with the laws, administrative regulations and the Articles of Association, furnish a written reply to such Shareholder(s) stating its agreement or disagreement to the convening of the extraordinary meeting within ten days after having received such requisition. In the event that the Board agrees to convene an extraordinary meeting, a notice for convening such meeting shall be given within five days after the relevant Board resolution is passed and consent of the relevant Shareholder(s) shall be obtained in case of any changes to the original requisition in the notice. In the event that the Board disagrees to convene an extraordinary meeting or does not furnish any reply within ten days after having received such requisition, in which case Shareholder(s) individually or jointly holding more than 10% of the Shares of the Company may propose in writing the Board of Supervisors to convene the extraordinary meeting.

Additionally, Shareholders individually or jointly holding over 1% of the Company's Shares are entitled to put forward a temporary proposal to the Company 10 days before convening the Shareholders' general meeting and submit the proposal in writing to the convener. The convener shall issue a supplemental notice for the shareholders' meeting within 2 days upon receiving the proposal, inform other shareholders and, if within the terms of reference of the shareholders' meeting, add such a proposal to the agenda thereof for consideration at the shareholders' meeting, provided that no temporary proposal shall be submitted if it is in violation of any law, administrative regulation or the Articles of Association or not within the scope of duties and powers of the shareholders' meeting.

To safeguard Shareholders' interests and rights, a separate resolution is proposed for each issue at general meetings, including the election of individual Directors.

The Board of the Company is pleased to present this report together with the audited consolidated financial statements of the Group for the year ended December 31, 2024.

GLOBAL OFFERING

The H Shares were listed on the Main Board of the Stock Exchange on the Listing Date. 19,320,000 H Shares were offered in the Hong Kong public offering, and 19,320,000 H Shares were offered in the international offering. The offer price was determined at HK\$3.610 per offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027%, AFRC transaction levy of 0.00015% and the Stock Exchange trading fee of 0.00565%).

PRINCIPAL ACTIVITIES

The Company is a provider of intelligent vision products and system solutions encompassing intelligent automotive vision, high-end lighting and advanced display. Leveraging industry insights and proactive approaches to technological innovation, we house a broad array of our core "LED+" technologies that integrate LED technologies with integrated circuits (ICs), electronic control, software, sensors, optics and others.

BUSINESS REVIEW

A review of the Group's results for the year, a discussion and analysis of key factors related to its financial position and the prospects of the Group's business are set out in the "Management Discussion and Analysis" section of this annual report.

PRINCIPAL RISK AND UNCERTAINTIES

Our business involves certain risks and the most significant risks that we are facing include but are not limited to the following:

We face significant competition in the industry in which we operate, and if we are unable to compete effectively, our results of operations and financial condition may be materially and adversely affected.

The LED intelligent vision industry is intense and highly competitive with over 300 thousand market participants. China has the world's largest LED intelligent vision industry, with a market size of RMB440.2 billion in 2023 in terms of revenue. Based on applications, LED intelligent vision can be categorized into intelligent automotive vision, high-end lighting and advanced display. In terms of revenue in 2023, the top five manufacturers took up an aggregated market share of 49.2%, 39.3% and 66.6%, respectively, in China's intelligent automotive vision market, high-end lighting market and LCD TV backlight display market, respectively. Many of our competitors provide products comparable to those we offer and may further upgrade their products and optimize their services. Our competitors may have longer operating histories, greater brand recognition, better supplier relationships, larger customer bases or greater financial, technological or marketing resources than we do. As a result, our competitors may be able to respond more quickly and effectively to new or changing opportunities, technologies, standards or customer requirements than us and may have the ability to initiate or withstand significant industry evolvement or regulatory changes. Our competitors may have more advanced facilities or equipment, develop more advanced or efficient technologies, acquire more customers, have more professional staff or offer more competitive prices. If we are unable to stay competitive or compete successfully with our competitors, we may experience decreases in market share and sales volume, and may have to reduce our prices or make other concessions, thereby adversely affecting our profitability, business, financial condition and results of operations.

We are exposed to customer concentration risk.

Revenue from our five largest customers from 2021 to 2024 amounted to RMB997.6 million, RMB1,033.7 million, RMB1,366.6 million and RMB1,928.4 million, respectively, accounting for 71.8%, 73.2%, 73.5% and 74.4% of our total revenue, respectively. Revenue from our largest customer from 2021 to 2024 amounted to RMB423.6 million, RMB350.1 million, RMB705.8 million and RMB902.0 million, respectively, accounting for 30.5%, 24.8%, 38.0% and 34.8% of our total revenue, respectively. From 2021 to 2024, a majority of the sales of our intelligent automotive vision products were attributable to Geely Related Group, and the revenue from Geely Related Group was RMB50.6 million, RMB350.1 million, RMB705.8 million and RMB902.0 million, respectively, accounting for 3.6%, 24.8%, 38.0% and 34.8% of our total revenue, respectively, for the same periods. We expect that revenue from Geely Related Group will continue to increase in the near future. Our major customers' stable relationship with us and consistent demands are crucial to our business. Their business conditions, liquidity and solvency may have a significant impact on our business dealings. Any disruption in our business relationship with major customers could have a material adverse effect on our business, financial condition and results of operations. In the event that the existing major customers reduce or cease to purchase our products and we are unable to find new customers with similar level of demands at comparable terms within a reasonable period of time or at all, our business and profitability may be adversely affected.

Demand for our LED products depends on trends and developments in their corresponding end products and end markets.

We offer a broad portfolio of LED products to be used for a wide range of end products or targets, such as automotives and consumer electronics. As such, demand for our products depends to a large extent on trends and developments in the markets for end products. If the end product markets cannot maintain robust growth, our business and profitability may be adversely affected. Furthermore, the end markets of our products are characterized and defined by rapidly changing technology, frequent new product specifications and changing customer demands. Our success thus depends on the ability to adequately respond and adapt to technological developments in a timely and cost-effective manner, through continual improvement of our products and services. Our failure to adapt to such changes may have a material adverse effect on our business, operating results and financial condition.

ENVIRONMENTAL POLICIES AND PERFORMANCE

The Group is not exposed to any significant environmental risks. From the Listing Date to the end of the Reporting Period, the Group was not subject to any fines or other penalties for the non-compliance with environmental protection laws and regulations. An account of the Company's key relationships with its employees, customers and suppliers and others that have a significant impact on the Company and a discussion of the Company's environmental policies and performance are set out in the "Environmental, Social, and Governance Report".

During the Reporting Period, there was no material breach of, or non-compliance with, applicable laws and regulations by the Group.

DIVIDENDS

The Board has resolved to distribute a final dividend of RMB0.68 (tax inclusive) per 10 ordinary Shares, equivalent to an aggregate amount of RMB36.53 million, for the year ended December 31, 2024, subject to the approval by the annual general meeting of the Company to be held by and before June 30, 2025. Such final dividend, once approved, is expected to be paid by August 31, 2025. The proposed final dividend shall be declared in RMB and paid in Hong Kong dollars to the holders of H shares. The final dividend payable in Hong Kong dollars will be converted from RMB at the average exchange rate of RMB to Hong Kong dollars as published by the People's Bank of China for the five business days prior to the forthcoming annual general meeting of the Company and the final dividend payable to the holders of Domestic Unlisted Shares will be paid in RMB.

Pursuant to the Notice of the State Administration of Taxation on Issues Concerning Collection and Management of the Individual Income Tax after the Abolishment of Guo Shui Fa [1993] No. 045 (Guo Shui Han [2011] No. 348) (《國家税務總 局關於國稅發[1993]045號文件廢止後有關個人所得稅徵管問題的通知》(國稅函[2011]348號)), dividend and bonus income received by overseas resident individual shareholders who hold shares issued by domestic non-foreign invested enterprises in Hong Kong is subject to the payment of individual income tax under the items of "interests, dividend and bonus income", which shall be withheld and paid by the withholding agents according to relevant laws. The overseas resident individual shareholders who hold shares issued by domestic non-foreign invested enterprises in Hong Kong are entitled to the relevant preferential tax treatment pursuant to the provisions in the tax treaties entered into between the countries where they reside and the PRC and the tax arrangements between Mainland China and Hong Kong (Macau). The relevant tax rate for dividends under the relevant tax treaties and tax arrangements is generally 10%, and for the purpose of simplifying tax administration, domestic non-foreign invested enterprises issuing shares in Hong Kong may, when distributing dividends and bonus, generally withhold individual income tax at the rate of 10%, and are not required to file an application. If the tax rate for dividends is not equal to 10%, the following provisions shall apply: (1) for citizens from countries which have entered into tax treaties stipulating a tax rate of lower than 10%, the withholding agents can file applications on their behalf to claim the relevant agreed preferential treatments, and upon approval by the competent tax authorities, the excess tax amounts withheld will be refunded; (2) for citizens from countries which have entered into tax treaties stipulating a tax rate of higher than 10% but lower than 20%, the withholding agents will withhold the individual income tax at the agreed-upon effective tax rate when distributing dividends and bonus, and are not required to file an application; (3) for citizens from countries without tax treaties and under other situations, the withholding agents will withhold the individual income tax at the rate of 20% when distributing dividends and bonus.

Pursuant to the Notice of the State Administration of Taxation on Issues Concerning Withholding the Enterprise Income Tax on Dividends Paid by Chinese Resident Enterprises to Holders of H Shares who are Overseas Non-resident Enterprises (Guo Shui Han [2008] No. 897) (《國家稅務總局關於中國居民企業向境外H股非居民企業股東派發股息代扣代繳企業所得稅有關問題的通知》(國稅函[2008]897號)), a PRC resident enterprise, when distributing dividends for 2008 and for the years afterwards to holders of H Shares who are overseas non-resident enterprises, shall withhold and pay enterprise income tax at a flat rate of 10%.

In accordance with current convention of the Hong Kong Inland Revenue Department, no taxes will be paid for dividends paid by the Company in Hong Kong.

There is no arrangement under which a Shareholder has waived or agreed to waive any dividend.

RESERVES

Pursuant to the requirements of the Articles of Association, Directors (including non-executive Directors) shall be elected at the Shareholders' meeting for a term of three years. A Director shall be eligible for re-election on the expiry of each term. The Company has implemented a set of effective procedures for appointment of new Directors. The nomination of new Directors shall be first deliberated by the Nomination Committee and then submitted to the Board, subject to approval by election at the Shareholders' meeting of the Company.

Each of the executive Director, non-executive Directors and independent non-executive Directors and Supervisors has entered into a service contract or letter of appointment with the Company with a specific term. Such term is subject to his or her retirement and re-election at the Shareholders' meeting of the Company in accordance with the Articles of Association.

Save as disclosed above, none of the Directors or Supervisors has entered into any service contract or letter of appointment with the Company or any of its subsidiaries other than the contracts/letters of appointment expiring or determinable by the employer within one year without payment of compensation (other than statutory compensation).

Directors' Interests in Competing Business

During the year ended December 31, 2024, none of the Directors or their respective close associates (as defined under the Listing Rules) had interests in business that competed or was likely to compete, either directly or indirectly with our business, which would require disclosure under Rule 8.10 of the Listing Rules.

Continuing Connected Transactions

Details of the Group's continuing connected transactions (the "Continuing Connected Transactions") are set out as follows:

I. Supply Framework Agreement

On October 12, 2024, the Group entered into the products and services supply framework agreement with Geely Group, a connected person of the Company (the "Supply Framework Agreement"), pursuant to which our Group may, from time to time, provide Geely Group with the intelligent automotive vision products, including the relevant prototypes and spare parts, and development services. Geely Holding is indirectly held as to over 50% by LI Shufu (李書福), the father-in-law of ZHENG Xin, our non-executive Director, and the father of LI Xingxing (李星星), who is a substantial Shareholder of our Company by virtue of his interest in Yaoning Technology. The Supply Framework Agreement has an initial term commencing on the Listing Date and ending on December 31, 2026, and may be renewed as the parties mutually agree, subject to the compliance with the requirements under Chapter 14A of the Listing Rules and all other applicable laws and regulations.

The annual cap for above continuing connected transaction for the year ended December 31, 2024, was RMB1,081 million, and the actual transaction amount for the year ended December 31, 2024, was approximately RMB902 million. Please refer to the Prospectus of the Company for further details.

II. Procurement Framework Agreement

On October 12, 2024, the Group entered into the procurement framework agreement with Geely Group (the "Procurement Framework Agreement"), pursuant to which the Group may, from time to time, procure from Geely Group certain services and products, including but not limited to warehousing and other services, such as consultancy services for assistance in project application (the "Procurement"). The Procurement Framework Agreement has an initial term commencing on the Listing Date and ending on December 31, 2026, and may be renewed as the parties may mutually agree, subject to the compliance with the requirements under Chapter 14A of the Listing Rules and all other applicable laws and regulations. Please refer to the Prospectus of the Company for further details.

During the year ended December 31, 2024, the transaction amount of the Procurement made by the Group under the Procurement Framework Agreement amounted to RMB8.1 million, which exceeded the original annual cap for the year ended December 31, 2024 under the Procurement Framework Agreement of RMB4.4 million (the "**Original 2024 Annual Cap**"). Such exceeding of the Original 2024 Annual Cap was due to (i) that as disclosed in the Prospectus, the Company procures supply chain logistics services both from external independent parties and from Geely Group, in order to improve the customer experience of Geely Group as one of the important customers of the Group; and (ii) that the business department of the relevant subsidiary of the Group, having considered factors including the terms and conditions of the supply chain logistics services provided by Geely Group, decided to increase the proportion of procurement from members of Geely Group in the fourth quarter of 2024, which was unbeknown to the management of the Company due to failure of timely internal report caused by the negligence of the operating personnels of the relevant subsidiary of the Group.

Revision of 2025 and 2026 Annual Caps

In view of the fact that the Original 2024 Annual Cap has been exceeded and taking into account the expected further increase in the transaction amounts in relation to the procurement of supply chain logistics services, the Board resolved on January 23, 2025, to revise the existing annual caps for the years ending December 31, 2025 and 2026, respectively, as follows:

The Directors (including all the independent non-executive Directors) have confirmed that the transactions contemplated under the Procurement Framework Agreement and the revised annual caps for the years ending December 31, 2025 and 2026, respectively, are fair and reasonable, are on normal commercial terms or better and in the ordinary and usual course of business of the Company, and are in the interests of the Company and the Shareholders as a whole.

Enhanced Internal Control Measures of Continuing Connected Transactions

The Directors are of the opinion that the actual transaction amount under the Procurement Framework Agreement exceeding the Original 2024 Annual Cap is unintentional. In order to ensure that the Company is in compliance with the applicable requirements of the Listing Rules going forward and with a view to preventing such event from re-occurring, the Company has taken the following measures to further strengthen its internal control over continuing connected transactions:

- (a) The Company has trained and will continue to arrange regular training for its staff, including those from the business operations, finance, legal and compliance departments, to enhance their familiarity with the Listing Rules and to raise their awareness of compliance with the internal control procedures in relation to the Group's continuing connected transactions:
- (b) The Board and each of the internal departments (including the finance, legal and compliance, and business operations departments) will be jointly responsible for evaluating the terms under continuing connected transactions framework agreements, in particular the fairness and reasonableness of the pricing policy as well as the proposed annual caps under each transaction;
- (c) All members of the Group will be required to report to the finance department of the Company, which will closely monitor the actual transaction amounts of their continuing connected transactions on a monthly basis. If at any time the actual transaction amount reaches 80% of the proposed annual caps for the relevant continuing connected transaction, the finance department of the Company shall report to the senior management of the Company. The senior management shall seek advice from the Audit Committee and the Board shall consider taking appropriate measures, including but not limited to further revising the revised annual caps and complying with the relevant announcement and/or independent Shareholders' approval requirements (if necessary) in accordance with the Listing Rules; and

(d) Before renewing, adding to the existing business and/or commencing new forms of business with any connected persons, the relevant business operations department should first report to the finance and compliance departments, and the senior management should assess whether the scope of the existing continuing connected transactions and the relevant proposed annual caps shall be revised and/or whether new framework agreements shall be entered into for such new transactions.

For further details, in relation to the Procurement Framework Agreement and the exceeding of the Original 2024 Annual Cap, please refer to the annuancement of the Company dated January 23, 2025.

Save as disclosed in this annual report, during the year ended December 31, 2024, the Company had no connected transactions or continuing connected transactions which fell to be disclosed in accordance with the provisions under Chapter 14A of the Listing Rules in relation to the disclosure of connected transactions and continuing connected transactions.

- (c) in accordance with the relevant agreements governing them on terms that were fair and reasonable and in the interests of the Company and the Shareholders as a whole.

Confirmation of the Auditor

The Auditor has performed the relevant procedures regarding the Continuing Connected Transactions as outlined above in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) Assurance Engagements Other Than Audits or Reviews of Historical Financial Information and with reference to Practice Note 740 (Revised) Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules issued by the Hong Kong Institute of Certified Public Accountants. The Auditor has issued a qualified letter containing its findings and conclusions in respect of the continuing connected transactions disclosed by the Group in this annual report in accordance with Rule 14A.56 of the Listing Rules.

Based on the work performed, in respect of the disclosed Continuing Connected Transactions entered into by the Group during the Reporting Period as set out above, the Auditor confirms that:

- a. nothing has come to its attention that causes it to believe that the disclosed continuing connected transactions have not been approved by the Board;

On November 8, 2024, the Company was successfully listed on the Hong Kong Stock Exchange. The net proceeds received by the Group from the Global Offering (after deducting underwriting fees and relevant expenses) amounted to HK\$79.04 million. The Company will apply such net proceeds in accordance with the purposes as set out in the Prospectus.

TREASURY POLICY

The Group has adopted a prudent treasury management policy to (i) ensure that the Group's funds are properly and efficiently collected and deployed such that there is no material shortfall in cash which may interrupt the Group's daily business operations; and (ii) maintain adequate liquidity to cover the Group's operation cash flows, and administrative expenses. The Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities, and other commitments can meet its funding requirements all the time.

EMOLUMENT POLICY

As at December 31, 2024, the total number of employees of the Group was 3,020. Staff costs (including Directors' remuneration) of the Group for the Reporting Period amounted to approximately RMB356,729 thousand, and the total remuneration of the Group's Directors, Supervisors and senior management for the Reporting Period amounted to approximately RMB14,891 thousand.

Our success depends on our ability to attract, retain and motivate qualified personnel. We use various methods for our recruitment, including campus recruitment, internal and external recommendation and recruiting through headhunting firms or agents, to satisfy our demands for different types of talents, and we adopt high standards and stringent procedures in our recruitment to ensure the quality of new hiring. Our employees typically enter into standard labor contracts with us.

We provide competitive compensation packages. Remuneration packages for our employees mainly comprise basic salary and performance-based bonus. In addition, we are required under the PRC law to make contributions to statutory employee benefit plans (including pension plans, medical insurance and housing funds) at a certain percentage of our employees' salaries, including bonus and allowance up to a maximum amount specified by the local government. We set performance targets for our employees primarily based on their position and department, and we periodically review their performance. The results of such reviews are used in their salary determinations, bonus awards and promotion appraisals. To maintain and enhance the knowledge and skill levels of our workforce, we provide our employees with internal training, including orientation programs for new employees and technical training for existing employees. We also offer external training opportunities to our management team and other staff.

REMUNERATION OF DIRECTORS AND THE FIVE HIGHEST-PAID EMPLOYEES

In compliance with the CG Code, the Company has established the Remuneration and Appraisal Committee to formulate remuneration policies. Details of the remuneration of the Directors and chief executives are set out in Note 8 to the consolidated financial statements. None of the Directors or chief executives waived or agreed to waive any remuneration and there were no emoluments paid by the Group to any of the Directors, chief executives or any of the five highest-paid individuals as an inducement to join, or upon joining the Group, or as compensation for loss of office.

PRE-EMPTIVE RIGHTS

There are no provisions for pre-emptive rights under the Articles of Association and the laws of the PRC which oblige the Company to offer pre-emptive rights of new shares to existing Shareholders on their shareholding proportion.

TAX RELIEF AND EXEMPTION

The Group is not aware of any tax relief and exemption to the holders of any securities of the Company as a result of their holding of such securities.

CONTINUING DISCLOSURE OBLIGATIONS UNDER RULES 13.20, 13.21 AND 13.22 OF THE LISTING RULES

The Company did not have any continuing obligations under Rules 13.20, 13.21 and 13.22 of the Listing Rules during the period from the Listing Date up to the end of the Reporting Period.

PENSION SCHEME

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain proportion of its payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

SHARE INCENTIVE SCHEMES

The Share Incentive Schemes do not constitute a share scheme under Chapter 17 of the Listing Rules and during the Reporting Period, were carried out through the Share Incentive Schemes, which did not involve the Company directly issuing new Shares to the participants of the Share Incentive Schemes (the "Participants"). After the grant of the awards of the Share Incentive Scheme I, the Share Incentive Scheme III, the Participants of the respective Share Incentive Schemes have become limited partners of Jingyu Investment, Jingrui Investment or Jingshi Investment and Jingling Investment and are indirectly interested in the incentive shares under the terms and conditions contained in relevant agreements of Share Incentive Scheme II, Share Incentive Scheme III and Share Incentive Scheme III, respectively.

The awards of the Share Incentive Schemes are subject to regulatory lock-up requirement and a stipulated lock-up period commencing from the grant date until two years after the Listing Date. During the lock-up period of the Share Incentive Schemes, the Participants shall not dispose of, or request to dispose of, or transfer to external parties or the other Participants under the Share Incentive Schemes, their limited partnership interests in the employee shareholding platforms.

As of December 31, 2024, all of the restricted share units under the Share Incentives Schemes have been granted to certain eligible Participants as an award under the respective Share Incentive Schemes.

PUBLIC FLOAT

Based on the publicly available information and to the best knowledge of the Directors, the Directors confirm that the Company has maintained the aforementioned minimum public float as required by the Stock Exchange since the Listing Date and up to this annual report date.

REVIEW OF AUDITED ANNUAL RESULTS AND APPROVAL OF ANNUAL REPORT

The Audit Committee has reviewed the audited annual results and the annual report of our Company for the year ended December 31, 2024.

The annual report and the consolidated financial statements of the Group for the year ended December 31, 2024 were approved and authorised for issue by the Board on March 18, 2025.

SUBSEQUENT EVENTS

Saved as disclosed as above, after due and careful consideration, our Directors confirm that, there has not been any material adverse change in financial or trading position or prospects of the Company since December 31, 2024, and there has been no event since December 31, 2024 and up to this annual report date which would materially affect the information set out in the audit's report.

Revenue recognition

For the year ended 31 December 2024, revenue of the Group in total was RMB2,592,064,000 of which revenue from the sale of automotive intelligent vision, advanced display and high-end lighting products amounted to RMB1,023,495,000, RMB807,098,000 and RMB761,471,000, respectively.

Revenue recognition is a key audit matter because the revenue amounts were significant to the consolidated financial statements as a whole. Besides, revenue is one of the performance indicators of the Group, and there is an inherent risk of management manipulating revenue recognition to achieve expected performance and meet earnings expectations among investors.

The Group's disclosures relating to the revenue recognition are included in note 2.4, note 4, and note 5.

Our audit procedures in relation to the assessment of revenue recognition included the following:

- (a) understanding, assessing and testing the design, implementation and operating effectiveness of the Group's key internal controls over revenue recognition;
- (b) inspecting key customer contracts to identify terms and conditions relating to goods acceptance and assessing the Group's timing of recognition of revenue with reference to the requirements of the prevailing accounting standards;
- (c) performing an analytical review of revenue to analyse the fluctuations in revenue and gross profit during the year;
- (d) performing tests of details for revenue recognition, including but not limited to the invoices, customs declaration and delivery notes;
- (e) performing cut-off tests of revenue before and after the year end, on a sample basis;
- (f) obtaining external confirmations for sales transactions during the year and compare them with the accounting records:
- (g) performing alternative procedures for non-replied confirmations; and
- (h) reviewing the disclosures of operating revenue in the notes to the consolidated financial statements.

OTHER INFORMATION INCLUDED IN THE ANNUAL REPORT

The directors of the Company are responsible for the other information. The other information comprises the information included in the Annual Report, other than the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. 1. CORPORATE INFORMATION

2. ACCOUNTING POLICIES

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with IFRS Accounting Standards (which include all International Financial Reporting Standards, International Accounting Standards ("IASs") and interpretations) issued by the International Accounting Standards Board ("IASB") and the disclosure requirements of the Hong Kong Companies Ordinance.

These financial statements have been prepared under the historical cost convention, except for certain financial assets which have been measured at fair value through profit or loss, or other comprehensive income. They are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "**Group**") for the year ended 31 December 2024. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control. When the Company has less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises the related assets (including goodwill), liabilities, any non-controlling interest and the foreign currency translation reserve; and recognises the fair value of any investment retained and any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

The nature and impact of the revised IFRS Accounting Standards that are applicable to the Group are described below:

- (a) Amendments to IFRS 16 specify the requirements that a seller-lessee uses in measuring the lease liability arising in a sale and leaseback transaction to ensure the seller-lessee does not recognise any amount of the gain or loss that relates to the right of use it retains. Since the Group has no sale and leaseback transactions with variable lease payments that do not depend on an index or a rate occurring from the date of initial application of IFRS 16, the amendments did not have any impact on the financial position or performance of the Group.
- (b) The 2020 Amendments clarify the requirements for classifying liabilities as current or non-current, including what is meant by a right to defer settlement and that a right to defer must exist at the end of the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement. The amendments also clarify that a liability can be settled in its own equity instruments, and that only if a conversion option in a convertible liability is itself accounted for as an equity instrument would the terms of a liability not impact its classification. The 2022 Amendments further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date affect the classification of that liability as current or non-current. Additional disclosures are required for non-current liabilities that are subject to the entity complying with future covenants within 12 months after the reporting period.

The Group has reassessed the terms and conditions of its liabilities as at 1 January 2023 and 2024 and concluded that the classification of its liabilities as current or non-current remained unchanged upon initial application of the amendments. Accordingly, the amendments did not have any impact on the financial position or performance of the Group.

(c) Amendments to IAS 7 and IFRS 7 clarify the characteristics of supplier finance arrangements and require additional disclosure of such arrangements. The disclosure requirements in the amendments are intended to assist users of financial statements in understanding the effects of supplier finance arrangements on an entity's liabilities, cash flows and exposure to liquidity risk. As the Group does not have supplier finance arrangements, the amendments did not have any impact on the Group's financial statements.

Amendments to IFRS 10 and IAS 28 address an inconsistency between the requirements in IFRS 10 and in IAS 28 in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to IFRS 10 and IAS 28 was removed by the IASB. However, the amendments are available for adoption now.

The amendments require disclosures of information that enable users of financial statements to understand the impact of a currency not being exchangeable. Earlier application is permitted. When applying the amendments, an entity cannot restate comparative information. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening balance of retained profits or to the cumulative amount of translation differences accumulated in a separate component of equity, where appropriate, at the date of initial application. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IFRS 9 and IFRS 7 clarify the date on which a financial asset or financial liability is derecognised and introduce an accounting policy option to derecognise a financial liability that is settled through an electronic payment system before the settlement date if specified criteria are met. The amendments clarify how to assess the contractual cash flow characteristics of financial assets with environmental, social and governance and other similar contingent features. Moreover, the amendments clarify the requirements for classifying financial assets with non-recourse features and contractually linked instruments. The amendments also include additional disclosures for investments in equity instruments designated at fair value through other comprehensive income and financial instruments with contingent features. The amendments shall be applied retrospectively with an adjustment to opening retained profits (or other component of equity) at the initial application date. Prior periods are not required to be restated and can only be restated without the use of hindsight. Earlier application of either all the amendments at the same time or only the amendments related to the classification of financial assets is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Annual Improvements to IFRS Accounting Standards — Volume 11 set out amendments to IFRS 1, IFRS 7 (and the accompanying Guidance on implementing IFRS 7), IFRS 9, IFRS 10 and IAS 7. Details of the amendments that are expected to be applicable to the Group are as follows:

- IFRS 7 Financial Instruments: Disclosures: The amendments have updated certain wording in paragraph B38 of IFRS 7 and paragraphs IG1, IG14 and IG20B of the Guidance on implementing IFRS 7 for the purpose of simplification or achieving consistency with other paragraphs in the standard and/or with the concepts and terminology used in other standards. In addition, the amendments clarify that the Guidance on implementing IFRS 7 does not necessarily illustrate all the requirements in the referenced paragraphs of IFRS 7 nor does it create additional requirements. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.
- IFRS 9 Financial Instruments: The amendments clarify that when a lessee has determined that a lease liability has been extinguished in accordance with IFRS 9, the lessee is required to apply paragraph 3.3.3 of IFRS 9 and recognise any resulting gain or loss in profit or loss. In addition, the amendments have updated certain wording in paragraph 5.1.3 of IFRS 9 and Appendix A of IFRS 9 to remove potential confusion. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.
- IFRS 10 Consolidated Financial Statements: The amendments clarify that the relationship described in paragraph B74 of IFRS 10 is just one example of various relationships that might exist between the investor and other parties acting as de facto agents of the investor, which removes the inconsistency with the requirement in paragraph B73 of IFRS 10. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

IAS 7 Statement of Cash Flows: The amendments replace the term "cost method" with "at cost" in paragraph 37 of IAS 7 following the prior deletion of the definition of "cost method". Earlier application is permitted. The amendments are not expected to have any impact on the Group's financial statements.

IFRS 18 replaces IAS 1 Presentation of Financial Statements. While a number of sections have been brought forward from IAS 1 with limited changes, IFRS 18 introduces new requirements for presentation within the statement of profit or loss, including specified totals and subtotals. Entities are required to classify all income and expenses within the statement of profit or loss into one of the five categories: operating, investing, financing, income taxes and discontinued operations and to present two new defined subtotals. It also requires disclosures about management-defined performance measures in a single note and introduces enhanced requirements on the grouping (aggregation and disaggregation) and the location of information in both the primary financial statements and the notes. Some requirements previously included in IAS 1 are moved to IAS 8 Accounting Policies, Changes in Accounting Estimates and Errors, which is renamed as IAS 8 Basis of Preparation of Financial Statements. As a consequence of the issuance of IFRS 18, limited, but widely applicable, amendments are made to IAS 7 Statement of Cash Flows, IAS 33 Earnings per Share and IAS 34 Interim Financial Reporting. In addition, there are minor consequential amendments to other IFRSs. IFRS 18 and the consequential amendments to other IFRSs are effective for annual periods beginning on or after 1 January 2027 with earlier application permitted. Retrospective application is required. The Group is currently analysing the new requirements and assessing the impact of IFRS 18 on the presentation and disclosure of the Group's financial statements.

IFRS 19 allows eligible entities to elect to apply reduced disclosure requirements while still applying the recognition, measurement and presentation requirements in other IFRSs. To be eligible, at the end of the reporting period, an entity must be a subsidiary as defined in IFRS 10 *Consolidated Financial Statements*, cannot have public accountability and must have a parent (ultimate or intermediate) that prepares consolidated financial statements available for public use which comply with IFRSs. Earlier application is permitted. As the Company is a listed company, it is not eligible to elect to apply IFRS 19. Some of the Company's subsidiaries are considering the application of IFRS 19 in their specified financial statements.

2.4 MATERIAL ACCOUNTING POLICY INFORMATION

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Fair value measurement

The Group measures its financial instruments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

- Level 1 based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, contract assets, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

A party is considered to be related to the Group if:

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is principally calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation methods are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress is stated at cost less any impairment losses, and is not depreciated. It is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible assets may be impaired. The amortisation period and the amortisation method for intangible assets with finite useful lives are reviewed at least at each financial year end.

The estimated useful lives of intangible assets are determined by considering the period of the economic benefits to the Group or the periods of validity of intangible assets protected by the relevant laws, as well as by referring to the industry practice.

Research and development costs

All research costs are charged to profit or loss as incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including insubstance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

(c) Short-term leases

The Group applies the short-term lease recognition exemption to its short-term leases of buildings (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option).

Lease payments on short-term leases are recognised as an expense on a straight-line basis over the lease term.

Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease term and is included in other income and gains in the consolidated statement of profit or loss and other comprehensive income due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under IFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

Purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset.

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

Financial assets at fair value through other comprehensive income (debt instruments)

For financial assets at fair value through other comprehensive income, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to profit or loss.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in profit or loss.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset, nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of its continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Impairment of financial assets

The Group recognises an allowance for expected credit losses ("FCLs") for all debt instruments not held at fair value through profit or loss ("FVTPL"). ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

General approach (Continued)

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group.

A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime FCLs

Simplified approach

For trade and bills receivables and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and bills payables, other payables and accruals, and interest-bearing bank borrowings.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (trade and other payables, and borrowings)

After initial recognition, trade and other payables, and interest-bearing borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average cost basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal. The amount of write-down of inventories to net realisable value and all losses of inventories are recognised as other expenses in the period the write-down or loss occurs.

Cash and cash equivalents

Cash and cash equivalents in the statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, subject to an insignificant risk of changes in value and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

The Group provides for warranties in relation to the sale of intelligent vision products and systems. Provisions for these assurance-type warranties granted by the Group are initially recognised based on sales volume and past experience of the level of repairs and returns. The warranty-related cost is revised annually.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of each reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of each reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a
 transaction that is not a business combination and, at the time of the transaction, affects neither the
 accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary
 differences; and
- in respect of taxable temporary differences associated with investments in subsidiaries and an associate, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial
 recognition of an asset or liability in a transaction that is not a business combination and, at the time of the
 transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal
 taxable and deductible temporary differences; and
- in respect of deductible temporary differences associated with investments in subsidiaries and an associate, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of each reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to profit or loss by way of a reduced depreciation charge.

Revenue recognition

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

Sale of intelligent vision products and systems

Revenue from the sale of intelligent vision products and systems is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the products and systems.

Volume rebates

Retrospective volume rebates may be provided to certain customers once the quantity of products and systems purchased during the period exceeds a threshold specified in the contract. Rebates are offset against amounts payable by the customer. To estimate the variable consideration for the expected future rebates, the most likely amount method is used for contracts with a single-volume threshold and the expected value method for contracts with more than one volume threshold. The selected method that best predicts the amount of variable consideration is primarily driven by the number of volume thresholds contained in the contract. The requirements on constraining estimates of variable consideration are applied and a refund liability for the expected future rebates is recognised.

Rendering of services

Revenue from automotive intelligent vision development services is primarily generated through the development of several intelligent automotive projects and is recognised at a point in time as the control of services is delivered to the customer.

Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Rental income is recognised on a time proportion basis over the lease terms.

Contract assets

If the Group performs by transferring goods to a customer before being unconditionally entitled to the consideration under the contract terms, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for impairment of financial assets. They are reclassified to trade receivables when the right to the consideration becomes unconditional.

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related services to the customer).

Contract costs

Other than the costs which are capitalised as inventories, property, plant and equipment and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify.
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future.
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other contract costs are expensed as incurred.

Employee benefits

Pension scheme

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain proportion of their payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

Housing fund - Mainland China

The Group contributes on a monthly basis to a defined contribution housing fund plan operated by the local municipal government. Contributions to this plan by the Group are expensed as incurred.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Events after the reporting period

If the Group receives information after the reporting period, but prior to the date of authorisation for issue, about conditions that existed at the end of the reporting period, it will assess whether the information affects the amounts that it recognises in its financial statements. The Group will adjust the amounts recognised in its financial statements to reflect any adjusting events after the reporting period and update the disclosures that relate to those conditions in light of the new information. For non-adjusting events after the reporting period, the Group will not change the amounts recognised in its financial statements, but will disclose the nature of the non-adjusting events and an estimate of their financial effects, or a statement that such an estimate cannot be made, if applicable.

Share-based payments

The Company operates a share award scheme. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services in exchange for equity instruments ("equity-settled transactions"). The cost of equity-settled transactions with employees is measured by reference to the fair value at the date on which they are granted.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service or performance conditions.

For awards that do not ultimately vest because non-market performance or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

Foreign currencies

These financial statements are presented in RMB, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of each reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Foreign currencies (Continued)

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currency of one overseas subsidiary is a currency other than RMB. As at the end of the reporting period, the assets and liabilities of this entity are translated into RMB at the exchange rate prevailing at the end of the reporting period and its statement of profit or loss is translated into RMB at the weighted average exchange rate for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the cumulative amount in the reserve relating to that particular foreign operation is recognised in profit or loss.

For the purpose of the consolidated statement of cash flows, the cash flows of the overseas subsidiary are translated into RMB at the exchange rate ruling at the dates of the cash flows. Frequently recurring cash flows of the overseas subsidiary which arise throughout the year are translated into RMB at the weighted average exchange rate for the year.

3. MATERIAL ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Deferred tax assets

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and the level of future taxable profits, together with future tax planning strategies.

Deferred tax assets (Continued)

The Group has tax losses of RMB129,343,000 (2023: RMB120,358,000) carried forward. These losses related to subsidiaries that have a history of losses, have not expired, and may not be used to offset taxable income elsewhere in the Group. The subsidiaries have neither any taxable temporary difference nor any tax planning opportunities available that could partly support the recognition of these losses as deferred tax assets. On this basis, the Group has determined that it cannot recognise deferred tax assets on the tax losses carried forward.

If the Group had been able to recognise all unrecognised deferred tax assets, the profit and equity would have increased by RMB20,826,000 (2023: RMB18,133,000). Further details on deferred tax are disclosed in note 17 to the financial statements.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of each reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. Further details are given in note 15.

Provision for expected credit losses on trade and bills receivables and contract assets

The Group uses a provision matrix to calculate ECLs for trade and bills receivables and contract assets. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns.

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade and bills receivables is disclosed in note 19 to the financial statements.

Estimation uncertainty (Continued)

Write-down of inventories to net realisable value

The Group reviews the carrying amounts of the inventories at the end of the year to determine whether the inventories are carried at the lower of cost and net realisable value. The net realisable value is estimated based on the current market situation and historical experience on similar inventories. Any changes in the assumptions would increase or decrease the amount of inventories written down or the related reversals of write-down and affect the Group's financial position.

Leases — Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates (such as the subsidiary's stand-alone credit rating).

Share-based payments

The Group makes the best estimate of the number of exercisable equity instruments at the end of the reporting period during the waiting period. Share-based payment expenses are recognised based on the fair value at the grant date and the latest subsequent information obtained. The Group has evaluated the fair value of the equity instruments at the grant date based on the recent transaction price, and also estimated the number of exercisable equity instruments.

10. INCOME TAX

The Group is subject to income tax on an entity basis on profits arising in or derived from the jurisdictions in which members of the Group are domiciled and operate.

Hong Kong

The subsidiary incorporated in Hong Kong is subject to Hong Kong profits tax at the rate of 16.5% on the estimated assessable profits arising in Hong Kong. No provision for Hong Kong profits tax has been made as the Group had no assessable profits derived from or earned in Hong Kong during the year.

Mainland China

Pursuant to the Corporate Income Tax Law of the PRC and the respective regulations (the "CIT Law"), the subsidiaries which operate in Mainland China are subject to CIT at a rate of 25% on the taxable income, except for those which are subject to tax concession as set out below:

- (a) In 2021, the Company was accredited as a High and New Technology Enterprise ("**HNTE**") with an effective period of consecutive three years, the Company renewed the HNTE status after the expiration in 2024. Therefore the Company was entitled to a preferential CIT rate of 15% for the years ended 31 December 2024 and 2023.
- (b) In 2022, a subsidiary of the Group was accredited as a HNTE, and was entitled to a preferential CIT rate of 15% for the years ended 31 December 2024 and 2023.

Subject to certain restrictions set out in the relevant PRC regulations and in the articles of association of the subsidiaries, the statutory surplus reserve may be used either to offset losses or to be converted to increase paid-in capital, provided that the balance after such conversion is not less than 25% of the registered capital of the respective entities. The reserve cannot be used for purposes other than those for which it is created and is not distributable as cash dividends.

(c) Foreign currency translation reserve

The foreign currency translation reserve comprises all foreign exchange differences arising from the translation of the financial statements of companies of which the functional currencies are not RMB. The reserve is dealt with in accordance with the accounting policy set out in note 2.4.

(d) Special reserve - safety fund

Pursuant to the revised *Measures for the Extraction and Use of Enterprise Safety Production Funds* issued in November 2022, the Group is required to set aside a fund for safety-related maintenance and production. The safety fund can be used for the maintenance of production and improvements in safety and is not available for distribution to shareholders.
