### **PROFIT WARNING**

This announcement is made by Hope Life International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors of the Company (the “**Directors**”) wishes to inform the Company’s shareholders (the “**Shareholders**”) and potential investors of the Company that based on preliminary review of the unaudited consolidated management accounts of the Group, and other relevant information currently available to the Company, the Group expects to record a net loss of not less than HKD24.4 million for the year ended 31 December 2024 (“**FY2024**”) as compared to the net loss amounted to HKD0.9 million for the year ended 31 December 2023.

Based on the relevant information currently available to the Company, the Board considers that the expected increase in net loss of the Group was mainly attributable to the increase in finance costs from interests on other borrowings and provision for impairment loss under expected credit loss model.

The Company is still in the process of finalising annual results of the Group for FY2024. The information contained in this announcement is based on preliminary assessment of the unaudited consolidated management accounts of the Group for FY2024 and information currently available to the Group. It remains subject to finalisation and necessary adjustments, and has not been confirmed, audited nor reviewed by the Company’s auditor and has not been reviewed by the audit committee of the Company. Therefore, the actual results of the Group for FY2024 may be subject to further amendments and adjustments where necessary. Shareholders and potential investors are advised to exercise caution when using such data to evaluate the Group’s financial conditions and results of operations. Shareholders and potential investors are advised to refer to the financial performance of the Group for FY2024 to be disclosed in the Group’s annual results announcement, which is expected to be published on or around 31 March 2025.
