OVERVIEW

INDUSTRY REVIEW

1. The Company's businesses

The Company is principally engaged in public utility and financial investment businesses, which are the two major sources of profit of the Company. In particular, public utility includes (1) city gas; (2) environmental municipality and (3) urban transportation; and financial investment businesses includes (1) non-banking financial business and (2) venture capital business. During the Reporting Period, there was no material change in the Company's principal business.

1. Public utility

(1) City gas

The company is mainly engaged in city gas business which is in the downstream demand side of natural gas, including residential and non-residential gas. The scope of the Company's gas business includes gas sales and gas installation engineering services and the business model is to procure gas from the upstream suppliers, sell the gas to end users via self-built urban pipeline network, and also provide relevant distribution services. The primary gas supply biller in Shanghai is Shanghai Gas, and those outside Shanghai are primarily PetroChina and Sinopec. The business operations mainly concentrate in Yangtze River Delta Region. The Company's subsidiaries Shanghai Dazhong Gas and Nantong Dazhong Gas are the sole suppliers of piped natural gas in the South Puxi Area in Shanghai and Nantong, Jiangsu Province, respectively, with more influential in Shanghai and the Yangtze River Delta. Shanghai Dazhong Gas owns a natural gas pipeline network of 7,000 km in length, serves more than 2 million gas users; Nantong Dazhong Gas has a natural gas pipeline network of 3,000 km in length, serves around 0.75 million gas users. During the Reporting Period, Shanghai Dazhong Gas achieved natural gas sales of 1.033 billion cubic meters; Nantong Dazhong Gas achieved natural gas sales of 0.42 billion cubic meters, a year-on-year increase of approximately 10%.

Major performance drivers: Through continuously improve the user service experience by expanding and optimizing online and offline services, the Company building a multichannel service system; actively explore extended services for diversified development, continuously beef up the efforts to promote value-added businesses, including gas insurance, gas stove, alarm and other value-added businesses; and improve the quality of gas value-added service; carry out fine engineering management, facilitate obsolete gas pipeline network transformation projects in an orderly, efficient and coordinated manner, and further improve the Company's ability of overall secure supply.

概覽

行業回顧

(一) 公司從事的業務情況

公司以「公用事業、金融創投」業務雙輪驅動，構成了公司主要利潤來源。其中公用事業包括(1)城市燃氣；(2)環境市政及(3)城市交通；及金融創投包括(1)非銀金融服務及(2)創投業務。報告期內，公司的主營業務未發生重大變化。

一、公用事業

1、城市燃氣

公司主要從事天然氣下游需求端的城市燃氣業務，包括居民及非居民用氣，主要業務範圍包括燃氣銷售和燃氣安裝工程服務，經營模式為向上游供應商購買氣源後，通過自建城市管網銷售給終端客戶並提供相關輸配服務。上海地區供氣結算方主要為上海燃氣，上海以外地區供氣結算方主要為中石油和中石化。經營範圍集中於長三角，子公司上海大眾燃氣以及南通大眾燃氣分別是上海浦西南部、江蘇省南通市區唯一的管道燃氣供應商，在上海市以及長三角地區較有影響力。上海大眾燃氣擁有天然氣管網長度約7,000公里，服務燃氣使用者約200萬戶；南通大眾燃氣擁有天然氣管網長度超過3,000公里，服務燃氣使用者約75萬戶。報告期內上海大眾燃氣實現天然氣銷售量10.33億立方米；南通大眾燃氣實現天然氣銷售量4.2億立方米，同比增長約10%。

主要業績驅動因素：通過拓展並優化線上、線下服務，建設多渠道服務體系，持續提升用戶服務體驗；積極探索多元發展的延伸服務，持續加大在燃氣保險、灶具、報警器等增值業務方面的推廣力度，提升燃氣增值服務質量；實施精細化工程管理，有序、高效、統籌推進燃氣老舊管網改造工程，進一步提升公司整體安全保障供應能力。

(2) Environmental and municipal works

The Company is mainly engaged in sewage treatment and infrastructure investment and operations in the environmental and municipal fields. The sewage treatment business mainly engages in the investment, construction and operation of city domestic sewage and industrial sewage treatment plants. Currently, a number of sewage treatment plants under the Company are operated by two subsidiaries of the Company, i.e. Dazhong Jiading Sewage and Jiangsu Dazhong. The current infrastructure investment project operated by the Company is the Xiangyin Road Tunnel Construction Development Co., Ltd. in Shanghai which is invested, constructed and operated under BOT arrangement. The main model of the Company's sewage treatment business is to conduct physical, chemical and biochemical treatment of domestic sewage, industrial and commercial sewage, and initial rainwater and other sewage collected through the urban sewage pipe network, followed by discharge into the receiving water bodies after meeting the appropriate national environmental protection standards. In accordance with the concession agreements entered into with local governments, the local governments make regular payments based on water volumes and unit prices. Currently, the Company operates 9 wastewater treatment plants in Shanghai and Jiangsu with a total capacity of 465,000 tons per day, in which our subsidiary, Dazhong Jiading Sewage, has realised a capacity of 200,000 tons of urban sewage per day, and the discharge standards have reached the class A+ of Shanghai's highest level; our subsidiary, Jiangsu Dazhong, conducts operation mainly in Yunlong district, Jiawang district, Peixian and Pizhou of Xuzhou city, and together with Donghai county of Lianyungang, with the total scale of 265,000 tons per day. The Xiangyin Road Tunnel is currently in operation and is one of the important cross-river passages connecting the two sides of the Pujiang River in Shanghai, with a total annual traffic volume of nearly 23.5 million vehicles. The Company organizes the daily operation, maintenance, repair and safety management of the tunnel to ensure the smooth and safe operation of the tunnel. In addition, the company currently has no other municipal projects under construction or proposed for construction.

Major performance drivers: increase the effectiveness of comprehensive utilization of space resources, improve the efficiency and water quality of sewage treatment, and facilitate energy conservation and consumption reduction, quality improvement and efficiency increase; continuously apply more efficient sewage treatment processes, continuously build up IT drive, adopt scientific management for equipment maintenance, pursue innovative application of integration between sewage treatment technology and photovoltaic technology in an adaptive manner, and increase the corporate ability of integrated operations.

2、環境市政

公司於環境市政領域主要從事污水處理及基礎設施投資運營。污水處理業務主要為城市生活污水和工業廢水處理廠的投資建設和運營，目前公司下屬多家污水處理廠分別由子公司大眾嘉定和江蘇大眾運營。公司當前運營的基礎設施項目為以BOT方式投資、建設和運營的上海翔殷路隧道建設發展有限公司。公司的污水處理業務主要模式為通過城市污水管網所收集的生活污水、工業業污水、初期雨水及其他污水進行物理、化學及生化處理，達到國家相關環保標準後排放入相應受納水體的全過程。通過與地方政府簽訂《特許經營協議》，由當地政府主管部門核定水量和單價，定期結算。目前公司在上海、江蘇共運營9家污水處理廠，總處理能力為46.5萬噸/日。其中，子公司大眾嘉定日處理規模為20萬噸，出水標準達到上海市最高污水排放標準的一級A+；子公司江蘇大眾目前業務主要涉及江蘇省徐州市雲龍區、賈汪區和沛縣，邳州市四個區縣及連雲港市東海縣，總處理規模達到26.5萬噸/日。翔殷路隧道現處於運營期，是聯通上海浦江兩岸的重要越江通道之一，年車流總量近2,350萬輛次。公司組織對隧道的日常營運養護維修及安全管理，以保障隧道暢通和安全運行。除此之外，公司當前無其他在建或擬建市政項目。

主要業績驅動因素：提升空間資源綜合利用效能，提高污水處理效率和水質，促進節能降耗和提質增效；不斷應用更高效的污水處理工藝，持續完善信息化建設，對設備養護進行科學管理，因地制宜推進污水處理技術和光伏技術相融合的創新應用，提升企業綜合運營能力。

(3) Urban transportation

The urban transportation service business of the Company mainly focuses on the comprehensive transportation, which is operated by Dazhong Logistics and Dazhong Transportation. Dazhong Logistics, a subsidiary of the Company, is a modern service company providing integrated solutions to cargo transportation, licensed to transport hazardous goods (Class II flammable gas, Class III flammable liquids and Class IX miscellaneous hazardous substances and articles) in Shanghai, functioning as the largest specialized LPG distributor in Shanghai that provides important addition to the Company's pipelined gas sales service. Dazhong Logistics provides efficient services and standardized settlement mechanism via its "96811" comprehensive service platform. Dazhong Transportation mainly develops around taxi operation, car rental and other market segments, and provides integrated transportation support services such as taxi, car rental, road passenger transport and tour coach chartering.

Major performance drivers: actively adopt more pragmatic and flexible approaches to operation management by closely revolving around the important mission to construct "five centers" as laid down in "Shanghai Municipal Government Work Report 2024", exploit the advantages of digital transformation and industry resource integration, continuously improve quality of service and expand scope of services; facilitate the construction of integrated charging stations and promote the collaborative development between smart urban infrastructure and new energy vehicle.

2. Financial Investment business

(1) Non-banking financial services

The non-banking financial services business is operated by its holding subsidiaries, Dazhong Financial Leasing, Dazhong Factoring and Dazhong Asset Management, which are mainly engaged in financial leasing, factoring business and asset management, etc. By focusing on market segments, Dazhong Financial Leasing is deeply engaged in market segment such as "modern logistics, data centers, energy conservation and environmental protection, modern manufacturing and small and micro businesses". During the Reporting Period, business in supply chain finance developed rapidly, factoring business continued to advance steadily, and platform finance made significant progress.

Major performance drivers: Continue to promote the "technology-driven, small and decentralized" consumer finance cooperation model. For the market segment to be precise and thorough, leverage on the sales growth trend of domestic new energy vehicles, deepen the supply chain finance business and continue to expand the business scale.

3、 城市交通

公司的城市交通服務業務以綜合交通運輸為核心，由大眾運行物流和大眾交通運營。大眾運行物流是一家為貨物運輸提供綜合解決方案的現代服務企業，擁有上海市危險品運輸（第二類易燃氣體、第三類易燃氣體及第九類雜項危險品物質和物品）資質，是上海市最大的第三方專業配送LPG的物流公司，為公司管道燃氣銷售的重要補充。大眾運行物流通過「96811」綜合服務平台提供高效的服務和標準化的結算機制。大眾交通主要圍繞出租車運營、汽車租賃等細分市場發展，提供出租車和汽車租賃、道路客運、旅遊包車等綜合交通配套服務。

主要業績驅動因素：緊緊圍繞《上海市政府2024年政府工作報告》「五個中心」建設的重要使命，積極採取更為務實、靈活的運營管理模式，發揮數字化轉型和產業資源整合優勢，不斷提升服務品質，擴大服務範圍；推進綜合充電場站建設，促進智慧城市基礎設施和新能源汽車協同發展。

二、金融創投業務

1、 非銀金融服務

非銀金融服務業務由控股子公司大眾融資租賃、大眾保理及大眾資管運營。主要包括融資租賃、保理及資產管理業務等。大眾融資租賃通過聚焦細分市場，在「現代物流、數據中心、節能環保、現代製造和小微業務」等行業深耕細作。報告期內，供應鏈金融業務發展迅速，保理業務穩步推進，平台金融取得突破。

主要業績驅動因素：繼續推進「科技驅動、小額分散」的消費金融合作模式，深耕細分市場，做精做透；借助國產新能源汽車銷量增長趨勢，深化供應鏈金融業務，持續擴大業務規模。

(2) Venture Capital Investment

The business segment of venture capital investment mainly invests in multi-domain investment through direct investment and equity investment in special funds and PE funds, covering multiple phases of investment targets, such as PE, M&A and secondary market private placement. The Company has a wholly-owned venture capital platform “Dazhong Capital”, and important equity investment platforms which are Shenzhen Capital Group, Huacan Fund and Dacheng Huicai

Major performance drivers: Make direct investment and follow-up investment with the help of high-quality investment platforms, while leveraging the Company’s industrial resource advantages to achieve synergistic integration effects; strengthen post-investment management, establish an effective communication mechanism for capital and projects through multiple channels, and increase the probability of project exit, improve the efficiency of investment funds, and strive to create stable investment returns.

II. Industry information

(1) City Gas

The government highly values the development of the city gas industry by enacting a series of policy documents successively such as “Guiding Opinions on Establishing and Perfecting the Upstream and Downstream Price Linkage Mechanism”, pursuing the market-oriented reform of natural gas, straightening out the natural gas price transmission mechanism and providing endogenous driving forces for desirable operation of gas operation companies. The enactment and implementation of the “Implementation Plan for Renewal and Transformation of Aging Natural Gas Pipelines and Etc 2022-2025”, and the “Provisional Measures for Special Management of Investments in Renewal and Transformation of Aging Urban Gas Pipelines and Etc and Affordable Housing Program within the Central Government Budget” give express guidance and support for meter renewal and gas pipeline network maintenance and inspection, aiming at accelerating the effort to renew and transform aging urban gas pipelines and improving the safety and reliability of gas supply. In August 2024, the “Administrative Measures for Natural Gas Utilization” enacted and implemented provides express guidance and specification for high-quality development of the natural gas industry.

(2) Environmental and Municipal Works

The municipal sewage treatment is an important part of environmental infrastructure and an important step towards sustainable development, featuring significant attributes of rigid demands of livelihood and stringent regulatory characteristics.

2、創投業務

公司的創投業務主要通過直投及參股專項基金、私募基金等多渠道，進行多領域投資，涵蓋PE類、併購類、二級市場定增等投資標的多階段。公司全資創投平台為「大眾資本」，重要參股投資平台分別為深創投、華臻基金和大成匯彩。

主要業績驅動因素：借助優質投資平台進行直投和跟投，同時發揮公司產業資源優勢實現協同整合效應；強化投後管理工作，通過多渠道為資本和項目建立有效的溝通機制，增加項目退出概率，提高投資資金使用效率，創造穩健的投資收益。

(二) 公司所處行業情況

1、城市燃氣

政府高度重視城市燃氣行業發展，相繼出台《關於建立健全上下游價格聯動機制的指導意見》等系列政策文件，推進天然氣市場化改革，理順天然氣價格傳導機制，為燃氣運營企業良好運營提供內生動力。《城市燃氣管道等老化更新改造實施方案2022-2025年》與《城市燃氣管道等老化更新改造和保障性安居工程中央預算內投資專項管理暫行辦法》的頒佈與實施，在表具更新與燃氣管網維護巡查方面給予明確指導與支持，旨在加快城市燃氣管道老化更新改造工作，提升燃氣供應的安全性和可靠性。2024年8月，頒佈實施的《天然氣利用管理辦法》為天然氣行業的高質量發展提供了明確指導和規範。

2、環境市政

市政污水處理為環境基礎設施的重要組成部分，是實現可持續發展的重要環節，具有顯著的民生剛需屬性，以及嚴監管特徵。

Along with the deepening effort of green development in China, the industry's regulatory system has become increasingly well-established. In March 2024, the enactment and implementation of the "Notice on Issuing the Implementation Plan for Facilitating Renewal of Buildings and Municipal Infrastructure Equipment" requires the classification of key projects to promote the renewal of building and municipal infrastructure equipment renewal for prioritized projects, endeavors to expand domestic demands, benefiting livelihood and ensuring safety, safeguards the safe, green and smart operation of urban infrastructure, and facilitates high-quality development of cities; in May 2024, the enactment and implementation of the "Administrative Measures for Franchising of Infrastructure and Public Utilities" further reinforces the effectiveness of institutional execution and guide the industry through orderly operation while standardizing the management of concession projects.

(3) Urban Transportation

Along with a rapidly increased in adoption rate of new energy vehicles and increasing popularization of battery charging and replacement services, the continuous development of intelligent connected vehicle technology has brought new opportunities of growth to urban transportation service providers. In addition, the successive enactment of important policy documents such as the "14th Five-Year" Development Plan for Modern Integrated Transportation System provides important support for constructing a flawless modern integrated transportation system, aiming at driving the industry towards being more efficient, intelligent, green and sustainable. Transportation of dangerous goods is characterized by numerous varieties, high specialization, numerous rules and regulations and high risk, so the regulatory authorities have enacted many regulatory policies targeting the dangerous goods transportation industry, in a bid to strengthen supervision over warehousing and transportation safety of hazardous chemicals and continuously increase the room for industry integration.

(4) Non-banking Finance

Currently, regulatory policies gradually guide non-banking finance sector to return to its roots and improve its ability to serve the real economy. With the increasingly demanding regulatory requirements of regulatory authorities for non-banking finance sector, financing lease and factoring business are moving towards being more standardized and specialized, with the industry concentration expected to further improve.

3、城市交通

隨著新能源車普及率快速提高，充換電服務日益普及，智能網聯汽車技術不斷發展，給城市交通服務商帶來了新發展機遇。此外，《「十四五」現代綜合交通運輸體系發展規劃》等重要政策文件陸續出台，為構建完善的現代綜合交通體系提供重要支持，旨在推動行業向更高效、智能、綠色和可持續的方向發展。危險品運輸具有種類多、專業性強、規章制度多及風險高的特點，針對危險品運輸行業，近年來監管部門出台多項監管政策，加強危險化學品倉儲與運輸安全監管，持續提升行業整合空間。

4、非銀金融

當前，監管政策逐步引導非銀金融業回歸本源，提高服務實體經濟的能力。隨著監管機構對非銀金融業的監管要求不斷提高，融資租賃及保理業務向更加規範和專業的方向發展，行業集中度有望進一步提升。

(5) Venture Capital Investment Business

In 2024, the executive meeting of the State Council brought forward the exposition on development focused on venture capital investment twice within three months, all emphasizing the need to straightening out all steps of “financing, investment, management and exit”, especially the need to improve the exit mechanism and support M&As and equity transfer development. In addition, the State Council issued the new “nine policies of the State Council” for capital markets, which, coupled with the continuous construction of the “1+N” policy system, will drive the capital markets into a new stage of high-quality development.

ANALYSIS OF CORE COMPETITIVENESS

(1) Service Quality Advantage

With high-standard service quality and a spirit of professionalism and excellence, the Company has earned a solid market reputation. During the Reporting Period, the Company once again ranked among the “Top 100 service enterprises of Shanghai in 2024”, with improved rankings compared to the last year. Subsidiaries such as Dazhong Gas and Dazhong Logistics, serves as key suppliers for the 7th China International Import Expo. With a high sense of responsibility and mission, they diligently carried out various tasks, contributing wisdom and strength to the country’s economic development and high-level opening-up with practical actions.

(2) Regional Industry Advantage

Shanghai Dazhong Gas provides supply services covering seven administrative regions west of the Huangpu River and south of the Suzhou River in Shanghai. Nantong Dazhong Gas mainly undertakes the construction of gas pipelines, urban gas transmission and distribution, natural gas sales, and gas appliance sales in Nantong (including Gangzha District, Chongchuan District, Economic and Technological Development Zone, and Sutong Science and Technology Industrial Park etc.). The sewage treatment projects of Dazhong Jiading Sewage and Jiangsu Dazhong are mainly operated in the form of BOT, focusing on regional sewage treatment. The Company has a stable regional service scope and term, and the market and business model are less likely to fluctuate, and with the growth of natural gas demand and sewage treatment in the region, it will bring continuous and stable income to the Company.

5、創投業務

2024年，國務院常務會議三個月內兩次提出聚焦創投發展的論述，均強調疏通「募投管退」各環節，特別是改善退出機制，支持併購、股轉發展。此外，國務院印發資本市場新「國九條」，「1+N」政策體系持續建設中，將推動資本市場進入高質量發展新階段。

核心競爭力分析

(1) 服務質量優勢

公司憑藉高標準服務質量和專業進取、精益求精的服務精神，贏得了穩固的市場聲譽。報告期內再次榮登「2024上海百強企業榜」，各項排名較上年均有所提升。子公司上海大眾燃氣及大眾運行物流作為中國第七屆進口博覽會的保供單位，以高度的責任感和使命感，抓實、抓細各項工作，以實際行動為國家經濟發展和高水平對外開放貢獻智慧和力量。

(2) 行業區域性優勢

上海大眾燃氣供應服務範圍覆蓋上海黃浦江以西、蘇州河以南七個行政區域，南通大眾燃氣主要承擔南通市區（港閘區、崇川區、經濟技術開發區、蘇通科技產業園區等）的燃氣管網建設、城市燃氣輸配、天然氣銷售以及燃器具銷售等相關業務。大眾嘉定、江蘇大眾的污水處理項目主要為BOT形式，經營內容主要為區域性污水處理。公司擁有穩定的區域服務範圍和期限，市場和業務模式波動變化可能性較小，隨著區域內的天然氣需求量和污水處理量的增長將為公司帶來持續穩定的收益。

(3) Advantage in Sound Corporate Governance

As a public company listed in Shanghai and Hong Kong, the Company is regulated by securities regulators in the two places and draws attention from investors. The Company has formed a flawless corporate governance structure and normative operation model over the past years through strict compliance with regulatory provisions in both places. The Company received the "Board Best Practice Case" and "Listed Company Board Office Best Practice Case" from China Association for Public Companies respectively during the year. In recent years, the Company established a top-down ESG governance structure by integrating ESG factors into consideration of corporate strategy and business decision-making, and in the future, the Company will continuously perfect its corporate governance structure, closely combine robust business development with ESG management, and integrate resources to optimize its energy structure in order to achieve green, low-carbon development. Within the reporting period, the Company's ESG performance was rated by CCXGF as "A+" and received the "2024 Listed Company Sustainability Best Practice Case" from China Association for Public Companies and "Golden Award • Annual ESG Vanguard Award" from Guru Club.

(4) Advantage in Investment Experience

The Company has invested in several high-quality investment platforms through equity investment, engaging in extensive cooperation in various aspects and dimensions to enhance its mergers and acquisitions and resource integration capabilities. Shenzhen Capital Group, in which the Company holds equity, ranks among the top in the domestic venture capital industry in terms of the number of invested enterprises and the number of invested enterprises became listed.

During the Reporting Period, the Company's core competitiveness remained unchanged.

FINANCIAL REVIEW

Main Operations within the Reporting Period

In 2024, the Company recorded a total revenue of RMB6,283.53 million, representing a decrease of 0.82% from RMB6,335.78 million in the corresponding period of the last year. Net profit attributable to shareholders of the Company amounted to RMB233.15 million, representing an increase of 9.69% from which in the corresponding period of the last year.

(3) 健全的公司治理優勢

作為滬港兩地上市的公眾公司，公司受到境內外兩地證監部門的監管和投資者的關注。公司嚴格遵照兩地各項監管規定，多年來形成了完善公司治理結構和規範化的運作模式。公司於年內分別獲得中國上市公司協會「董事會優秀實踐案例」及「上市公司董辦最佳實踐案例」。近年來，公司將ESG因素融入企業戰略及經營決策的考量中，建立了自上而下的ESG治理架構，今後，公司將持續完善公司治理結構，把穩健的業務發展與ESG管理緊密結合，整合資源優化能源結構，實現綠色低碳發展。報告期內，公司主體ESG等級獲中誠信綠金評定為「A+」，並獲評中國上市公司協會「2024上市公司可持續發展優秀實踐案例」及格隆匯「金格獎•年度ESG先鋒獎」。

(4) 投資經驗的優勢

公司通過參股多家地方優質投資平台，多方面多維度展開廣泛合作，提升併購和資源整合能力。公司參股的深創投在投資企業數量、投資企業上市數量居國內創投行業前列。

報告期內，公司核心競爭力未發生變化。

Revenue

The Group's revenue decreased by 0.82% from RMB6,335.78 million for the year ended December 31, 2023 to RMB6,283.53 million for the year ended December 31, 2024, with the revenue from four segments remaining relatively stable during the period.

Piped Gas Supply

The revenue from the pipelined gas supply business decreased by 0.31% from RMB5,768.89 million for the year ended December 31, 2023 to RMB5,751.18 million for the year ended December 31, 2024. For the years ended December 31, 2023 and 2024, the revenue from the pipelined gas supply business accounted for 91.05% and 91.53% of the Group's total revenue, respectively.

Wastewater Treatment

The revenue from the wastewater treatment business decreased by 4.04% from RMB323.53 million for the year ended December 31, 2023 to RMB310.45 million for the year ended December 31, 2024. For the years ended December 31, 2023 and 2024, the revenue from the wastewater treatment business accounted for 5.10% and 4.94% of the Group's total revenue, respectively.

Public Infrastructure Projects

The revenue from public infrastructure projects increased by 2.00% from RMB19.96 million for the year ended December 31, 2023 to RMB20.36 million for the year ended December 31, 2024. For the years ended December 31, 2023 and 2024, the revenue from public infrastructure projects accounted for 0.32% and 0.32% of the Group's total revenue, respectively.

Transportation Services

The revenue from the transportation services decreased by 5.71% from RMB120.97 million for the year ended December 31, 2023 to RMB114.06 million for the year ended December 31, 2024. For the years ended December 31, 2023 and 2024, the revenue from the transportation services accounted for 1.91% and 1.82% of the Group's total revenue, respectively.

Financial Services

The revenue from financial services decreased by 14.59% from RMB102.42 million for the year ended December 31, 2023 to RMB87.47 million for the year ended December 31, 2024. For the years ended December 31, 2023 and 2024, the revenue from financial services accounted for 1.62% and 1.39% of the Group's total revenue, respectively.

Gross Profit and Gross Margin

Our gross profit decreased by 2.69% from RMB930.64 million for the year ended December 31, 2023 to RMB905.58 million for the year ended December 31, 2024. The gross profit from the piped gas supply business decreased by 0.54% from RMB599.28 million for the year ended December 31, 2023 to RMB596.02 million for the year ended December 31, 2024. The gross margin on the piped gas supply business decreased by 0.03% from 10.39% for the year ended December 31, 2023 to 10.36% for the year ended December 31, 2024.

Selling and Distribution Costs

The selling and distribution costs decreased by 3.31% from RMB203.29 million for the year ended December 31, 2023 to RMB196.55 million for the year ended December 31, 2024.

Administrative Expenses

The administrative expenses decreased by 1.00% from RMB519.08 million for the year ended December 31, 2023 to RMB513.90 million for the year ended December 31, 2024.

Net Investment Revenue and Income

The net investment revenue and income increased by RMB183.30 from RMB (67.30) million for the year ended December 31, 2023 to RMB116.00 million for the year ended December 31, 2024. The relevant increase was mainly due to the dividend income from financial assets within the holding period decreased compared to the same period of the previous year, as well as the fluctuations in the fair value of financial assets.

行政開支

行政開支由截至2023年12月31日止年度的人民幣519.08百萬元減少1.00%至截至2024年12月31日止年度的人民幣513.90百萬元。

Share of Results of Associates

The share of results of associates decreased by 37.23% from RMB324.20 million for the year ended December 31, 2023 to RMB203.49 million for the year ended December 31, 2024. The relevant decreases was mainly due to the equity investment profits of associates, including Dazhong Transportation and Hua Can Fund decreased RMB148 million compared with the same period of last year.

Profit before tax

As a result of above, the profit before tax increased by 7.90% from RMB402.88 million for the year ended December 31, 2023 to RMB434.71 million for the year ended December 31, 2024.

Net Profit

As a result of above, the net profit increased by 8.16% from RMB303.63 million for the year ended December 31, 2023 to RMB328.43 million for the year ended December 31, 2024.

Total Comprehensive Income

As a result of above, our total comprehensive income increased by 63.41% from RMB261.92 million for the year ended December 31, 2023 to RMB428.00 million for the year ended December 31, 2024.

CAPITAL STRUCTURE, LIQUIDITY AND FINANCIAL RESOURCES

Overview

The Group finances its liquidity requirements primarily through cash flows generated from operating activities and proceeds from interest-bearing bank loans, debt instruments and other borrowings. Its primary uses of cash include cash paid for purchase of goods and receipt of services, cash paid for and to employees, various taxes and dues paid and payment for other activities related to operating activities. The Group does not use financial instruments for hedging purposes, nor does it hedge its foreign currency net investments in currency lending and/or other foreign currency hedging instruments.

DISCUSSION AND ANALYSIS OF FUTURE DEVELOPMENT

1 Industry structure and trends

1. Gas Industry

Currently, China's natural gas industry has entered a period of stable. On the premise of ensuring the stability of core profitability, it relies on their own operating and management advantages, city gas companies are expanding extended services and transform into a comprehensive energy service provider through the development of diversified businesses. In the future, the continuous development and progress of digital and intelligent technologies will effectively promote IoT-enabled and the digitalization of operation and management of gas pipeline networks, thereby comprehensively improving the operational efficiency and safety levels of gas companies.

2. Environmental and Municipal Works

The environmental and municipal industries involve national economy and the people's livelihood such that environmental infrastructure is an important support for perfecting the modern environmental governance system, as three ministries and commissions of the State jointly issued the Implementing Opinions on Facilitating Synergistic Effects of Pollution and Carbon Reduction in Sewage Treatment, laying out measures including adaptive promotion of the "photovoltaic+ sewage plant" model and the need to actively pursue a development model combining photovoltaic power generation with sewage treatment technology in order to achieve green low-carbon transformation of sewage treatment industry and the synergic effects of pollution and carbon reduction. In the future, the sewage treatment industry will focus more on technological innovation, fine management and resource recycling, as a result of which characteristics such as high treatment efficiency, small footprint and stable water quality will become the prioritized directions of development.

1. 燃氣行業

當前，國內天然氣行業已進入平穩發展期，在確保核心盈利能力穩定的前提下，依託自身經營管理優勢拓展延伸服務，通過發展多元化業務向綜合能源服務商轉型。未來，數智化技術的不斷發展和進步，將有效推動燃氣管網實現物聯網化及運營管理的數字化，全面提升燃氣企業經營效率及安全水平。

2. 環境市政

環境市政產業涉及國計民生，環境基礎設施是完善現代環境治理體系的重要支撐，國家三部委聯合印發《關於推進污水處理減污降碳協同增效的實施意見》，提出包括因地制宜推廣「光伏+污水廠」模式等措施，積極推動光伏發電和污水處理技術結合的發展模式，以實現污水處理行業的綠色低碳轉型和減污降碳協同增效。未來，污水處理行業將更多以技術創新、精細化管理及資源化利用為主，處理效率高、佔地面積小、水質穩定等特點將成為重點發展方向。

3. Urban Transportation

Traditional cruising taxis deepen the shift towards an operating model of “cruising-internet integration” so as to fully increase the operational efficiency and competitiveness of cruising taxis and facilitate deep, integrated development of smart transportation and smart city. Dazhong Logistics has years of experience on dangerous goods transportation, a line of business characterized by high regional concentration and strong specialization; in the future, the core competitiveness of logistics and transportation companies will gradually transform from cost effectiveness competitiveness in the logistics process alone into overall service quality competitiveness.

4. Non-banking Finance

In the recent years, regulatory policies have been gradually guiding financing lease companies to return to their roots, focus on main business and increase their ability to serve the real economy. In the context of greatly advocating the development of new-quality productivity, the demands for transformation and upgrading of energy structure and industrial structure bring new opportunities of growth for endogenous development of the financing lease industry. In the future, the financing lease industry will resonate with the national industry orientation and enable high-quality development of the real economy.

5. Venture Capital Investment

In 2024, both the meeting of the Political Bureau of the CPC Central Committee and the Third Plenary Session of the 20th CPC Central Committee brought forward relevant expositions on encouraging venture capital investment and patient capital, while the General Office of the State Council specifically enacted the “Several Policy Measures to Promote High-quality Development of Venture Capital Investment”; with the continuously improved policies supporting long-term capital investment into early phase, small and long-term projects and key and core technology, venture capital has become an important reform-deepening mechanism for developing new-quality productivity, fostering new industries, incubating new approaches and forming new driving forces. Investment in high-quality innovation projects encompassing scientific and technological innovation and industry innovation demands will become the theme of future investment.

3. 城市交通

傳統巡游出租車深化「巡網融合」經營模式轉變，以充分提升巡游出租車運營效率和競爭力，促進智慧交通和智慧城市深度融合發展。大眾運行物流深耕危險品運輸，危險品運輸業務地域集中度高，專業性強；未來，物流運輸企業核心競爭力將逐步由單純物流環節成本效率競爭力，轉化為綜合服務質量競爭力。

4. 非銀金融

近年來，監管政策逐步引導融資租賃公司回歸本源，專注主業，提高服務實體經濟的能力。在大力倡導發展新質生產力背景下，能源結構和產業結構轉型升級需求為融資租賃行業的內源式發展帶來新發展機遇。未來，融資租賃行業將與國家產業導向同頻共振，賦能實體經濟高質量發展。

5. 創投業務

2024年中共中央政治局會議、二十屆三中全會均提出鼓勵發展風險投資、耐心資本的相關論述，國務院辦公廳專門出台《促進創業投資高質量發展的若干政策措施》促進行業高質量發展；在支持長期資本投早、投小、投長期、投硬科技政策的不斷完善下，創投成為發展新質生產力、培育新產業、催生新模式、形成新動能的重要深化改革機制。圍繞科技創新和產業創新需求投資優質創新項目將成為未來投資主旋律。

(II) Corporate Development Strategy

The year 2025 is the concluding year for targets and tasks of China's "14th five-year" plan, and also the year of planning for the "15th five-year" plan. The Company will persist in the overall tone of working steadily while progressing, resolutely endeavor to make public utilities business stronger, better and bigger as its primary line of business, and make greater efforts to pursue development, assure security, stabilize growth, innovate, promote reforms and take multiple measures to ensure completion of various operating objectives of the year.

(III) Business Plan

1. Further raise the level of ESG and advance new energy at the service of public utilities

The Company, while always solidifying its main business, will actively pursue new energy to serve the development of public utilities by continuously improving its ESG performance and surrounding its core business. The Company will adaptively explore the possible fusion between clean energy and traditional public utilities pursue development modules such as combining photovoltaic power generation with sewage treatment and combining charging stations with transportation, increase the comprehensive resource utilization effectiveness and facilitate energy conservation, consumption reduction, quality improvement and efficiency increase. The Company will also optimize its governance structure, beef up compliance management and transparency, enhance its industry competitiveness, establish a responsible corporate image and pursue corporate innovation and development in the field of public utilities, all by continuously raising its ESG levels.

2. Exploit the new national policies on venture capital investment to "exit from existing investment projects whenever possible"

In 2024, the executive meetings of the State Council brought forward for many times the need to focus on venture capital investment, and straighten out all steps of "financing, investment, management and exit", especially the need to improve the exit mechanism and support M&As and equity transfer for development. The Company will explore various pipelines for exit from existing investment projects to achieve income on equity investments.

(二) 公司發展戰略

2025年是我國「十四五」規劃目標任務的收官之年，同時也是「十五五」規劃的謀劃之年。公司將堅持穩中求進工作總基調，堅定不移做強做優做大公用事業主業，以更大的力度抓發展、保安全、穩增長、勇創新、促改革，多措並舉確保完成年度各項經營目標。

(三) 經營計劃

1. 持續提升ESG水準，推進新能源服務公用事業

公司在始終貫徹夯實主業理念的基礎上，圍繞核心業務，通過持續提升ESG水準，積極推動新能源服務公用事業發展。公司將因地制宜地探索清潔能源與傳統公用事業的融合，推動光伏發電和污水處理結合、充電場站與交通運輸結合等發展模式，提高資源綜合利用效能，促進節能降耗和提質增效。公司亦將通過持續提升ESG水準，優化治理結構，加強合規管理與透明度，增強行業競爭力，樹立負責任的企業形象，推動公司在公用事業領域的創新與發展。

2. 把握國家對創投出台的新政，存量投資專案「應退盡退」

2024年，國務院常務會議多次提出聚焦創投發展，強調疏通「募投管退」各環節，特別是改善退出機制，支持併購、股轉發展。公司將探索多種存量投資項目退出管道，實現股權投資收益。

3. *Strengthen the red line on “workplace safety” and hold accountable for safety across the board*

The Company will continuously perfects its safety policies, make clear management objectives and duties, hold fast to the bottom-line mindset, raise the awareness of red line, solidify the shield for workplace safety, and drive its safety performance to turn favorable steadily and continuously.

4. *Beef up talent cultivation efforts and enhance teambuilding exercise*

The Company will set up an innovative and capable team of professionals, intensify investment in talent and do a good job of personnel motivation, hold fast to its “two-pronged” approach to talent introduction and cultivation, in an effort to build a talent echelon that is well-trained, young, advanced and smart.

5. *Further increase cash flows from operating activities, adjust its debt structure, and lower the debt-to-asset ratio*

The Company will still keep informed of “cash flows and debt-to-asset ratio” as two red lines, continuously pursue fine management of cash flows and tighten the control over debt-to-asset ratio through optimizing cash flow management, beefing up budget management, increasing fund utilization efficiency and optimizing the debt structure.

6. *Strengthen internal control and effectively guard against risks*

The Company will further improve its rules and regulations and internal control process, continually optimize its corporate governance structure, strengthen its internal control system, build an efficient risk prevention mechanism and pursue continuous, healthy and stable corporate growth, all pursuant to the latest laws and regulations and normative guidance and in light of its operational realities.

(IV) Potential Risks

During the production and operation process, the Company will actively take various measures to mitigate various operational risks. However, the following risks and uncertainties still exist in the actual production and operation process:

公司仍將持續關注「現金流、資產負債率」兩條紅線，通過優化現金流管理、加強預算管理、提高資金使用效率以及優化債務結構等措施，持續推進現金流精細化管理、壓實資產負債率管控。

6. *強化內控建設，切實防範風險*

公司將依據最新的法律法規和規範指引，結合自身實際，進一步完善公司規章制度及內部控制流程，持續優化公司治理結構，強化內部控制體系，打造高效的風險防範機制，推動公司持續、健康、穩定發展。

(四) 可能面對的風險

公司在生產經營過程中，將會積極採取各種措施，努力規避各類經營風險，但實際生產經營過程仍存下述風險和不確定因素：

1. Risk of unexpected fluctuation on nature gas price

The current pricing policy of urban gas enterprises generally involves a cross-subsidy model where non-residential users subsidize residential users. The terminal selling price of gas is determined by the local government pricing authority. Due to the periodic adjustments made by the government pricing authority, there may be a lag in price adjustments relative to market changes. Moreover, the purchase price of gas is significantly influenced by domestic supply and demand as well as international market prices. If the procurement cost increases due to a rise in gas purchase prices, the Company's operational performance may be significantly affected, as the pricing flexibility between upstream and downstream is limited. The Company actively promotes the government departments in improving the mechanism for linking prices between upstream and downstream sectors, accelerating cost transmission.

2. Risk of changes to environmental protection policy

In recent years, the government has continuously intensified the implementation of environmental policies and formulated urban pollution emission standards. The government's efforts to address environmental issues have also imposed stricter requirements on the Company's environmental management. If there are changes in national environmental policies in the future leading to adjustments in technical standards related to the issuer's industry, it will impose certain pressures on the issuer's production and operation. The Company's subordinate sewage treatment enterprises operate and manage in strict accordance with local sewage discharge standards to ensure that the discharge is up to standard, and further control the procurement quality and reduce procurement costs through centralized procurement. In addition, each sewage treatment plant regularly upgrades its sewage treatment equipment and introduces new technologies into the sewage treatment process to improve its environmental treatment capabilities.

1. 天然氣價格波動風險

城市燃氣企業現行銷售定價政策普遍採用非居民用戶補貼居民用戶的交叉補貼模式，終端售氣價格由地方政府主管部門核定。由於政府價格主管部門調整價格有一定的周期，相對於市場變化，價格調整可能存在滯後性。而購氣價格受國內供需及國際市場價格的影響較大，若氣源採購價格上漲導致採購成本上漲，由於上下游價格疏導受限，公司經營業績會受較大影響。公司積極推動政府主管部門完善上下游價格聯動機制，加快成本疏導。

2. 環保政策變化風險

近年來國家陸續出台環保新規，持續加大環保政策的執行力度，對公司的環保管理提出了更為嚴格的要求。若將來因國家環保政策變化原因，導致公司相關行業技術標準調整，將會對公司的生產經營帶來一定壓力。公司下屬各家污水處理企業嚴格按照當地污水排放標準進行運營管理，確保達標排放，通過集採進一步把控採購品質降低採購成本。此外，各污水廠定期對污水處理設備升級改造，對污水處理工藝進行新技術的導入，以提升環境治理能力。

3. Risk of safety

In daily operations, the Company mainly faces risks associated with gas operation safety and engineering construction. Natural gas is a kind of flammable and explosive gaseous fuel, which is easy to cause explosion and fire accidents, thus seriously threatening safety of people and properties. In the transmission and distribution process, factors like aging urban pipeline networks, extreme weather condition and vandalism might cause pipeline leakage, posing a major risk to gas sales companies; in the process of gas use, inadequate safety awareness and lack of proper operation skills on the part of users would also cause safety hazards; in terms of engineering construction, as public utility projects are generally characterized by long construction period, complicated construction environment and great implementation difficulties, it's easy to cause damages to ecological environment and urban infrastructure due to improper construction management, therefore construction contractors are required to be extremely specialized and capable of fine management. To avoid any safety accidents occurring, the Company fully pursues the accountability for workplace safety, always persists in its guidelines of "safety first, prevention foremost and comprehensive management" according to the national workplace safety policy and standards, strengthens supervision and management of workplace safety, and rigorously carries out its various rules and regulations on safety management.

4. Risk of exchange rate fluctuations

The Company's accounting currency is RMB and now has part of funds raised from listing of H Shares and retained in USD. Due to effects of changes in overall operation of the national economy, national macroeconomic condition, monetary policies and international environment, the RMB/USD exchange rate fluctuations would pose a risk of exchange loss. The Company will keep close track of changes to domestic and overseas exchange rate markets, and closely monitor risks arising from exchange rate fluctuations to minimize their effects on the Company's assets.

5. Risk of changes in value of financial assets and investment income

Fluctuations of financial market prices are closely connected with values of financial assets held by the Company and will affect the size and ability of monetization of the Company's financial assets. Meanwhile, the Company's investment income mainly comes from affiliates such as Dazhong Transportation and Shenzhen Capital Group, with considerable effects on the Issuer's profits. If the macroeconomic condition and capital market are unfavorable, it will affect the growth in the Company's investment income, thereby adversely affecting the Company's profitability. The Company will keep close track of progress of domestic and overseas investment projects, prudently select investment targets with a focus on principal security, and continuously improve its investment management and risk control process to create relatively robust investment income.

3. 安全風險

於日常經營中，公司主要面臨燃氣運營安全和工程施工風險。天然氣屬易燃易爆的氣態燃料，容易引起爆炸和火災事故，嚴重威脅人員和財產的安全。在輸配環節，城市老舊管網老化，極端天氣影響和人為破壞等因素都可能導致管道泄漏，是燃氣銷售公司面臨的主要風險；在燃氣使用環節，用戶安全意識不足，缺乏正確的操作技能，亦會導致安全隱患；在工程施工方面，因為公用事業類項目通常具有建設周期長、施工環境複雜、實施難度較大的特點，容易因施工管理不善導致危害生態環境和城市基礎設施，因而施工方被要求具備極強的專業性和精細化管理的能力。為避免安全事故發生，公司防微杜漸，全面壓實安全生產主體責任，根據國家安全工作政策和標準，始終堅持「安全第一，預防為主，綜合治理」的方針，加強安全生產的監督管理，嚴格執行公司各項安全管理工作制度。

4. 匯率波動風險

公司記帳本位幣為人民幣，現存部分以美元留存的H股上市募集資金，受國民經濟總體運行狀況、國家宏觀經濟、金融政策以及國際環境變化的影響，人民幣兌美元的匯率波動存在匯兌損失的風險。公司將密切關注境內外匯率市場變化，嚴密監控匯率波動產生的風險，盡可能減少其對公司資產的影響。

5. 金融資產價值及投資收益波動風險

金融市場價格的波動與公司持有的金融資產的價值存在緊密的聯動關係，將影響公司金融資產的變現規模和變現能力。同時，公司投資收益主要來自於大眾交通、深創投等企業，投資收益對公司利潤影響較大。如果宏觀經濟和資本市場不景氣，將影響公司投資收益的增長，從而對公司盈利能力造成不利影響。公司將密切關注境內外投資項目的進展，審慎篩選投資標的，以資金安全為重，並不斷完善投資管理和風險控制流程，創造相對穩健的投資收益。

BUSINESS REVIEW

MAIN CUSTOMERS AND SUPPLIERS

For the year ended December 31, 2024, purchases from the five largest suppliers and the largest supplier of the Group, Shanghai Gas, accounted for 65.97% and 47.34% of the total purchases of the Group respectively (2023: 64.55% and 49.46%). Save as disclosed above, none of Directors or their close associates or any shareholders (who owns more than 5% of the Company's share capital to the best of Directors' knowledge) has any interests in the five largest suppliers of the Group.

For the year ended December 31, 2024, the total sales from five largest customers of the Group accounted for 9.03% of the total sales of the Group.

Relationship with Employees

The Group regards its employees as the most important assets of the Group and values maintaining good relationship with employees. The Group is committed to providing its employees with stable work environments and formulates normative talent recruitment, competition for job and other policies according to law always following the principles of fairness, impartiality and merit-based recruitment. The Group provides its employees with competitive compensation package, including basic wage, performance bonus and other employee benefits. The Group also provides social insurance and other benefits to its employees, such as basic pension insurance, basic medical insurance, worker's compensation insurance, unemployment insurance, maternity insurance, housing and personal accident insurance pursuant to China's labor law and the relevant provisions of the national and local governments. Basic pension insurance, basic medical insurance, unemployment insurance and housing funds are contributed by the Group and the employees at a certain proportion in accordance with the relevant local requirements. The worker's compensation insurance and maternity insurance are generally paid by the Group. The Group reviews the performance of its employees annually, and the results are considered in his or her annual salary assessment and promotion appraisal. The Group also provides on-the-job training to its employees from time to time. For relevant details, please refer to the "2024 Sustainability Development Report of Shanghai Dazhong Public Utilities (Group) Co., Ltd" published by the Company on the Hong Kong Stock Exchange on March 28, 2025.

Relationship with Suppliers

The Group contracts its main construction business of pipelined gas to suitably qualified, independent third-party professional contractors. The Group selects third-party contractors generally from its list of qualified contractors, and has established long-term strategic relationship with several contractors. Subcontracting costs are separately negotiated and earmarked for projects, compliant with market standards. The Group supervises project implementation and ensures pipeline construction is conducted according to all relevant standards and provisions. Apart from the onsite supervising engineers of the Group, the Group also appoints third-party professional supervising companies to supervise project construction.

The suppliers to the pipelined gas business also include upstream gas distributors. The pipelined gas supplier to the Group in Shanghai is Shanghai Gas. The pipelined natural gas suppliers to the Group in Nantong area are PetroChina, etc. In Shanghai, the indicative purchase price of pipelined gas is set by Shanghai Municipal Commission of Housing and Urban-Rural Development. In Nantong area, the purchase price of pipelined gas to the Group is determined through consultations with the pipelined gas suppliers based on the threshold price set by the NDRC or goods are purchased in the form of spot goods.

The Group conducts sewage treatment and public infrastructure project business mainly through BT and BOT contract. The Group mainly engages independent third-party professional design companies and construction companies as contractors at the construction stage of such products. The Group values its relationship with suppliers and has established long-term partnership with multiple contractors on project construction, repair and maintenance.

Relationship with Customers

The Group is committed to providing its customers with safe and stable services. The Group is responsible for repair and maintenance of pipelines and fittings as property of customers. The Group operates multiple service centers, where end users can make payments or acquire repair and other services. The Safety and Service Department of the Group formulates safety and maintenance measures and supervise the implementation of such measures. The Group has a maintenance schedule, pursuant to which maintenance personnel conducts inspection and maintenance of pipe networks of the Group. The Group also allocated independent third-party contractors to perform pipeline inspection and maintenance on a regular base. The Group closely monitors the operation of its contractors.

管道燃氣業務的供應商亦包括上游燃氣分銷商。本集團在上海的管道燃氣供應商為上海燃氣。本集團在南通地區的管道天然氣供應商為中石油等。於上海，管道燃氣指引採購價格由上海市住建委設定。於南通地區，本集團的管道燃氣採購價格乃與上游管道燃氣供應商根據國家發改委設定的門檻價格磋商釐定或現貨採購。

本集團主要通過BT及BOT合同開展污水處理及公共基礎設施項目業務。本集團主要委聘獨立第三方專業設計公司及建設公司於該等項目建設階段中充當承包商。本集團重視其與供應商的關係，並已與多名承包商就項目建設、維修及維護建立長期關係。

與客戶的關係

本集團致力為客戶提供安全及穩定的服務。本集團負責客戶物業管道及相關配件的修復及維護服務，而本集團運營多個服務中心，終端用戶可前往付款或獲取維修及其他服務。本集團的安全及服務部制定安全及維護措施以及監督該等措施的執行。本集團有維護安排日程，據此維護工作人員在本集團的管道網絡進行檢查及維護工作。本集團亦委聘獨立第三方承包商進行定期管道檢查及維護工作。本集團密切監控承包商的運作。

The Group charges resident and non-resident end-users different retail prices according to relevant regulations. Retail prices for non-residential purposes such as industrial and commercial end-users are generally higher than those for residential purposes. Local NDRC counterparts and/or price bureaus can adjust retail prices from time to time for various reasons. For certain non-residential users who consume large amounts of pipelined gas, the Group generally signs individual supply agreements with them.

The Group's gas and sewage business sign concession agreements with local governments in return for service fees paid by relevant local governments to the Group. The fees charged by the Group within the concession period are calculated based on the treatment volume and unit price as set forth in relevant concession agreements. The Group charges service fee for basic water volume on a monthly basis and charges service fee for excess water volume on an annual basis.

ENVIRONMENTAL POLICY AND PERFORMANCE

The Group is subject to many PRC environment laws and regulations, including but not limited to the "Environmental Protection Law of the PRC", "Environmental Impact Assessment Law of the PRC" and "Water Pollution Control Law of the PRC". The Group also adopted multiple measures to promote environmental protection, reduce emissions of greenhouse gases, noise and harmful wastes, improve raw materials use efficiency and reduce natural resource consumption. For relevant details, please refer to the "2024 Sustainability Development Report of Shanghai Dazhong Public Utilities (Group) Co., Ltd" published by the Company on the website of the Hong Kong Stock Exchange on March 28, 2025.

COMPLIANCE WITH RELEVANT LAWS AND REGULATIONS HAVING SIGNIFICANT INFLUENCE

The Group has formulated compliance procedures to ensure compliance with applicable laws, regulations and rules having significant influence on it, including but not limited to the Company Law, Securities Law of the PRC, the Code for Governance of Listed Companies issued by CSRC, the Hong Kong Listing Rules (including CG Code) and the Listing Rules of Shanghai Stock Exchange. The Board is responsible for supervising policies and practices regarding the Group's compliance with laws and regulatory provisions, and reviewing relevant policies on a regular basis. Relevant employees and relevant operating entities would inform themselves of any change in applicable laws, regulations and rules from time to time.

To the best of the Company's knowledge, for the year ended December 31, 2024, it has complied with relevant laws and regulations having significant influence over the Company's business and operations in all material aspects.

TAX RELIEF

For Hong Kong Stock Exchange investors investing in A-share stocks of the Company on the Shanghai Stock Exchange (“**Investors of Northbound Trading**”), according to the *Individual Income Tax Law of the People’s Republic of China* and its implementing regulations and the *Notice on Several Issues with Withholding of Enterprise Income Tax on Distribution of Dividends by Chinese Resident Enterprises to Overseas H-Share Nonresident Enterprise Shareholders* (Guo Shui Han [2008] No. 897) issued by the State Taxation Administration of China on November 6, 2008, the Company shall withhold income tax at a 10% rate and report withholdings to the competent tax authority. In case of tax residents of other countries among Shanghai-HK Stock Connect investors, and the taxation agreement signed between their countries of residence and China providing that the income tax rate on dividends is lower than 10%, enterprises or individuals may file an application for entitlement to taxation agreement benefits to the competent tax authority having jurisdiction over the Company either by themselves or through withholding agents, whereupon the competent tax authority will rebate taxes based on the difference between the collected taxes and payable tax calculated based on the tax rate stipulated in the taxation agreement after satisfactory review.

For Shanghai Stock Exchange investors investing in H-share stocks of the Company on Hong Kong Stock Exchange (“**Investors of Hong Kong Stock Connect**”), pursuant to the relevant requirements under the Notice on the Tax Policies Related to the Pilot Program of the Shanghai-Hong Kong Stock Connect [Caishui [2014] No. 81], as to mainland Chinese individual investors, the Company shall withhold individual income tax at a 20% rate; as to mainland Chinese securities investment funds, tax will be collected by reference to individual investors; the Company will not withhold income tax on dividends with respect to mainland Chinese corporate investors, but payable taxes shall be reported and paid by companies themselves. As to all investors investing in stocks of the Company via Shenzhen-Hong Kong Stock Connect, according to the Notice on the Tax Policies Related to the Pilot Program of the Shenzhen-Hong Kong Stock Connect [Caishui [2016] No. 2017], income tax on dividends shall be paid by reference to the tax policies on Shanghai-Hong Kong Stock Connect and Hong Kong Stock Connect.

Should the holders of H shares of the Company have any doubt in relation to the aforesaid arrangements, they are recommended to consult their tax advisors for relevant tax impact in Mainland China, Hong Kong and other countries (regions) on the possession and disposal of the H shares of the Company.

對於上海證券交易所投資者投資香港聯交所本公司H股股票(「**港股通**」)，根據《關於滬港股票市場交易互聯互通機制試點有關稅收政策的通知(財稅[2014]81號)》的相關規定，對內地個人投資者，本公司應按照20%的稅率代扣個人所得稅；對內地證券投資基金，比照個人投資者徵稅；對內地企業投資者本公司不代扣股息紅利所得稅款，應納稅款由企業自行申報繳納。對於通過深港通投資本公司股票的所有投資者，根據《關於深港股票市場交易互聯互通機制試點有關稅收政策的通知(財稅[2016]127號)》，股息所得稅參照滬股通和港股通的稅收政策進行繳納。

According to the title transfer agreement, the Dazhong Business Management, Shanghai Yixiang and Dazhong Wanxiang agrees to sell and the Dazhong Financial Leasing agrees to purchase the assets at a consideration of RMB65,000,000, as determined by the contractors after consultation with reference to the value of the assets, which is approximately valued at RMB88,474,790.34. According to the financial leasing contract, the assets shall be leaseback to the Dazhong Business Management, Shanghai Yixiang and Dazhong Wanxiang during the lease term at the total rental amount of RMB69,905,564.76, which shall be paid by the Lessee in cash in twelve quarterly instalments to Dazhong Financial Leasing. The term of the agreement is 36 months, commencing from the date of payment of the consideration by Dazhong Financial Leasing.

Dazhong Financial Leasing is a non-wholly owned subsidiary of the Company. Dazhong Business Management is the substantial shareholder of the Company. Shanghai Yixiang and Dazhong Wanxiang is the subsidiary of our substantial shareholder, Dazhong Business Management. Therefore, both Shanghai Yixiang and Dazhong Wanxiang are therefore the connected persons of the Company by virtue of being the associates of Dazhong Business Management.

For details, please refer to the announcement of the Company dated November 14, 2022.

6. Master Gas Purchase Agreement signed with Shanghai Gas Group in 2015

During 2024, Shanghai Dazhong Gas and other subsidiaries purchased natural gas from Shanghai Gas in its ordinary course of business at the total consideration of RMB2,954.48 million.

On December 16, 2015, Shanghai Dazhong Gas entered into a framework gas purchase agreement (the "Framework Agreement") with Shanghai Gas Group in connection with the purchase of piped gas, pursuant to which the parties confirmed and agreed on the expected annual supply volume of piped gas and other volume based parameters each year. The Framework Agreement has a term of 20 years from January 1, 2014 to December 31, 2033.

5. 於2022年11月14日簽訂的所有權轉讓協議及融資租賃合同

於2022年11月14日，大眾融資租賃與大眾企管、上海軼祥及大眾萬祥訂立所有權轉讓協議及融資租賃合同。大眾融資租賃受讓大眾企管、上海軼祥及大眾萬祥的資產，同時，資產應回租予大眾企管、上海軼祥及大眾萬祥，而大眾企管、上海軼祥及大眾萬祥有義務支付租金。根據所有權轉讓協議，大眾企管、上海軼祥及大眾萬祥同意出售，而大眾融資租賃同意購買資產，代價為人民幣65,000,000元，乃訂約方參考資產價值，即約人民幣88,474,790.34元後經磋商釐定。根據融資租賃合同，資產應於租期內回租予大眾企管、上海軼祥及大眾萬祥，總租金為人民幣69,905,564.76元，該租賃代價應由承租人於租期內按季度分十二(12)期以現金支付予大眾融資租賃。合同有效期為自大眾融資租賃支付代價日期起36個月。

大眾融資租賃為本公司的非全資子公司。大眾企管為本公司的主要股東。上海軼祥及大眾萬祥各自為本公司主要股東大眾企管的子公司。故此，上海軼祥及大眾萬祥作為大眾企管的聯繫人，因而視為本公司的關連人士。

6. 於2015年與燃氣集團簽訂的主燃氣購買協議

2024年內，上海大眾燃氣於日常業務過程中自上海燃氣購買天然氣，總代價為人民幣2,954.48百萬元。

於2015年12月16日，上海大眾燃氣與燃氣集團就購買管道燃氣簽訂一份框架燃氣購買協議（「**框架協議**」），據此，訂約雙方確認及同意每年管道燃氣的預期年度供應量以及其他以氣量為基礎之參數。框架協議由2014年1月1日起至2033年12月31日為期20年。

The annual cap for the purchase of natural gas by the Group for the year ended December 31, 2024 is RMB4 billion. According to the relevant PRC laws and regulations, the price of the natural gas purchased by the Group from Shanghai Gas is fixed by the relevant local competent authorities. As Shanghai Gas Group is a connected person of the Company, and Shanghai Gas is spun off from Shanghai Gas Group to undertake natural gas business, the purchase of the natural gas by Shanghai Dazhong Gas from Shanghai Gas constitutes continuing connected transactions of the Group upon Listing.

The above continuing connected transactions had followed the policies and guidelines when determining the prices and terms of the transactions conducted for the year ended December 31, 2024.

The independent non-executive Directors have reviewed the continuing connected transactions as described above and confirmed that, during the Reporting Period, such transactions have been entered into:

- (i) in the ordinary and usual course of business of the Group;
- (ii) on normal commercial terms or better; and
- (iii) in accordance with the relevant agreements on terms that are fair and reasonable and in the interests of the Shareholders as a whole.

The auditor of the Company has sent a letter to the Board and confirmed, with respect to the aforesaid continuing connected transactions:

- (i) nothing has come to its attention that causes the auditor to believe that the disclosed continuing connected transactions have not been approved by the Board;
- (ii) for transactions involving the provision of goods or services by the Group, nothing has come to its attention that causes the auditor to believe that the transactions were not, in all material respects, in accordance with the pricing policies of the Group;
- (iii) nothing has come to its attention that causes the auditor to believe that the transactions were not entered into, in all material respects, in accordance with the relevant agreements governing such transactions; and
- (iv) with respect to the aggregate amount of each of the continuing connected transactions, nothing has come to its attention that causes the auditor to believe that the disclosed continuing connected transactions have exceeded the maximum aggregate annual value in respect of each of the disclosed continuing connected transactions.

截至2024年12月31日本集團購買的天然氣的年度上限為人民幣40億元。根據相關中國法律及法規，本集團從上海燃氣購買天然氣的價格乃由相關地方主管機關釐定。由於燃氣集團為本公司關連人士。上海燃氣為從燃氣集團分立出來承接天然氣業務的公司。上海大眾燃氣自上海燃氣購買天然氣於上市後構成本集團的持續關連交易。

PERFORMANCE OF NON-COMPETITION AGREEMENT

To ensure that Dazhong Business Management does not compete with the Company, Dazhong Business Management entered into a non-competition agreement with the Company on November 2, 2016 (“**Non-competition Agreement**”) which took effect upon listing. Details of the Non-competition Agreement are set out in the section headed “Substantial Shareholders – Non-competition Agreement” of the prospectus of the Company dated November 23, 2016.

Dazhong Business Management had provided the Company with a written confirmation to confirm that, for the year ended December 31, 2024, it had complied with the undertakings under the Non-competition Agreement. The Directors (including the independent non-executive Directors) have reviewed the status of compliance with the undertakings under the Non-competition Agreement by Dazhong Business Management and have confirmed that, as far as they can ascertain, Dazhong Business Management has complied with the undertakings thereunder throughout the period.

EQUITY-LINKED AGREEMENT

During the Reporting Period, the Group has not entered into any equity-linked agreements.

SUBSEQUENT EVENTS

After the end of the Reporting Period to the latest practical date of this report, there were no significant events regarding the business or financial performance of the Group that should be disclosed.

重要事項

I. CASH DIVIDENDS

1. The Company's profit distribution should value the reasonable return on investment to investors. The Company determines reasonable profit distribution plans each year based on its current operating status and funding plans for its project investment, and maintains the continuity and stability of its profit distribution policy. The Company's profit distribution may not exceed the limits of accumulated distributable profits, or affect the ability of the Company to continuously operate and develop.
2. During the Reporting Period, the Company carried out its 2023 profit distribution plan according to its profit distribution policy: based on the total share capital of 2,952,434,675 Shares as at the end of 2023, a proposed cash dividend of RMB0.035 (tax inclusive) for every share or total cash dividends of RMB103,335,213.63 will be distributed. That profit distribution plan has been deliberated and approved by the 2023 AGM of the Company held on June 18, 2024, and this profit distribution has been completed on August 8, 2024 in compliance with the Company's cash dividend policy.

II. FULFILLMENT OF COMMITMENTS

Commitments made by the actual controller, shareholders, related parties or acquirers of the Company, the Company or other relevant parties during the Reporting Period or continuing into the Reporting Period

During the Reporting Period, there were no undertakings of the de facto controller, shareholders, related parties, acquirer and the Company during reporting period or subsisting to the Reporting Period applicable.

III. MATERIAL CONTRACTS AND THEIR PERFORMANCE

Guarantee

The amount of guarantees incurred to subsidiaries during the Reporting Period totaled RMB1,195.17 million, and the balance of guarantees to subsidiaries at the end of the Reporting Period totaled RMB742.10 million.

The ratio of total guarantees to the net assets of the Company at the end of the Reporting Period was 8.74%.

No guarantees other than those to subsidiaries occurred within the Reporting Period, and the total guarantees at the end of the Reporting Period consist solely of guarantees to subsidiaries.

BASIC INFORMATION ON CORPORATE GOVERNANCE

As a dual-listed Company listed on the Shanghai Stock Exchange and the Hong Kong Stock Exchange, the Company has remained in strict compliance with the Articles of Association, relevant laws and regulations in the PRC and listing rules of Shanghai Stock Exchange during the Reporting Period. The Company has also complied with the Hong Kong Listing Rules during the Reporting Period. The Company is committed to rigorous corporate governance and risk management

I. Corporate Governance

During the Reporting Period, the Company strictly followed the Company Law, Securities Law, Code of Corporate Governance for Listed Companies and relevant laws and regulations promulgated by the CSRC, the Shanghai Stock Exchange and the Hong Kong Stock Exchange as well as the requirements under the Articles of Association of the Company. The corporate governance structure was constantly optimized to enhance operational capabilities, and the internal control mechanism was improved to push forward the standardisation of the Company. Currently, the Company has formed a governance mechanism with clear authorities and responsibilities and checks and balances as well as an effective internal control mechanism in compliance with the requirements of listed companies, and is operated strictly in accordance with the legislation.

Corporate governance is detailed as follows:

- (i) *Shareholders and general meetings:* The Shareholders have lawful rights prescribed by laws and regulations and Articles of Association. The Company convenes and holds general meetings strictly according to relevant provisions of the Listing Rules of Shanghai Stock Exchange and the Hong Kong Listing Rules and requirements of the Articles of Association, and ensures all Shareholders especially minority Shareholders enjoy the equal status and rights and assume corresponding obligations. During the Reporting Period, the Company held one annual general meeting for 2023 and the first H-share class meeting for 2024 in a combination of onsite and video conferencing, which were convened and held in compliance with requirements of the Company Law and the Articles of Association. The Company engaged practicing lawyers to attend the general meetings and confirm and witness the convening procedure, matters for consideration and identities of attendants at the meetings, thus ensuring the lawfulness and validity of the general meeting.

企業管治基本資料

I. 公司治理

公司治理情況具體如下：

- (一) *股東與股東大會：*公司股東享有法律法規及《公司章程》規定的合法權利。公司嚴格按照《上海證券交易所上市規則》、香港上市規則相關規定和《公司章程》的要求召集、召開股東大會，確保所有股東特別是中小股東都享有平等的地位和權利，並承擔相應的義務。報告期內，公司以現場與視頻會議相結合的方式召開了1次2023年年度股東大會及2024年第一次H股類別股東大會，會議的召集、召開符合《公司法》《公司章程》等相關規定的要求。公司聘請了執業律師出席股東大會，對會議的召開程序、審議事項、出席人身份進行確認和見證，保證了股東大會的合法性和有效性。

(II) *Directors and the Board:* The Board persists in the sustainable development strategy, works strictly according to laws and regulations issued by the CSRC and stock exchanges of dual listing place, and effectively promotes normative operation and scientific decision-making of the Board. The Company's Board consists of 9 Directors, including 4 independent non-executive Directors, who provide stronger support for the Company's compliant and scientific decision making. The Company has an well-established corporate governance structure, with the Board, Board of Supervisors and management staffed with comprehensive and diversified personnel. The Board has Strategic Development and ESG Committee, Audit Committee, Nomination Committee, Remuneration and Appraisal Committee, each with clearly-defined duties in terms of investment decision, internal control supervision, appointment and dismissal and performance appraisal and each with legal and regulatory compliance. During the Reporting Period, the Company held 5 Board meetings, 7 Audit Committee meetings, 1 Nomination Committee meeting, 2 Remuneration and Appraisal Committee meetings and 1 Strategic Development and ESG Committee meeting, which considered and adopted resolutions to revise the Articles of Association and rewrite the Independent Non-executive Director System; meanwhile, to further build up the Board and in light of the sustainability management guidelines, the strategic development committee of the Board was renamed to the Strategic Development and ESG Committee. Relevant meetings were convened and held all in compliance with requirements of relevant provisions such as the Company Law and the Articles of Association.

(III) *Supervisors and Board of Supervisors:* The Board of Supervisors consists of 3 Supervisors, including one employee Supervisor, elected by the Company's workers' congress. Members of the Board of Supervisors effectively performed their duties in a manner responsible and accountable to all Shareholders, and supervise the financial position of the Company and performance of duties by Directors and senior management of the Company for lawfulness and compliance. During the Reporting Period, the Company held 5 meetings of Board of Supervisors in total, all convened and held in compliance with requirements of relevant provisions including the Company Law and the Articles of Association.

(二) *董事和董事會:* 董事會堅持可持續發展戰略，嚴格按照中國證監會、兩地交易所的各項法律法規開展工作，有效促進董事會規範運作和科學決策。董事會人員組成總人數為9名，其中獨立非執行董事4名，為公司合規科學的決策提供了強有力的支持。公司法人治理結構完善，董事會、監事會、經理層人員配備具有全面性、多元化。董事會下設戰略發展與ESG委員會、審計委員會、提名委員會、薪酬與考核委員會，在投資決策、內控監督、人員任免、績效評估等方面的工作權責分明、合規合法。報告期內，公司共召開5次董事會會議，7次審計委員會會議、1次提名委員會會議、2次薪酬與考核委員會會議、1次戰略發展與ESG委員會會議，相關會議審議並通過修訂《公司章程》及重修《獨立非執行董事制度》的議案；同時為進一步加強董事會建設，結合可持續發展管理方針，戰略發展委員會更名為戰略發展與ESG委員會。相關會議的召集、召開均符合《公司法》《公司章程》等相關規定的要求。

(三) *監事和監事會:* 監事會由3名監事組成，其中職工監事1名，由公司職工代表大會選舉產生。監事會成員本著對全體股東負責的態度，切實履行自身職責，對公司財務狀況以及公司董事及高級管理人員履職情況的合法性、合規性進行監督。報告期內，公司共召開5次監事會，會議的召集、召開均符合《公司法》《公司章程》等相關規定的要求。

- (IV) *Information disclosure and transparency:* The Board secretary responsible for managing information disclosure according to the Administrative Measures for Information Disclosure of Listed Companies. The Company performs its information disclosure obligation in a true, accurate and complete manner strictly according to requirements of relevant laws and regulations in Shanghai and Hong Kong, ensuring timeliness and consistency of information disclosure in both places of listing. The Company discloses its operating and financial data to investors and stakeholders on a regular basis; completely discloses Board reports, Board of Supervisors reports, financial budget and final accounting reports, independent directors' work reports, Audit Committee's work report and other relevant information involving performance of duties by the Board, corporate governance and financial condition, all subject to deliberation of the general meeting.
- (V) *Investor Relations and Stakeholders:* The Company consistently values investor relations management and maintains communication with its investors through investor hotline, E-interaction with Shanghai Stock Exchange, and receiving visiting individual investors, etc. During the Reporting Period, the Company sufficiently communicated with its investors by holding press conference meeting with investors in Hong Kong and the "collective results briefing on annual report of listed companies in Shanghai 2024" and "online open day for investors of listed companies in Shanghai 2024 & interim results briefing" online. The Company disclosed to the general public "Environmental, Social and Governance (ESG) Report of Shanghai Dazhong Public Utilities [Group] Co., Ltd." for 8 consecutive years. During the Reporting Period, while maintaining stable and continuous development, the Company actively gave back to its investors and completed its profit distribution for 2023.
- (VI) *Regarding the Management of Insider Information Informant Registration:* During the Reporting Period, the Company strictly adhered to the relevant requirements of the "Measures for the Administration of Information Disclosure by Listed Companies" and the provisions of the "Internal Control System for the Management of Insider Information Informants." formulated by the Company. The Company conducted registration and management of both insider information informants and internal information users to ensure the legality and fairness of information disclosure. During the Reporting Period, there were no instances of insider information informants engaging in illegal or irregular trading of the Company's stocks.

- (五) *投資者關係及相關持份者:* 公司一貫重視投資者關係管理, 通過投資者熱線電話、上海證券交易所「上證E互動」、接待投資者來訪等方式保持投資者溝通。報告期內, 公司通過在香港召開投資者分析師交流會現場會議及召開「關於參加2024年上海轄區上市公司年報集體業績說明會」、「上海轄區上市公司2024年投資者網上集體接待日暨中報業績說明會」等線上方式與投資者充分溝通。公司連續8年向公眾披露《上海大眾公用事業(集團)股份有限公司環境、社會及管治(ESG)報告》。報告期內, 公司在保持穩定持續發展的同時, 積極回報廣大投資者, 實施完成了2023年度利潤分配工作。
- (六) *關於內幕信息知情人登記管理:* 報告期內, 公司嚴格執行《上市公司信息披露管理辦法》的相關要求以及公司制訂的《內幕信息知情人管理制度》相關規定, 對內幕信息知情人和內部信息使用人進行登記管理, 保證信息披露合法公平。報告期內不存在內幕信息知情人違法及違規買賣公司股票的情況。

There was no material discrepancy between corporate governance and relevant requirements of CSRC during the Reporting Period.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

To ensure balanced distribution of power and strengthen independence and accountability, the positions of chairman of Board and chief executive officer of the Company are held by Mr. Yang Guoping and Mr. Liang Jiawei, respectively.

The Chairman of board leads the Board, responsible for formulating the corporate and business strategies and making important corporate and operating decisions. The chief executive officer is dedicated to business development and responsible for day-to-day operations and management and supervising the implementation of the Company's business strategy and plan.

INDEPENDENT NON-EXECUTIVE DIRECTORS

During the Reporting Period, the Board complied with the following provisions of the Hong Kong Listing Rules: (1) the board of a listed issuer must include at least three independent non-executive directors; (2) at least one independent non-executive director of them must possess suitable professional qualification or possess suitable accounting or relevant financial management expertise; and (3) independent non-executive directors must account for at least one third of the total number of board members.

The Company has received annual written confirmation from each independent non-executive Directors regarding his or her independence according to the independence guidance as set out in Rule 3.13 of the Hong Kong Listing Rules. The Company is of the opinion that all independent non-executive Directors are independent.

RE-ELECTION OF DIRECTORS

The Company has executed service contract with each executive Director and executed appointment letter with each non-executive Director and independent non-executive Director. The term of office of each non-executive Director is three years. All Directors have been appointed pas per the term of office that expires at the expiration of the incumbent Board's tenure, and are entitled to reelection upon the expiration of term for a term of office of three years. The appointment and dismissal of any Director is subject to approval of Shareholders at the general meeting.

The Board must make objective decisions in the best interests of the Company.

All Directors (including non-executive Directors and independent non-executive Directors) bring different valuable business experience, knowledge and specialties of various kinds to the Board, allowing it to operate efficiently and effectively. All Directors can access all data of the Company comprehensively and timely and require the joint company secretary and senior management to provide services and opinions. Directors may seek independent professional opinion as appropriate when requested in order to perform their duties to the Company, at the sole cost of the Company. Directors are required to disclose details about other positions held by them to the Company, while the Board reviews the contributions to be made when each Director performs their duties to the Company on a regular basis.

The Company's management is responsible for (including but not limited to) executing the Board resolutions and carrying out the Company's business plan and investment suggestions under the leadership of the chief executive officer of the Company. The Company's management shall report to the Board in a timely manner in order for the Board to make well-informed decisions in the best interests of the Company as a whole.

Mechanisms ensuring independent views and opinions

The Company ensures independent views and opinions are introduced for the Board through the following mechanisms:

- (1) the Nomination Committee shall review the composition of the Board and the independence of independent non-executive Directors on an annual basis;
- (2) The Company obtained confirmations from each independent non-executive Director that they are independent from the Company according to Rule 3.13 of the Hong Kong Listing Rules. The Company believes that all independent non-executive Directors are independent;

Gender Diversity and Equal Opportunities Policy

To this end, we have adopted policies on compensation, dismissal, equal opportunities, diversity and antidiscrimination. Accordingly, the Company gives each job applicant an equal job opportunity and we have an internal policy in place to ensure that there is no discrimination as to gender, age and ethnicity. In addition, we have stipulated in our internal guidelines that decision in relation to human resource management, which include but not limited to promotion, salary increment and dismissal within the Company would be based solely on the employee's performance, experience and capability. The selection procedure for Directors and senior executives: (I) the Nomination Committee shall actively communicate with relevant departments of the Company to develop the Company's requirements and needs for new Directors and senior managements, and form them into written materials; (II) the Nomination Committee can extensively search candidates for Directors, managers and other senior managements within the Company and its holding (equity participation) company and on talent markets; (III) search and collect information about occupation, education, professional title, detailed work experience and all part-time jobs of preliminary candidates and form them into written materials; (IV) solicit consent from nominees to nomination, otherwise they may not be regarded as candidates for Directors and senior managements; (V) convene a Nomination Committee meeting to conduct qualification review of the preliminary candidates according to conditions of employment of Directors and senior executives; (VI) provide recommendations on Director candidates and candidates for newly-appointed senior executives and relevant materials thereon to the Board 10 days before electing new Directors and appointing new senior managements and (VII) conduct other subsequent work based on decisions and feedback from the Board.

SHAREHOLDER'S RIGHTS

Shareholders request an extraordinary general meeting to be held

According to Article 53 of the Articles of Association, Shareholders requesting an extraordinary general meeting or class meeting shall do so according to the following procedure:

Shareholders holding 10% or more of Shares either alone or in aggregate have the right to request the Board to hold extraordinary general meeting and shall file a request in writing to the Board. The Board should give a written feedback consenting or dissenting to the convening of an extraordinary general meeting within 10 days of receipt of the request according to laws, regulations and the Articles of Association.

Where the Board consents to holding an extraordinary general meeting, it should give a notice of general meeting within 5 days of making a Board resolution, provided that any change to the original request in the notice should be subject to consent of relevant shareholders. Where the Board disagrees with holding an extraordinary general meeting or fails to give any feedback within 10 days of receipt of the request, ordinary Shareholders (including preferred Shareholders whose voting power is restored) holding 10% or more of shares either alone or in aggregate have the right to propose the Supervisory Board to hold an extraordinary general meeting, and should file a request to the Supervisory Board in writing.

Where the Supervisory Board consents to holding an extraordinary general meeting, it should give a notice of general meeting within 5 days of receipt of the request, provided that any change to the original request in the notice should be subject to consent of relevant shareholders.

Should the Supervisory Board fail to give a notice of general meeting within the prescribed time limit, the Supervisory Board shall be deemed not to convene or hold the general meeting, in which case ordinary Shareholders (including preferred Shareholders whose voting power is restored) holding 10% or more of Shares either alone or in aggregate for more than 90 consecutive days may convene and chair a general meeting themselves. The costs necessary for the general meeting convened by the Supervisory Board or the shareholders themselves shall be undertaken by the Company.

Bring forward proposals at general meeting

According to Article 58 of the Articles of Association, where the Company holds a general meeting, the Board, the Supervisory Board and Shareholders holding 3% or more of Shares either alone or in aggregate have the right to bring forward proposals to the Company.

Shareholders holding 3% or more of Shares either alone or in aggregate may bring forward provisional proposals and submit them in writing to the convener 10 days prior to the general meeting. The convener shall give a supplementary notice of general meeting within 2 days of receipt of the proposals, announcing the contents of the provisional proposals.

Except as otherwise specified in the preceding provisions, the convener may not modify any proposal already indicated in the notice of general meeting or add any new proposal thereto upon giving the announcement of notice of general meeting.

The general meeting may not vote or make any resolution on any proposal not listed in the notice of general meeting or in compliance with the Articles of Association.

The Company has established a set of corporate policies, including detailed internal monitoring and risk management policies, in order to supervise all material aspects of various departments, including operating procedures, assignment of duties, resource management, approval process and internal evaluation standards, and ensure that the Company's resources, employee qualification and experience in terms of accounting, internal audit and financial reporting functions and related to the ESG performance and reporting of the issuer as well as training courses received by employees and relevant budgets are sufficient. The Company would evaluate its internal monitoring and risk management policies for effectiveness and make revisions thereto in order to reflect changes to market condition, applicable laws and regulations and the risk profile of various business segments of the Company.

The Board confirms its responsibility for risk management and internal monitoring system and reviewing their effectiveness. Such systems are designed to manage (not eliminate) the risk that business objectives cannot be achieved, and can only reasonably instead of absolutely avoid misrepresentations or error. The Board has overall responsibility for evaluating and determining the nature and extent of the willingness to take risks it is willing to take in order to achieve the Company's strategic objectives, and establishing and maintaining appropriate and effective risk management and internal monitoring system through identification, assessment and management.

The Audit Committee assists the Board in leading the management of the risk management and internal monitoring system and supervising the design, implementation and supervision of the risk management and internal monitoring system. The Company set up an internal audit department responsible for internal audit function, and conducting independent audit of the adequacy and effectiveness of the risk management and internal monitoring system. The internal audit department examines major matters such as relevant accounting practice and all significant monitoring matters, and provides the Audit Committee with its findings and improvement suggestions.

For the year ended December 31, 2024, the Board reviewed the risk management and internal monitoring system twice and reviewed the effectiveness of risk management and internal monitoring system of the Company and its subsidiaries, believing the risk management and internal monitoring system is effective and adequate.

As at 31 December 2024, the Company holds a 50% equity interests in two subsidiaries, namely Shanghai Dazhong Gas Co., Ltd. ("Shanghai Dazhong Gas") and Nantong Dazhong Gas Co., Ltd. ("Nantong Dazhong Gas") (together as "50% Subsidiaries"). The directors of the Company considered that the Company has the practical ability to direct the relevant activities of 50% Subsidiaries, which demonstrates the Group has power over 50% Subsidiaries, exposure to variable returns from 50% Subsidiaries and ability to use its power to affect its variable returns throughout the year based on all relevant facts and circumstances. Therefore, the Company is able to consolidate these entities in the consolidated financial statements. The determination of the Company has control over 50% Subsidiaries is a key audit matter due to the significant judgement involved and the potential financial impact is significant to the presentation of consolidated financial statements.

Our response:

Our audit procedures in relation to assessment of appropriateness of consolidation of 50% Subsidiaries included:

- obtained and reviewed those relevant terms in the shareholders' agreements and articles of association of 50% Subsidiaries;
- obtained and reviewed minutes of the board meeting of 50% Subsidiaries;
- discussed with management of the Company concerning the basis for consolidation of financial statements of 50% Subsidiaries; and
- attended interviews with the directors of 50% Subsidiaries, and enquired certain facts and circumstances concerning the consolidation of 50% Subsidiaries.

As at 31 December 2024, the Company had investments in five entities, namely Shenzhen Capital Group Co., Ltd. ("Shenzhen Capital Group"), Shanghai Electronic Intelligence System Co., Ltd. ("SEISYS"), Suchuang Gas Corporation Limited ("Suchuang Gas"), Vietnam Investment Securities Company ("IVS") and Jiangsu Dongneng Natural Gas Pipeline Network Co., Ltd. ("Jiangsu Dongneng Natural Gas") in which the Group held 10.80%, 16.63%, 19.31%, 12.02% and 10% of their equity interests, respectively. The directors of the Company considered that the Group has significant influence over these five investments since the Group actively participates in these five entities' operating and financial policies, and thus investments in these five entities are accounted for as associates of the Group using the equity method. The determination of the Group has significant influence over these investments is a key audit matter due to the significant judgement involved and potential financial impact is significant to the presentation of consolidated financial statements.

Our response:

Our audit procedures in relation to assessment of the existence of significant influence over investees included:

- obtained and reviewed those relevant terms in the shareholders' agreements and articles of association of these five entities;
- obtained and reviewed minutes of the board meetings of these five entities;
- discussed with management of the Company concerning the basis of these five entities accounted for as associates in the consolidated financial statements; and
- attend an interviews with the directors of these five entities and enquired relevant facts and circumstances concerning the significant influence over these five entities.

Lease receivables impairment assessment

Refer to note 27 to the consolidated financial statements and the material accounting policy information on note 4(j)(ii).

As at 31 December 2024, the Group's gross lease receivables balance amounted to approximately RMB1,088,937,000 and the expected credit losses ("ECLs") were approximately RMB55,500,000.

The assessment on ECLs relies on the analysis and judgement by the management. The key factors includes the debtors' and guarantors' financial and operating conditions, any other pledged assets, the liquidity of the collaterals of the leases and loans and the cash flow forecast of the debtors' business with reasonable discount rates. The assessment on ECLs on lease receivables mainly depends on the external macroeconomic conditions and internal credit risk management. The ECLs determined by the Group had also included the review on historical loss experience and other adjusting factors.

Since the Group's management involves complex and significant judgements in identifying and accruing impairment of receivables, we determine that the impairment of lease receivables is a key audit matter.

Our response:

Our audit procedures in relation to ECLs assessment on lease receivables included:

- assessed the methodologies and inputs adopted by the management of the Group in estimating the expected credit loss of lease receivables;
- checked to lease agreements and subsequent repayments of the lease receivables; and
- checked to the accuracy of records and evaluated the reasonableness of management's judgement on collateral held and credit worthiness of the debtors.

Fair value measurement for financial assets

Refer to note 48(b) to the consolidated financial statements and material accounting policy information on note 4(j)(i).

As at December 31, 2024, the Group has financial assets of approximately RMB2,836,679,000 measured at fair value, and which approximately RMB2,638,215,000 are measured at fair value with level 3 inputs. Level 3 inputs for financial assets and liabilities are not based on active market prices, nor based on observable market data.

Management has applied valuation techniques to determine the level 3 fair value of financial assets that are not quoted in active markets. These valuation techniques such as market approach and income approach, which include significant unobservable inputs, involve management making subjective judgements and assumptions. With different valuation techniques, inputs and assumptions applied, the valuation results can vary significantly. Therefore, we consider that the fair value measurement of financial assets with level 3 inputs is a key audit matters.

1. GENERAL INFORMATION

Shanghai Dazhong Public Utilities (Group) Co., Ltd. (the "Company") was established in the People's Republic of China (the "PRC") on 1 January 1992, as a joint-stock limited company. On 4 March 1993, the Company was listed on the Shanghai Stock Exchange. Its registered office and the principal place of business activities is located at No. 518, Shang Cheng Road, Pudong New District, Shanghai, the PRC; and 10/F, Building 1, Zhongteng Building, No. 2121 Longteng Avenue, Xuhui District, Shanghai, the PRC, respectively.

The Company's shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "SEHK") on 5 December 2016.

The Company is principally engaged in investment holding. The principal business activities of the Group included piped gas supply, wastewater treatment, public infrastructure projects, investments, transportation services and financial services.

In the opinion of the directors, the immediate holding company is Shanghai Dazhong Business Management Co., Limited, ("Shanghai Dazhong Business Management") a company incorporated in the PRC, and the ultimate controlling shareholder of the Company is Shanghai Dazhong Business Management Employee Share Ownership Committee.

1. 一般資料

董事認為，直接控股公司為上海大眾企業管理有限公司(「上海大眾企業管理」)(一家於中國註冊成立的公司)，而本公司的最終控股股東為上海大眾企業管理有限公司職工持股會。

The consolidated financial statements have been prepared in accordance with all applicable International Financial Reporting Standards, International Accounting Standards (“IASs”) and Interpretations (hereinafter collectively referred to as the “IFRS Accounting Standards”) and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the SEHK.

(b) Basis of preparation

The consolidated financial statements have been prepared under the historical cost basis except for certain financial instruments, which are measured at fair values as explained in the material accounting policy information set out below.

(c) Functional and presentation currency

The consolidated financial statements are presented in Renminbi (“RMB”) and all values are rounded to the nearest thousand except when otherwise indicated. Each entity within the Group maintains its books and records in its own functional currency. The functional currency of the Company is RMB.

4. MATERIAL ACCOUNTING POLICY INFORMATION

(a) Business combination and basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries (the “Group”). Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the dates of acquisition or up to the dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those used by other members of the Group.

The Group accounts for business combinations using the acquisition method when the acquired set of activities and assets meets the definition of a business and control is transferred to the Group. In determining whether a particular set of activities and assets is a business, the Group assesses whether the set of assets and activities acquired includes, at a minimum, an input and substantive processes and whether the acquired set has the ability to produce outputs.

(b) 編製基準

綜合財務報表乃根據歷史成本法編製，惟按公允價值計量的若干金融工具除外，詳情見下文載列的重大會計政策資料。

(c) 功能及呈列貨幣

綜合財務報表以人民幣(「人民幣」)呈列，所有金額均調整至最接近之千元，惟另有註明者除外。本集團各實體以其本身的功能貨幣列賬及記錄。本公司的功能貨幣為人民幣。

4. 重大會計政策資料

(a) 業務合併及綜合基準

綜合財務報表包括本公司及其子公司(「本集團」)的財務報表。集團內各公司間的交易及結餘連同未變現盈利於編製綜合財務報表時悉數對銷。未變現虧損亦予以對銷，惟交易有證據顯示所轉讓資產出現減值則除外，於此情況下，虧損於損益確認。

於年內收購或出售子公司的業績自收購日期起至出售日期止(如適用)載於綜合損益及其他全面收益表。必要時，須對子公司財務報表作出調整，以使其會計政策與本集團其他成員公司的會計政策貫徹一致。

當收購的一系列活動及資產符合業務的定義及控制權轉移至本集團時，本集團使用收購法將業務合併入賬。於釐定一系列特定活動及資產是否為業務時，本集團評估收購的系列資產及活動是否至少包含一項投入及實質過程及收購的系列資產及活動是否有能力帶來產出。

(a) Business combination and basis of consolidation (Continued)

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests in the subsidiary is the amount of those interests at initial recognition plus such non-controlling interest's share of subsequent changes in equity. Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to owners of the Company. Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income is attributed to such non-controlling interests even if this results in those non-controlling interests having a deficit balance.

Changes in the Group's interests in a subsidiary that do not result in a loss of control of the subsidiary are accounted for as equity transactions. The carrying amount of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

(b) Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: (1) power over the investee, (2) exposure, or rights, to variable returns from the investee, and (3) the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

收購後，代表於子公司目前擁有權益的非控股權益賬面金額為該等權益於初步確認時的金額加以有關非控股權益應佔權益的其後變動。非控股權益列入綜合財務狀況表的權益項目內，與本公司擁有人應佔的權益分開呈列。損益及其他全面收益的各組成部分歸屬於本公司擁有人及非控股權益。總全面收益乃歸屬於有關非控股權益，即使這會導致有關非控股權益出現虧絀結餘。

倘本集團於一間子公司的權益變動並未導致失去控制權，則作為權益交易入賬。本集團權益及非控股權益的賬面值會予以調整，以反映其於子公司的相關權益變動。非控股權益的調整金額與已付或已收取代價公允價值之間的任何差額直接於權益確認，並歸屬於本公司擁有人。

(b) 子公司

子公司為本公司可行使控制權的投資對象。倘符合以下三個因素，本公司控制該投資對象：(1) 對投資對象的權力、(2) 來自投資對象可變回報的風險或權利、及(3) 利用其權力影響該等可變回報的能力。當有事實或情況顯示任何該等控制因素可能出現變動時，控制權會被重新評估。

(b) Subsidiaries (Continued)

De-facto control exists in situations where the Company has the practical ability to direct the relevant activities of the investee without holding the majority of the voting rights. In determining whether de-facto control exists the Company considers all relevant facts and circumstances, including:

- the size of the Company's voting rights relative to both the size and dispersion of other parties who hold voting rights;
- substantive potential voting rights held by the Company and other parties who hold voting rights;
- other contractual arrangements; and
- historic patterns in voting attendance.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

(c) Associates

An associate is an entity over which the Group has significant influence and that is neither a subsidiary nor a joint arrangement. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

Associates are accounted for using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the associates' net assets except that losses in excess of the Group's interest in the associate are not recognised unless there is an obligation to make good those losses.

(b) 子公司(續)

倘本公司擁有實際能力引導投資對象相關活動，而毋須持有大多數投票權，則存在實際控制權。釐定實際控制權是否存在時，本公司考慮所有相關事實及情況，包括：

- 相對其他持有投票權人士之數量及分散情況，本公司投票權規模；
- 本公司及其他持有投票權人士所持有的實際潛在投票權；
- 其他合約安排；及
- 參與投票的歷史模式。

於本公司財務狀況表中，投資子公司按成本減減值虧損(如有)列賬。子公司的業績由本公司以已收及應收股息為基準入賬。

(c) 聯營公司

聯營公司為本集團對其擁有重大影響力的實體，既非子公司，亦非合營安排。重大影響力指有權力參與投資對象的財務及經營決策，但並非對該等政策擁有控制或聯合控制權。

聯營公司乃採用權益法入賬，據此聯營公司按成本初步確認，此後其賬面值於聯營公司的資產淨值內調整以反映本集團應佔收購後變動，惟超過本集團於聯營公司的權益的虧損不會確認，除非有責任彌補該等虧損。

Profits and losses arising on transactions between the Group and its associates are recognised only to the extent of unrelated investors' interests in the associate. The investor's share in the associate's profits and losses resulting from these transactions are eliminated against the carrying value of the associate. Where unrealised losses provide evidence of impairment of the asset transferred they are recognised immediately in profit or loss.

Any premium paid for an associate above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the associate. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of investment, after reassessment, is recognised immediately in profit or loss. Where there is objective evidence that the investment in an associate has been impaired, the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

The Group discontinues the use of the equity method from the date when the investment ceases to be an associate. When the Group retains an interest in the former associate and the retained interest is a financial asset, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition in accordance with IFRS 9. The difference between the carrying amount of the associate at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing a part interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, all amounts previously recognised in other comprehensive income in relation to that associate are recognised on the same basis as would be required if that associate had directly disposed of the related assets or liabilities.

本集團與其聯營公司之間的交易產生的損益僅於不相關投資人於聯營公司擁有權益時方才確認。該等交易產生的投資人分佔聯營公司盈利及虧損與聯營公司的賬面值對銷。倘未變現虧損證明資產轉移的減值，則即時於損益確認。

就聯營公司已付任何溢價高於已收購本集團應佔可識別資產、負債及或然負債的公允價值的部分撥充資本，計入聯營公司的賬面值。本集團應佔可識別資產及負債的淨公允價值高於投資成本的部分，經重新評估後，即時於損益確認。倘客觀證據證明聯營公司投資有減值，則投資的賬面值與其他非金融資產相同方式檢測減值。

本集團自投資終止為聯營公司當日起終止採用權益法。倘本集團保留於前聯營公司的權益且保留權益屬金融資產，則本集團按該日的公允價值計量保留權益，而該公允價值根據國際財務報告準則第9號被視為於初步確認時的公允價值。聯營公司於終止採用權益法當日的賬面值與任何保留權益公允價值間的差額及出售於聯營公司的部分權益的任何所得款項，於釐定出售該聯營公司的收益或虧損時入賬。此外，本集團會將先前在其他全面收益就該聯營公司確認的所有金額入賬，基準與該聯營公司直接出售相關資產或負債所規定者相同。

When the Group reduces its ownership interest in an associate but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

In the Company's statement of financial position, investments in associates are carried at cost less impairment losses, if any. The results of associates are accounted for by the Company on the basis of dividends received and receivable during the year.

(d) Joint arrangements

The Group is a party to a joint arrangement where there is a contractual arrangement that confers joint control over the relevant activities of the arrangement to the Group and at least one other party. Joint control is assessed under the same principles as control over subsidiaries.

The Group classifies its interests in joint arrangements as either:

- *Joint ventures*: where the Group has rights to only the net assets of the joint arrangement; or
- *Joint operations*: where the Group has both the rights to assets and obligations for the liabilities of the joint arrangement.

(d) 合營安排

倘現有合約安排把某項合營安排之有關業務之共同控制權賦予本集團及至少另一合營安排方，則本集團為有關合營安排一方。於評估共同控制權時，會使用評估子公司控制權之相同原則。

本集團把其於合營安排之權益分類為：

- 合營企業：倘本集團僅有權享有合營安排之資產淨值；或
- 合營業務：倘本集團有權享有合營安排之資產及有義務承擔其負債。

In assessing the classification of interests in joint arrangements, the Group considers:

- the structure of the joint arrangement;

- the contractual terms of the joint arrangement agreement; and
- any other facts and circumstances (including any other contractual arrangements).

The Group accounts for its investment in a joint venture in the same manner as investments in associates (i.e. using the equity method — see note 4(c)).

The Company's investment in a joint venture is stated at cost less impairment losses, if any. Result of a joint venture is accounted for by the Company on the basis of dividend received and receivable.

(e) Goodwill

Goodwill represents the excess of the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interest in the acquiree and the fair value of the Group's previously held equity interest in the acquiree over the fair value of the identifiable assets and liabilities measured as at the acquisition date.

Where the fair value of identifiable assets and liabilities exceed the aggregate of the fair value of consideration paid, the amount of any non-controlling interest in the acquiree and the acquisition date fair value of the acquirer's previously held equity interest in the acquiree, the excess is recognised in profit or loss on the acquisition date, after re-assessment.

商譽指所轉讓代價之公允價值、於被收購方之任何非控股權益數額與本集團先前於被收購方所持股權之公允價值之總額超出於收購日期計量可識別資產及負債之公允價值之部份。

倘可識別資產及負債之公允價值高於所付代價之公允價值、於被收購方之任何非控股權益之金額以及收購方先前於被收購方持有之股權之收購日期公允價值的總額，則超出部份於重估後於收購日期在損益確認。

A cash-generating unit to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired.

For goodwill arising on an acquisition in a financial year, the cash-generating unit to which goodwill has been allocated is tested for impairment before the end of that financial year. When the recoverable amount of the cash-generating unit is less than the carrying amount of the unit, the impairment loss is first allocated to reduce the carrying amount of any goodwill allocated to the unit first, and then to the other assets of the unit on a pro-rata basis on the carrying amount to each asset in the unit. However, the loss allocated of each asset will not reduce the individual asset's carrying amount to below its fair value less cost of disposal (if measurable) or its value in use (if determinable), whichever is the higher. Any impairment loss for goodwill is recognised in profit or loss and is not reversed in subsequent periods.

(f) Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of property, plant and equipment includes its purchase price and the costs directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are recognised as an expense in profit or loss during the financial period in which they are incurred.

(e) 商譽(續)

獲分配商譽的現金產生單位會每年進行減值測試，但如果有跡象顯示該現金產生單位可能會發生減值，則會更頻繁地進行減值測試。

就於財政年度內進行收購所產生之商譽而言，獲分配商譽之現金產生單位會於該財政年度結束前進行減值測試。當現金產生單位之可收回金額少於該單位賬面值時，減值虧損會首先分配至撇減該單位獲分配之任何商譽之賬面值，繼而基於該單位內各資產之賬面值按比例分配至該單位之其他資產。然而，分配至各項資產之虧損將不會令到獨立資產之賬面值減至低於其公允價值減出售成本(如可計量)或其使用價值(如可釐定)(以較高者為準)。商譽之任何減值虧損於損益確認，而不會於往後期間撥回。

(f) 物業、廠房及設備

物業、廠房及設備按成本減累計折舊及累計減值虧損列賬。物業、廠房及設備的成本包括購買價以及購買有關項目直接應佔的成本。

其後成本只有在與該項目有關的未來經濟利益有可能流入本集團，而該項目的成本能可靠計量時，才計入資產的賬面值或確認為獨立資產(如適用)。被替代部分的賬面值終止確認。所有其他維修及保養在產生的財政期間於損益確認為開支。

Property, plant and equipment are depreciated so as to write off their cost net of expected residual value over their estimated useful lives on a straight-line basis. The useful lives, residual value and depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period. The useful lives are as follows:

Leasehold improvements	3-5 years
Motor vehicles	3-10 years
Gas pipelines and machinery	3-30 years
Equipment, furniture and fixtures	1-20 years

Construction in progress is stated at cost less impairment losses. Cost comprises direct costs of construction as well as borrowing costs capitalised during the periods of construction and installation. Capitalisation of these costs ceases and the construction in progress is transferred to the appropriate classes of property, plant and equipment when substantially all the activities necessary to prepare the assets for their intended use are completed. No depreciation is provided for in respect of construction in progress until it is completed and ready for its intended use.

An asset is written down immediately to its recoverable amount if its carrying amount is higher than the asset's estimated recoverable amount.

The gain or loss on disposal of an item of property, plant and equipment is the difference between the net sale proceeds and its carrying amount, and is recognised in profit or loss on disposal.

物業、廠房及設備按於其估計可使用年期使用直線法折舊，以將其成本(扣除預計剩餘價值)撇銷。於各報告期末，使用年期、剩餘價值及折舊法會予以審閱及調整(如適合)。使用年期載列如下：

燃氣管道及機器	3至30年

在建工程乃以成本減減值虧損入賬。成本包括建築工程的直接成本及在建築及安裝期間資本化的借款成本。當資產投入原定用途所需的準備工作大致完成時，這些成本便會停止資本化，而在建工程亦會轉入物業、廠房及設備的適當類別內。除非在建工程已經完成，並可隨時投入原定用途，否則在建工程不計提任何折舊撥備。

倘資產的賬面值高於其估計可收回金額，資產實時撇減至其可收回金額。

出售物業、廠房及設備項目的收益或虧損，指銷售所得款項淨額與其賬面值兩者間的差額，於出售時在損益中予以確認。

(g) Investment property

Investment property is property held either to earn rentals or for capital appreciation or for both, but not held for sale in the ordinary course of business, use in the production or supply of goods or services or for administrative purposes.

Investment property is stated at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any. Depreciation is charged so as to write off the cost of investment property net of expected residual value over the estimated useful life using straight-line method. The useful life, residual value and depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period.

(h) Leases

The Group as lessee

All leases are required to be capitalised in the statement of financial position as right-of-use assets and lease liabilities, but accounting policy choices exist for an entity to choose not to capitalise (i) leases which are short-term leases and/or (ii) leases for which the underlying asset is of low-value. The Group has elected not to recognise right-of-use assets and lease liabilities for low-value assets and leases for which at the commencement date have a lease term of less than 12 months. The lease payments associated with those leases have been expensed on straight-line basis over the lease term.

(g) 投資物業

投資物業為持作賺取租金或資本升值或兩者兼有，惟並非於日常業務過程中持作出售、用於生產或提供貨品或服務，或作行政用途的物業。

投資物業按成本減其後累計折舊及其後累計減值虧損(如有)列賬。折舊乃以直線法按估計可使用年期扣除，以撇銷投資物業之成本(扣除預期剩餘價值)。可使用年期、剩餘價值及折舊方法於各報告期末檢討並於適當情況下作出調整。

(h) 租賃

本集團作為承租人

所有租賃須於財務狀況表資本化為使用權資產及租賃負債，惟實體獲提供會計政策選擇，可選擇不將(i)屬短期租賃的租賃及/或(ii)相關資產為低價值的租賃進行資本化。本集團已選擇不就低價值資產以及於開始日期租賃期少於12個月的租賃確認使用權資產及租賃負債。與該等租賃相關的租賃付款已於租賃期內按直線法支銷。

Right-of-use asset

The right-of-use asset is initially recognised at cost and would comprise:

- (i) the amount of the initial measurement of the lease liability (see below for the accounting policy to account for lease liability);
- (ii) any lease payments made at or before the commencement date, less any lease incentives received;
- (iii) any initial direct costs incurred by the lessee; and
- (iv) an estimate of costs to be incurred by the lessee in dismantling and removing the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories.

The Group measures the right-of-use assets applying a cost model. Under the cost model, the Group measures the right-to-use at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liability.

The Group has leased a number of properties under tenancy agreements which the Group exercises its judgement and determines that it is a separate class of asset apart from the leasehold land and buildings which is held for own use. As a result, the right-of-use asset arising from the properties under tenancy agreements are carried at depreciated cost.

使用權資產

使用權資產初步按成本確認並將包括：

- (i) 初步計量租賃負債的金額(見下文有關租賃負債入賬的會計政策)；
- (ii) 於開始日期或之前作出的任何租賃付款減已收取的任何租賃獎勵；
- (iii) 承租人產生的任何初步直接成本；及
- (iv) 承租人根據租賃條款及條件規定的情況下分解及移除相關資產時將產生的估計成本，除非該等成本乃為生產存貨而產生則除外。

本集團採用成本模式計量使用權資產。根據成本模式，本集團按成本減任何累計折舊及任何減值虧損計量使用權，並就租賃負債的任何重新計量作出調整。

本集團已根據租賃協議租賃若干物業，按本集團自行判斷，確認其為持作自用的租賃土地及樓宇以外的獨立資產類別。因此，租賃協議項下物業產生的使用權資產按折舊成本列賬。

Lease liability

The lease liability is recognised at the present value of the lease payments that are not paid at the date of commencement of the lease. The lease payments are discounted using the interest rate implicit in the lease, if that rate can be readily determined. If that rate cannot be readily determined, the Group uses the lessee's incremental borrowing rate.

The following payments for the right-to-use the underlying asset during the lease term that are not paid at the commencement date of the lease are considered to be lease payments:

- (i) fixed lease payments less any lease incentives receivable;
- (ii) variable lease payments that depend on an index or a rate, initially measured using the index or rate as at commencement date;
- (iii) amounts expected to be payable by the lessee under residual value guarantees;
- (iv) exercise price of a purchase option, if the lessee is reasonably certain to exercise that option; and
- (v) payments of penalties for terminating the lease, if the lease term reflects the lessee exercising an option to terminate the lease.

Subsequent to the commencement date, the Group measures the lease liability by:

- (i) increasing the carrying amount to reflect interest on the lease liability;
- (ii) reducing the carrying amount to reflect the lease payments made; and
- (iii) remeasuring the carrying amount to reflect any reassessment or lease modification, or to reflect revised in-substance fixed lease payments.

(h) 租賃(續)

租賃負債

租賃負債按於租賃開始日期未支付之租賃付款的現值確認。租賃付款將採用租賃暗含的利率貼現(倘該利率可輕易釐定)。倘該利率無法輕易釐定,本集團採用承租人的增量借款利率。

下列並非於租賃開始日期支付的租賃期內就相關資產之使用權支付之款項被視為租賃付款:

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to lessee. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

Amounts due from lessees under finance leases are recorded as receivables at the amount of the Group's net investment in the leases. Finance lease income is allocated to accounting periods so as to reflect a constant periodic rate of return on the Group's net investment outstanding in respect of the leases.

Any changes in the scope of the consideration for a lease that was not part of the original terms and conditions of the lease are accounted for as lease modifications. Interest income calculated using the effective interest method, foreign exchange gains and losses and impairment are recognised in profit or loss. Other net gains and losses are recognised in other comprehensive income. On derecognition, gains and losses accumulated in other comprehensive income are reclassified to profit or loss.

FVTPL: Financial assets at FVTPL include financial assets held for trading, financial assets designated upon initial recognition at FVTPL, or financial assets mandatorily required to be measured at fair value. Financial assets are classified as held for trading if they are acquired for the purpose of selling or repurchasing in the near term. Derivatives, including separated embedded derivatives, are also classified as held for trading unless they are designated as effective hedging instruments. Financial assets with cash flows that are not solely payments of principal and interest are classified and measured at FVTPL, irrespective of the business model. On initial recognition of an equity investment that is not held for trading, the Group could irrevocably elect to present subsequent changes in the investment's fair value in other comprehensive income. This election is made on an investment-by-investment basis. Equity investments at FVTOCI are measured at fair value. Dividend income are recognised in profit or loss unless the dividend income clearly represents a recovery of part of the cost of the investments. Other net gains and losses are recognised in other comprehensive income and are not reclassified to profit or loss. All other equity instruments are classified as FVTPL, whereby changes in fair value, dividends and interest income are recognised in profit or loss.

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the assets' original effective interest rate.

The Group measured loss allowances for trade receivable using IFRS 9 simplified approach and has calculated ECLs based on lifetime ECLs. The Group has established a provision matrix that is based on the Group's historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For other debt financial assets, ECLs are based on lifetime ECLs except when there has not been a significant increase in credit risk since initial recognition and debt investment securities that are determined to have low credit risk at the reporting date, in which case the allowance will be based on the 12-months ECLs.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECL, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be in default when: (1) the debtor is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to action such as realising security (if any is held); or (2) the financial asset is more than 90 days past due.

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

The Group considers a financial asset to be credit-impaired when:

- significant financial difficulty of the debtor;
- a breach of contract, such as a default or being more than 90 days past due;
- the restructuring of a loan or advance by the Group on terms that the Group would not consider otherwise;
- it is probable that the debtor will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for a security because of financial difficulties.

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

Interest income on credit-impaired financial assets is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset. For non credit-impaired financial assets, interest income is calculated based on the gross carrying amount.

(iii) Financial liabilities

The Group classifies its financial liabilities, depending on the purpose for which the liabilities were incurred. Financial liabilities at FVTPL are initially measured at fair value and financial liabilities at amortised costs are initially measured at fair value, net of directly attributable costs incurred.

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at FVTPL.

(v) Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

(vi) Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument. A financial guarantee contract issued by the Group and not designated as at FVTPL is recognised initially at its fair value less transaction costs that are directly attributable to the issue of the financial guarantee contract. The Group derecognises a financial asset when the contractual rights to the future cash flows in relation to the financial asset expire or when the financial asset has been transferred and the transfer meets the criteria for derecognition in accordance with IFRS 9.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires.

(k) Inventories

Inventories are initially recognised at cost, and subsequently at the lower of cost and net realisable value. Cost comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition. Cost is calculated using the weighted average method. Net realisable value represents the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

(l) Service concession arrangements

The Group has entered into a number of service concession arrangements with certain governmental authorities in the PRC or their designees (the "Grantors"). The service concession arrangements consist of Build-Operate-Transfer ("BOT") arrangements and Transfer-Operate-Transfer ("TOT") arrangements. Under the BOT arrangements, the Group carries out construction work of the wastewater for the Grantors and receives in return a right to operate the service project concerned for a specified period of time (the "concession period") in accordance with the pre-established conditions set by the Grantors, and the service project shall be transferred to the Grantors at nil or minimal consideration at the end of the concession period. A TOT arrangement is similar to a BOT arrangement, except that the Group pays consideration for the right to operate the sewage and reclaims water treatment or water distribution service that has been built.

Under IFRIC 12 “Service Concession Arrangements”, service concession arrangements are accounted for as follows if:

- (i) the grantor controls or regulates what services the operator must provide with the infrastructure, to whom it must provide them, and at what price; and
- (ii) the grantor controls through ownership, beneficial entitlement or otherwise any significant residual interest in the infrastructure at the end of the term of the arrangement.

The Group's rights over the infrastructure

Infrastructure constructed by the Group under service concession arrangements is not recognised as property, plant and equipment of the Group because the contractual service arrangement does not convey the right to control the use of the infrastructure to the Group. The Group as the operator has access to operate the infrastructure to provide the public service on behalf of the grantor in accordance with the terms specified in the contract.

Consideration received or receivable by the Group for the construction services

Consideration received or receivable by the Group for the construction services rendered under service concession arrangement is recognised at its fair value as a financial asset or an intangible asset.

A financial asset is recognised to the extent that (a) the Group has an unconditional right to receive cash or another financial asset from or at the direction of the grantor for the construction services rendered; and (b) the grantor has little, if any, discretion to avoid payment, usually because the agreement is enforceable by law.

The Group has an unconditional right to receive cash if the grantor contractually guarantees to pay the Group (a) specified or determinable amounts or (b) the shortfall, if any, between amount received from users of the public services and specified or determinable amounts, even if the payment is contingent on the Group ensuring that the infrastructure to be constructed meets specified quality of efficiency requirements. The financial asset is accounted for in accordance with the policy set out for “Financial instruments” in note 4(j).

An intangible asset (concession intangible asset) is recognised to the extent that the Group receives a right to charge users of the public service, which is not an unconditional right to receive cash because the amounts are contingent on the extent that the public uses the service. The intangible asset (concession intangible asset) is accounted for in accordance with the policy set out for “Intangible assets” in note 4(i).

If the Group is paid partly by a financial asset and partly by an intangible asset, in which case, each component of the consideration is accounted for separately and the consideration received or receivable for both components are recognised initially at fair value of the consideration received or receivable.

Contractual obligations to restore the infrastructure to a specified level of serviceability

The Group has contractual obligations which it must fulfill as a condition of its licence, that is (a) to maintain the wastewater treatment plants it operates to a specified level of serviceability; and/or (b) to restore the plants to a specified condition before they are handed over to the grantor at the end of the service concession arrangement. These contractual obligations to maintain or restore the wastewater treatment plants are recognised and measured in accordance with the policy set out for "Provisions and contingent liabilities" in note 4(v).

(m) Revenue recognition

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Depending on the terms of the contract and the laws that apply to the contract, control of the goods or service may be transferred over time or at a point in time. Control of the goods or service is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- creates or enhances an asset that the customer controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

Contract Assets

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with IFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

Contract liabilities

A contract liability represents the Group's obligation to transfer services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

Income taxes for the year comprise current tax and deferred tax.

Current tax is based on the profit or loss from ordinary activities adjusted for items that are non-assessable or disallowable for income tax purposes and is calculated using tax rates that have been enacted or substantively enacted at the end of reporting period. The amount of current tax payable or receivable is the best estimate of the tax amount expected to be paid or received that reflects any uncertainty related to income tax.

Deferred tax is measured at the tax rates appropriate to the expected manner in which the carrying amount of the asset or liability is realised or settled and that have been enacted or substantively enacted at the end of reporting period, and reflects any uncertainty related to income taxes.

The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the assets to be recovered.

An exception to the general requirement in determining the appropriate tax rate used in measuring deferred tax amount is when an investment property is carried at fair value under IAS 40 "Investment Property". Unless the presumption is rebutted, the deferred tax amounts on these investment properties are measured using the tax rates that would apply on sale of these investment properties at their carrying amounts at the reporting date. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the property over time, rather than through sale.

Income taxes are recognised in profit or loss except when they relate to items recognised in other comprehensive income in which case the taxes are also recognised in other comprehensive income or when they relate to items recognised directly in equity in which case the taxes are also recognised directly in equity.

(o) Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than entity's functional currencies (foreign currencies) are recognised at the rates of exchange prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated. Exchange differences on monetary items are recognised in profit or loss in the period in which they arise.

For the purpose of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. RMB) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve, attributed to non-controlling interests as appropriate.

(p) Capitalisation of borrowing costs

Borrowing costs attributable directly to the acquisition, construction or production of qualifying assets which require a substantial period of time to be ready for their intended use or sale, are capitalised as part of the cost of those assets. Income earned on temporary investments of specific borrowings pending their expenditure on those assets is deducted from borrowing costs capitalised. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(q) Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets (including property, plant and equipment) are recognised as deferred income in the statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable and are recognised as other revenue, rather than reducing the related expense.

The benefit of a government loan at a below-market rate of interest is treated as a government grant, measured as the difference between proceeds received and the fair value of the loan based on prevailing market interest rates.

(r) Employee benefits

(i) Short term employee benefits

Short term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of each reporting period in which the employees render the related service. Short term employee benefits are recognised in the period when the employees render the related service.

(iii) Defined contribution retirement plans

Contributions to defined contribution retirement plans are recognised as an expense in the profit or loss when the services are rendered by the employees.

One of the subsidiaries of the Company provides supplementary pension subsidies to retired employees in the PRC. Such supplementary pension subsidies are considered as defined benefit plans. The cost of providing benefits is determined using the projected unit credit method, with actuarial valuations being carried out at the end of each annual reporting period. Remeasurement, comprising actuarial gains and losses is reflected immediately in the consolidated statement of financial position with a charge or credit recognised in other comprehensive income in the period in which they occur. Remeasurement recognised in other comprehensive income will not be reclassified to profit or loss. Past service cost is recognised in profit or loss in the period of a plan amendment. Net interest is calculated by applying the discount rate at the beginning of the period to the net defined benefit liability or asset. Defined benefit costs are categorised as follows:

- service costs (including current service cost, past service cost, as well as gains and losses on curtailments and settlements);
- net interest expense or income; and
- remeasurement.

The retirement benefit obligation recognised in the consolidated statement of financial position represents the actual deficit or surplus in the Group's defined benefit plans. Any surplus resulting from this calculation is limited to the present value of any economic benefits available in the form of reductions in future contributions to the plans. A liability for a termination benefit is recognised at the earlier of when the Group entity can no longer withdraw the offer of the termination benefit and when it recognises any related restructuring costs.

Cash and cash equivalents comprise cash balances and short-term deposits and highly liquid investments with maturities of three months or less from the date of acquisition that are subject to an insignificant risk of changes in their fair value, and are used by the Group in the management of its short-term commitments. For the purpose of the statement of cash flows, bank overdrafts that are repayable on demand and that form an integral part of the Group's cash management are included in cash and cash equivalents.

Consolidation of entities in which the Group holds 50% voting rights

Control over Shanghai Dazhong Gas

The Company and Shanghai Gas Co., Ltd. ("Shanghai Gas") each holds a 50% equity interests in Shanghai Dazhong Gas and each party has the right to appoint three directors to the six-member board of directors. The legal representative and the chairman of the board of Shanghai Dazhong Gas, Mr. Yang Guoping, is appointed by the Group pursuant to the articles of association of Shanghai Dazhong Gas. In assessing whether the Group has power over Shanghai Dazhong Gas, the following considerations were taken into account:

Purpose and design of Shanghai Dazhong Gas: The directors consider that the purpose and design since the establishment of Shanghai Dazhong Gas is for the Group to control it. Moreover, the management and operation system of Shanghai Dazhong Gas was set up by the Group and key management personnel overseeing the relevant activities which significantly affect the returns (i.e. the "Relevant Activities") are nominated and appointed by the Group. In addition, the Group has veto right to block any changes to the current system.

Relevant Activities of Shanghai Dazhong Gas and how decisions about the Relevant Activities are made: The directors have determined that the Relevant Activities of Shanghai Dazhong Gas are: (a) design and construction of gas pipelines; (b) appointment, evaluation and remuneration of key management personnel; (c) budgeting and financial management; (d) management of supply and sales volume difference and major customer discount; and (e) strategic investments. On the other hand, given the strict regulation in the gas supplies supply, neither the Group nor Shanghai Gas, which was also the key gas supplier of the Group in Shanghai, was able to adjust the gas procurement and retail price or opt to suspend or terminate gas supply. Accordingly, the directors conclude that supply and sale of piped gas (excluding management of supply and sale volume difference and major customer discount) are not the Relevant Activities. While it was not specified in the articles of association or shareholders' agreement of Shanghai Dazhong Gas, in practice, all important decisions relating to the Relevant Activities were made at the executive management meetings led by the chairman of the board appointed by the Group.

對上海大眾燃氣的控制

本公司及上海燃氣有限公司(「上海燃氣」)各自持有上海大眾燃氣的50%股權，各方有權委任董事會六名董事中的三名董事。上海大眾燃氣的法定代表人兼董事會主席楊國平先生乃由本集團根據上海大眾燃氣的組織章程委任。於評估本集團是否可對上海大眾燃氣行使權力時，已考慮到以下的因素：

*上海大眾燃氣的目的及意圖：*董事認為自上海大眾燃氣成立以來，其目的及意圖為讓本集團控制上海大眾燃氣。此外，上海大眾燃氣的管理及營運體系由本集團設置，而負責監管對回報構成重大影響的相關活動(即「相關活動」)的主要管理層人員由本集團提名及委任。再者，本集團擁有否決權阻止更改現行體系。

*上海大眾燃氣的相關活動及有關相關活動之決策如何制定：*董事確認上海大眾燃氣的相關活動為：(a)燃氣管道的設計及建設；(b)主要管理人員的委任、考核及薪酬；(c)預算及財務管理；(d)供應及銷量差額以及主要客戶折扣的管理；及(e)戰略投資。另一方面，鑒於燃氣供應的規管嚴格，本集團及上海燃氣，亦即本集團於上海的主要燃氣供應商，均無法調整燃氣採購及零售價格或決定暫停或終止燃氣供應。因此，董事認為，管道燃氣的供應及銷售(不包括供應及銷量差額以及主要客戶折扣的管理)並非相關活動。儘管上海大眾燃氣組織章程或股東協議並無訂明，但實際上，有關相關活動的所有重要決策均在本集團所委任的董事會主席主導的行政管理會議上制定。

The current ability of the Group to direct relevant activities: The directors concluded that the Group has the current ability to direct the Relevant Activities of Shanghai Dazhong Gas as:

- the Group can nominate and appoint key management personnel of Shanghai Dazhong Gas, which includes the chairman and legal representative, secretary of the board, chief financial officer, chief economist and chief engineer. These key management personnel are those who collectively and individually have the ability to direct the Relevant Activities;
- the chairman appointed by the Group directs Shanghai Dazhong Gas on all significant transactions through his active leadership in the executive management meetings. The chairman is also the legal representative of Shanghai Dazhong who is responsible for signing key contracts with external parties and making relevant payments; and
- the Group has majority voting rights at the remuneration committee which determines the remuneration of key management as an incentive to achieve operational and financial goals of Shanghai Dazhong Gas.

The directors also consider that Shanghai Dazhong Gas does not rely on Shanghai Gas operationally or financially and Shanghai Gas cannot unilaterally approve any changes to the arrangement discussed above. Based on the above, the directors consider that the Group is the party that has power over Shanghai Dazhong Gas.

本集團主導相關活動的現有能
力：董事認為，本集團具有現有
能力以主導上海大眾燃氣的相關

- 本集團可提名及委任上海大眾燃氣的主要管理人員，包括董事長及法定代表人、董事會秘書、財務總監、總經濟師及總工程師。該等主要管理人員為共同及個別地有能力主導相關活動的人士；
- 由本集團委任的董事長於行政管理會議上透過其積極領導，領導上海大眾燃氣的所有重大交易。董事長亦為上海大眾的法定代表人，負責與外部實體簽署主要合約並支付有關款項；及
- 本集團於薪酬委員會上具有大多數投票權，該委員會釐定主要管理層的薪酬，作為達成上海大眾燃氣經營及財務目標的激勵。

董事亦認為，上海大眾燃氣在經營或財務方面並無依賴上海燃氣，而上海燃氣不得單方面批准更改上述安排。按照上文所述，董事認為，本集團為可對上海大眾燃氣行使權力的一方。

Since the Group holds 50% equity interests in Shanghai Dazhong Gas, it is considered that the Group has sufficient exposure from variable returns of Shanghai Dazhong Gas and is able to use its power to affect the variable returns.

Based on all relevant facts and circumstances above, the directors consider that the Company has the practical ability to direct the relevant activities of Shanghai Dazhong Gas, which demonstrates the Group has power over Shanghai Dazhong Gas, exposure to variable returns from Shanghai Dazhong Gas and ability to use its power to affect its variable returns throughout the year.

Control over Nantong Dazhong Gas

The Group and Nantong Gas Co., Ltd. each holds 50% equity interest in Nantong Dazhong Gas and each has appointed three directors to the board of directors which currently comprises of six members. The Group has also appointed the chairman of the board, the vice general manager and the financial controller of Nantong Dazhong Gas. In addition, the procedural rules of the board of directors of Nantong Dazhong Gas specifically provides that the chairman of the board has (i) a casting vote in the event of a deadlock of board vote and (ii) a veto right on matters in daily operations.

Significant influence over investees

The Group has an investment in an entity, namely Shenzhen Capital Group (as defined in note 24(a)) in which it holds 10.80% of its equity interests. The directors consider that the Group has a significant influence over this entity based on the following factors: (1) the Group has the right to appoint 2 directors out of a total of 13 directors of the board of directors of Shenzhen Capital Group and (2) these 2 directors also act as members of strategy and budget committee, remuneration and assessment committee and nomination committee of Shenzhen Capital Group. The above demonstrates that the Group actively participates in the entity's operating and financial policies, and thus investment in Shenzhen Capital Group is accounted for as an associate of the Group.

The Group also has investments in four entities, namely SEISYS (as defined in note 24(a)), Suchuang Gas (as defined in note 24(a)), Vietnam Investments Securities Company ("IVS") and Jiangsu Dongneng Natural Gas (as defined in note 24(a)), in which the Group holds 16.63%, 19.31%, 12.02% and 10.00% of their equity interests respectively. The directors consider that the Group has significant influence over SEISYS based on the following factors: (1) the Group has appointed 2 directors to the boards of directors which consisting of 9 executive directors; and (2) the appointed director actively participates in the policy-making process of the entity. Besides, the directors consider that the Group has significant influence over Suchuang Gas based on the following factors: (1) the Group has appointed 1 director to the boards of directors which consisting of 9 directors; and (2) the appointed director actively participates in the policy-making process of the entity. Besides, the directors consider that the Group has significant influence over Vietnam Investment Securities Company based on the following factors: (1) the Group has appointed 1 director to the board of directors which consisting 5 directors; and (2) the appointed director actively participates in the policy-making process of the entity. Furthermore, the directors consider that the Group has significant influence over Jiangsu Dongneng Natural Gas based on the following factors: (1) the Group has appointed 1 director to the board of directors which consisting of 7 directors; and (2) the appointed director actively participates in the policy-making process of the entity.

Significant influence over investees (Continued)

The Group has certain investments, in which it holds more than 20% of their equity interests or voting right during the year. The directors of the Company consider that the Group has no significant influence nor control over the entities based on the fact that the Group does not participate in any operating and financial policies of the entities and exercise its influence on the operating and financial policies in the board of directors of entities. The Group therefore accounted for these entities as financial assets at FVTPL.

No control over 50% equity interest in an investee

The Group held equity interest of 50% in Tiancheng Huifeng (as defined in note 24(a)). The directors of the Company considered that the Group has significant influence over this entity based on the following factors: (1) Tiancheng Huifeng has established the Investment Committee for decision making of relevant activities and policy-making, of which the Group has appointed 2 committee members to the Investment Committee (total 5 members), with the other 3 committee members appointed by the other shareholders, who owned another 50% equity interests in Tiancheng Huifeng; and (2) the appointed committee members actively participate in the policy-making process of the entity and the decision making of relevant activities are based on simple majority voting. The directors of the Company concluded that the Company only had significant influence and no control over Tiancheng Huifeng.

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Useful lives of non-current assets

The Group depreciates the property, plant and equipment, investment properties and the intangible assets over their estimated useful lives in accordance with the accounting policies stated in notes 4(f), 4(g) and 4(i) respectively. Such estimated useful lives reflect the directors' best estimate of the periods that the Group intends to derive future economic benefits from the use of these assets.

Impairment of non-financial assets (except for goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets at the end of each reporting period. They are tested for impairment when there are indicators that the carrying amounts may not be recoverable. When value-in-use calculations are undertaken, management estimates the expected future cash flows from the asset or corresponding cash-generating unit and determines a suitable discount rate in order to calculate the present value of those cash flows.

Impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the value in use of the cash-generating units to which goodwill has been allocated. The value in use calculation requires the directors to estimate the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate the present value. The carrying amount of the Group's goodwill as at 31 December 2024 is RMB12,737,000 (2023: RMB12,737,000).

商譽減值

Expected credit losses on financial assets

The Group makes estimates of expected credit losses attributable to financial assets, including the incorporation of forward-looking information to supplement historical credit loss rates.

The assessment on ECLs relies on the analysis and judgement by the management. The key factors includes the debtors' and guarantors' financial and operating conditions, any other pledged assets, the liquidity of the collaterals of the leases and loans and the cash flow forecast of the debtors' business with reasonable discount rates. The assessment on ECLs on lease receivables mainly depends on the external macroeconomic conditions and internal credit risk management. The ECLs determined by the Group had also included the review on historical loss experience and other adjusting factors.

Further information on the impairment assessment on financial assets are provided in note 49.

Construction contracts

Revenue recognition on an uncompleted project is dependent on estimating the total outcome of the construction contract, as well as the work done to date. Based on the Group's recent experience and the nature of the construction activity undertaken by the Group, the Group makes estimates of the point at which it considers the work is sufficiently advanced such that the costs to complete and revenue can be reliably estimated. However, actual outcomes in terms of total cost or revenue may be higher or lower than estimated at the end of each reporting period, which would affect the revenue and profit recognised in future years as an adjustment to the amounts record to date.

未完成項目的收益確認取決於對建築合約總結果的估計，以及迄今已進行的工程。根據本集團的近期經驗及本集團進行的建築業務的性質，本集團會估計其認為工程已充分預付以致能可靠估計完成成本及收益的時間點。然而，有關總成本或收益的實際結果可能高於或低於各報告期末的估計，其將會影響於未來年度作為迄今所入賬金額的調整確認的收益及溢利。

Estimation of the amortisation period of deferred income

The Group receives fees from customers in advance in exchange for the connection of their gas pipelines. These fees are received upfront and gradually amortised. The Group determines the estimated amortisation period of ten years for its revenue recognition. Any change in the estimation would significantly affect the timing of revenue recognition.

Retirement benefit obligations

The retirement benefit obligations are estimated based on a number of factors that are determined on an actuarial basis using a number of assumptions as disclosed in note 41(a). The accuracy of the estimate mainly depends on the extent of deviation between the actuarial assumptions and the actual conditions. Any changes in these assumptions will have an impact on the carrying amount of retirement benefit obligations.

IFRIC 12 "Service Concession Arrangements"

As explained in note 4(l), the Group recognises its BOT and TOT arrangements under IFRIC 12 "Service Concession Arrangements" because (i) the Grantors control and regulate the services that the Group must provide with the infrastructure at a pre-determined service charge in respect of these BOT and TOT arrangements, and (ii) upon expiry of concession right agreement, the infrastructure has to be transferred to the Grantors at nil or minimal consideration.

The fair value of the construction services under each of the BOT arrangements was calculated as the estimated total construction cost plus a profit margin. The profit margins were estimated based on prevailing market rates applicable to similar construction services rendered in similar locations at dates of agreements.

The Group recognises the consideration received or receivable in exchange for the construction services as a financial asset and/or an intangible asset under public-to-private concession arrangement. However, if the Group is paid for the construction services partly by a financial asset and partly by an intangible asset, it is necessary to account separately for each component of the operator’s consideration. The consideration received or receivable for both components shall be recognised initially at the fair value of the consideration received or receivable.

The segregation of the consideration for a service concession arrangement between the financial asset component and the intangible asset component, if any, requires the Group to make an estimate of a number of factors, which include, inter alia, fair value of the construction services, expected future wastewater treatment volume of the relevant wastewater treatment plant over its service concession period, future guaranteed receipts and unguaranteed receipts, and also to choose a suitable discount rate in order to calculate the present value of those cash flows. These estimates are determined by the Group’s management based on its experience and assessment on current and future market condition. Any change in the key assumptions, will result in change in the carrying value of the financial receivable.

Subsequently to initial recognition, the intangible asset is measured at cost, which includes capitalised borrowing costs, less accumulated amortisation and impairment losses. The estimated useful life of an intangible asset, which is the key assumption in a service concession arrangement, is the period from when the Group is able to charge the public for the use of the infrastructure to the end of the concession period. Any change in the expected useful life would change the carrying amount of the intangible assets.

Estimation of assets restoration obligations

The Group has contractual obligations whereby it must fulfill as a condition of its licence that is to maintain the wastewater treatment plants it operates to a specified level of serviceability and/or to restore the plants to a specified condition before they are handed over to the grantor at the end of the service concession arrangement. Provision is recognised for the future restoration, which the amount recognised is the present value of the estimate future expenditure. The estimation of the future expenditure is based on current local conditions and requirements, including legal requirement, contractual requirement, technology, price level, etc. Changes in any of these estimates will impact the level of provision made.

The Group as lessor

Classification between finance lease and operating lease

Leases are required to be classified as either finance leases (which transfer substantially all the risks and rewards of ownership, and give rise to asset and liability recognition by the lessee and a receivable by the lessor) and operating leases (which result in right-of-use assets recognition by the lessee, with the asset remaining recognised by the lessor). Situations that would normally lead to a lease being classified as a finance lease include the following:

- the lease transfers ownership of the asset to the lessee by the end of the lease term;
- the lessee has the option to purchase the asset at a price which is expected to be sufficiently lower than the fair value at the date the option becomes exercisable and, at the inception of the lease, it is reasonably certain that the option will be exercised;
- the lease term is for the major part of the economic life of the asset, even if title is not transferred;

Except for the wastewater plant in Pizhou which is operated under TOT arrangement, the rest are operated under BOT arrangements.

No advance payments were made to the grantors for getting the above BOT and TOT arrangements.

The concession rights arose from wastewater treatment plant located in Jiading District, Shanghai.

49. FINANCIAL RISK

The Group exposures to credit, interest rate, liquidity and foreign currency risks arises in the normal course of its business.

The Group's principal financial instruments mainly include trade and bills receivable, lease receivables, restricted bank deposits, cash and cash equivalents and trade and bills payable, interest-bearing borrowings which arise directly from its operations. The Group has other financial assets and liabilities such as deposits and other receivables, and other payables and accruals. The main purpose of these financial instruments is to raise finance for the Group's operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The Group does not hold or issue derivative financial instruments either for hedging or for trading purposes. The board reviews and agrees policies for managing each of the risks which are summarised below:

Interest rate risk

The Group's exposure to market risk for changes in interest rates relates primarily to its interest-bearing bank loan and other borrowings. The Group does not use derivative financial instruments to hedge its interest rate risk. With all other variable held constant, the Group's profit after tax and equity is affected through the impact on floating rate borrowings, as follows:

Concentrations of credit risk exist when changes in economic, industrial or geographic factors similarly affect groups of counterparties whose aggregate credit exposure is significant in relation to the Group's total credit exposure.

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Group. At the end of each reporting period, the Group's maximum exposure to credit risk which cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statements of the financial position.

In order to minimise credit risk, the Group has tasked its finance team to develop and maintain the Group's credit risk grading to categorise exposures according to their degree of risk of default. Management uses publicly available financial information and the Group's own historical repayment records to rate its major customers and other debtors. The Group's exposure and the credit ratings of its counterparties are continuously monitored and the aggregate exposure is spread amongst approved counterparties.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

Loss allowances on other receivables is measured as either 12-month ECLs or lifetime ECLs, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, then impairment is measured as lifetime ECLs.
